The Licesing Act 2003 requires a Statement of Licencing Policy to be published every 5 years by each Licensing Authority. Publishing a new Statement of Licensing Policy for Brent is intended to update the existing Statement of Licensing Policy to ensure that it is relevant in light of changes to legislation, regulations, guidance and specific Brent circumstances and environment.

The new Statement of Licensing Policy will have some level of impact for: public services, particularly those with an enforcement role; residents, particularly those that live near areas with alcohol-related or Night Time Economy impacts; and, the owners, operators, staff and customers of premises licensed to sell alcohol. The Statement of Licensing Policy may also have some impact on individuals who suffer alcohol-related harms, and their families and communities.

It is unlikely that the new Statement of Licensing Policy will have any impact on the equalities or of the protected charecteristics.
