# BRENT COUNCIL'S REPRESENTATION ON OUTSIDE BODIES AND OTHER APPOINTMENTS

#### 1.0 **SUMMARY**

This report requests nominations to outside bodies that currently require representation from Brent Council and other Member appointments.

#### 3.0 **DETAIL**

# 3.1 New Bodies since May 2004

Historic Environment Champion

This position has been created following a recommendation from the Office of the Deputy Prime Minister that local Councils appoint to this position. It is proposed that the Council nominates an Historic Environment Champion to contribute to the Council's development of a vision for historic buildings in order to provide a framework for their regeneration.

### 3.2 Changes to Bodies

#### 3.2.1 Ackworth Trust

The Ackworth Trust ceased to exist during the municipal year 2004-2005 and consequently the Council is no longer required to provide the Trust with Member representation.

### 3.2.2. Brent Education & Environmental Centres Advisory Body

The Brent Education & Environment Centres Advisory Body ceased to exist during the municipal year 2004-2005 and consequently the Council is no longer required to provide this Body with Member representation.

# 3.2.3. Changing Practices SRB Board

The Changing Practices SRB Board ceased to exist during the municipal year 2004-2005 and consequently the Council is no longer required to provide Member representation to this body.

#### 3.2.4. Connexions London West

The Connexions London West body ceased to exist during the municipal year 2004-2005 and consequently the Council is no longer required to provide this Body with Member representation.

# 3.2.5 Early Years Development & Childcare Partnership (EYDCP)

The EYDCP ceased to exist during the municipal year 2004-2005 and consequently the Council is no longer required to provide this Body with Member representation.

# 3.2.6 North West London Strategic Health Authority Continuing Care Review Panel

The Continuing Care Review Panel no longer accepts Member representation as a result of changes to their terms of reference during the 2004 municipal year.

#### 3.3 Additional Information

#### 3.3.1 Wembley National Stadium Trust

The Council previously maintained representation on the Wembley National Stadium Trust (WNST), but stepped down in order to prevent any conflict of interest when assessing the planning application for the Stadium. It has since been agreed by the trustees, including the Chair, to reinstate a representation on the Trust for the London Borough of Brent.
