## 1. Apologies for Absence

#### 2. Declarations of Interests

## 3. Statement of Community Involvement

The report informed Members that a binding report was issued by the Planning Inspector, following the Independent Examination on the Statement of Community Involvement (SCI) and that the SCI passed its test of soundness. - (viii) that the Constitutional Working Group be re-established comprising two Members from each political group and supported by the Director of Policy and Regeneration and the Borough Solicitor, to review the Constitution and, in particular, the role of Overview and Scrutiny and the Members Allowance scheme:
- (ix) that the Head of Procurement and Risk Management review the method of reporting to Members on contract matters;
- (x) that the Head of Property and Asset Management submit a quarterly report to the Performance and Finance Select Committee setting out details of any asset disposals.

# 5. Review of Representation of Political Groups on Committees and Appointments to Committees

The Council is required to review and determine the representation of the political groups on committees and allocate committee places to political groups accordingly at, or as soon as practicable after, its Annual meeting.

Councillors Beswick and Colwill jointly moved a motion to determine the political balance of the Council's committees and sub-committees. The motion was put to the vote and declared CARRIED.

#### 6. The Executive
