4. Mayor's Announcements

The Mayor thanked the Deputy Mayor, Councillor Ralph Fox for chairing the last Council meeting in his absence while in India. He stated that he had gone to India to receive an award – "Pride of Gujarat 2008" and had been honoured to receive such an award. He had attended nearly as many functions as the number of days of his stay and had kept Brent's flag flying. People in India had been very happy to hear about the diversity of Brent's residents and its unity.

The Mayor announced that the Council has once again secured a strong three star or 'good' rating in this year's annual assessment by the Audit Commission. The Council was also judged to be 'improving well' by the independent inspectors who commented favourably on the progress being made in priority areas such as educational attainment, street cleanliness, children's services and sport. Inspectors had also commented that the Council was ambitious, had a clear focus on achieving value for money and a strong financial standing. The Mayor reminded Members that the Memorial Service to honour the former Deputy Lieutenant, Brian Caesar-Gordon was taking place on 14th March at 11.30am at St Johns the Evangelist Church and then onto a tree planting and bench unveiling at Barham Park.

The Mayor announced with sadness the sudden death of Mr Mohammed Hoda from the Wembley Mosque who was known to most councillors.

The Mayor was pleased to announce that Brent had won an award at the New Year's Day Parade along with a cheque of £1,000 for the Mayor's Charity Appeal. He expressed his gratitude to the Youth Volunteers from Alperton School who paraded for Brent and gained this award.

The Mayor informed Members that he would be holding his "end of year" charity dinner on Saturday 19th April and asked that everyone support him on this occasion.

Finally, the Mayor thanked the Dawat Bar and Restaurant which had supplied the food after Council meetings during this year in office.

5. **Procedural motion**

Councillor Sneddon moved a procedural motion relating to the conduct of business which, following agreeing an amendment to it, was put to the vote and CARRIED.

 - (d) the Chair of Overview and Scrutiny Committee to speak for up to 10 minutes;
 - (e) the Leader of the Opposition to speak for up to 10 minutes:
 - (f) a general debate to follow during which the usual rules for debate will apply as set out in Standing Orders 46 and 47 save as set out in this procedural motion;
 - (g) voting on each Group's budget proposals shall be taken en bloc.

6. 2008/2009 Budget and Council Tax

The Council had before it a report from the Director of Finance and Corporate Resources regarding the 2008/2009 budget which included the final report of the Budget Panel. The Leader of the Council addressed the Council and moved the motion circulated in his and Councillor Blackman's names. Councillor J Moher addressed the Council and moved a separate budget motion circulated in his name proposing a number of alternative budget decisions. Councillor Blackman addressed the Council in support of the recommendations in the report.

Councillor Mendoza reported on the deliberations of the Budget Panel and thanked the members of the Panel and officers for their work during the year. He pointed out that the Panel had found the budget to be realistic and robust. There was concern that priority areas of growth had again been deferred and the Panel had called for information to be provided on the progress being made on delivering the Corporate Strategy priorities. Members of the Panel had noted how the population figures used by the Government continued to underestimate the number of people living in Brent and urged that an allparty approach to this be adopted. Members of the Panel were concerned at the risk of overspend in the Adult Social Care area and urged the Executive to look carefully at this. Finally it was noted that a number of the Panel's recommendations from last year had still to be addressed.

Councillor Jones addressed the meeting and explained some of the changes that had been agreed to the way overview and scrutiny operated. These included tracking the recommendations made by overview and scrutiny to ensure they were addressed. She drew attention to some of the provisions contained in the Local Government and Public Involvement in Health Act and the Police and Justice Act that would require attention by overview and scrutiny. In the meantime members of overview and scrutiny were meeting with representatives of the Post Office and the Metropolitan Police to consider the changes each of these bodies were proposing to make. Other task groups were continuing with their work.

Councillor John addressed the meeting by saying that she felt it was time the Administration took responsibility for the decisions they were taking and that there had been far worse financial settlements for local government in the past. She expressed her support for the call to use more accurate population estimates but pointed out that this was not just a Brent issue. She felt many aspects of the budget represented a continuation of the work started under the previous Administration. Referring to reported proposals for Brent's day centres, Councillor John

felt that these were not in the best interests of the service and should be looked at again.

Councillor Dunwell moved a motion seeking changes to the funding of the neighbourhood working scheme and using the consequent savings to reduce home care charges in 2008/09.

A general debate then followed at the end of which the separate motions in the names of Councillors J Moher and Dunwell were both put to the vote and declared LOST.

The Council then voted on the motion in the names of the Leader and Deputy Leader of the Council which was declared CARRIED.

being the aggregate of the sums which the Council estimates will be payable for the year into its general fund in respect of redistributed non-domestic rates and revenue support grant reduced by the amount of the sums which the Council estimates will be transferred in the year from its general fund to its collection fund in accordance with Section 97(4) of the Local Government Finance Act 1988.

(e) £1,033.11

being the amount at (c) above less the amount at (d) above, all divided by the amount for the taxbase specified above calculated by the Council, in accordance with Section 33(1) of the Act, as the basic amount of its Council Tax for the year.
