Following a detailed report in March 2008 Members approved the procurement and delivery of a new Civic Centre for Brent. In May, the Executive agreed, in principle, to acquire a site in the Wembley regeneration area for the purposes of constructing a new Civic Centre. This report sets out the available procurement routes for the delivery of the new Civic Centre, describes the methodology behind officers' internal evaluation, with expert advice, of those options and recommends an option for approval. The report also asks members to give their approval to acquire the freehold interest in the site as well as the leasehold interest at no additional cost

This report provides Members with an update on the case of *Risk Management Partners Ltd v London Borough of Brent* concerning participation in the London Authorities Mutual Ltd (LAML). It then explains the need for new Insurance arrangements for public liability and property, post 1 October 2008 and requests approval to invite tenders in respect of Insurance Services as required by Contract Standing Orders 88 and 89.

11 Brent Local Area Agreement 2008-2011 Cllr Blackman Duncan McLeod p. 81

This local area agreement is the responsibility of the Local Strategic Partnership 'Partners for Brent' and is signed off on their behalf by Councillor Paul Lorber, the Leader of the Council and Chair of the LSP. At its meeting on February 13th 2008 the LSP reviewed and agreed to the formal submission of the local area agreement priorities, and following negotiations the LSP agreed the arising changes which resulted from the negotiation process at its meeting on May 7th 2008, which is signed off by Councillor Lorber as Chair of the LSP. The Local Area Agreement will be formally agreed and signed off by the Council's Executive on June 16th 2008, and by the Local Strategic Partnership again at their next meeting on July 23rd 2008.
