Brent Council's Representation on Outside Bodies

1.0 Summary

1.1 This report concludes a review of appointments made by the Council to outside bodies. As a result of the review there are recommendations to introduce new arrangements to assess requests for Council appointments to outside bodies and a process for members to report back on the activities of the outside body.

2.0 Recommendations

That members:

- 2.1 Note the findings of the review of appointments to outside bodies.
- 2.2 Note that as a result of the review the Council no longer appoints representatives to a number of outside bodies which are set out in appendix 2.
- 2.3 Agree to adopt the process for assessing new requests for appointments to outside bodies as set out in paragraph 3.10 of this report.
- 2.4 Note that updated guidance for members appointed to outside bodies will be circulated to members following consideration of the guidance by the Standards Committee.
- 2.5 Agree to introduce the annual reporting procedure set out in paras 3.15-3.16 of this report with effect for the 2009/10 municipal year.

3.0 Detail

- 3.1 Each year the Council nominates or appoints members to be Council representatives on external organisations or outside bodies. The number of outside bodies to which the Council makes appointments is large and there is a wide variety of organisations. In some cases the Council is required by statute or Trust Deed to make a nomination or appointment but in others the organisation has simply requested that the Council make an appointment.
- 3.2 A review of the appointment of members to outside bodies has been underway for some time. Members who hold positions on outside bodies have been consulted, representatives of the organisations that the Council nominates to have also been consulted as well as the Corporate Management Team and relevant lead members. The appointment of members as school governors was not part of this review as these appointments are made by the Director of Children and Families under a policy and procedure that was recently reviewed by the Executive.
- 3.3 There were four aspects to the review;
 - a) To carry out a review of the list of outside bodies to which appointments and nominations were being made at the time to ensure that all appointments were necessary and appropriate.
 - b) To develop a standard form and process for assessing the merits of appointing or nominating members to new outside bodies
 - c) To publish an updated guidance for members who are appointed to outside bodies about the rights, responsibilities and duties that arise with an appointment or nomination.
 - d) To develop a comprehensive database of the outside bodies to which the Council makes appointments or nominations and relevant information on the organisation i.e. trust deeds or constitutions.
- 3.4 This report sets out the findings and/or results of each part of the review. Members are asked to agree new arrangements to assess requests for Council appointments to outside bodies and a process for members to report back on the activities of the outside body.

Review of outside bodies to which appointments were being made

- 3.5 When the review began the Council had a list of 59 bodies to which 103 appointments were made. This total is higher than the number of members as some members were appointed to more than one outside body and a small number of appointments of non-members are also made. As a result of the interim findings of the review and as part of the annual appointments process the Council agreed to cease making appointments to 12 outside bodies in May 2008 and a further 4 bodies in May 2009.
- 3.6 In some cases the recommendation that appointments to these bodies be ceased was because the organisation no longer needed a Council nominee i.e. the organisation had disbanded. In other cases the recommendations was because the organisation failed to answer any enquires from the Council about the purpose and need for an appointment and the member appointed to the outside body did not support continuing with the appointment. Where a

member or the body itself considered the appointment worthwhile then officers recommended that the Council continue to make an appointment.

3.7 In May 2009 the Council made appointments to 46 outside bodies and a full list of all the appointments is set out in appendix 1. A list of the bodies which the Council has now ceased making appointments to is set out as appendix 2.

New requests for appointments

- The review set out to establish a consistent approach to considering new requests for appointments or nominations to outside bodies. Officers have therefore drafted a set of questions which requests administrative information about the body but also information about the aims and objectives of the organisation and the benefits to the Council and community from any appointment (Appendix 3). This information is similar to the information that was requested from existing outside bodies during the review.
- 3.9 Such requests will then be considered by the Council or the General Purpose Committee. It is not considered possible to have set criteria against which to assess whether an appointment should be made as the organisations vary considerably and judging whether an appointment should be made will depend on each situation.
- 3.10 In future if an organisation would like a member of the Council to be appointed to their organisation they would be required to submit a completed form to the Council. The relevant Service Area or Corporate Director would then submit a report indicating support (or otherwise) for the appointment to either the Council or the General Purposes Committee for members to decide whether to make the appointment

Guidance for members on outside bodies

- 3.11 Officers have prepared guidance for members appointed to outside bodies explaining the different rights, responsibilities and duties of members appointed to each type of organisation i.e. limited company, trust, charitable organisation.
- 3.12 The guidance will be presented to the Standards Committee for approval at their meeting on 8 July 2009 as the guidance deals with personal and prejudicial interests as well as touching on other matters of ethics and probity. The guidance will then be issued to all members who are nominated or appointed to an outside body or who may be nominated or appointed.

Reporting back to the Council

3.13 Feedback from the members appointed to outside bodies is considered important as, for example, it will enable the Council to monitor the aims and objectives of the outside body to ensure that they stay consistent with the Council's corporate objectives and to ensure the time commitment required is appropriate. The information will also assist members who are newly appointed to outside bodies, officers and members of the public understand the role of the outside body and the Councils role on that body.

- 3.14 Regular information about the activities of the organisation will help the Council monitor the continued need for an appointment to be made.
- 3.15 Officers therefore recommend the introduction of an annual report from members on the activities of the outside body. The information in the annual report would mirror the matters covered in the form that outside bodies will now complete when making a request for a Council nomination i.e. aims and objectives of the organisations, time commitment, benefit to the Council and community (Appendix 4).
- 3.16 The form would be completed early in the year in time to form part of an annual review of outside bodies in March. This would then assist with decisions on appointments to outside bodies at the May Council meeting. Members are asked to agree that an annual report be introduced for the 2009/10 year. The first annual reports would therefore be due in early 2010.

Developing a Database

- 3.17 Democratic Services now have a complete database of information on the outside bodies to which members are appointed including the basis of any appointment, legal structure of the organisation, purpose of the organisation, whether an allowance is payable and the time commitment required. Legal Services hold copies of the relevant trust deeds and Constitutions.
- 3.18 Officers have identified the relevant service area within which each organisation falls and a link officer has been appointed for each outside body. That service area and the link officer will be responsible for liaising with the organisation. For example where the member is appointed as a trustee or director they will ensure that appropriate insurance arrangements are in place.
- 3.19 The annual returns discussed above will provide information about any changes to the organisation and help maintain this database as an accurate record.

4.0 Financial Implications

4.1 There are no financial implications from this report.

5.0 Legal Implications

- 5.1 The Local Democracy and Economic Development Bill will introduce a new duty on the Council to promote democracy. This duty has two facets; one is to publicise and promote democracy in the sense of what the Council does and the other is to promote democracy in the sense of what connected authorities such as GLA, NHS Trusts and the Police Authority do. Obtaining and using the feedback from members that represent the Council on outside bodies will help the Council satisfy this new duty as it will improve the information that the Council has on connected bodies.
- 5.2 The Local Democracy and Economic Development Bill also makes provision for the Audit Commission to audit a company, limited liability partnership, or industrial and provident society where it appears that the entity is or likely to

be connected with a council and some of the outside bodies may be covered by this. Councils must notify the Audit Commission when an entity becomes or ceases to be connected to the council and the information obtained from the annual reports will assist the Council in meeting this new duty.

5.3 Members who are appointed to outside bodies take on particular rights, responsibilities and duties associated with that position. In some cases, such as when a member is appointed as a director or trustee this could result in situations where the member is held personally liable for actions of the organisation. It is therefore important that members are aware of the situations in which this can occur (through the guidance) and that as far as possible members are covered by insurance.

- 11. What do you feel are the benefits for your organisation from having a member of the Council appointed to your organisation?
- 12. Are there any cost and/or resource implications for the Council from the appointment?
- 13. Are there allowances payable to the member appointed (including travel or reimbursement of other expenses)? If so please list them
- 14. What risks are there to a member who is appointed to your organisation? i.e. a potential liability arising from being a trustee or company director. If so, what insurance arrangements are in place to indemnify the member from claims against them personally?
