p.7 5. Brent's Draft Health and Well-Being Strategy 2008 - 2013

This covering report introduces the draft Health and Well-being Strategy 2008 – 2018. The accompanying Health and Well-being Strategy 2008-2018 and Action Plan has been produced in close collaboration with the Brent teaching Primary Care Trust as well as a range of service areas across the Council. It is a requirement of the Local Government and Public Involvement in Health Act 2007 that the Council with its partners on the Local Strategic Partnership produce a health and well being strategy to address local health inequalities and promote healthy life style choices which support the prevention of ill-health.

During the process of producing the Health and Well-being Strategy 2008 – 2018 the partners within the LSP, the agencies that form the Health and Social Care Strategic Partnership and the wider general public have all been consulted on the local health priorities. Their views have been used to shape the vision and work streams that form the strategy as well as the detailed programmes and targets that comprise the action plan 2008-2010.

The draft Brent's Health and Well-Being Strategy 2008 – 2013 is attached as Appendix 1 and the draft Action Plan attached as Appendix 2.

p.47 6. **Burnley Road GP Surgery**

The Chair of the Health Select Committee has agreed to put this item on the Committee agenda following a request from Councillor Lesley Jones. Residents in the Dudden Hill area are concerned that the GP surgery at Burnley Road, which was closed in 2002, will not be reopened as was originally intended. Access to other health sites in the area has been problematic for some residents, exacerbated recently by the re-routing of the 226 bus whilst Thames Water was working on Anson Road.

Brent tPCT has set out the reasons for not reopening the Burnley Road practice in a letter to Councillor Jones, which is included as an appendix to this report.

p.53 7. Working with Brent LINk

Brent Council has appointed the Community Investors Development Agency Ltd, (CIDA) as interim host for the Brent Local Involvement Networks (LINk). CIDA will be at the Committee meeting on 9th July to outline their work programme for the duration of their contract. By the 30th September 2008, a permanent LINk host must be in place. LINks have been created to give people an opportunity to influence and change aspects of health and social care in their area. They will replace the Patient and Public Involvement Forums.

This is an opportune time for the Health Select Committee to consider how it should work with the LINk. This report sets out some possible ways that working relationships could be developed. However, at this stage it is very difficult to say with confidence how working relationships are likely to be formed. It is important that the LINk develops over the coming months and that the Health Select Committee supports this. The LINk will ultimately have to decide its own work programme but given the overlap in the work that the Health Select Committee and the LINk will do, some joint work can only be beneficial.
