#### p.7 5. **GP Access Survey**

The results of the 2007/08 National Patient Satisfaction survey have been published. The survey was managed by IPSOS Mori and results have been sent to each PCT in England. The survey measures patient satisfaction with access to their GP. Specifically, it looks at satisfaction with four indicators - Telephone Access; 48 Hour Access to GP; Advance Booking; and Appointment with Specific GP.

The results for Brent show that satisfaction for three out of the four measures was below satisfaction levels for London (telephone access, advance booking and appointment with a specific GP) and all measures were below the average level for England. NHS Brent has produced an action plan to tackle these issues.

#### p.15 6. **GP Led Health Centre**

NHS Brent has started the procurement process for a GP led health centre and also intends to procure a provider for GP services at Harlesden Medical Centre. Officers from NHS Brent will be attending the Health Select Committee to update members on the work that has happened to date. This is also an opportunity for members to ask NHS Brent about the new service and comment on the proposals and public engagement strategy.

#### p.31 8. World Class Commissioning – NHS Brent Strategic Plan

NHS Brent is preparing for its World Class Commissioning Assessment. The aim of world class commissioning is to improve health outcomes for patients and reduce health inequalities. For the first time, the success of PCT commissioning arms will be judged using an agreed assurance framework that assesses progress against three elements:

- Outcomes these will reflect the overall improvement in the health and wellbeing of the population. Eight of these will be selected locally, based on strategic priorities. Two, life expectancy and health inequalities, are to be included for all PCTs.
- Competencies there are eleven competencies which reflect improvements in the PCTs skills and behaviours as commissioners.
- Governance this reflects the underlying grip that the PCT Board and the organisation has on its core business.

#### p.39 9. Fitness for Purpose – Willesden Inpatient Wards

In the light of two serious untoward incidents and concerns about nurse staffing levels and skills for the three wards at the Willesden Centre for Health and Care, NHS Brent commissioned an external review to look into the issues at the centre. This review confirmed that staff resources needed to be increased and clinical governance needed to be strengthened to ensure that the current services could be satisfactorily delivered. The Chair of the Committee has asked for this item to be included on the agenda so that members can be updated on the steps NHS Brent has taken to resolve the problems at Willesden Centre for Health and Care.

#### 10. Monks Park Health Centre

The Chair of the Health Select Committee has asked NHS Brent to provide an update on the Monks Park Health Centre. He has been concerned by reports that the centre is under-occupied and would like NHS Brent to clarify what services currently operate from the centre and whether it is at full capacity. NHS Brent will provide a verbal update at the meeting.
