The following petitions have been verified by Democratic Services and contain in excess of 50 signatures:-

Wembley Hill Road – Safety Campaign Petition

This petition calls for the installation of "a Pelican Crossing at the junction of Wembley Hill Road / Mostyn Avenue/ South Way and for action to stop buses obstructing the view at the junction with Linden Avenue."

Wembley Stadium Event Day Parking: Brent Residents Parking Options Petition

This petition states:-

"We the undersigned deplore the situation where Brent Council, Members and Departments, are seen to be addressing 'protective parking' around the new Wembley Stadium solely by offering the surrounding residents/businesses 'CPZ' (Controlled Parking Zone) solutions or similar (e.g. 'stadium event day protective parking').

We require that Brent Council, its' Members and Departments, offer all residents/businesses surrounding Wembley Stadium Area, (to at least a radius of 2 miles) extra choices. These are:

- 1. Street Barrier and Sign Systems (not necessarily manned)
 - a) For all areas that previously had a barrier type scheme operating and
 - b) For all other areas that may be geographically suitable for barrier type schemes.
- 2. Single Yellow Line street markings with flip-up/flip-down signs indicating days/times of 'event' day parking restrictions.
- 3. 'Tow Away' Street Zones where geographically suitable.
- 4. No extra protective event day parking scheme at all."



Oaklands Road and Howard Road (CPZ Zone GM)

This petition calls for the retention of the existing operational hours of the Controlled Parking Zone in Zone GM (Howard Road and Oaklands Road) from Monday to Saturday from 10am to 9pm.

Queensbury Station Parade CPZ – Zone QA

This petition states:-

"We, the undersigned being residents and traders of the Queensbury Station Area, hereby strongly request the London Borough of Brent Council, its Highways Committee and Departments to formally note and action the following points:-

- 1. To completely <u>withdraw</u> the proposed Queensbury Station Area Controlled Parking Zone (CPZ) Zone QA (Feb 2003) Scheme and its Proposals forthwith.
- To instruct the Brent Transportation department to develop in conjunction with QARA, a non-CPZ scheme in the zone area to improve local public access and usage, parking, and traffic control. (ie- a joint QARA/ Transportation working party, with full QARA consultation and consent (see previous Decisions and agreements of the Committee)).
