SUMMARY OF RECOMMENDATIONS:

2.3

- (a) That Committee notes the outcome of the informal consultation with residents and businesses of the proposed Church Road area (zone HY) CPZ and approves to proceed with the CPZ in Cobbold Road, Franklyn Road, Ilex Road and in Roundwood Road between Church Road and Franklyn Road, subject to satisfactory statutory consultation. (operational times of the CPZ be Monday to Friday, 8.30 am to 6.30 pm as demonstrated by majority)
- (b) That Church Road and Yewfield Road be re consulted and the results of the consultation be reported to the next Highways Committee.
- (c) That Committee approves the implementation of "At Any Time" (double yellow line) waiting restrictions on all road junctions within the consulted HY boundary area.
- (d) That Committee notes the outcome of the informal consultation with residents and businesses of the proposed Mount Pleasant Road area (Zone MP) CPZ and approves the CPZ proposals for their area to be withdrawn.
- (e) That Committee notes the petitions received from residents and businesses of the proposed Mount Pleasant area and approves the implementation of "At Any Time" (double yellow line) waiting restrictions on all road junctions within the consulted area boundary zone MP. (items 3.8 -3.9 and Appendix D of the main report).

(a) Proposed Zone HY – results of consultation

Informal consultations on the proposed controlled parking zone HY (Church Road area) were carried out in October 2004, the results of which are tabulated below. The area consulted and area of support is shown on the map below.



The consultation responses indicate majority support for CPZ measures from Cobbold Road, Franklyn Road, Ilex Road and section of Roundwood Road between Church Road and Franklyn Road. It is therefore recommended that Committee approves to proceed with CPZ on these streets.

Members are reminded that the above streets are located south of Church Road shopping area. If the Committee is going to proceed with the CPZ on those streets, it is highly probable that parking will be displaced to Church Road, Conley Road, Yewfield Road and on the periphery of the zone. The analysis also show that residents and businesses from Church Road have indicated that they feel parking is a problem in their street.

In view of these responses, and previous experience of parking displacement in other zones, officers' recommendations are that Church Road, Conley Road and Yewfield Road be included in the proposed Zone HY zone. If approved, these streets will be included in the statutory consultation which will provide an opportunity for residents to object to the proposals for their inclusion in the CPZ should they wish to. This will therefore provide an opportunity for these streets to be withdrawn from the CPZ.

Recommendation 2.3 (a, b, c):

- (a) That Committee notes the outcome of the informal consultation and approves to proceed with the CPZ in Cobbold Road, Franklyn Road, Ilex Road and section of Roundwood Road between Church Road and Franklyn Road subject to statutory consultation. (operational period of the CPZ be Monday to Friday, 8.30 am to 6.30pm as demonstrated by the majority)
- **(b)** That Church Road and Yewfield Road be re consulted and the results of the consultation be reported to the next Highways Committee.

(c) That Committee approves the implementation of "At Any Time" (double yellow line) waiting restrictions on all road junctions within the proposed zone HY. (consultation area boundary)

(b) Proposed Zone MP - results of consultation

Informal consultations on the proposed controlled parking zone MP (Mount Pleasant Road Area - Appendix B of the main CPZ progress report) was carried out in June 2007, the results of which are tabulated below. The area consulted and area of support is shown on the map below.

All the streets consulted were against the CPZ proposals for the area. There was no single street that was in favour of the proposals. It is therefore recommended that the CPZ proposals for the proposed MP zone be withdrawn.

As mentioned in item 3.9 of the main report, Members are reminded that the Council received a petition which contain more than 300 signatures objecting to the proposed CPZ. They also requested the Council to implement yellow line measures at junctions. In view of these requests, it is therefore recommended that "at any time" (double yellow lines) restrictions be implemented at all junctions within the consulted area boundary zone MP.
