Submissions

As Chair I wish to state for the record that all submissions proposed for consideration in the formal paperwork for this body need to be submitted to the Officer Support Group no later than 2 weeks in advance of any of the already declared meeting dates

As Chair I will with my colleagues (Vice Chairs) exercise the final decision about what papers will be included in an agenda dispatch

We invite written submissions from any affected Local Authority, local Overview and Scrutiny Committee or interested organisation and would ask that any such documents are submitted to the Officer Support Group by no later than 29th February 2008

JPCT comment following Chair's enquiry re conclusion of the work of JOSC

'The following proposal will be put for consideration to the next meeting of the Joint Committee of PCTs on the 19 Dec:

The Joint Committee of PCTs' current timetable has consultation closing on 7 March, followed by drafting of the independent consultant's report and draft London Commissioning Group (LCG) recommendations during March/April.

We would like to invite the JOSC to finalise and supply its report to the programme office and independent consultants by 2 May 2008

In order to avoid Mayoral election purdah, we propose that the independent consultant's report is presented to public, PPIs, PCT Boards, the JOSC and other invitees as soon as possible after the Mayoral elections. To avoid the election count and the bank holiday the first potential date is the 6 May. We would like to invite the JOSC to present at this meeting.

The independent report, responses to the consultation and LCG recommendations would then be shared with the PCT Boards and JOSC. We would like the final report to go to the JCPCT on the 30 May, taking account of PCT Board views and JOSC views amongst others'.
