NORTH AMERICAN RUDDY DUCKS AT THE BRENT RESERVOIR

1.0 SUMMARY

1.1. This is a covering report concerning the request received in the attached letter of 12 July 2004 from the government's Central Science Laboratory to British Waterways. The request is for permission to undertake a cull of the North American Ruddy Ducks at the Brent Reservoir. The cull would be part of a Government programme to control the introduced North American Ruddy Duck in the UK and Europe; and hence to help conserve the globally threatened but closely related White-headed Duck in Spain.

2.0 RECOMMENDATIONS

2.1 Members are asked to advise officers to investigate the implications of either going ahead with or not going ahead with the proposed cull, including any legal issues, and taking into account the views of the Welsh Harp Joint Consultative Committee. If necessary, to report to the appropriate Committees of the Councils.

3.0 FINANCIAL IMPLICATIONS

3.1 None specific. Any cull, if agreed, would be undertaken by the Central Science Laboratory at their expense. They have Public Liability Insurance and which includes cover for the control methods.

4.0 STAFFING IMPLICATIONS

4.1 None specific.

5.0 ENVIRONMENTAL IMPLICATIONS

5.1 The proposal for the cull is that inter-breeding of the North American Ruddy Duck is threatening the survival of the White-headed Duck in Spain. Locally a cull may have various environmental implications.

6.0 LEGAL IMPLICATIONS

- 6.1 Countryside and Rights of Way Act 2000 (S28H) in relation to culls at Sites of Special Scientific Interest.
- 6.2 Bonn Convention (Article III (4c)) requires the UK government to endeavour to control factors that are endangering the (White-headed Duck).
- 6.3 Bern Convention (Article 11 (2b)) requires the UK to strictly control the introduction of non-native species.
- 6.4 Convention on Biodiversity (Article 8 h).
- 6.5 Ruddy Duck control in England is carried out by the Central Science Laboratory under licence from the Department for Environment, Food and Rural Affairs.
