As it stands, we can still hear through the door, only it is much worse when it's open. We have noted an effort to keep the door closed which is appreciated.

The only permanent solution in our eyes is for the door to be blocked up as this will insure that the problem does not persist or return over time.

I'm glad to hear that the staff won't be smoking outside our front door anymore – although, only this week I walked out in the morning to find the chef sitting on our flower planter and smoking – I'm not sure how this would be monitored? We understand that it is a family business and we believe it to be an asset to the area, we would respectfully request that every effort is made to ensure that it doesn't impinge on our quality of life.

In relation to the points raised in your letter, the Management Team at Vicki's are willing to agree to the following to assuage any concerns you may have in regards to the procurement of an alcohol licence for 43 Kilburn Lane.

1. The problematic rear door will be closed and padlocked at ALL TIMES.
2. Bins and large outdoor ashtrays will be placed outside for those who wish to smoke and removed EVERY NIGHT.
3. Vicki's Staff Members will NEVER smoke anywhere near the front door to your property.
4. Sweeping the area outside your front door will be added to our clean down rota and will be done EVERY NIGHT.
