Thank you for your email

I would ask again that you provide some calculations to justify the proposed increase in capacity. As it stands the sketch shows the removal of 4 tables and chairs but not the tables and chairs that are around the wall of the lower basement. This would mean that the lower basement would not exclusively be used for dancing.

Again if you wish to submit scaled plans of 1:100 outlining the proposed changes and calculated justification for the increase in capacity to include escape capacity calculations then this can be reviewed. Until this is submitted the representations will remain as before.

Have you also taken into account escape capacities and door width. I would have been preferable if you could have provided some calculations as to how you came to the capacity of 150.

Please find attached the plan for Masti, as described in my previous email of last week. The plan will be scaled 1:100 on A3 sized paper.

The justification for the increase in capacity is as follows.

- 1. The premises currently is trading below the full capacity at 110 for the lower basement.
- 2. By increasing the capacity for the lower basement by 40 persons, to 150, this will allow the demand for the activity of dancing to be met by the club. Currently the demand for customers wishing to dance exceeds the current capacity limits, as all dancing takes place on the lower basement floor, the floor above reaming as a restaurant style layout. As Masti changes to a nightclub style venue after 23:00 hours, the current capacity of 110 is not sufficient to meet the demand of the public. The premises has demonstrated over the years that they are more than capable of providing a safe night time venue for entertainment, and by increasing this capacity, none of the 4 licensing objectives would be compromised.
- 3. The current number of door staff is sufficient to cater for the increase in capacity.
- 4. Fire regualtauons are not breached in terms of safe numbers by the increase in capacity.
- 5. The increase in numbers will not cause any issue to the current dispersal policy in place at the venue.
- 6. All current restrictions re entry to the premises at the door will remain in place. Additional customers will only permitted if they fulfil the current criteria for entry.
- 7. Door staff will continue to monitor the numbers who wish to use the dance facilities on the lower basement, and ensure that the capacity of 150 is not breached at any time.

I have printed off the plan on A2 paper and measured it using a scale rule of 1:100 and have the following measurements

Main area 40.34m2
Minus existing dance floor area of 10.20m2

Equals 30.20m2

Using the *Technical Standards for Places of Entertainment guidance 2013* section B3 Accommodation I have reached the following capacities for the lower basement

30.20 / 1m2 = 30 people in a seated capacity

40.34 / 0.5m2 = 80 people when used for a dance area. This would involve the removal all fixed and removable seating and purely for dancing.




