If a Member is aware they have a Disclosable Pecuniary Interest* in an item of business, they must declare its existence and nature at the start of the meeting or when it becomes apparent and must leave the room without participating in discussion of the item.

If a Member is aware they have a Personal Interest** in an item of business, they must declare its existence and nature at the start of the meeting or when it becomes apparent.

If the Personal Interest is also significant enough to affect your judgement of a public interest and either it affects a financial position or relates to a regulatory matter then after disclosing the interest to the meeting the Member must leave the room without participating in discussion of the item, except that they may first make representations, answer questions or give evidence relating to the matter, provided that the public are allowed to attend the meeting for those purposes.

***Disclosable Pecuniary Interests:**

- (a) **Employment, etc.** - Any employment, office, trade, profession or vocation carried on for profit gain.
- (b) **Sponsorship** - Any payment or other financial benefit in respect of expenses in carrying out duties as a member, or of election; including from a trade union.
- (c) **Contracts** - Any current contract for goods, services or works, between the Councillors or their partner (or a body in which one has a beneficial interest) and the council.
- (d) **Land** - Any beneficial interest in land which is within the council's area.
- (e) **Licences** - Any licence to occupy land in the council's area for a month or longer.
- (f) **Corporate tenancies** - Any tenancy between the council and a body in which the Councillor or their partner have a beneficial interest.
- (g) **Securities** - Any beneficial interest in securities of a body which has a place of business or land in the council's area, if the total nominal value of the securities exceeds £25,000 or one hundredth of the total issued share capital of that body or of any one class of its issued share capital.

****Personal Interests:**

The business relates to or affects:

- (a) Anybody of which you are a member or in a position of general control or management, and:
 - To which you are appointed by the council;
 - which exercises functions of a public nature;
 - which is directed is to charitable purposes;
 - whose principal purposes include the influence of public opinion or policy (including a political party or trade union).
- (b) The interests of a person from whom you have received gifts or hospitality of at least £50 as a member in the municipal year;

or

A decision in relation to that business might reasonably be regarded as affecting the well-being or financial position of:

- You yourself;
- a member of your family or your friend or any person with whom you have a close association or any person or body who is the subject of a registrable personal interest.

Dear all,

Yesterday I visited the above premises which on arrival had alcohol displayed for sale in the bar area. I immediately called the owner of the premises Nihat Algul (The proposed licence holder being his son Gokcan Algul) and asked him why there was alcohol being displayed for sale.

Mr Nihat Algul explained that he removed the alcohol for some time when he understood they didn't have TENs in place but because the agent NARTs had explained once the consultation period was over they would be able to sell immediately, Mr Nihat Algul then replaced the alcohol for sale.

I explained to Mr Nihat Algul that he could not display alcohol for sale and it would need to be removed immediately and explained that representations had been put in for the application from various responsible authorities but that no agreement had been made with the agent to date with regards to these. Mr Nihat Algul then directed his staff to remove all of the alcohol and place it in a store room. Before I left the premises, all of the alcohol was removed.

As English is not Mr Nihat Algul's first language, I asked for Gokcan's phone number but as he works later in the day and would be sleeping, I spoke to Mehmet Algul **(who is also included in this email)**, another son who runs the Lezziz Charcoal branch in Kingsbury. Mehmet Algul explained the following regarding what they were told by the agent;

- They would only need to apply for a variation application because they were only modifying their existing premises licence (which is why we initially received the variation application)
- They would be able to continue using their current licence for 13 Walm Lane (which already contains the alcohol element) as long as they kept the alcohol on the side of the premises where the licence exists
- When Mehmet asked the agent why TENs applications hadn't been made if they had been requested to, the agent initially said it was because the applicant hadn't paid for them but Mehmet states that he was never asked for any payment. In the same way when he had requested for a premises licence application to be done, the agent had requested payment when it was due and therefore can't understand why they didn't ask for payment but also did not submit any TENs application. Mehmet had believed the TENs were being applied for by the agent.
- They would be able to sell alcohol and serve hot food as soon as the 28 day consultation had finished

As a result, Mehmet Algul would now like to deal with the application himself. All of the alcohol has been removed and no hot food or drink is to be served between 23.00hrs and 05.00hrs until he has had confirmation the licence has been granted whether this be by the Licensing Authority or the Licensing Committee at the hearing.

Apologies for my delay in responding to you, I was on holiday up until today.

Unfortunately, I cannot accept those terms. I have had numerous complaints from local resident/s who are very concerned about the proposed extended hours and sale of alcohol.

It has also come to my attention that despite my meeting with the applicants son to discuss the situation, the business has decided to operate without an appropriate licence- both in terms of the supply of alcohol and serving late night refreshments. I made it clear then that the business had the opportunity to make applications for Temporary Event Notices to try to alleviate the potential financial impact on their business and to avoid breaking licensing laws. Lezziz has simply carried on the business on their own terms and in addition sold alcohol.

I refer to your application for a premises licence for the above premises. The Public Safety Team is making a Representation to the Licensing Authority on the grounds of public safety.

Providing you are willing to accept the following proposed licence condition the Representation will be withdrawn.

Licence Condition

1. The socket outlets or other power supplies used for DJ equipment, band equipment and other portable equipment that are accessible to performers, staff or the public shall be suitably protected by a residual current device (RCD) having a rated residual operating current not exceeding 30 milliamps.

2. Any locks or flush latches on exit doors shall be unlocked and kept free from fastenings other than push bars whilst the public are on the premises.

3. kitchen doors must provide half hour fire protection and be fitted with a self-closing device.

On exit doors any locks or flush latches shall be unlocked and kept free from fastenings other than push bars or pads whilst the public are on the premises.

5. Provide highlighted and clearly visible nosings' to the stairs leading from ground floor to the mezzanine level to prevent trips and falls to customers and staff. Provide adequate lighting to this area.

Subject to risk assessment, the maximum number of persons permitted on the Premises (not including staff) shall be: 175

In order for the Public Safety Team to withdraw this representation, it will be necessary for you to confirm in writing or via Email that you accept the above licence condition.

We will require this condition to appear on the licence schedule should the licence be granted.

Please note that the setting of the capacity for the premises and means of escape in case of fire is dealt with by the London Fire Brigade and you are advised to contact them regarding those matters.

If you are in control of any part of a commercial premise, you are under a legal obligation to carry out a detailed fire risk assessment to identify risks and hazards in the premises. A fire risk assessment is essential in keeping your premises safe for everyone. You must keep a written record of your fire risk assessment if your business has five or more people.

I certify that I have considered the application shown above and I wish to make a representation that the likely effect of the grant of the application is detrimental to the Licensing Objectives for the reasons indicated below.

An officer of the Licensing Authority, in whose area the premises are situated, who is authorised for the purposes of exercising its statutory function as a 'Responsible Authority' under the Licensing Act 2003.

The application has been made for a new premises licence under section 17 of the Act.

The Licensing Authority representations are primarily concerned with the four licensing objectives;

- the prevention of crime and disorder;
- public safety;
- the prevention of public nuisance; and
- the protection of children from harm.

Following a meeting at the premise on Monday 3rd September 2018, the Licensing Authority require the following points to be included in the operating schedule or added as conditions on the premises licence:

1. A CCTV system shall be installed and maintained in a good working order at the premises.
2. CCTV recording shall be kept for 31 days and shall be made available to the police or an authorised officer of Brent Council upon request.
3. The CCTV system shall provide coverage of the customer entrance to the premise.

5. The CCTV system shall be capable of obtaining clear facial recognition images and a clear head and shoulder image of every person entering or leaving the premises.
6. A “Challenge 25” policy shall be adopted and adhered to.
7. A sign stating “No proof of age – No sale” shall be displayed at the point of sale.
8. Any staff directly involved in selling alcohol for retail to consumers and staff who provide training including managers shall undergo regular training of the Licensing Act 2003 legislation (at least every 12 months). The training shall be documented and signed off by the DPS and the member of staff receiving the training. This training log shall be kept centrally and made available for inspection by police and relevant authorities upon request.
9. An incident log shall be kept at the premises, and made available for inspection on request to an authorised officer of Brent Council or the Police, which will record the following:
 - (a) all crimes reported to the venue
 - (b) all ejections of patrons
 - (c) any complaints received
 - (d) any incidents or disorder
 - (e) any faults in the CCTV system
 - (f) any refusal of the sale of alcohol
 - (g) any visit by a relevant authority or emergency service.
10. Customers shall not be permitted to take open alcoholic drink containers outside the premises as defined on the plan submitted to and approved by the Licensing Authority.
11. The front outside seating area on facing Olympic Way shall cease being used at 20:00 hours daily. All tables and chairs must be removed.
12. No drinks shall be served other than in plastic or toughened glasses.
13. A copy of the premises licence summary including the hours which licensable activities are permitted shall be visible from the outside of each entrance to the premises.
14. No noise or vibration shall be detectable at any neighbouring noise sensitive premises.
15. Notices asking customers to leave quietly shall be conspicuously displayed at all exits.

Wembley Event Days

16. Customers shall not be allowed to congregate outside the premises.
17. The DPS or deputy shall work in partnership with the Police and if necessary comply with any direction given by a senior Police Officer on duty at the event.
18. The premises will cease the sale of alcohol (1) one hour before the advertised kick off time.
19. A suitable number of door supervisors of a suitable gender mix, shall be employed on Wembey Event Days.

20. Door supervisors shall wear clothing that can be clearly and easily identified on CCTV.

21. A register/log containing the names, badge number, dates & times of duty security staff and any incidents that occur shall be kept and made available to the Police and Licensing Authority.

In order for the Licensing Authority to withdraw this representation, it will be necessary for you to confirm in writing that you are willing to accept the above conditions.

The application has been made for a new premises licence under section 17 of the act. The Police representations are primarily concerned with the Protection of Children from Harm, Prevention of Crime and Disorder, The Prevention of Public Nuisance, and Public Safety.

On the 3rd September 2018 I conducted a visit at the venue to discuss the proposed application, we discussed the application and event day conditions, and to uphold the four licensing objectives I propose the following conditions.

1. CCTV shall be installed to Home Office Guidance standards and maintained in a good working condition and recordings shall be kept for 31 days and shall be made available to police and authorised Officers from Brent Council.
2. A staff member from the premises who is conversant with the operation of the CCTV system shall be on the premises at all times when the premises is open. This staff member must be able to provide a Police or authorised council officer copies of recent CCTV images or data with the absolute minimum of delay when requested.
3. An incident log shall be kept at the premises, and made available for inspection on request to an authorised officer of Brent Council or the Police, which will record the following:
 - (a) All crimes reported to the venue
 - (b) All ejections of patrons
 - (c) Any complaints received
 - (d) Any incidents of disorder
 - (e) Any faults in the CCTV
 - (f) Any refusal of the sale of alcohol
 - (g) Any visit by a relevant authority or emergency service.
4. A "Challenge 25" policy shall be adopted and adhered to
5. The outside seated area shall cease to be used from 20.00 hours daily.
6. Customers/staff shall not be allowed access/use of the outside seating area from 20:00hrs daily.

Wembley Stadium Sporting Event Day Conditions

- (a) Customers shall not be allowed to congregate outside the premises.
- (b) No drinks shall be served in glass containers.
- (c) The DPS or deputy shall work in partnership with the Police and if necessary comply with any direction given by a senior Police Officer on duty at the event.
- (d) The premises will stop the sale of Alcohol (1) one hour before the advertised kick off time
- (e) On Football event days at Wembley stadium the venue will only take one set of supporters (Fan Zone) on the production of a valid ticket for the game, the designated team will be allocated by the Metropolitan Police after a risk assessment has been conducted.
- (f) The venue will Not show live sport on football event days.
- (g) A personal licence holder shall be present on the premises and supervise the sale of alcohol on football event days
- (h) The premises will not open post an event until the following day.
- (i) All windows will be screened and the inside of the venue will not be visible from the outside.
