Notes for Members - Declarations of Interest:

If a Member is aware they have a Disclosable Pecuniary Interest* in an item of business, they must declare its existence and nature at the start of the meeting or when it becomes apparent and must leave the room without participating in discussion of the item.

If a Member is aware they have a Personal Interest** in an item of business, they must declare its existence and nature at the start of the meeting or when it becomes apparent.

If the Personal Interest is also significant enough to affect your judgement of a public interest and either it affects a financial position or relates to a regulatory matter then after disclosing the interest to the meeting the Member must leave the room without participating in discussion of the item, except that they may first make representations, answer questions or give evidence relating to the matter, provided that the public are allowed to attend the meeting for those purposes.

*Disclosable Pecuniary Interests:

- (a) **Employment, etc. -** Any employment, office, trade, profession or vocation carried on for profit gain.
- (b) **Sponsorship -** Any payment or other financial benefit in respect of expenses in carrying out duties as a member, or of election; including from a trade union.
- (c) **Contracts -** Any current contract for goods, services or works, between the Councillors or their partner (or a body in which one has a beneficial interest) and the council.
- (d) **Land -** Any beneficial interest in land which is within the council's area.
- (e) **Licences-** Any licence to occupy land in the council's area for a month or longer.
- (f) **Corporate tenancies -** Any tenancy between the council and a body in which the Councillor or their partner have a beneficial interest.
- (g) **Securities -** Any beneficial interest in securities of a body which has a place of business or land in the council's area, if the total nominal value of the securities exceeds £25,000 or one hundredth of the total issued share capital of that body or of any one class of its issued share capital.

**Personal Interests:

The business relates to or affects:

- (a) Anybody of which you are a member or in a position of general control or management, and:
 - To which you are appointed by the council:
 - which exercises functions of a public nature;
 - which is directed is to charitable purposes;
 - whose principal purposes include the influence of public opinion or policy (including a political party of trade union).
- (b) The interests a of a person from whom you have received gifts or hospitality of at least £50 as a member in the municipal year;

or

A decision in relation to that business might reasonably be regarded as affecting the well-being or financial position of:

- You yourself;
- a member of your family or your friend or any person with whom you have a close association or any person or body who is the subject of a registrable personal interest.

One Stop Caribbean – 17-19 High Street Harlesden NW10 4NE TEN's 35538 & 35539 – Police Supporting Evidence

Last year Notting Hill Carnival (NHC) fell on Sunday the 25th and Monday the 26th of August 2024.

Unfortunately, there were scenes of violent disorder, criminal damage, residential burglaries, firearm sightings, believed firearms discharge, police helicopters, riot trained police officers, arrests, stop and searches, fires in the street and assaults on emergency workers along the High Street Harlesden and Craven Park Road. This was due to the this stretch of road been used for BBQ's and a street party which was an unauthorised extension of NHC.

One Stop Caribbean were a contributing factor to these mass scenes of carnage and disorder. The venues SIA refused entry to uniform police officers which is an offence under the licensing act (section 179) and where obstructive once entry was gained. The loud music and hot food been generated by the venue was one of the many activities drawing people to the scene. Police have requested that the music be turned off, for it to be turned back on once the speakers were placed outside the venue a short while later.

This blatant disregard for a simple request shows an appalling attitude and lack of control from the DPS, management team and the SIA. The loud music and party atmosphere created by One Stop Caribbean will have attracted more people to the area when police were trying to clear the area.

This is a snap shot of just some of the intelligence and incidents that police received regarding NHC for the High Street and Craven Park Road:-

Call from the London Ambulance Service (LAS) requesting urgent assistance with a violent male Intelligence that a firearm (gun) was been taken to Craven Park Road

Second intelligence that a firearm and drugs where in a vehicle going to this area

A dispersal order was put in place by Inspersor from Wembley police station for this section of Harlesden from the 25th to 27th of August due to anticipated scenes of violence

Parties / Unauthorised Music Events (UME) organised for the Saturday, Sunday and Monday

Another report re a 'shooting' firearms in this vicinity

Gang members attended the 'carnival' in Harlesden / Craven Park Road / High Street

Residential burglary that occurred on 27/08/24

There are similar intelligence reports for this years NHC for this area of Harlesden. Police have already made visits to licensed venues reminding them of their obligations under the licensing act, The Public space Protection Order and the Cumulative Impact Zones that cover this part of the borough.

The Police and local authority are doing everything they can to make this year's celebrations as safe and enjoyable as possible. Extending licensing activities over the bank holiday weekend will only undo this work at add more scenes of violence and damage to the community.

This Temporary Event Notice (along with any other) over the August bank holiday weekend must not be authorised. Authorising this TEN will mean adding to scenes of mass disorder, failing to uphold all four of the licensing objectives and causing mass disruption to the residents and business owners along Harlesden High Street and Craven Park Road.

Police will also be showing bodycam footage at the hearing, so all involved can get a clear understanding of the scenes that occurred last year and what we are trying to avoid this year.
