Summary of Changes to the Constitution Since 2017

A fundamental review of the Council's Constitution was commenced in 2017. A constitutional amendment list from 2017 – June 2026 is available on the Council's Constitution information page.

The table below is a summary of the changes to the Constitution made as a following that review and also includes other and subsequent changes made to reflect changes to legislation and council policy and practice. It does not include the annual review of the Member Allowances scheme or statutory increases to procurement thresholds, unless otherwise stated.
