#### Amendments to S106 Heads of Terms

The third item in the proposed Heads of Terms should be amended to read:

"Up to £40,000 towards improvement of local bus stops and/or amendments to Controlled Parking Zones following Travel Plan monitoring".

#### **Additional Representations Received**

A letter of support from a local resident of NW10 was received on 19th February. .It outlines the limitations of the existing building, the need to change and develop the Library service and supports the comprehensive redevelopment.

Response: noted

A further letter of objection has been received from the 'Keep Willesden Green' group dated 19th February. This refers to a range of objections but highlights what they regard as a poor relationship to 15 Grange Road, a reduction in the size and quality of the space available for the library, the loss of the existing playspace and the quality of the replacement, the value of the existing local space, the 'building line' relationship of the development with 148 Brondesbury Park and what they see as the constrained area around the vehicle entrance to the housing part of the development.

Response: these issues are generally covered in the updated agenda report and/or were highlighted on the Member's site visit.

A further letter of objection from a resident dated 19th February in relation to the agenda reports assessment of parking against Brent standards. It suggests that policy TRN22 would require parking to service general needs, that the proposals won't cater for residents, including those attending evening events, who cannot take advantage of public transport, that policy PS12 requires a minimum of one space for educational and community facilities and that the disabled parking provision is inadequate in terms of policy TRN35 and PS15.

In response to these issues, Transportation have reconfirmed that the assessment of the principal use as a Library is the appropriate one to use in terms of parking and that one space is not required. They confirm that there is no policy requirement for general visitor parking and that the Servicing Management Plan (S106 requirement) can cover some of the specific needs for functions etc. In terms of disabled parking, they acknowledge that the indicated 4 spaces on Grange Road would replace the existing servicing bay but confirm that there is scope within the carriageway to meet the standard layout in terms of size (through the Traffic Regualtion Order process).

Recommendation: Remains approval subject to legal agreement and to referral onto the London Mayor for his Stage 2 consideration.
