Good morning,

Just for info, the Metropolis closed voluntarily this evening (31st Jan).

In brief, this was due to the sheer quantity of info coming through from Crime Stoppers around AK47s etc to be used at the 'birthday party' booked there tonight.

CRIMINT QKRT 00443761 refers, email below from Gav is also a summary.

The manager at the Metropolis is Mr A [REDACTED], mobile [REDACTED]. he was spoken to by QK2/3 and then by myself in person - very pro. Discussion held whether to close using the new ASB act, he elected for a voluntarily closure, I explained fully that this was his decision to do so. He asked me to speak with the promoter to which I greed. He also put the place in darkness and kept his security team on duty and I have arranged for ND presence during the first part of the night.

The promoter was Mr [REDACTED] - [REDACTED] he has not been answering calls from police all afternoon, but did speak to me this evening and is very unhappy with me.

A later CAD 7662 gave me added reason to be pleased the place was closed.

Just to confirm the intelligence picture around this proposed event.

I have now been able to confirm the details of this event and ascertain the details of the promoter and the acts that seem to be involved.

Among these DJ's intel states that B [REDACTED] is linked to violent events

S [REDACTED] B [REDACTED] is known to be [REDACTED] who is a gang linked music promoter/ DJ with links to the QK gang Church Road Soldiers.

An event which was to be held yesterday by a different promoter on YR sector was cancelled after intel received for threats of gangs attending etc. This event had some DJ's in common with this event, with S [REDACTED] and the B [REDACTED] G [REDACTED] both appearing on that event.

The YR event was also noted to have been advertised at an event last Sunday (25/01/2015) on KG sector, this was a similar event that ended in serious violence with 2 stabbings and serious disorder. That event was cancelled. Notably one of the DJ's raised of concern for that event was a male called [REDACTED] known as [REDACTED] on the DJ circuit. It is notable that he is not on the list of attendees for this event but was for both the cancelled event in YR and the KG event. His home address is in Brent [REDACTED] NW10. Of note our intel received stated that a [REDACTED] was somehow involved in potential violence at the QK event. Research by YR could find no record of an [REDACTED] linked to the WILLESDEN address however they noted a [REDACTED] shown living almost next door.

In regards to intel specific to this event we have now received four separate pieces of intelligence that there will be a shooting or some form of attack at this event. The promoter appears to have been far from up front with police. He described this as a private birthday party however it can clearly be found advertised as CASHINO ROYALE although labelled as a 'birthday party' this is a commonly used term for a large promoted event, the promoters birthday was on 10/01 so about 3 weeks ago.

Although I have not been able to conduct a full detailed intelligence trawl in regard to this event it is clear to me at this time that there is a considerable risk of serious violence in relation to this event. In particular I am concerned that it will be attended by gang members both local and from other parts of London and that there is a very real danger of conflict and escalation involving weapons.

Thank you for your email. I would like to forward our sincerest apologies for the trouble which over the weekend. We are still hearing the full details of what happened. Due to the nature of the business deal we had little time to prepare Mr Lakani for what is usually a well tempered event. We did take advice from yourselves in regards to going against the split and all the messages leading up to the event lead us to believe that we wouldn't have much of a problem. Obviously things didn't pan out as well as we would have hoped but in any case we deliberately had some of our experienced staff working for Mr Lakanis team just to help them through the event. My understanding is that we had 7 door staff for the event and this I believe is more than sufficient. Never the less we would like to apologise for any problems which are responsible for, we have worked very well with the authority in the past and have never had a problem. We will of course be speaking to Mr Lakani based on this letter and your advice to better prepare him for the upcoming games.

Alisan on Saturday was a disgrace and I am currently seeking advice to see whether I can prosecute both the current DPS and Premises Licence Holder. There was little control, not sufficient door staff and a complete lack of understanding about how to work a football game. At the end of the game the situation required 30+ police officers with 4 horses just to deal with the problems caused by your premises.

I then met Mr Lakani who only took over the premise this week with no previous experience of football games at Wembley. In addition you had booked a team against the split which led directly to the problems we encountered, he then did his best to work this event but had to admit defeat, this was an extremely unfair position to put anyone in for their first time. I understand that this business deal only concluded this week however you should have been mindful of the coming weeks and all the Wembley events.
