Police representations to the application for a premises licence at 'Location Café' 232 High Road, NW10 2NX.

I certify that I have considered the application shown above and I wish to make representations that the likely effect of the grant of the application is detrimental to the Crime and Disorder Licensing Objective for the reasons indicated below.

Licensing Constable 157QK

An officer of the Metropolitan Police, in whose area the premises are situated, who is authorised for the purposes of exercising its statutory function as a 'Responsible Authority' under the Licensing Act 2003. Police representations are mainly connected with the prevention of crime and disorder and public safety.

The application has been made for a premises licence under section 19 of the Act.

Page 4 of this application describes the premises as a place for the public to enjoy tea, coffee, soft drinks and sandwiches. Unfortunately this is not what I discovered during a visit to the location.

On Saturday 14th December 2013 at approximately 2030 hours I attended the venue with my colleague PC Lewis-Evans. Entering the premises from the main High Road the venue looked closed as there were no customers in the front room, however I could smell the distinct pungent aroma of shisha smoke. I introduced myself to a Somali male who was standing behind the serving counter. He was not the owner or the manager just 'a friend' helping out. I then opened a solid wooden door at the rear of the front room and discovered approximately 6 customers sitting in a room (named as Café on the plans submitted with the application) watching football on a large screen television. I walked through this room; the smoke smell was stronger and thicker. I passed a kitchen (named as utility room on the plans submitted with the application) to my right that contained over 20 shisha smoking hookahs, shisha smoking pipes hanging on the wall and tubs of shisha tobacco. There is an

external door leading from the utility room as I opened it I saw a chiminea stacked with burning coals to feed the Hookahs. As I entered the back room there were approximately a dozen males sitting around smoking shisha. This room was fully enclosed. There are shutters at the rear of this room, even if they had been open this room would have been more than 50% enclosed. The only means of escape was the front entrance door. If a fire had broken out in the front of the building customers would have been trapped. Standing in this room I could feel the effects of the smoke and possible carbon monoxide.

I waited at the front of the venue for approximately half hour for the manger to return. During this time I never saw any food preparation. The kitchens main function is for shisha preparation. The rear shutters were opened and the Shisha Hookhahs were removed to the kitchen area.

This venue is breaching Section 8 of the Health Act. The venue has planning permission for A2 (office) use and has no building regularization certificate (structural safety).

Police are objecting to the premises licence application, this venue is designed specifically to breach legislation and put public safety at risk.

I reserve the right to bring further evidence to the hearing should any arise between now and then.

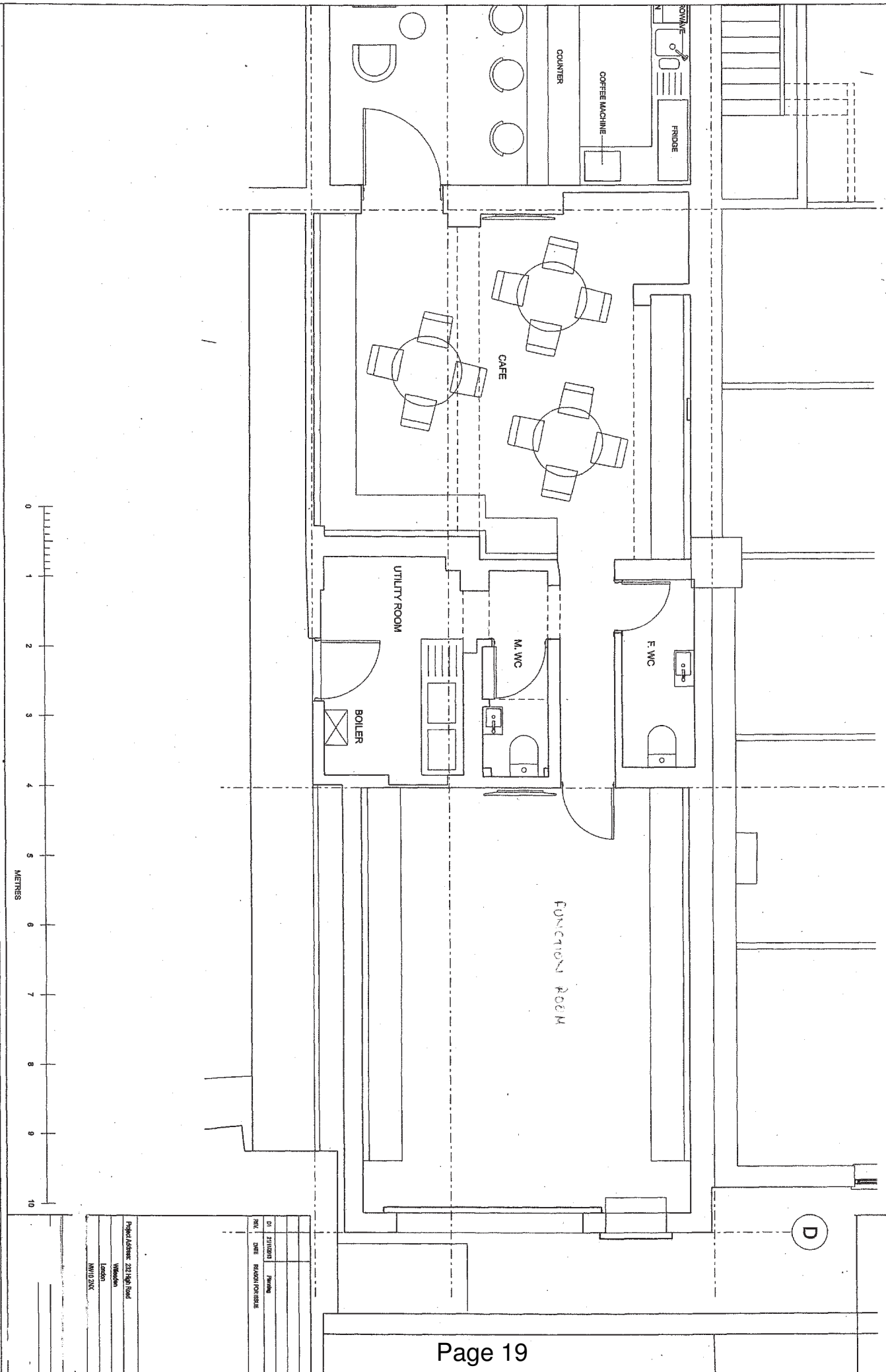

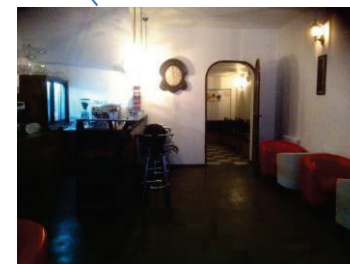

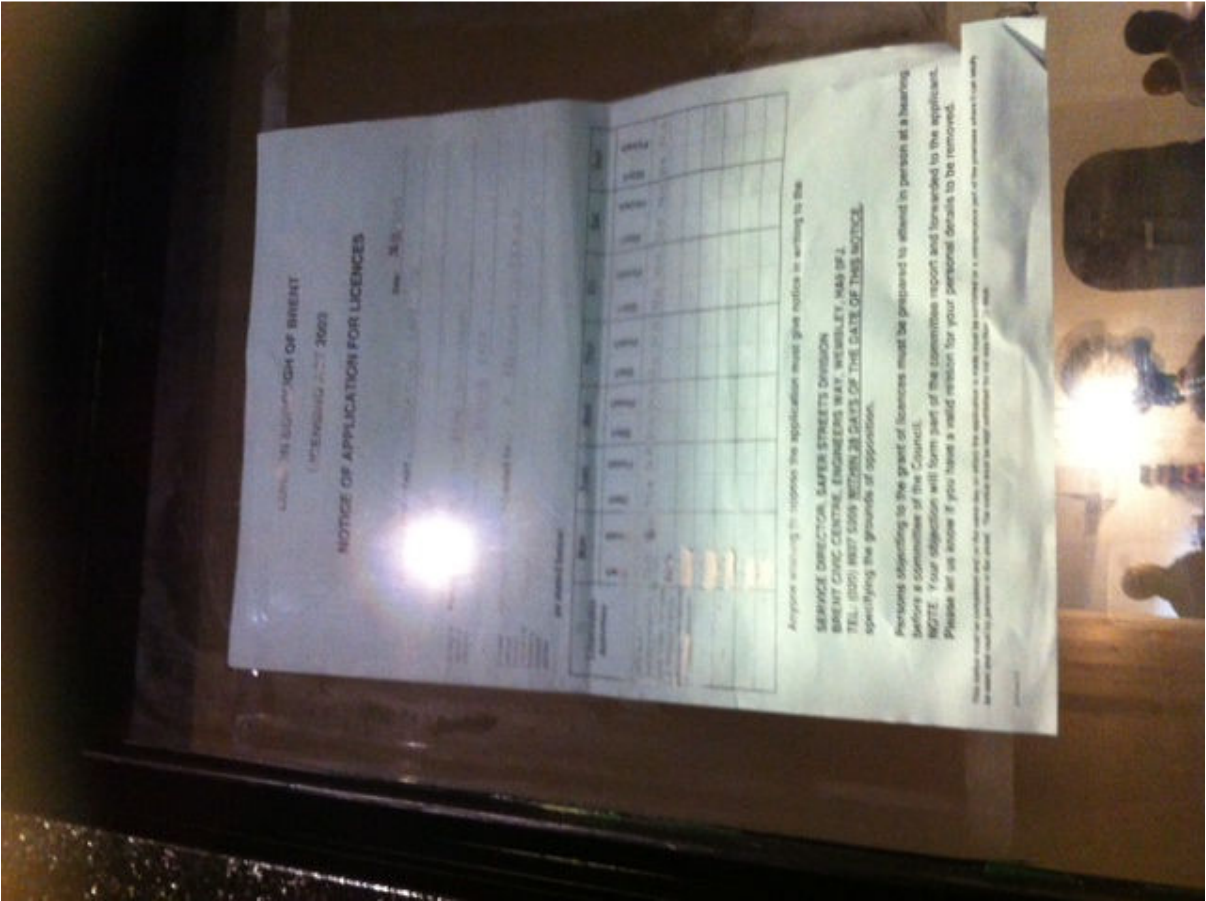


FLOOR PLAN (LOCATION'S CAFE)

8.1 Where responsible authorities and interested parties do not raise any relevant representations regarding the application made to the council, the council will grant the licence or certificate subject only to the conditions that are consistent with the operating schedule or club operating schedule and any mandatory conditions prescribed in the Act itself.

8.2 Where responsible authorities and interested parties raise relevant representations, the council may, if it is satisfied at a hearing or otherwise, impose conditions where considered necessary for the promotion of the licensing objectives.

8.3 Any conditions attached by the council or submitted by the applicant must focus on the direct impact of the activities taking place at licensed premises, on those attending the premises and residents and persons working in the area.

8.4 Any conditions attached to licences will be tailored to the individual needs, style and characteristics of the particular premises and events concerned and will be drawn from a 'model pool of conditions' (where appropriate) to the particular premises.



I certify that I have considered the application shown above and I wish to make **representations** that the likely effect of the grant of the application is detrimental to the Council's Licensing Objectives for the reasons indicated below.

An officer of the Metropolitan Police, in whose area the premises are situated, who is authorised for the purposes of exercising its statutory function as a 'Responsible Authority' under the Licensing Act 2003.

The application has been made for a premises licence under section 34 of the act.

On 22nd January 2014 I visited the venue as part of the consultation process. During my visit I noticed that there was a large number of high strength beers, lagers and ciders on display, this is breach of already existing condition 4.

"No high strength beers, lagers and ciders above 6.5% ABV shall be stocked"

It was also noted that there were no screens for the alcohol to be covered outside of the authorised hours. Under Section 137 of the Licensing Act 2003 this is an offence in that:

"It is an offence for a person, on any premises, to expose for sale by retail any alcohol in the circumstances where the sale of that alcohol would be unauthorised"

I spoke with Mr Memik Cagin who is the premises licence holder and the designated premises supervisor and made him aware of the breach. Whilst I was there I also spoke on the phone to Mr Cagin's representative from NARTS licensing department and made them aware of the current breach. Both parties assured me that products would immediately be removed and this would not be breached again. I expressed

my concern over extending licensable activity hours whilst current conditions weren't being complied with.

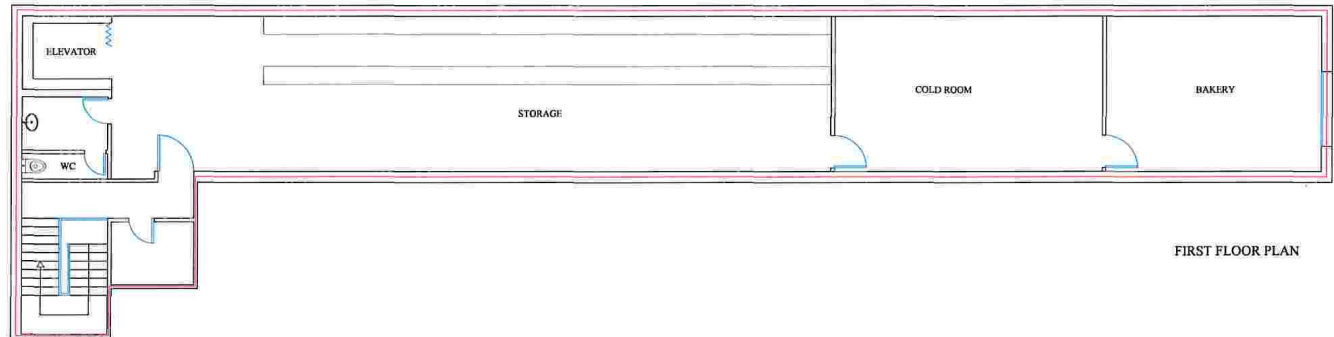
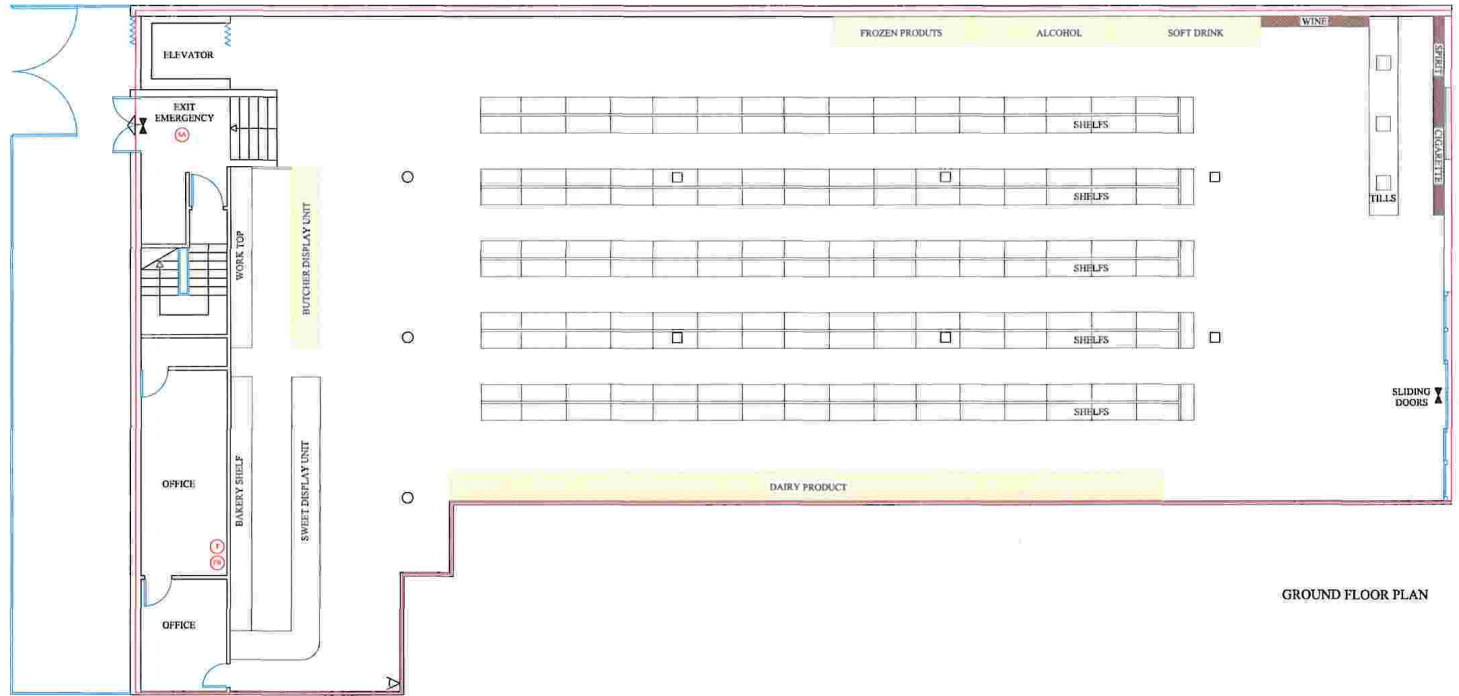
I was then made aware by London Borough of Brent Licensing inspectors that they had also made a consultation visit to the venue on 25th January 2014, during their visit they noted the following breaches:

- Selling high strength alcohol
- Alcohol not covered up after midnight
- Refusal/Incident log present but not filled in

In view of the above it is my opinion that you are finding it difficult to comply with your existing conditions despite having them brought to your attention. I am therefore unable to agree your application at this time.
