2. **Application by Rene Lawrence for a Temporary Event Notice on 19 June 2014 for 'The Shop' (75 Chamberlayne Road, London NW10 3ND) pursuant to the provisions of the Licensing Act 2003**

RESOLVED:

that the application by Rene Lawrence for a Temporary Event Notice on 19 - 25 June 2014 for 'The Shop' (75 Chamberlayne Road, London, NW10 3ND) pursuant to the provisions of the Licensing Act 2003 **be refused**.

The Alcohol and Entertainment Licensing Sub-Committee (B) felt that after careful consideration of the application and of the evidence from the Police and the Council's Nuisance Control Team, that the applicant had not sufficiently demonstrated that they would be able to meet the licensing objectives (prevention of crime and disorder, prevention of public nuisance, ensuring public safety and protection of children from harm). In view of these considerations, the application for a Temporary Event Notice was accordingly refused.
