# Police Objection to the Temporary Event Notice for The Shop, 75 Chamberlayne Road, NW10 3ND

I certify that I have considered the notice shown above and I wish to make **representations** that the use of the premises for the temporary event would undermine the crime prevention initiative, for the reasons indicated below.

An officer of the Metropolitan Police, in whose area the premises are situated, who is authorised for the purposes of exercising its statutory function as a 'Responsible Authority' under the Licensing Act 2003.

A Temporary Event Notice has been given under section 100 Licensing Act 2003 by Mr Rene Lawrence.

Police are formally making representations to the notice under section 104 Licensing Act 2003. The Police objection is primarily concerned with the crime and disorder and prevention of public nuisance objectives.

The application is for 19th to 25th June from midnight to 0200 hours daily. Reason decribed as *'Usual night of entertainment. We would like to extend our opening hours to our patrons can watch the Word Cup'. Maximum persons expected 150.* 

The Police made an application to review this Premises Licence and it was heard and determined by Brent Licensing sub committee on 17th August 2012. At that hearing residents made submissions of noise and nuisance caused by The Shop's customers.

On 13th October 2013 these local residents made contact with Brent Police and complained that the operation of The Shop was once again having a negative effect on their home life. The front door of the premises was constantly being left open

whilst the premise was engaged in licensable activities. Noise from music and customers was then emanating in to the street. Similar noise was also escaping from an open rear window.

A meeting was held one 23rd October 2013 between me, the premises licence holder Mr Luke Allen and his bar manage and applicant for this TEN, Mr Rene Lawrence. The excuse for the noise was the introduction of new sound equipment and lack of training on it for the staff. He has no excuse for the front door being left open but made reassurances that it would not happen again. I told Mr Allen that I would be making representations to any further TEN's and this would include a stringent list of conditions.

In April 2014 Brent Police were contacted again by disgruntled residents who were being disturbed in the early hours by noise and nuisance from The Shop. In particular, Sunday nights when live music was provided and noise from customers in the street. Residents alleged the front door of the premises were been left open during licensable activities allowing the noise to dissipate from the venue. I wrote a warning letter to Mr Allen on 30th April 2014.

Since October 2013 The Shop has submitted 10 TEN notifications and on each occasion Brent Police have made representations for the premises to operate within the existing premise licence conditions.

Unfortunately the management of The Shop has shown time and time again that they can not retain control of the amount of noise and disruption produced by their customers. In the first instance after a Police warning they appear to take action but this is very short lived. This TEN is to provide licensable activities until 2am on both weekdays and weekends to show world cup football matches. These games will undoubtedly bring emotionally shouting and cheering which is totally unacceptable for the local residents. The TEN indicates there could be up to 150 persons on the premises, this amount would be excessive as the capacity for the premises is only 60 (80 if they have had building work to the front doors). These TEN's are during the warmer, lighter evenings when residents tend to have their windows open and any additional disruption with have an effect of their quality of life.

Police believe to allow these TEN's to go ahead will be to the detriment of local residents and not promote the licensing objectives of prevention of crime and disorder and prevention of public nuisance.

Dear Mr Lawrence,

I would like to confirm that I have considered the above proposal with regard to the prevention of public nuisance.

On behalf of the Regulatory Services (Environmental Health) I would like to Make representations to the T.E.N on the following grounds:

That the proposed operating hours are inappropriate due to the close proximity of residential dwellings.

The operating schedule does not address the prevention of public nuisance from:

- airborne entertainment noise
- Structure borne noise or vibrations from entertainment
- Noise generated by patrons in external areas of the premises e.g. beer garden
- Noise from patrons exiting the premises.

# Prevention of nuisance from noise/vibration *Airborne*

All doors and windows will remain closed during the licensed activities. Where a door is used for patrons to enter or leave the premises the door will be fitted with a self-closing device and staff told to ensure that it is not propped open. A member of staff shall be positioned at the door to ensure it is opened for as brief a period as possible.

#### Structure borne

World cup is a very high spirited event, were emotions can get the better of people when a goal is scored, or in disagreement with decisions. The cheering from fans sound energy to adjoining properties will cause disturbance.

#### **Outside Areas**

No music/television will be played for the benefit of patrons in the beer garden or other external areas of the premises.

Signs shall be displayed on the frontage instructing patrons to recognise the residential nature of the area and conduct their behaviour accordingly – The management reserve the right to ask patrons to move inside the premises or leave if it is felt that they could be disturbing neighbours after 22:00.

The number of persons permitted to utilise the frontage for smoking will be restricted to 14 persons.

#### Patrons entering/exiting premises.

Where people queue to enter the premises a licensed door supervisor shall supervise and ensure the potential patrons behave in an acceptable manor

When the premises turn out a licensed door supervisor shall supervise patrons and ensure the leave in a prompt and courteous manor, respecting the neighbours.

A licensed door supervisor will be positioned on the exit door to ensure, as far as reasonably practical, that patrons leave drinks within the premises.


#### **Supporting Information**

A review of the premises licence has been undertaken in August 2012, were as the committee had decided that there is to be no regulated entertainment. Since the decision we have witnessed loud amplified music emanating from the premises.



I have considered the TEN application Ref 222188770 and **I wish to make representations** that the likely effect of the grant of the application for is detrimental to Licensing Objectives, primarily, the prevention of public nuisance for the following reasons.


- 1. The premises was subjected to a licence review in August 2012 as a result of complaints of noise from regulated entertainment.
- 2. The applicant/licensee will not be able to control airborne noise from cheering/yelling football fans which would cause unacceptable noise disturbance to local residents in close proximity to the venue.
- 3. The extension of hours applied for is inappropriate for this event as it encroaches into the normal sleeping hours of local residents in close proximity to the venue who would be disturbed by the noise from the fans.
- 4. There is no evidence that the premises has adequate sound-proofing against airborne and structure borne noise. Since the licence review, officers from the Nuisance Control Team have witnessed external break-out of loud music emanating from the premises.
