I am writing to make a complaint about Club Jet Set on the Harrow Road. Aside from the music which can be heard, each Saturday, when the club closes at 4am it seems that the clientèle congregate outside of the club for at least an hour, shouting at each other. The management and door staff seemingly do nothing to move them on (or clear up the vomit that the clubbers kindly leave in the area too).

Three weeks ago the police were called due to the trouble that was being caused – this is not an isolated incident and in the 18 months I have lived in the area, the police have been called regularly.

Aside from the noise pollution and litter that is evident post club nights, within one mile of the venue there have been three stabbings in the last few weeks. The area has more than its fair share of violent crime already and judging by the shouting and arguing that occurs every weekend outside the club, it seems quite possible that more violence will erupt in the near future.

I fully appreciate that people need to have somewhere to go for entertainment, but the management is clearly not responsible enough to handle such a late license in a primarily residential area. Added to this there is no public transport at the time the club closes or a local cab office in the vicinity, so I do wonder the extent to which drink/drug-driving is being encouraged, and drug dealing within very close proximity to the school on Furness/Palermo Road.

I'd be keen to know on what basis a late license has been granted to this club, what checks are made to ensure that it is operating in a professional manner, and what steps will be taken to reduce the extent to which the club is disturbing its residential neighbours. It is simply not fair that my weekends (and I expect those of many other local residents) should be ruined on a regular basis.

The footage at 04:34 shows one male in a white top intimating a weapon in his waistband (the footage is not clear enough to see what he actually has). HE eventually gets into the front passenger seat. All persons present on the premises who are required to carry out a security activity must be licensed by the Security Industry Authority.

(d) The responsible person shall take all reasonable steps to ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.

(e) The responsible person shall ensure that no alcohol is dispensed directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of a disability).

(f) The responsible person shall ensure that free tap water is provided on request to customers where it is reasonably available.

(g) The premises licence holder or club premises certificate holder shall ensure that an age verification policy applies to the premises in relation to the sale or supply of alcohol.

(h) The responsible person shall ensure that-

(i) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures-

- beer or cider: half pint;

- gin, rum, vodka or whisky: 25ml or 35ml; and

- still wine in a glass: 125ml; and

(ii) customers are made aware of the availability of these measures.

# Annexe 2 - Conditions Consistent With the Operating Schedule

1. Admission to club by Club Scan, photographic ID to be produced by all patrons (driving licence, passport, oyster card) to staff and electronic records to be kept on Club Scan and checked every time a patron attends the premises.

2 At least 2 door supervisors shall be employed after 22:00 hours on any day when the premises are open for the sale of alcohol past midnight.

3 A register/log containing the names, badge number, dates & times of duty of security staff and any incidents that occur shall be kept and made available to the Police and Licensing Authority.

4 No entry or re-entry shall be permitted after 01:00 hours.

5 CCTV shall be installed and maintained in a working condition.

6 All CCTV recordings shall be kept for 31 days and shall be made available to police and licensing officers if requested.

7 Police officers shall be given unhindered access via the internet to view live images from the CCTV at any time when the premises is open to the public.

8 Customers shall not be permitted to take open glass containers outside the premises as defined on the plan submitted to and approved by the Licensing Authority.

9 A copy of the premises licence summary including the hours which licensable activities are permitted shall be visible from the outside of each entrance to the premises.

10 The total number of people permitted on the premises including staff and performers shall not exceed 236 (180 in the main club area and 56 in the restaurant).

11 Notices explaining the licensee's policy on admission and searching shall be placed at each entrance.

12 The Portman Group proof of age scheme or similar such scheme shall be adopted.

13 Notices clearly explaining the licensee's drugs policy shall be displayed at the entrance and at suitable places through out the premises.

14. The front smoking area is to be limited to 10 persons at any one time and there is to be no consumption of alcohol, soft drinks or food. Area to be monitored by door staff.

15. The rear fire exit is to remain closed and only be used in the case of emergency.

16. No persons are to be permitted to remain at the rear of the club premises.

17. One toilet attendant in each of the male and female toilets at all times during licensing hours.

18. The management reserve the right to refuse entry to all persons not in smart casual dress. Smart casual dress not to include football tops, hooded tops, sports tops, jeans or trainers.

19. All furniture and soft furnishings shall comply with relevant fire safety standards.

20. A fire detection and warning system together with suitable and sufficient fire extinguishers shall be installed and maintained.

21. An emergency lighting system shall be installed and maintained in good order.

22. Public transport information including night time travel options shall be made available.

23. All windows and doors shall remain closed during licensed activities. Where a door is used for patrons to enter or exit the premises the door shall be fitted with a self closing device and shall not be propped open.

24. Windows and doors shall be fitted with an alarm that instructs staff when the window or door has been opened.

25. Entrance exit to the premises shall be via a lobbied door.

26. All speakers shall be mounted on anti-vibration mountings.

27. No music shall be audible at or within the site boundary of any residential property.

28. All entertainments shall utilise the in-house amplification system, the maximum output of which shall be controlled by the duty manager.

29. The level of amplified entertainments shall be controlled by a sound limiting device set at a level agreed with the licensing authority.

30. No Music shall be played in the beer garden or other external area of the premises.

31. No form of loudspeaker or sound amplification shall be sited on or near the exterior of the premises or in any foyer, doorway, window or opening to the premises.

32. Notices asking customers to leave quietly shall be conspicuously displayed at all exits.

33. Management to have a dedicated cab firm and must ensure that all cabs are booked via the in-house booking system.

34 Notices explaining the licensee's policy on admissions and searching shall be placed at each entrance.

35. All deliveries shall take place during the normal working day (i.e. 09:0 to 18:00 daily).

36 . No children shall be admitted unless accompanied by a responsible adult.

37. Nudity, striptease and other entertainment of an adult nature shall not be permitted on the premises.

- 38. The licensee shall undertake a risk assessment agreed by the police and licensing authority of any significant promotion or event, using the Metropolitan Police Service/Event Risk Assessment Form (Form 696) or an equivalent and provide a copy to the Metropolitan Police and Brent Licensing Unit not less than 14 days before the event is due to take place.
- 39. Where an event has taken place the licensee shall complete a Debrief Risk Assessment Form (Form 696A) and submit this to the Metropolitan Police and Brent Licensing Unit within three days of the conclusion of the event.

Please state the ground(s) for review (please read guidance note 1) This venue is located within a parade of shops, on a busy road. However, it's within close proximity to residential properties. The lease of the premise is held by the premises licence holder, Beer Barrel Limited. The designated premises supervisor (DPS) is, Mr. Mavji Meghani, who is the director for Beer Barrel Limited. I am aware that Mr. Meghani has been DPS of the premise since November 2005. Over the previous three years, several visits have been made by the responsible authority's. There has been a lack of management and lack of understanding of the authority and conditions of the premises licence. During visits conducted by police, the DPS has never been at the premises. His role is more of, owner/director, rather than a hands on daily supervisor. This lack of supervision has been highlighted in Licensing Act 2003 legislation breaches, witnessed by responsible authorities during their visits to the venue. Police request the removal of the current DPS, Mr. Mavji Megahni, and a new appointment of someone who will manage the day to day supervision. Since 2012, the premises licence holder has been aware that they have been using the authority of this premises licence without informing the licensing authority of the change of layout. The change of layout differs from the original plans submitted to the licensing authority, thus operating in breach of the authority. For example, A new rear partially enclosed smoking area has been erected with a reported locked rear gate. This also has an impact on public safety and the prevention of public nuisance licensing objectives. Police have received complaints recently of children being in the premise during early hours of the morning, noise, nuisance and licensable activity after authorised hours. On Sunday 15th February 2015 at 5.47am, officers witnessed unauthorised licensable activity taking place, namely the supply of alcohol. There were no door supervisors present and neither was the DPS. Upon further examination of CCTV footage from the evening, police identified that children had been present, some appeared to be as young as three (3) years old running around on the packed dancefloor in the early hours of the morning. Police also noticed public nuisance taking place with the dispersal of an earlier party at around 2.00am and the subsequent dispersal which takes place after police arrive, at around 6.15am.

The current operation at this premise is detrimental to the licensing objectives. The licence holder has been advised, but continues to ignore the responsible authorities. The above displays the risks of allowing the premises to continue operating in such an irresponsible way.

To assist Beer Barrel Limited control the venue more sucessfully, police consider some of the conditions of the current premises licence need to be re-worded appropriately to support current legislation and best practice.

# Police request the following conditions to be removed from the premises licence;

1. CCTV shall be installed and maintained in a working condition.

2. All CCTV recordings shall be kept for 31 days and shall be made available to police and licensing officers if requested.

Having viewed footage, it requires a date and time stamp to assist both staff/other authorities accessing it, downloading and viewing it. It currently does not meet the Home Office standard.

3. The licensee or his/her duputy shall be a member of, and actively participate in the local pubwatch scheme. *Membership of such a scheme is voluntary and, as such is not enforceable.* 

4. Signs alerting customers to theft shall be displayed.

Outdated condition which is no longer relevant to this premise.

5. A suitable burglar alarm linked to the police station shall be fitted and maintained. *Burglar alarms are no longer 'linked' to police stations, so would not be enforceable.* 

6. The Portman Group proof of age scheme or similar such scheme shall be adopted.

Due to the easy accessibility of such cards on the internet, this is better managed with an age verification scheme.

7. A free supply of drinking water shall be made available to customers.

This is now covered by a mandatory condition.

8. Public transport information including night time travel options shall be made available.

This premise already benefits from good transport links with 24 hours buses running outside and nearby Alperton tube station. This is now outdated with most customers gaining travel information from their smartphones via the internet.

9. No children shall be admitted unless accompanied by a responsible adult. *This would be best practice but not enforceable. An age verification condition is better suited.* 

### Police require the following conditions to be added to the premises licence;

1. CCTV shall be installed to Home Office Guidance standards and maintained in a good working condition and recordings shall be kept for 31 days, display the correct time/date and shall be made available to police and authorised Officers from Brent Council.

2. A CCTV camera shall be installed to cover the entrance of the premises and further cameras installed to cover the beer garden and smoking areas.

3. Customers will not take open drink containers outside the premises as defined on the plan submitted to and approved by the Licensing Authority.

4. A "Challenge 25" policy shall be adopted and adhered to.

5. An incident log shall be kept at the premises, and made available for inspection on request to an authorised officer of Brent Council or the Police, which will record the following:

- (a) all crimes reported to the venue
- (b) all ejections of patrons
- (c) any complaints received
- (d) any incidents of disorder
- (e) all seizures of drugs or offensive weapons
- (f) any faults in the CCTV system
- (g) any refusal of the sale of alcohol
- (h) any visit by a relevant authority or emergency service.

6. No entry or re-entry shall be permitted after 2300 hours.

7. The outside drinking areas shall cease at 2300 hours.

8. After 2300 hours smoking areas shall be limited to ten persons and each area shall be suitably supervised.

9. A personal licence holder fluent in English shall be present on the premises and supervise the sale of alcohol throughout the permitted hours for the sale of alcohol.

Also, as stated above, police request the **removal of the current DPS** Mr. Mavji Megahni and the appointment of a new DPS in his place.

### This list is not exhaustive and relies upon up to date plans of the premise.

Police feel these requests are in keeping with the Licence holders human rights and promote the running of his business and livelihood. These conditions are wholly reasonable, proportionate and appropriate measures to be put in place to promote the licensing objectives.

Police reserve the right to give evidence on any further incidents which may take place at, or in the vicinity of the premises, between the service of this application and the hearing and/or during the time allowed for any appeal proceedings.

Please provide as much information as possible to support the application (please read guidance note 2)

29/06/2012 at 10.00pm - Special police constable Wierciszewski visited the premise and reported that no door supervisors were on duty.

July 2012 - PC 157QK McDonald visited the premise with Brent Council's Mr. Alpesh Kerai (Property Database). It was noted that no door supervisors were on duty, the premises licence was not displayed, the DPS was not present and no statement of authorisation had been made. During this visit it became apparent that the plans submitted to the licensing authority were no longer a likeness to the premises (plans submitted are attached). This includes a new rear external area used for licensable activities (Picture attached - taken by PC Whitcomb during his visit on 10/03/2015). The premises licence holder was made aware, by letter, from the licensing authority that an application to vary the premises licence was required, submitting current plans of the venue.

20/04/2013 - PC 157QK McDonald visited the venue at 1.00am. During her visit, amplified music was being played and dancing taking place. Alcohol was being supplied from behind the bar. No door supervisors were on duty and the DPS was not present. No door supervisor log was kept. There was a rear external area with glasses of alcohol on the table. The fire exit door from this area was padlocked closed. PC McDonald requested that this gate be opened. This request took the manager a good ten minutes to action, as he had to search for the key. The premises licence holder was contacted again and told it was now a matter of urgency that the they submit the new plans and vary the premises licence. Any alteration to a premises licence can affect public safety and fire risk assessment.

#### CRIS 1917823/13 (Attached)

On 03/08/2013 police were called to the venue after a report was made of an assault. Upon arrival officers found the male victim covered in blood and suffering with a facial injury, which amounted to a grivous bodily harm. The victim had been sat was friends having a drink and smoking a cigarette at the rear of the pub. The suspect, who was entering the pub from the rear door, brushed past one of the victims' friends. This initially resulted in a verbal argument taking place, however, the suspect went on to assault the victims' friend. The suspect was then joined by two other males who joined in on the assault. The victim tried to intervene, however, he too was attacked, leaving him with facial injuries.

#### CAD's 1958/15FEB15, 1911/15FEB15 &1828/15FEB15 (Attached)

On Sunday 15th February 2015 police received three complaints with regards to the premise being open after hours, children being present and that there was noise nuisance. PC 558QK Homer attended the venue in response to these complaints and arrived at 5.47am. He stated that upon arrival, 'the shutters were down at the front and the rear smoking area gate was padlocked, despite the venue full of customers'. After gaining access he noticed that the premise was open to the public for the India V Pakistan cricket match. He noted that posters had been placed up inside the premise 'advertising' that the match was going to be screened in the venue from 3.30am until 'daylight'. A £10 entry fee would secure you 'two free pints' and 'breakfast' (PC Homer took a photograph of this posters and a copy is attached). This is in spite of the fact that the premise is licensed until 4.00am on this particular day and no temporary event notice, for this event, was given to the local authroty. The officer also witnessed supply of alcohol across the bar taking place. There were no door supervisors on duty and staff were unable to produce the premises licence to him upon request.

#### 19/02/2015

PC Lewis-Evans attended the venue to hold a meeting with Mr. Mavji Meghani. She noted that no copy of premise licence was available and that Mr. Meghani was completely unaware of any of his licence conditions. PC Lewis-Evans requested to inspect the door supervisors log, which was not completed correctly. Only partial SIA badge numbers had been recorded. The officer also informed Mr. Meghania

that a full variation was required as the premise has a door through to the next building.

# 10/03/2015


I attended the venue for a subsequent meeting with Mr. Meghani. He handed me a two (2) page A4 reposnse to the incident which occurred on 15th February 2015, at his premise. A copy of this has been attached. During my visit I noted the following breaches. No sign alerting customers to theft, no notice requesting customers leave quietly, no notice showing local taxi numbers displayed, no notice explaining the licencee's policy on searching, security log not filled in correctly (see below) and there was no incident record. Further, the premise still no longer represents the current plan submitted to the local authority back in 2005. At the rear of the premise a shelter has been erected. Under this shelter, tables and chairs are present, and it appears to be used as a smoking/drinking area. The rear laundry room has been converted into a gents toilet. Inside the pub a pool table (marked Pool Table 2 on the plan) has been removed and this area is now open plan with tables and chairs. A raised platform area at the front of house, no longer exists and has been replaced with tables and chairs at floor level. There is a door, to the left of the entrance opposite the bar, which leads to a restaurant called 'Mohmoh's'. This door was shut but unlocked, allowing customers to freely access this area. This is a separate premise entirely. The restaurant is not part of the pub, and has it's own exlusive main entrance leading from the street. However, Mr. MEGHANI described this to me as his, 'dining area'. There was also a locked partitian door (not shown on the current plan) with a wooden blind across it. Mr MEGHANI explained that there is concrete behind this door which leads to a premise not owned by him. I also requested to see the door supervisors/incident record (copy has been attached). Mr. Mavji Meghani supplied me with a single A4 sheet of printed paper which is dated between 31st December, year not stated, until 22/02/2015. On examination of this record, there is overwriting of times, some entries are not signed for and SIA badge numbers have only partially been recorded (There are sixteen (16) numbers on an SIA door supervisors badge). At the bottom of the record it reads, 'Page 14 of 33', yet when asked, Mr. Megahani was unable to produce the rest of the document. There was no separate incident log available. This is a breach of condition number four (4) of the premises licence.

## 10/03/2015

I requested CCTV from the premise following PC HOMERS visit on 15/02/2015, via a letter (attached). Mr Mavji Meghani produced this to me upon my request, along with a letter in response to the incident on 15/02/2015. This letter has been attached. I have examined the CCTV footage. It is worth noting that none of the footage is time or date stamped, which has proved viewing the footage very difficult. Disk 1 of 3 apparently shows 12.00am-2.00am (15/02/2015). It appears that a party is taking place. The Premise is open to the public and alcohol being served. During the first fifteen minutes of this footage a young child aged around 10-11 years old can been seen on the dance floor with a female. Also a younger female child aged around two (2) years old can been seen with a older female, running around on the dance floor, while other customers are dancing merrily. Condition twenty-three (23) of the current premises licence states that, 'No children shall be premitted on the premises after 2100 hours'. The Pub is very busy. A DJ is playing music whilst another male is singing into a microphone. Most tables are full with patrons drinking and dancing on the dance floor and in bar areas. Televisions are on, one door supervisor can be seen working on the main entrance/exit which leads from and to Ealing Road. Disk 2 of 3 apparently shows 2.00am-2.30am with people loitering outside the premise in groups.

Disk 3 of 3 apparently shows 4.00am-6.30am. Camera 'Ch 04:01' at six minutes shows alcohol still being served across the bar. The premise should now be closed and licensable activity stopped. Camera labelled 'Ch 03' shows no door staff on duty at all. The premise is still very busy with many patrons sat at tables watching TV's showing the cricket match. Camera (Disk 3 (1) 'CH04:01' shows a young male child aged around fifteen (15) years old, with an older male aged around 50-60 years old, sat on a seat by a table watching the cricket match on television. Camera (Disk3(3) 'Ch 04:01' shows police arriving at 16 mins 30 seconds and the pub being cleared of customers. At around 6.15am camera (Disk 3 (3) Ch 02-01, shows customers loitering outside the pub in groups before moving off.

I certify that I have considered the application shown above and I do not wish to make representations that the likely effect of the review of the application is detrimental to the Licensing Objectives for the reasons indicated below.

Licensing Enforcement Officer: Lavine Miller-Johnson

An officer of the Licensing Authority, in whose area the premises are situated, who is authroised for the purposes of exercising its statutory function as a 'Responsible Authority' under the Licensing Act 2003.

The application has been made to review the premises licence under section 51 of the Act.

The Licensing Authority representations are primarily concerned with the four licensing objectives;

- the prevention of crime and disorder;
- public safety;
- the prevention of public nuisance; and
- the protection of children from harm.

Following my visit to the premise on 6<sup>th</sup> May 2015 where Mr Meghani and Mr Solanki were both present the following was found:

Mr Meghani has advised that, following the visit from the police they have agreed to abide by the new conditions that have been set. I am in full support of the imposed conditions.

Mr Meghani has made great attempt to apply these conditions immediately. I sat with Mr Meghani we went through his condition. All conditions have been met.





## Informative:

- As noted on the council's database system and during my own observation the plan of the premise is still incorrect and does not reflect the changes that have been made to the layout. During the visit Mr Meghani showed me a new plan of the premise. This plan is correct in accordance with the Licensing Act 2003. I have advised Mr Meghani as a matter of urgency, to submit this plan for a variation in order to ensure the correct layout of the premises is relfected on our system.
- I have also advised that Mr Meghani contact <u>Andreas.Kirschner@brent.co.uk</u> to arrange an inspection of the smoking area at the rear of the premise. From my observation this area is more than 50% enclosed.
- I have advised Mr Meghani to contact the local fire department to ensure that the fire exit leading from the kitchen was satisfactory.
- I have aslo advise Mr Meghani to address the issue of the backgate which is either left open unsecure or locked. He will need to consider another type of security for this exit. I have advised a push bar.



Dear Mr. Mghani,

I am writing this letter in regards to the review application submitted by me, on behalf of the Metropolitan Police service, to the London Borough of Brent. In respect of this application, you have responded to me in several communications, accepting and agreeing to conditions and requests by police. I shall summarise below as to what has been agreed;

### Conditions to be removed:

1. CCTV shall be installed and maintained in a working condition.

2. All CCTV recordings shall be kept for 31 days and shall be made available to police and licensing officers if requested.

3. The licensee or his/her duputy shall be a member of, and actively participate in the local pubwatch scheme.

4. Signs alerting customers to theft shall be displayed.

5. A suitable burglar alarm linked to the police station shall be fitted and maintained.

6. The Portman Group proof of age scheme or similar such scheme shall be adopted.

7. A free supply of drinking water shall be made available to customers.

8. Public transport information including night time travel options shall be made available.

9. No children shall be admitted unless accompanied by a responsible adult.

### Conditions to be added:

1. CCTV shall be installed to Home Office Guidance standards and maintained in a good working condition and recordings shall be kept for 31 days, display the correct time/date and shall be made available to police and authorised Officers from Brent Council.

2. A CCTV camera shall be installed to cover the entrance of the premises and further cameras installed to cover the beer garden and smoking areas.

3. Customers will not take open drink containers outside the premises as defined on the plan submitted to and approved by the Licensing Authority.

4. A "Challenge 25" policy shall be adopted and adhered to.

5. An incident log shall be kept at the premises, and made available for inspection on request to an authorised officer of Brent Council or the Police, which will record the following:

(a) all crimes reported to the venue

- (b) all ejections of patrons
- (c) any complaints received
- (d) any incidents of disorder
- (e) all seizures of drugs or offensive weapons
- (f) any faults in the CCTV system
- (g) any refusal of the sale of alcohol
- (h) any visit by a relevant authority or emergency service.

6. No entry or re-entry shall be permitted after 2300 hours.

7. The outside drinking areas shall cease at 2300 hours.

8. After 2300 hours smoking areas shall be limited to ten persons and each area shall be suitably supervised.

9. A personal licence holder fluent in English shall be present on the premises and supervise the sale of alcohol throughout the permitted hours for the sale of alcohol.

### **Removal of current DPS**

You have agreed to step down as DPS of Panthers and appoint a new DPS as your replacement.

### Opening hours and hours of licensable activity

You have agreed to the following hours of opening and for all licensable activities. These hours reflect 'hours of operation permitted by planning', as per the planning case history document which I have shown you during our recent meeting, and which I have attached for your information;

Monday 0800-2300 Tuesday 0800-2300 Wednesday 0800-2300 Thursday 0800-2300 Friday 0800-2300 Saturday 0800-2300 Sunday 1200-2230

As per our telephone conversation today, as we have no reached an agreement, I now in a position to withdraw my application. However, having spoken with Brent council licensing department, I have been informed that the matter must still go to hearing, although I can inform the committee that we have now reached an agreement.
