#### Please state the ground(s) for review (please read guidance note 1)

This venue is located at the end of a parade of shops, on a busy road, which meets with the junction of Pasture Road, Wembley. It is situated wholly within a residential area. The premises licence holder (PLH) and designated premises supervisor (DPS) is, Mr. Jagdish Devshi. He has been in these roles since 25th November 2005. During the past five years there has been a series of incidents which have occurred within the premises, resulting in police attendance. Mr. Devshi has continued to fail to uphold the licensing objectves of the prevention of crime and disorder, public safety and the prevention of public nuisance, as outlined in this application.

The venue has a long history, dating back to 2010, or crime and disorder. On 26/12/2010 a large scale fight, involving 20-30 customers, took place inside the premise. Police were called and it took some fifteen police officers to deal with and restore order. One male received common assault injuries. Four customers were arrested, three for affray and one for common assault. On 30/03/2011 a female motorists was stopped by male customers seen exiting the venue. The victim had her car damaged and was then subjected to racial verbal abuse. Another large scale disturbance took place on 30/01/2014, around fifty (50) customers were said to be 'smashing the pub up'. Police were called and It took a large number of officers to clear the bar after the management had lost control. Once outside a bottle was thrown towards a police vehicle and one arrest was made. This incident was reviewed by Brent police licensing team and staff were found to have served customers who were already drunk. This is an offence under s.141 Licensing Act 2003. Police issued a formal warning letter to Mr. Devshi. On another occasion, police were called to the venue as a group of males attended the venue drinking their own alcohol and refusing to leave, when asked to do so. Once again, Mr Devshi was unable to control the situation and police had to attend in large numbers to assist with ejection. These types of incidents draw police officers away from other calls, putting the public at risk of harm and the ongoing nuisance that the arrival of several police vehicles, police sirens, radios and then the subsequent dispersal of large groups cause to local residents.

Numerous other allegations of crime (as listed below in this application) have been made to police, which include criminal damage, theft of a mobile phone and harassment. The latest crime was a robbery, on Mr. Devshi himself, which occurred inside the premises. The subsequent investigation was hampered due to the current CCTV system, which was not working correctly. Despite appeals from police to have this looked at by an engineer, these were ignored and eventually the crime had to be closed.

Class A drug use has been an issue at this premise also. Brent council and Brent police have tested the toilet area for drugs use, on two separate occasions. Both of these tests were positive for cocaine. On the 02/04/2011, police were called the premises' beer garden, after residents heard noises. The premises were closed and no member of staff was present. When police arrived they found a male in the garden taking cocaine. This male was arrested and when officers spoke with Mr. Devshi, he told them that he knew the man and that he had *no problem at all* with the male being in his beer garden.

The venue has a history of noise complaints resulting in nuisance to local residents. On 30/11/2015 Brent council's noise team have previously attended and seized audio equipment from the venue in response to numerous noise complaints. On 08/12/2012, the council issued the venue with a noise abatement notice. I believe the premises were subject to a review following application from Brent noise team. Despite this, police attended recently on 02/05/2015 at 12.10am and found Mr. Devshi playing recorded amplified music in contravention of his authority. He is only allowed regulated entertainment until 11.00pm. This is an offence under s.134 Licensing Act 2003.

There have also been numerous breaches of the current premises licence, including door staff not being employed when they should be and suspected 'lock in's'.

Mr Devshi has exhibited a consistant lack of management and supervision. The evidence shows that he lacks control over patrons and through constant noise nuisance, Mr Devshi has failed to show any regard towards local residents. It is in my opinin that it would be detrimental to the licensing objectives if Mr. Devshi is allowed to continue running this operation in such a way.

Police request the **removal of the current DPS**, Mr. Jagdish Devshi and the appointment of a new DPS in his place.

To further reduce the risk to the licensing objectives and to assist the new DPS in upholding these objectives, in particular crime, disorder and to prevent public nuisance within such a densely populated residential area, police request the following **reduction of hours** be as follows:

**\*The opening hours of the premises:** 1000-2300 Monday - Sunday *These hours allow for 30 mins of drinking up time.* 

\*Supply of alcohol: 1000-2230 Monday-Sunday

\*The **removal** of '**The provision of late night refreshment**' - *This will no longer be required if the above hours are adopted.* 

\* All timings for regulated entertainment hours to **remain the same**.

To assist the new DPS control the venue more sucessfully, police consider some of the conditions of the current premises licence need to be re-worded appropriately to support current legislation and best practice.

#### Police request the following conditions to be removed from the premises licence;

1. (Condition number 8) Closed circuit television (CCTV) shall be installed and maintained in accordance with the Association of Chief police Officers (ACPO) guidance, and all recorded images kept and made available to the police and licensing authority for 31 days. *This is an outdated condition*. *The updated CCTV condition is more appropriately suited*.

2. (Condition number 7) Door supervisors of a sufficient number and gender mix, shall be employed from 21:00 hours on any day when the premises are open for the sale of alcohol past midnight. *Police are requesting a reduction of hours. If granted, this condition would no longer necessary.* 

#### Police request the following conditions be added to the premises licence;

1. CCTV shall be installed to Home Office Guidance standards and maintained in a good working condition and recordings shall be kept for 31 days, display the correct time/date and shall be made available to police and authorised Officers from Brent Council.

2. A CCTV camera shall be installed to cover the entrance of the premises and a further camera installed to cover the beer garden.

3. Customers will not take open drink containers outside of the premises or beer garden.

4. A "Challenge 25" policy shall be adopted and adhered to.

5. An incident log shall be kept at the premises, and made available for inspection on request to an authorised officer of Brent Council or the Police, which will record the following:

- (a) all crimes reported to the venue
- (b) all ejections of patrons
- (c) any complaints received
- (d) any incidents of disorder
- (e) all seizures of drugs or offensive weapons
- (f) any faults in the CCTV system
- (g) any refusal of the sale of alcohol
- (h) any visit by a relevant authority or emergency service.

6. A personal licence holder fluent in English shall be present on the premises and supervise the sale of alcohol throughout the permitted hours for the sale of alcohol.

7. Notices clearly explaining the licensee's drugs policy shall be displayed at the entrance, in all toilets and at suitable places throughout the premises.

8. Toilets shall be checked every two hours for the use of drugs and other illegal activities.

9. A toilet checklist shall be displayed on the wall in all toilets. Staff shall use these checklists to record their name and certify the time of the check. Checklists are to be replaced daily and all old checklists must be retained and made available for inspection by the police and authorised officers from Brent council.

10. A clear and unobstructed view into the premises shall be maintained at all times.

11. The outside drinking areas shall cease at 2200 hours.

12. Notices asking customers to leave quietly shall be conspicuously displayed at all exits.

13. The licensee shall make available and publish a telephone number for residents to make contact.

This list is not exhaustive.

Police feel these requests are in keeping with the Licence holders human rights and promote the running of his business and livelihood. These conditions are wholly reasonable, proportionate and appropriate measures to be put in place to promote the licensing objectives.

Police reserve the right to give evidence on any further incidents which may take place at, or in the vicinity of the premises, between the service of this application and the hearing and/or during the time allowed for any appeal proceedings.

Please provide as much information as possible to support the application (please read guidance note 2)

**12/11/2010** - Crime report 1929696/10 refers to a theft pickpocket which occurred inside the premise. The victim had his mobile phone stolen from the inside of his jacket pocket.

**14/12/2010** - Complaint to police that customers using the shisah area at moonbay are standing around on the street oustide arguing with passer by's and intimidating local residents.

**26/12/2010** - Crime report 1933478/10 refers to a large fight. At 12.30am police were called to the venue by Mr. Devshi as a large group were refusing to leave his premise. As offiicers arrived a fight was about to start in the pub, but those involved were stopped by police. The group of around 20-30 were ushered outisde by police and then a large fight broke out, with punches being thrown and a bottle smashed over the head of another. Three arrests followed. Those involved were later disposed of by way of fixed penalty notice's for disorder. This fight took eleven police units (that's around 22 police officers) to bring under control. This was Brent's total amount of officers on duty for the entire borough.

**14/01/2011** - A complaint was received regarding noise at 9.00pm and smoking at the premise. Mr. Mortimer (Brent police licensing manager) visited the venue and spoke with the licensee. The licensee was advised that the rear shisha area would need to be more than 50% open and that it would require a variation application.

**30/03/2011** Crime report 1908232/11. Allegation made to police of racially aggravated criminal damage to a motor vehicle. At 6.20pm the victim called police and reported that she was driving along East Lane, Wembley outside Moonbay bar with her son. She went on to say that a large group of 30-50 males came out of Moonbay bar and surrounded her car. The victim believes that the males had all been drinking inside the bar and had been watching the cricket match between India and Pakistan. One of the males in the group shouted; "You pakis! We won, we won!", whilst taking photographs of her and her son. The victims son wound down his window to tell the male to move out of the way, at which point the suspect shouted it again and threw a glass of what is believed to be alcohol into the vehicle. The victim was extremely shaken by the incident. This matter had to be closed due to insufficient evidence. Of note, staff informed police that the CCTV system encountered 'technical issues' and could not be retrieved.

**02/04/20111** Police were called to the venue after a local resident heard voices coming from the rear beer garden, despite the venue being closed. Police arrived and found two males who had gained access to the garden, and in the process of taking cocaine. Both males were arrested for possession of class A drugs and being found on enclosed premises for an unlawful purpose. No members of staff were present and it is believed the males had accessed the beer garden via a hole in the gate. When officers contacted the DPS, Mr Jagdish Devshi, he told officers that he knew the males and that he did NOT have a problem with them being there. He refused to give police a statement and case against the men resulted in no further action. One of the males was charged with drug offences. Crime reports 1908495/11 and 1908494/11 refers.

**13/05/2011** - Crime report 1912427/11 refers to an allegation s.4a public order. An incident took place where a heated argument took place in the venue between the DPS Mr Devshi and a known male who he allowed to carry out a shisha area in his beer garden. The suspect has shouted, 'I'm going to f\*cking smack him!" Customers called police fearing it was going to get out of hand. The suspect was issued with a fixed penalty notice for disorder.

**01/08/2011** Crime report 1920667/11 refers to a report of harrassment which has stemmed from a civil dispute and threats made to the DPS, Mr. Devshi. Suspect is a known male to him, whom he allowed the use of his beer garden for a shisha area. The suspect was later arrested and given a first instance harrassment warning.

**25/09/2011** Crime report 1925570/11 refers to an allegation of criminal damage. A house brick was thrown through the window of the venue. Motive behind this, remains unknown.

**24/04/2012** - PC 781QK Sweeney PC 977QK Hitching attend the premises to carry out a licensing inspection under the Op Condor. As part of this operation, police use drug testing swab kits in the toilet areas. This test proved postsitve for Class A drug use, namely cocaine.

**30/06/2012** - Information received that owner is undertaking lock-ins and drug activities (mainly cocaine). Visit carried out by Esther Chan, Brent council. Premises visited at 2.25am, where it appeared closed and in darkness. The front entrance and rear exit doors were locked, no access gained. However, Ms. Chan reports that she peered through a gap in the window and witnessed DPS, Jagdish Devshi behind the bar and approximately five people in front bar socialising. She also heard Bollywood music emanating from the premises. Suspected lock-in taking place.

01/07/2012 - Email received from Brent Council's licensing officer, Ms. Esther Chan who visited the premise at 3.10am. The email read as follows; 'We approached the premises and saw approximately four people leaving the premises via the rear emergency exit. We went through the back and saw owner Jagdish Devshi escorting his guests out. He appeared to be shocked when he saw our presence. As we made our way to the premise, I could smell Cannabis in the garden. There were approximately eight people around the bar socialising, drinking and listening to recorded Bollywood music. Mr Devshi was intoxicated, his speech was slurred and he made various hand gestures that did not coordinate with his words. When he was asked to repeat and confirm details, he did not make sense. Mr Devshi said it was his friend's (Jason Devshi) birthday and this was a private function that started at 00:30hrs All the drinks are free, which had accumulated to £150. Mr Devshi then said his brother will paying him for this event and in turn when it comes to his brother's birthday in August, his friend Jason Devshi will pay for everything at his venue in Camden. A few minutes later, Mr Devshi said Jason Devshi do not own the venue in Camden, when he was asked to repeat his statement. I then asked Mr Devshi what time he left the premises on Friday 29th June 2012. He stated he left the premises at 00:00hours and did not return. When I told him that I had witnessed people in the venue in the early hours, Mr Devshi then admitted that he had returned from home with five friends at approx 1:30am to drink at the venue. The drinks were free of charge. Toilet drug test swab taken – This proved Positive (high concentration) for cocaine. Once again, suspected lock-in taking place.

**30/11/2012** Police assist Martin Wood, Brent council environmental health officer, seize audio equiptment from the venue, following complaints from local residents regarding noise eminating from the venue.

08/12/2012 A noise abatement notice is issued by Brent council noise team.

**22/08/13** Premises licence reviewed by London borough of Brent. The committee added an additional conditon, namely that regulated entertainment shall sease at 23:00 hours Monday-Sunday unitil an accoustics survey is carried out.

**30/01/2014** - At 11.40pm Police were called to the venue after fifty (50) persons, said to be from the travelling community, were 'smashing up the pub'. When officers arrived, they found blood, smashed glass and beer all over the floor. Many customer appeared to be drunk. It was clear that a large disturbance had taken place. Clearly the management had lost control. It took fourteen (14) police units to clear the bar of customers. One arrest was made outside the venue (for behaviour likely to cause a person harrassment, alarm or distress - s.5 Public Order Act) after one of the female customers threw a bottle of alcohol towards a parked police vehicle, which smashed close to it. The suspect was later issued a fixed penalty notice for disorder. Crime report 1902574/14 refers.

Following this particular incident, Brent police duty officer, Inspector James Rawlinson emailed Brent police licensing unit. He said that he had asked staff why their customers were all so drunk and why they were unable to control the level of drunkeness within their premise. One member of staff commented that they were all, 'too scared to stop serving them'. No SIA door supervisors were on duty either.

**06/02/2014** - Following the incident on 30/01/2014, Brent police licensing manager, Mr. Mortimer requests CCTV. After examining this and police headcam footage, he witnessed staff selling alcohol to customers who were drunk. Mr. Mortimer issued Mr. Devshi with a warning letter, as this is an offence contrary to s. 141(1)(a) Licensing Act 2003.

**02/06/2014** - Police were called to the venue by the DPS after a group of around fourty (40) persons, described as being from the travelling community, walked into his bar with their own cans of beers. They refused to leave and then offered the DPS £10 per person if he allowed them to carry on drinking in his bar into the evening. He refused and yet again a large number of police officers had to attend to assist in ejecting them.

**20/03/2015** - At 4.30pm the DPS, Mr. Devshi was attacked inside his premise by an unknown group of males who walked in and one hit him around the head. During the melee, his chain was pulled from his neck and broken. The suspects then ran away from the venue. Police were called and this incident was recorded as a robbery. Crime report 1906617/15 refers. When police officers requested CCTV footgae, the system was not working and it was unable to download. This breaches condition eight (8) of the current premises licence. However, Mr. Devshi promised officers that he would hire a CCTV engineer to retrieve the footage for police.

**27/04/2015** - Now, over a month later since the robbery at Moonbay, DC Baillie from Brent police CID contacted the licensing police team and informs us that Mr. Devshi has not kept his promise in rectifying his CCTV system. He has not downloaded footage as requested.

**02/05/2015** - I attended the premise to chase CCTV requested by CID over one month ago. I Attended at 12.10am and spoke with DPS Jagdish Devshi. The curtains were drawn upon arrival but the main door was unlocked and a handful of customers remained inside still drinking. Mr. Devshi stated that he was now closed, however, It appeared very much open to me. Recorded amplified music was still being played inside, louder than 'background music'. The premise is only allowed to conduct regulated entertainment until 11.00pm. As such, this amounts to offence of carrying out unauthorised licensable activity, contrary to s.134 licensing Act 2003. There were also no SIA door supervisors on duty, which breaches condition number seven (7) of the premises licence. Part B of his licence was on display and he could not produce his Part A saying, "It must be somewhere in the office". I enquired about the CCTV footage for CID regarding the robbery at his venue. He informed me that his brother was downloading it tomorrow. I asked why he had not employed a CCTV engineer, as promised. He replied, "Well, that would have cost me £700". He told me that, currently, the CCTV system does not work at all. I told him that he is not to carry out any further licensable activity, if his CCTV does not work - As this breaches his authority. He said it would be rectified by tomorrow.

13/05/2015 - PC 157QK McDonald and I visited the venue to see if Mr. Devshi had rectified his CCTV.

DPS Jagdish Devshi was present. Shutter was half down but the premises was open. He has now changed his CCTV system over but did not know how to use it. There was no mouse to operate the system at all. As such, it was not in a working condition and breaches the CCTV licence condition. Although not a condition, Mr. Devshi produced his SIA door supervisors log, which only showed a few entries. He explained that he always closes at midnight unless he has an event on. However, he could not explain to me why on my last visit why there were no door supervisors on at 12.10am. He was advised that as he could not operate the CCTV that no licensable activities should be carried out until it is rectified.



Dear Mr Devshi

This letter will set out what I believe to be failings in the support and promotion of the Licensing Act 2003.

Having viewed the CCTV of the incident supplied by you as well as the Police headcam footage it is my opinion that several members of the group involved in the incident were served too much alcohol whilst in the premises and that they were drunk.

This is an offence under S141(1)(a) which states that "knowingly sell or attempt to sell alcohol to a person who is drunk", a conviction for this can lead to a fine.

Having viewed the CCTV supplied by you I believe that some of the camera's need to be re sited and I will discuss that with you when I visit.

In addition, whilst there is no condition requiring you to have door staff at that time however 'good practice' would suggest that they should have been obtained immediately you became aware of the numbers of guests present and the potential for disorder. Failing that it may have been sensible to alert the local Police so that those responsible for the area could offer you support.

The Metropolitan Police as a Responsible Authority under the Licensing Act 2003 reserves the right to initiate a Review of your Premises License and take enforcement action with reference to the commission of offences under the 'Act'.



# Police representation to the Variation of the Premises Licence at Savannah Lounge, 4 Lancelot Parade, Wembley, HA0 2AJ

I certify that I have considered the application shown above and I wish to make **representations** that the likely effect of the grant of the application is detrimental to the Council's Licensing Objectives for the reasons indicated below.

The application has been made to vary a premises licence under section 34 of the act.

### Officer: Michael Sullivan Licensing Constable PC 368QK

An officer of the Metropolitan Police, in whose area the premises are situated, who is authorised for the purposes of exercising its statutory function as a 'Responsible Authority' under the Licensing Act 2003.

The Police representations are primarily concerned with crime and disorder, and Public Nuisance.

This premise currently has authority through the premises licence to provide music, and dancing until 01.30 hours, alcohol until 02.00 hours and closed to the public at 02.30 hours, seven days a week. This is sufficient and acceptable timings for a predominantly residential street.

In January 2015 the premises submitted a Temporary event notice to hold an event at the location with a DJ and dancing until 0500 hours. Licensing Police visited the venue and spoke to Mr Vakaria expressing concerns of noise and nuisance to the local residents. Police were mainly concerned with music emanating from the venue and disturbance to residents from customers

arriving and leaving, car doors slamming, engines revving and customers saying long goodbyes in the street throughout the night. Police received reassurances from the DPS that this would not happen. The event went ahead without Police receiving any complaints.

Licensing Police were then contacted by Debra Sylvester a Licensing agent acting for Mr Vakaria. Ms Sylvester spoke about submitting more TEN's and also Police thoughts on an application to vary the premises licence to extend the hours to 0500 hours. Police reiterated their concerns and suggested to submit the TEN's for a period of time and monitor.

Police have now received this variation to extend the licensable hours and closing time of the premises for Thursday, Friday, and Saturdays.

Police are aware of a complaint from a local resident of noise nuisance in the early hours of Saturday 25th April 2015. As a result of this a disturbance noise abatement notice was served on the premises, there was a TEN in place for this event.

This breaches conditions

15. No Noise or vibration shall be detectable at any neighbouring noise sensitive premise.

16. The level of music shall be arranged so as not to cause a nuisance to local residents.

I have spoken to the resident who contacted Brent Noise Nuisance team to see if the incident they had reported was a one off, the complainant informed me that this is a regular occurrence, and that on occasions he has had to go and stay with friends due to the noise, he states that after complaining the noise reduced somewhat for a few days, but last weekend the noise was again unbearable and the walls were vibrating, he states that this went on until between 04.00 and 04.30 hours, he also said that as people leave the venue they are loud and rowdy and this is affecting his quality of life.

On Sunday 3rd May 2015 at 01.00 hours uniformed police officers conducted a licensing visit at the venue. There were no door supervisors on duty, there were ten customers inside the premises and alcohol was being supplied. Condition 2 of the premises licence states Door supervisors of a sufficient number and mix shall be employed from 21.00 hours on any day when the premises are open for the sale of alcohol past midnight. When the TEN application for this event was submitted an e-mail was received from the applicants agent outlining that all of the conditions currently attached to the premises license would apply, and that 2 door staff would be employed for the event, and that the same safeguards will be in place as for the previous events that had recently taken place for which TENs had been applied for. This shows a blatant disregard to the agreement made by the applicants agent to abide by the conditions of the License at a time they were being monitored on there performance and ability to run this type of event correctly, this suggest to me that profit over safety is the main goal of this business.

These incidents give police concerns that the licensing objectives are being undermined.

Police are objecting to this application to an extension of hours. The planning permission for this premise is for use as a restaurant until 0130 hours only. These timings were imposed for serious reasons and it would be neglectful of Police not to consider this. These incidents took place during winter/spring months and the concern is that the nuisance will be exasperated during the summer months when local residents will have their windows open throughout the night.

Another variation request is to increase the capacity from 120 to 150 people, which will ultimately increase disturbance to local residents in the early hours of the morning when revellers start to leave the club. This high volume of customers will also have an impact on parking around the venue; the current position is either double yellow lines or parking permits in close proximity to this address. There will be no public transport running at this time of the morning, meaning people will either drive to the club or be congregating in the streets waiting for taxis to arrive.

Police are concerned by the use of the smoking area which would be used up until the closing time of the club; this will see people standing outside talking until 05.00 hours and causing a noise nuisance to local residents.

I recently visited the premises and spoke to Mr Vekaria and I discussed the application with him, in particular we spoke about the proposal to vary his licence to open until 05.00 on Thursday, Friday and Saturday. I raised my concerns about the potential of 150 revellers leaving the premises at that time of the morning when Public Transport will be virtually non existent, he stated that a local cab company will be able to take his customers home. I visited the Mini-cab company and spoke with the controller who stated that they do have drivers on at that time of the morning, but I do not believe they would be able to accommodate that number of people. We also discussed the smoking areas; for the lower ground area the patrons use the back yard which overlooks a residential area, and the first floor patrons will use the front of the premises which is the main road and again overlooks a large residential block of flats. Mr Vekarria stated that there would be a system of one person out at a time to the smoking areas and that this would be controlled by the SIA staff. This is a completely unworkable solution that indicates a lack of 'late night venue' knowledge from the applicant. There would be disorder from customers waiting to exit the premises to have a cigarette. Two SIA staff would require permanent positions in the smoking areas; this would increase the overall numbers of security staff required to work in the premises. I then asked for the SIA log sheets, and checked for the sheet covering 3rd May 2015. Mr Vekaria confirmed that he had a TEN in place for this date and was open until the early hours of the morning but did not have any door security working the event. When asked why he stated it was an invitation only event, (Guest List) and that there was approximately fifty people present on the night, and for theses reasons he did not employ Door Staff, I explained to him that this was a breach of his licence and that having an event that was by invitation only did not exclude him from not having door security present from 2100 hours until 0200 hours (the start of the TEN). I then asked him to provide me with a copy of this Guest list which he was unable to produce.

On the 12th June 2015, at 23.30 hours licensing officers conducted a visit a the Savannah Lounge, on arrival they saw a group of about eight to ten males standing outside the front of the venue, they all appeared drunk and were talking loudly, two of the males appeared to be arguing and were shouting at each other in an aggressive manner, this went on for a few minutes before one of the males walked off, the other male then sat on a low wall next to the venue and started shouting at people as they walked past, his voice was loud and he sounded aggressive, after a few minutes he started to stagger off up towards WEMBLEY HIGH ROAD.

By this time a few more people had exited the Savannah Lounge and were also standing directly outside talking, they also appeared drunk and were talking loudly laughing and shouting, at this point Mr Vekaria came out of the venue, a male walked up to him and started hugging Mr Vekaria the male was very intoxicated and was staggering around, he then said something like 'I go in' or words to that affect and then staggered towards the front door of Savannah Lounge, where a member of staff shouted angrily at him to go away.

Officers were talking to Mr Vekaria and as they were speaking two motor vehicle pulled up directly outside the club, a large group of Asian males got out of the cars and started to walk towards the front doors of the Savannah Lounge, a couple of then said hello to Mr Vekaria , at which point he hesitantly said to them, ' the club is closed' the group stopped and one of them said 'WHAT' in a loud voice, the group looked confused and appeared surprised at what Mr Vekaria had just said, he then walked over to the group and spoke to them, officers were unable to hear what was being said, the group then went and sat in their vehicles which were parked across the road.

Officers observed the venue for about ten minutes to fifteen minutes, during this time several cars drove into the street beeping their horns, people came out of the club and got in them, there was still a small group of people coming and going from the Savannah Lounge and some stayed standing outside talking and due to being drunk were loud and in high spirits.

This atmosphere and noise felt more like a busy High Street on a Friday night rather than a quite residential road, directly opposite the Savannah Lounge is a large block of flats, this is no more than a few meters from the entrance to the front door of the club, due to the warm summer night officers noticed that some people had their windows open, this noise from revellers leaving the club and standing outside talking and shouting along with the vehicles stopping and beeping their horns must make for a very unpleasant place to live for these people who would undoubtedly be woken from their sleep.

Again as previously stated this highlights the disregard of the licensing legislation and shows a worrying trend.

In addition to the above, the applicant has not provided any information in the operation schedule to indicate how he will manage the exodus of 150 revellers at 5AM, or the use of external areas. The applicant has made this application with profit in mind over the licensing objectives and importantly the right to a peaceful home life for local residents.

The initial application for a premises licence at this address, indicated a bar restaurant. This variation is quite clearly now for a 'night club'. This premise and location is neither suitable nor fitting for such activities to 5AM.

If this application were to be granted Police consider it would have a detrimental affect on the local residents and will ultimately Breach the licensing objective The Prevention of Public Nuisance.



### Annexe 2 - Conditions Consistent With the Operating Schedule

- 1. CCTV shall be installed to Home Office Guidance standards and maintained in a good working condition and recordings shall be kept for 31 days and shall be made available to police and licensing officers if requested.
- 2. Door supervisors of a sufficient number and gender mix, shall be employed from 2100 hours on any day when the premises are open for the sale of alcohol past midnight.
- 3. A register/log containing the names, badge number, dates & times of duty of security staff and any incidents that occur shall be kept and made available to the Police and Licensing Authority.

- 4. Customers shall not be permitted to take open glass containers outside the premises as defined on the plan submitted to and approved by the Licensing Authority.
- 5. The licensee shall keep an incident book which shall be made available to the Police and Licensing Authority.
- 6. Signs alerting customers to theft shall be displayed.
- 7. A clear and unobstructed view into the premises shall be maintained at all times.
- 8. A copy of the premises licence summary including the hours which licensable activities are permitted shall be visible from the outside of each entrance to the premises.
- 9. A suitable intruder alarm complete with panic button shall be fitted and maintained.
- 10. The outside drinking areas shall cease at 2300 hours.
- 11. After 2300 hours outside smoking areas shall be limited to 5 persons and each area shall be suitably supervised.
- 12. A personal licence holder fluent in English shall be present on the premises and supervise the sale of alcohol throughout the permitted hours for the sale of alcohol.
- 13. On major event days at Wembley Stadium the following shall apply if the premises is hosting fans attending the event:
  - Customers shall not be allowed to congregate outside the premises.
  - The DPS shall work in partnership with the Police and if necessary comply with any direction given by the most senior Police Officer on duty at the event.
  - No alcohol or "alcopop" type drinks shall be displayed or sold in glass containers with the exception of wines and spirits.
  - No glass bottles shall be handed over the bar but decanted into plastic vessels.
- 14. The playing of live or recorded music shall not be permitted in any garden or external area.
- 15. No noise or vibration shall be detectable at any neighbouring noise sensitive premises.
- 16. The level of music shall be arranged so as not to cause a nuisance to local residents.
- 17. Nudity, striptease and other entertainment of an adult nature shall not be permitted on the premises.
- 18. The maximum number of persons permitted on the premises shall not exceed 50 persons including staff.
- 19. The locks and flush latches on the exit doors and gates shall be unlocked and kept free from fastenings other than push bars or pads whilst the public are on the premises.


