#### Dear All

Please see the attached police representations, following on from a telephone conversation with the applicant Mr Stefano Puccini, police have concerns about the front outside area being used, as it now appears that this area is the hotels Fire Evacuation point, during a recent meeting with the property manager for the site he stated the fire brigade had raised concerns about this location being fenced off and used by large numbers for licensable activity.

Police feel allowing this TEN would not uphold one of the licencing objectives namely 'Public Safety' as police feel having up to 300 people standing at the front of the hotel caged in would prevent a safe exit for people inside the hotel if there was the need to evacuate.

Mr PUCCINI agreed that this would breach health and safety policy of the hotel and is looking at other measures, until other alternatives are suggested and considered police will be objecting to the TEN.

#### Good Afternoon Michael

I've been asked to make direct contact with you in regards to the Novotel London Wembley.

In regards to evacuation and disperse. In some organisations E&D is a standard policy but within Accor hotels this is a reactive policy based on discrete criteria. Up to now this has been reactive to advice from CPNI following

incidents which require a change of approach to negate risk which would not otherwise have been present. These variations to our normal procedures are not subject to approval by any fire authority as since the Regulatory Reform Order 2005 it is incumbent on individual businesses to apply fire safety as they see fit but within the requirements of RRO. However, in line with the Dept of Business, Energy and Industrial Strategy guidelines on Primary Authority, we have entered a Primary Authority agreement with Greater Manchester Fire and Rescue Service who act as our single point of advice across the UK. E&D is taken on their advice also. I have attached, by way of example, the memo I issued following the Arena Bombing.

With regards to the TEN, I have advised that, while not incident related the principles are the same in that we would want, as a matter of sensible recourse, to avoid large crowds gathering and presenting a primary or secondary target and therefore advised that, for the purposes of the TEN, we pro-actively instigate the E&D primarily to avoid crowded places but also to manage evacuation safely.

### **Annexe 1 - Mandatory Conditions**

- (a) No supply of alcohol may be made at a time when no designated premises supervisor has been specified in the licence or at a time when the designated premises supervisor does not hold a personal licence or his or her licence has been suspended.
- (b) Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.
- (c) The premises licence holder or club premises certificate holder shall ensure that an age verification policy applies to the premises in relation to the sale or supply of alcohol.
- (d) The responsible person shall take all reasonable steps to ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.

An irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises in a manner which carries a significant risk of leading or contributing to crime and disorder, prejudice to public safety, public nuisance, or harm to children:-

- (i) games or other activities which require or encourage, or are designed to require or encourage, individuals to:
  - drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or
  - drink as much alcohol as possible (whether within a time limit or otherwise);
- (ii) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic (other than any promotion or discount available to an individual in respect of alcohol for consumption at a table meal, as defined in section 159 of the Act);

- (iii) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less;
- (iv) provision of free or discounted alcohol in relation to the viewing on the premises of a sporting event, where that provision is dependent on?
  - the outcome of a race, competition or other event or process, or
  - the likelihood of anything occurring or not occurring;
- (v) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner.
- (e) The responsible person shall ensure that no alcohol is dispensed directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of a disability).
- (f) The responsible person shall ensure that free tap water is provided on request to customers where it is reasonably available.
- (g) The premises licence holder or club premises certificate holder shall ensure that an age verification policy applies to the premises in relation to the sale or supply of alcohol.

The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and a holographic mark.

- (h) The responsible person shall ensure that-



Police feel allowing this TEN would not uphold one of the licencing objectives namely 'Public Safety' as police feel having up to 300 people standing at the front of the hotel caged in would prevent a safe exit for people inside the hotel if there was the need to evacuate. Mr PUCCINI agreed that this would breach health and safety policy of the hotel and is looking at other measures, until other alternatives are suggested and considered police will be objecting to the TEN.





Providing the licensee is willing to accept the following conditions Public Safety Team would withdraw the representation.

- The locks and flush latches on the exit doors and gates shall be unlocked and kept free from fastenings other than push bars or pads whilst the public are on the premises.
- The socket outlets (or other power supplies used for DJ equipment, band equipment and other portable equipment) that are accessible to performers, staff or the public shall be suitably protected by a residual current device (RCD having a rated residual operating current not exceeding 30 milliamps).
- Exits and exit routes are not obstructed (including by curtains, hangings or temporary decorations), and accessible via non-slippery and even surfaces, free of trip hazards and clearly identified
- Where chairs and tables are provided, internal gangways are kept unobstructed
- Temporary electrical wiring and distribution systems are not provided without notification to the licensing authority at least ten days before commencement of the work and/or prior inspection by a suitable qualified electrician.
- Subject to risk assessment, the maximum number of persons permitted on the Premises (not
  including staff) shall be: 120 persons when only the 90mm emergency escape door leading to the
  loading/unloading bay is in use.
- Subject to risk assessment, the maximum number of persons permitted on the Premises (not including staff) shall be: **300** persons when both the 90mm emergency escape door leading to the loading/unloading bay and double emergency escape doors in the malt store bay are in use.
- When the malt store is used as an exit route, the route must be clearly defined and free from obstructions.

In order for the Public Safety Team to withdraw this representation, it will be necessary for you or your client to **confirm in writing or via Email** that you accept the above licence conditions.

We will require these conditions to appear on the licence schedule should the licence be granted.

If you are in control of any part of a commercial premise, you are under a legal obligation to carry out a detailed fire risk assessment to identify risks and hazards in the premises. #### **Licence Conditions**

### 37 Humber Road NW2 6EN - Moncada Brewery

- 1 CCTV shall be installed to Home Office Guidance standards and maintained in a good working condition and recordings shall be kept for 31 days and shall be made available to police and authorised officers from Brent Council upon request.
- 2 The CCTV cameras shall be installed to cover the public entrance of the premises and the bar area.
- 3 The CCTV system shall be capable of obtaining clear facial recognition images and a clear head and shoulders image of every person entering or leaving the premises.
- 4 A member of staff trained in the use of the CCTV system shall be available at the premise at all times that the premises are open to the public.
- 5 A copy of the premises licence summary including the hours which licensable activities are permitted shall be visible from the outside of each entrance to the premises.
- 6 A "Challenge 25" policy shall be adopted and adhered to.
- 7 A sign stating "No proof of age No sale" shall be displayed at the point of sale.
- Any staff directly involved in selling alcohol for retail to consumers, staff who provide training and all managers will undergo regular training of Licensing Act 2003 legislation. This will be documented and signed for by the DPS and the member of staff receiving the training. This training log shall be kept on the premises and made available for inspection by police and relevant authorities upon request.
- 8 An incident log shall be kept at the premises, and made available for inspection on request to an authorised officer of Brent Council or the Police, which will record the following:
  - (a) all crimes reported to the venue
  - (b) all ejections of patrons
  - (c) any complaints received
  - (d) any incidents of disorder
  - (e) all seizures of drugs or offensive weapons
  - (f) any faults in the CCTV system
  - (g) any refusal of the sale of alcohol
  - (h) any visit by a relevant authority or emergency service.

- 9 Alcohol shall only be provided as an accompaniment to substantial food.
- 10 Customers shall not be permitted to take open drink containers outside the premises as defined on the plan submitted to and approved by the Licensing Authority.
- 11 Notices asking customers to leave quietly shall be conspicuously displayed at all exits.
- 12 The locks and flush latches on the exit doors and gates shall be unlocked and kept free from fastenings other than push bars or pads whilst the public are on the premises.
- 13 The socket outlets (or other power supplies used for DJ equipment, band equipment and other portable equipment) that are accessible to performers, staff or the public shall be suitably protected by a residual current device (RCD having a rated residual operating current not exceeding 30 milliamps).
- 13 Exits are not obstructed (including by curtains, hangings or temporary decorations), and accessible via non-slippery and even surfaces, free of trip hazards and clearly identified.
- 14 Public areas shall be maintained free from obstruction and trip hazards.
- 15 Where chairs and tables are provided, internal gangways are kept unobstructed.
- 16 Temporary electrical wiring and distribution systems are not provided without notification to the licensing authority at least ten days before commencement of the work and/or prior inspection by a suitable qualified electrician.
- 17 Subject to risk assessment, the maximum number of persons permitted on the Premises (not including staff) shall be: **80** persons.
- 18 All deliveries shall take place during the normal working day (i.e. 09:00 to 18:00 daily).
- 19 Refuse such as bottles shall be placed in receptacles outside the premises at times that will minimise the disturbance to nearby properties.
