- 8.4 Any conditions attached to licences will be tailored to the individual needs, style and characteristics of the particular premises and events concerned and will be drawn from a 'model pool of conditions' (where appropriate) to the particular premises.



I certify that I have considered the application shown above and I wish to make a representation.

An officer of the Licensing Authority, in whose area the premises are situated, who is authroised for the purposes of exercising its statutory function as a 'Responsible Authority' under the Licensing Act 2003.

The application has been made for a new premises licence under section 17 of the Act.

The Licensing Authority representations are primarily concerned with the four licensing objectives;

- the prevention of crime and disorder;
- public safety;
- the prevention of public nuisance; and
- the protection of children from harm.

The Licensing Authority require the following points to be included in the operating schedule or added as conditions on the premises licence:

- CCTV shall be installed to Home Office Guidance standards and maintained in a good working condition and recordings shall be kept for 31 days and shall be made available to police and authorised Officers from Brent Council.
- 2. A CCTV camera shall be installed to cover the entrance of the premises and a further camera to cover the entire servery counter and till.
- 3. A member of staff trained in the use of the CCTV system shall be available at the premise at all times that the premises are open to the public.
- 4. A copy of the premises licence summary including the hours which licensable activities are permitted shall be visible from the outside of each entrance to the premises.





- 5. Notices asking customers to leave quietly shall be conspicuously displayed at all exits.
- 6. Customers shall not be permitted to take open glass containers outside the premises as defined on the plan submitted to and approved by the Licensing Authority.
- 7. The licensee shall ensure customers leave the premises in a quiet and orderly manner.
- 8. No children shall be admitted unless accompanied by a responsible adult. All children must leave the premises by midnight.
- 9. A sign stating 'No proof of age, No sale' shall be displayed at the point of sale.
- 10. A 'Challenge 25' policy shall be adopted and adhered to
- 11. Alcohol shall only be provided as an accompaniment to a main meal.
- 12. The designated smoking area (DSA) shall be located at the front of the premises facing onto Ealing Road. Smoking shall be limited to 5 persons. This shall be in a cordoned off area and shall be monitored by the members of staff on duty at the premises.
- 13. If an external area exists at the rear of the premises, this shall not be used by members of the public at any time the premise is open carrying out licensable activities.
- 14. There shall be no vertical drinking permitted within the premises as defined on the plan submitted to and approved by the Licensing Authority.
- 15. An incident log shall be kept at the premises, and made available for inspection on request to an authorised officer of Brent Council or the Police, which will record the following:
 - (a) all crimes reported to the venue
 - (b) all ejections of patrons
 - (c) any complaints received
 - (d) any incidents of disorder
 - (e) all seizures of drugs or offensive weapons
 - (f) any faults in the CCTV system or searching equipment or scanning equipment
 - (h) any visit by a relevant authority or emergency service.
- 16. Any staff directly involved in selling alcohol for retail to consumers, staff who provide training and all managers will undergo regular training of Licensing Act 2003 legislation. This will be documented and signed for by the DPS and the member of staff receiving the training. This training log shall be kept on the premises and made available for inspection by police and relevant authorities upon request.
- 17. On major event days at Wembley Stadium the following shall apply:
- Customers shall not be allowed to congregate outside the premises.
- No glass shall be handed over the bar but decanted into plastic vessels
- The DPS or deputy shall work in partnership with the Police and if necessary comply with any direction given by a senior Police Officer on duty at the event.
- 18. No entry or re-entry shall be permitted after 23:00 hours Sunday to Thursday and 23:30 hours Friday and Saturday where seasonal variations apply.





- 19. Door supervisors of a sufficient number and gender mix shall be employed from 21.00hrs when the premises are open to the public carrying out licensable activities beyond midnight.
- 20. SIA Security shall wear clothing that can be clearly and easily identified on CCTV.
- 21. A register/log containing the names, badge number, dates & times of duty of security staff and any incidents that occur shall be kept and made available to the Police and Licensing Authority.

Reduction in Hours

The Licensing Authority require that all licensable activities terminate 30 minutes prior to the premises closing in order to give members of the public time to finish eating or drinking. It is therefore suggested that the following applies:-

Late Night Refreshment

be reduced to

Monday to Sunday 23.00-23.30hrs

I hope you are keeping well and am grateful for your response and agreement to remove conditions 11 and 17 in your representation. (Agreed).

I am still awaiting a response from the client with regard to the reduction in hours for LNR and the requirement for SIA staff for the non standard timings, (thank you, this isn't something I am willing to negotiate on) or any TEN they may apply for.

I have advised them that the SIA condition could only be applied to a TEN following a hearing if the Police or Public Health made a representation, and the licensing committee deemed that it was appropriate to attach that condition to the TEN. (As stated in my previous email, the committee are not permitted to add any new conditions, they can only add those already on the existing premises licence. Any additional conditions can only be agreed prior to committee. I will await your response on this).

They are seeking legal advice and a second opinion in this matter from another source, and I hope to be able to revert to you within the next couple of days.

The client has also made a comment with regard to your condition 18. I have offered them an alternative wording, and ask if you would be prepared to accept this:

18. No entry or re-entry shall be permitted after 23:00 hours Sunday to Thursday and 23:30 hours Friday and Saturday where seasonal variations apply, with the exception of any person who is standing outside the premises to smoke. The number of smokers will be monitored to ensure that the licensing objectives are fully promoted and staff will remind smokers of the notices with regard to noise and behaviour and respecting residents.

(This condition does not apply to smokers who are in a DSA (Designated Smoking Area) in a cordoned area (which must not be fixed. Removable rope barriers would be sufficient). They would still form part of the premises in terms of smoking. The extra wording is therefore not required).

I have passed the representation onto the client and await their response.

Most of the conditions you have suggested have already been included as part of the operating schedule, and this was further amended to include conditions from the police and public safety.

There are a few points that i require further clarification on.:

- 1) With regard to Wembley event days I thought that the premises were outside the earmarked area for this.
- 2) with regard to alcohol being served only to persons having a table meal, we have already met with the Police at the premises following their representations. They requested the same condition and it was agreed that this would not be required as the condition already in the operating schedule, that all alcohol sales are served directly to persons seated, would fully satisfy the prevention of crime and disorder strand of the Licensing objectives. The police subsequently withdrew their representation.

3) as the standard hours for licensable activity at the premises end before midnight, door supervisors would only
be required on the 3 non standard timings dates. This would prove somewhat onerous for the premises and
disproportionate for the size and nature of the premises. We would be willing to offer an alternative condition
that "on the 3 occasions for non standard tonnes each year, a risk assessment will be conducted and door
supervisors will be deployed accordingly"

I would respectfully object in granting this license based on the reasons shown below:

Please note that Fudam's owners have had a bad history with the trading standards at Brent, and I believe this was one of the reason's they were not granted a premises license previously. Also, upon spotting their notice, this time, unlike the previous occasion in which they applied, their notice did not display Brent's official licensing e-mail address, but only Fudam's appointed agents details. This does not seem entirely fair, as new residents in the area may not be aware of Brent Council's official licensing address, and for obvious reasons, may not want to send a rejection directly to Fudam's appointed agent.

Residents in Alperton are very disappointed that this restaurant has been considered once again for a premises license, especially as it has been rejected previously at the hearing both myself and others attended. Brent council are more than fully aware of the on-going problems with street drinking, paan/gudhka spitting, urination and further drinking at our local park - One Tree Hill, as well as anti-social behaviour taking place.

The name Fudam is actually the name of a town which is based in Diu,India. Unfortunately, the crowds who have been causing trouble and have been misbehaving are from Diu, India. Therefore, having a place which is familiar to some of the street drinkers (Mostly middle aged men) could greatly enhance further excessive drinking and anti - social behaviour from not only Fudam Restaurant, but could also lead towards One Tree Hill Recreational Ground. Even with a PSPO, we still unfortunately experience issues with street drinking, gudhka spitting on pavements as well as inside and outside of rubbish bins, and on the newly created pavements near Alperton station with regards to being a public

the newly created pavements near Alperton station with regards to being a public nuisance, crimes taking place as well as a fear of public safety. One Tree Hill is the nearest located park where a lot of drinkers have been hanging around continuously for quite sometime now (6-7 years), and thus may increase further with yet another place selling alcohol. As a result of this, the good reputation that we once had of not only One Tree Hill but our area, will continue to suffer.

I feel that there will also be greater competition with existing off-licence`s in terms of the price of alcohol, as it may alcoholic drinks could be even cheaper which could increase the consumption of alcohol as well as the longstanding problems in the area.

Also, the same crowd of people who drink on the streets also have been spotted sleeping, urinating on the side fences as well as the centre of One Tree Hill Recreational Ground at One Tree Hill hanging around in groups, and treating the

park as a `drinkers hangout`. Children on our road have felt threatened to go and play in our park side entrance (Braemar Avenue as well as Bowrons Ave) due to drinkers being around in big groups, and not only drink 1 or 2 bottles or cans but drink excessive amounts, and hang around and remain at One Tree Hill for long hours up until after midnight. I had even spotted them sleeping at the park as well as vomiting in the early hours of the morning.

We have already had enough problems constantly occurring and re-occurring on our street in our area for quite some time now, which has become never ending, and as a resident, I do not want to accept this as `the daily norm`. If a premises license is granted for Fudam, I feel as I am sure other residents would feel that our problems will double, not only for our road and area, but especially One Tree Hill, as it will turn into a `drinkers paradise` as well as a `pub`.

We appreciate the local police`s efforts in our area, but also recognise that they can not be present at all times. I have been spending a considerable amount of time trying to help rebuild and promote One Tree Hill as a great park to be at, as it has a lot of space available, has a nice outdoor gym, and used to be a quiet and pleasant park.

We do not want to see a fatality on our road or any other severe incidents happening in our area being linked to alcoholism, disorder and crime due to potentially cheaper alcohol being promoted or sold at a nearby shop as competition would be increased, and existing problems would be given a chance to develop further.

It is very disappointing to see another place applying for a premises license in the Alperton area given the fact we have been attending hearings on many occasions to discuss problems with councillors over and over again. I cannot understand why Brent Council's licensing committee would even consider any premises license applications given the amount of problems occurring over the years in Alperton. It feels like our views and observations based on living the area with residents ranging from 20,30, or 40 years plus, are continuously falling on deaf ears. We have had enough and really need to find a permanent solution fast.

Brent Council are just not listening, and are strangely trying to add to the issues we are having with particular emphasis to the problems addressed in this e-mail on premises licensing in the Alperton area of Wembley.

I wish to register my objection in granting of premises licence to serve liquor and late night entertainment to FUDAM, 238A, Ealing Road, Wembley, HA0 4QWD for the reasons mentioned below:

We currently have PSPO in place due to unsociable, criminal and violent behaviour by street drinkers who purchase the alcohol from nearby shops who urinate and expose them selves on the street.

The behaviour of these street drinkers and persons with influence of alcohol are frightening and our children are afraid to go out on their own due to absurd and disorderly behaviour of gangs of violent drinkers.

They often urinate openly on the street after drinking, exposing themselves with their personal parts being openly visible.

They litter the street with food packages, empty cans of beer and broken glass bottles which are dangerous to walk on and often our car gets punctured due to brocken beer bottles on the road.

I object this licence request based on the reasons shown below.

In Brent Council's statement of Licencing Policy, point 1.2, states the act establishes four objectives which are -

- *Prevention of crime and disorder
- *Public safety
- *Prevention of nuisance; and
- *Protection of children from harm

Unfortunately, there have been many incidents and problems occurring in Alperton particularly in Ealing Road relating to a substantial amount of alcohol consumption as well as ASB (anti - social behaviour) that have greatly affected all four of these core objectives stated in the Policy.

With relation to these 4 core objectives, issues such as: constant littering relating to food wastage on our streets, alcohol beverages being left on street corners, roads, alleyways as well as street littering, gudhka/paan spitting has also even occurred outside Fudam's restaurant and even on it's front doorstep as there is red colour from gudhka showing. I am grateful for the two representations from residents that you have forwarded to me. Please could you confirm if there have been any other representations from the ones agreed with Public Safety and the Police.

As no name or address has been provided for either resident I am unable to contact them to allay their fears and try to negotiate an agreement.

Please could you pass on my contact details to them and explain that I am more than happy to speak with them on the telephone, by email, or have a meeting at the restaurant. Hopefully this will show them that the premises is a restaurant and not an off licence and as such it is very unlikely to cause any problems.

Of particular concern is the allegation that the public notice is incorrectly worded. I would like to point out that the actual wording is the same as per the pdf on Brent's website, similarly with the wording for the newspaper advert.

With regard to the representations, and taking into account that most residents whilst being well intentioned and passionate, have little or no working knowledge of the licensing act 2003, and the legal procedure. I make the following observations as a response to their comments:

- 1. There is no actual evidence in either of the reps to support any of the allegations made that these premises would fail to promote the licensing objectives. Comments like the one made in rep 1 "We do not want to see a fatality on our road" are merely sensational, add no evidential weight and are not related to the premises application.
- 2. It is irrelevant that a previous application was refused as the legislation, guidance, and Brent's own licensing policy require that every application is treated as a new application and must be judged on its own merits.
- 3. Rep 1 is mostly irrelevant. The majority of the rep is concerned with the resident making a complaint that the council is generally letting residents down, and also failing to prevent anyone from applying for a premises licence.
- 4. If there has previously been any issue with Brent trading standards. Then this must be dealt with by the specific legislation that trading standards are empowered with. This may not be relevant to any decision a licensing authority or licensing sub committee can make under the Licensing Act 2003.
- 5. Rep 1 complains that this application if granted would exacerbate the issues of street drinking, Paan/gudhka spitting, rough sleepers, urinating in public, and furthermore all of this this would adversely impact on One Tree Hill. This is blatantly incorrect, there is no evidence or likelihood of this happening to support the claims, and more importantly the resident has failed to observe that the application is for a restaurant and not an off licence. They will not be selling alcohol to street drinkers and anyone who fails to meet meet an acceptable standard of dress and conduct, will not be permitted inside the premises.
- 6. I am sure that there must be a significant number of law abiding citizens who live in Fudam. It is a somewhat absurd link that using this name for the restaurant would be a draw for anyone who hails from Fudam, is a street drinkers, Paan/gudhka spitter, or general cause of anti social behaviour

I appreciate why the reps have been accepted and my comments were based on the premises being a restaurant. They will not be operating as an off licence and if it assists the residents and the authority, I can offer up a condition that only allows off sales only to persons who have consumed a meal at the premises, or to persons ordering a substantial takeaway meal in person at the premises (this will not include delivery of alcohol) For example this would allow anyone who has ordered a bottle of wine with their meal to take away the unfinished bottle of wine which will be suitably sealed, or for someone who has eaten a meal to purchase a bottle of wine to take away after their meal. This condition would prevent the premises from becoming an off licence and more significantly completely reduce the possibility of street drinkers obtaining alcohol from the premises.

Dear Resident,

I am the licensing consultant acting for Fudam at 238a Ealing Road Wembley HA0 4QL in their application for a premises licence.

I have read your representation and note the serious concerns you have with regard to the numerous anti-social problems associated with alcohol consumption by street drinkers.

I hope that the following information will assist and reassure you that these premises will not contribute to these problems:

- a) No sales of alcohol will made to street drinkers.
- b) Unless a satisfactory dress and behaviour code is complied with no person will be permitted to enter or remain on the premises.
- c) All staff will be fully trained to ensure compliance with the 4 licensing objectives.
- d) A significant amount of money has been invested in the business. With the premises being fitted out to a far higher standard and quality of furnishings than is the norm in the area.
- e) The premises are a family run, and family friendly restaurant, serving a variety of substantial meals and snacks, primarily for consumption on the premises.
- f) Both the Metropolitan Police and Brent's Public Safety team submitted representations with regard to the 4 Licensing Objectives. Full agreement has been reached with both responsible authorities. A raft of conditions has been agreed to their satisfaction that the premises will fully support the licensing objectives. Following the agreements the representations were withdrawn
- g) A maximum capacity limit of 43 seated members of the public, has also been agreed
- h) Alcohol may not be consumed by anyone unless they are seated at a table or the fully supervised service counter
- All sales of alcohol will be directly made and supervised by serving staff (waiters) to ensure that no excessive consumption takes place and that customers drink responsibly
- j) There will be no vertical drinking at anytime
- k) Off sales have been requested primarily to allow anyone who has consumed food at the premises to take away an unfinished bottle of wine. This will be properly sealed prior to them leaving the premises. It would be irresponsible to require that any unfinished wine be drunk prior to them leaving the premises, and the request has been made for this reason.
- I) The premises will not become an off licence, and will not make sales of alcohol for consumption off the premises other than in the example given above, or if someone has enjoyed a particular alcoholic drink with a meal and wishes to purchase a full and sealed bottle to take away with them, or if they have made a substantial food order to take away in person. Single bottles or cans of beer/lager/cider will be excluded from this.
- m) Alcohol will not be sold with any orders made for delivery of food.







Police representation to the Premises Licence application for 'Fudam, 238A, Ealing Road, Wembley, HA0 4QL'.

I certify that I have considered the application shown above and I wish to make representations that the likely effect of the grant of the application is detrimental to the Council's Licensing Objectives for the reasons indicated below.

I am of the opinion that the risk to the Council's objectives can be mitigated by removing the requested variations or attaching conditions to the Licence as shown below.

If these conditions were accepted in full I would withdraw my representation.

Police Officer: Paul Scott Licensing Constable PC 3302NW

An officer of the Metropolitan Police, in whose area the premises are situated, who is authorised for the purposes of exercising its statutory function as a 'Responsible Authority' under the Licensing Act 2003.

The application has been made for a premises licence under section 17 of the act.

The Police representations are primarily concerned with crime and disorder and the prevention of public nuisance.

On Thursday 12th September, police met with the applicant Miss Velgi and Mr Altman, Licensing Consultant. The premises will be run as a restaurant and not a bar. Bookings at the venue were discussed and the applicant agrees that a booking procedure will be adopted at the venue. This will include names and addresses of applicants.

The restaurant is to be a family run business and is not the type of venue that would be attracting street drinkers and will <u>not</u> supply high strength beers. Seasonal variations were discussed and agreed, as were the hours for the supply of alcohol and late night refreshments.

Police require the following points should be included in the operating schedule or added as conditions on the premises licence.

Closed Circuit Television (CCTV)

Good quality CCTV is essential as a deterrent for the prevention of crime and the detection of offenders. It allows for both covert and overt monitoring of the premises. With proper signage, this reassures both staff and clientele, that this is a safe environment where illegal activities are not tolerated.

All cameras and recording equipment will be installed and maintained in accordance with Home Office Guidance and the manufacturers instructions and will be fully operational when the premises are open to the public. Furthermore, images will be retained for 31 days.

Notices shall be displayed at the entrance to the premises, and in prominent positions throughout the premises, advising that CCTV is in operation.

Operating Hours to be displayed on Premises

A notice displaying the opening hours, the type of licensing activity and licence conditions should be clearly displayed and visible to anyone <u>outside</u> the premises. This may be incorporated in the summary of the licence, which must be displayed, or take the form of a separate item. Likewise the name of the Designated Premises Supervisor (D.P.S.) should be similarly displayed. This will allow the Police and other responsible authorities to readily identify the licence details. Clearly displayed opening hours will also reduce any confusion for customers prior to entering the premises and possible conflict when the premises close/stop selling alcohol.

Hours for the sale of Alcohol

This restaurant is located in an area that has regularly had issues and continues to have issues regarding anti-social behaviour and street drinkers. This is an issue that the police are working hard to eradicate and Police consider in order to promote the licensing objectives in particularly to prevent crime and disorder and public nuisance that the authorised sales of alcohol do not begin daily until 10.00 hours and finish at 23.30hrs. This was agreed with the applicant. There will be a half hour drinking up time and the premises will close to the public at 00.00hrs.

The restaurant is also situated in a residential area and it is felt that customers leaving the venue could cause considerable noise nuisance to those residents residing in the flats both adjacent and above the restaurant. Notices asking customers to leave quietly shall be conspicuously displayed at all exits.

Police require the following points should be added as conditions on the premises licence as below.

CCTV shall be installed to Home Office Guidance standards and maintained in a good working condition and recordings shall be kept for 31 days and shall be made available to police and authorised Officers from Brent Council upon request.

A CCTV camera shall be installed to cover the entrance of the premises and the main restaurant, bar area and entrance to the toilets.

The CCTV system shall display on any recordings the correct date and time of the recordings.

The CCTV camera that covers the entrance to the premises, shall be capable of obtaining clear facial recognition images and a clear head and shoulder image of every person entering or leaving the premises.

A 'Challenge 25' policy shall be adopted and adhered to at all times.

With the exception of persons seated on the chairs around the service area, as shown on the plan, all sales and supplies of alcohol will only be served directly to persons at a table.

A copy of the premises licence summary including the hours which licensable activities are permitted shall be visible from the outside of each entrance to the premises.

Customers will not take open drink containers of alcohol outside the premises as defined on the plan submitted to and approved by the Licensing Authority.

Customers carrying open or sealed alcohol drinking vessels shall not be admitted to the premises.

An incident log shall be kept at the premises, and made available for Inspection on request to an authorised officer of Brent Council or the Police, which will record the following:

- 1) All crimes reported to the venue.
- 2) Any complaints received.
- 3) Any faults in the CCTV system.
- 4) Any visits by a relevant authority or emergency service.
- 5) Any refusal of the sale of alcohol.

All deliveries shall take place during normal working hours (i.e.09.00hrs to 18.00hrs daily).

Notices asking customers to leave quietly shall be conspicuously displayed at all exits.

No children shall be permitted on the premises after 22.00hrs, unless accompanied by a responsible adult.

Police propose the following hours for licensable activities:

Late Night Refreshments

23.00hrs - 00.00hrs - Seven days a week.

Supply of Alcohol

10.00hrs – 23.30hrs – Seven days a week.

Hours Premises is Open to the Public

10.00hrs - 00.00hrs.

Seasonal variations

- 23.30hrs on 24th December until 02.00hrs on 25th December.
- 23.30hrs on Boxing Day until 02.00hrs on 27th December.
- 23.30hrs on 31st December until 02.00hrs on 1st January.

Good morning Paul,

I am grateful for your prompt response in this matter and have sent the information to the applicant.

I am awaiting their response and will reply to you as soon as I receive their instructions.

I would not envisage the majority of the conditions presenting a problem, and am happy to remove similar worded conditions from our operating schedule and replace them with the ones you have suggested.

The one issue is with regard to your proposed conditions at paragraphs 6, 7 & 8 with regard to alcohol sales being made as an accompaniment to food.

Whilst the premises is primarily food led and the cut between wet sales, which also includes non alcohol drinks, and dry sales, is anticipated to be 20% wet and 80% dry. They would like the facility to serve alcohol by waiter or waitress service to persons seated at a table other than as an accompaniment to a table meal.

For example if a group of six people were eating at the premises and the 7th has already eaten elsewhere prior to joining them, that person could still be served alcohol without having to place a food order.

We are confident that the levels of alcohol consumption without food will be low, and that the other conditions mitigate the likelihood of anyone becoming drunk and causing an issue for the responsible authorities.

For these reasons we respectfully ask if you would reconsider your proposed conditions at paragraphs 6, 7 & 8 and accept our condition 6 in the operating schedule under the public safety section:

PUBLIC SAFETY

6) With the exception of persons seated on the chairs around the service area, as shown on the plan, all sales and supplies of alcohol will only be served directly to persons seated at a table

I have had an opportunity to speak with the client and they have confirmed that the area to the front of the "service counter" is 10 metres x 4.5 metres with the 2 door foyer area being approximately 2 metres by 1 metre.

By my calculations after subtracting the foyer area would leave a usable space of 43 square metres.

I have advised them that the maximum number of people this would accommodate would be 43 and that we should accept this as a condition for the occupancy capacity and hopefully allow you to withdraw the representation.

It would be up to the applicant to decide what would be suitable qualifications.

My comments would be as a standard demonstration of competence would be through training, instruction, experience and supervision. The assessment of a premises capacity would require a technical understanding the assessment process and procedures along with knowledge of current guidance and legislation.

The HSE state the following:

Competence can be described as **the combination of training**, **skills**, **experience and knowledge that a person has and their ability to apply them to perform a task safely**. Other factors, such as attitude and physical ability, can also affect someone's competence.

As an employer, you should take account of the competence of relevant employees when you are conducting your <u>risk assessments</u>^[1]. This will help you decide what level of information, instruction, training and supervision you need to provide.

Someone's level of competence only needs to be proportionate to their job and place of work. You would not need, for example the same health and safety competence to work in an office as you would on a construction site.

As with the guidance this would be down to the assessor but most common would be Approved Document B,

I am most grateful for your response and have asked the client to carefully read the proposed conditions. I await their response, although I am sure that this will mostly be acceptable to them.

I hope the following explanation will reassure you that this is not a large capacity venue, or a vertical drinking establishment:

The premises is a small restaurant covering approximately 35 square metres (Public space) with a maximum of 46 covers at the tables, plus a maximum of 8 persons seated at the servery area. There is no vertical drinking, and all alcohol is served to the tables. These are conditions that will be applied to the premises licence. With the exception of the 3 dates for non-standard timings there is no requirement for live or recorded music.

With regard to condition 4, is the "capacity specific risk assessment" satisfactorily covered by the fire risk assessment. As this is a separate legal requirement under The Regulatory Reform (Fire Safety) Order 2005.

I ask this to ensure that any conditions are appropriate, precise, and do not duplicate other statutory legislation/requirements.
