Police representation to the premises licence variation application for 'Eastern European Food & Wine', 297, Harrow Road, Wembley, HA9 6BD.

I certify that I have considered the application shown above and I wish to make representations that the likely effect of the grant of the application is detrimental to the Council's Licensing Objectives for the reasons indicated below.

I am of the opinion that the risk to the Council's licensing objectives are too high to accept the premises licence variations.

An officer of the Metropolitan Police, in whose area the premises are situated, who is authorised for the purposes of exercising its statutory function as a 'Responsible Authority' under the Licensing Act 2003.

The application has been made to vary the premises licence under section 34 of the act.

The Police representations are concerned with all four licensing objectives: The prevention of crime and disorder, Public safety, the prevention of nuisance and the protection of children from harm.

This application has asked to <u>remove</u> condition 5 of the licence. This is currently worded as such:

No high strength beers, lagers and ciders above 5.5% ABV shall be stocked.

The proposed variation is for the following:

We apply to hold and sell higher strength alcohol of all types.

An application was received by the Metropolitan Police on 6th December 2019 in relation to the variation of a premises licence for Eastern European Food & Wine, 297, Harrow Road, Wembley, HA9 6BD.

The Police as a responsible authority are concerned with the high level of street drinking in Brent and the high levels of alcohol related crime and disorder and anti-social behaviour that this brings. It is felt that by the selling of high strength alcohol, this will in turn create more problems for the Police and more anti-social behaviour that local residents will have to put up with and reluctantly accept.

Generally speaking and disregarding the Christmas and New Year periods, calls to Police for drunken and general anti-social behaviour is not as high during the winter months. But as the year progresses and the weather becomes warmer, drunken related crime and anti-social behaviour increases tenfold.

Police are conscious of the need for off-licenses not to sell high strength alcohol and for any recently applied for new premises licenses in Brent, the selling of high strength beer and cider has not been included in conditions for that business. This also applies to the selling of single cans. The sales of high strength alcohol is something that the police do not encourage and this has been reflected in new applications.

The applicants licence start date was September 2007 and the premises was granted a twenty four (24) hour licence, seven (7) days a week to sell alcohol. In the twelve years that have passed since the licence was granted, Brent has seen a lot of changes and a very real increase in drunken crime and disorder, including an increase in anti-social behaviour.

The premises currently has seven (7) conditions. For Brent in 2019, this is quite unusual. Generally, a new premises application for an off-licence has around fifteen (15) to twenty (20) conditions.

Furthermore, the premises does not have any 'Match Day' conditions during football matches at Wembley Stadium. Match day conditions are generally placed on all licenced premises within a mile radius of the stadium. Match day would include such conditions as customers not congregating outside the premises, no glass bottles to be sold and no more than four cans to be sold at one time. This does not currently apply to this venue, which is within the one mile stadium footprint.

In June and July of next year, Euro 2020 is being held throughout Europe. There will be seven (7) matches played at Wembley stadium. England are guaranteed at least three (3) matches at Wembley Stadium. A further match is then being held at the stadium before the two semi-finals and the final itself. Major event football matches bring with it their own problems. There is a huge increase in drunken crime and disorder and anti-social behaviour. This is on top of the usual football events at the stadium, including the FA Cup final and the play off finals.

Having an off-licence close to the stadium that sells high strength alcohol on match days, could itself cause even further problems and Police are concerned that this will have a major impact on the surrounding area. This in turn will have a detrimental effect on the four licensing objectives.

Furthermore, the off-licence is situated on a busy school route. With the premises having a twenty four (24) hour licence, any early morning street drinking of high strength alcohol has potential to cause issues surrounding children making their way to school.

Finally, there have been very few problems of crime and disorder regarding the venue itself and this is recognised by Police. However, the granting of a licence for the sale of high strength alcohol causes police concerns regarding an increase in crime and disorder and has the potential to cause both aggravation and nuisance for local residents.

Police respectively ask that a variation to sell high strength beers, lagers or ciders (i.e. not more than 6%ABV) is not granted for the reasons given by Police. However as a sign of working in good faith with this establishment we would not be adverse to them selling products up to and including 6%ABV which is similar to a couple of other venues near to the area as an alternative. Police would also ask that there is to be no selling of single cans of high strength beers, lagers and ciders.

I certify that I have considered the application shown above and I wish to make a representation.

An officer of the Licensing Authority, in whose area the premises are situated, who is authroised for the purposes of exercising its statutory function as a 'Responsible Authority' under the Licensing Act 2003.

The application has been made for a variation to a premises licence under section 34 of the Act.

The Licensing Authority representations are primarily concerned with the four licensing objectives;

- the prevention of crime and disorder;
- public safety:
- the prevention of public nuisance; and
- the protection of children from harm.

Street Drinking

High strength alcohol has been an issue in the area for a number of years and has contributed to alcohol related anti-social behaviour, specifically that associated with drinking. The main issue with permitting premises to sell high strength alcohol is the fact that quite often licence holders and their employees struggle to work out who is and is not a street drinker but when this is then brought to their attention by officers, they relinquish any responsibility associated to the street drinking because street drinkers no longer look the same in appearance as they did some years ago. By removing all low cost high strength alcohol, this removes the pressure from licence holders and the DPS and goes some way in resoving the issues in street drinking.

High Strength Alcohol

In order to permit high strength beer, lager or cider, the licensing authority would need to restrict this to **three** brands of alcohol. These three brands of alcohol would need to be kept behind the counter out of





reach of customers so that they would have to ask for the alcohol. This would give members of staff an opportunity to engage with customers and offer a better chance of assessing and making a decision in whether they should be served the alcohol. Usually customers select the alcohol from a fridge in the main sales area, place their money on the counter without having to say a word and this would therefore avoid this.

If you would like to serve alcohol, this is the condition under which the Licensing authority would be happy to allow high strength alcohol. If you reply and let me know which three names you would propose, I will then consider each of them.

In addition the Licensing Authority would require the following conditions be removed from the existing licence, the ones that would remain and the additional ones that would be added:-

Exisiting Premises Licence Conditions to be Removed

- 1. CCTV shall be installed and maintained in a working condition.
- 2. All CCTV recordings shall be kept for 31 days and shall be made available to police and licensing officers if requested.
- 5. No high strength beers, lagers, and ciders above 5.5% ABV shall be stocked.

Existing Premises Licence Conditions to Remain on the Premises Licence

- 3. A copy of the premises licence summary including the hours which licensable activities are permitted shall be visible from the outside of each entrance to the premises.
- 4. A personal licence holder shall be present on the premises and supervise the sale of alcohol throughout the permitted hours for the sale of alcohol.
- 6. "Raid Control" crime prevention measures shall be installed and all staff given suitable training.
- 7. A "Challenge 21" policy shall be adopted and adhered to.

Premises Licence Conditions to be Added

The Licensing Authority require the following points to be included in the operating schedule or added as conditions on the premises licence:

- 1. CCTV cameras shall be installed to cover the entrance of the premises, the ENTIRE servery counter, till and the units behind the counter.
- 2. CCTV shall be installed to Home Office Guidance standards and maintained in a good working condition and recordings shall be kept for 31 days. The recordings shall be made available to Police and authorised officers from Brent Council upon request.
- 3. The CCTV system shall be capable of obtaining clear facial recognition images and a clear head and shoulders image of every person entering or leaving the premises.
- 4. A member of staff shall always be present on the premises whilst they are open who is capable operating the CCTV system and able to facilitate immediate viewing of CCTV footage upon the request of the Police and Authorised Officer of the Licensing Authority.
- 5. The CCTV monitor screen showing all cameras shall be available on the shop floor and visible to customers.





- 6. An age verification scheme, such as Challenge 25, shall be implemented at the premises at all times.
- 7. A sign stating "No proof of age No sale" shall be displayed at the point of sale.
- 8. Regular (every 12 months) documented staff training on licensing legislation and operating procedures shall be given. The training shall be signed and dated and a copy of these training records available for inspection by Police and local authority enforcement officers.
- 9. A clear and unobstructed view into the premises shall be maintained at all times.
- 10. An incident log shall be kept at the premises, and made available for inspection on request to an authorised officer of Brent Council or the Police, which will record the following:
 - a) All crime reported to the venue
 - b) Any complaints received in respect of the sale and consumption of alcohol
 - c) Any faults in the CCTV system
 - d) Any refusal of the sale of alcohol
 - e) Any visit by a relevant authority or emergency service.
- 11. No high strength beers, lagers, and ciders above 6.0% ABV shall be stocked or sold, with the exception of three named alcohol (NAME 1, NAME 2, NAME 3), which must be stocked behind the servery counter.
- 12. No single cans of beer, lager or cider shall be sold.
- 13. A suitable intruder alarm complete with panic button shall be fitted and maintained.
- 14. An age till prompt system shall be utilised at the premises in respect of age restricted products.

In order for the Licensing Authority to withdraw this representation, it will be necessary for you to confirm that you accept the above removal and additional conditions in writing. I also await your three suggested high strength alcohols you would like to serve.

- Guinness (e.g. Foreign Extra Stout) you will need to give the exact name of the beer you wish to sell
- Tennents Super this is one of the most common alcohol related to street drinking and would not be permitted
- K-Cider this is one of the most common alcohol related to street drinking in the immediate area and would not be permitted

Please let me know if you have any other suggestions.

In terms of the condition 'No single cans of beer, lager or cider shall be sold', this is to avoid customers from buying one single can and drinking it on the street. It is common practice for street drinkers to buy one can at a time and then go into a premises to buy more.

I look forward to hearing from you soon.

Firstly we wish to thank you for such a speedy response. With the festive and holiday season, we were not expecting a response until early January 2020 and to receive your response more than a fortnight before that date was very much appreciated.

We have considered and deliberated on your letter very carefully and have the following comments:

- 1 As parents with children ourselves, we consider the image that our business portrays in the local community to be as important as profitability;
- 2 We have worked hard to recover the business from the neglect of the previous owners. We have been listening to our customers and building the business to be a proper local convenience store by assisting with their requests to hold various grocery products. We would not wish to have "undesirable customers" in our shop since that would dissuade our regular customers from continuing to come to our store;

3 In relation to the higher ABV items, we wish to be able to sell items requested by our regular and sensible customers and not to encourage street drinkers from entering our shop. We believe that your suggestion of only holding high volume items behind the counter is an excellent idea for the reasons you described;

4 We recognise (as you stated) that a lot of the street drinking tends to be cheaper but high volume ciders such as White Star, Black Star, Diamond White and Frosty Jack. These are not the sort of items that our customers are requesting and indeed our regular customers would probably not buy such items. As such we have a common objective to avoid such drinks being sold/promoted;

5 We value our relationship of cooperation with neighbours, the council, the police and other regulatory bodies. We would wish to continue to work within the boundaries laid out and whilst we currently have fewer conditions attached with the licence, we do not see this as reasons not to maintain the strictest regime of compliance and regulatory observance; and

6 We already comply with most of your proposed revised conditions for the varied premises licence and are generally supportive of these new conditions if they will enhance the licensing objectives being met by us and the neighbourhood more widely.

As such, we welcome your proposal to only display beers, lagers and ciders of upto 6% in the chillers and shelves open to the customers to pick themselves and only to serve three brands of beers lagers and ciders of above 6% from behind the counter when requested. We would suggest the following three brands to be stocked behind the counter to be served only once we are absolutely assured of the nature of the customer involved. These three brands are:

Guinness (e.g. Foreign Extra Stout); Tennents Super; and K-Cider

We would however ask for clarification of the condition numbered 12 in your letter. Please can you confirm or clarify the situation in regard to this condition: "No single cans of beer, lager or cider shall be sold."

To us, the condition seems counter intuitive - clearly selling more than single cans could cause more drunkenness, be it in people's homes. Or have we misunderstood the aim of this condition in some way? As you are in the office tomorrow, would it be possible for you to call me to clarify this please?

We look forward to your speedy reply and a timely and mutually agreeable outcome to our application.

May we also take this opportunity to wish you and the team a Happy and Prosperous 2020.

- (e)—valued added tax∥ means value added tax charged in accordance with the Value Added Tax Act 1994.
- 3.Where the permitted price given by Paragraph (b) of paragraph 2 would (apart from this paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that subparagraph rounded up to the nearest penny.
- 4.(1) Sub-paragraph (2) applies where the permitted price given by Paragraph (b) of paragraph 2 on a day (—the first day∥) would be different from the permitted price on the next day (—the second day∥) as a result of a change to the rat e of duty or value added tax.
- (2)The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.



Any staff directly involved in selling alcohol for retail to consumers and staff who provide training including managers shall undergo regular training of the Licensing Act 2003 legislation (at least every 6 months). The training shall be documented and signed off by the DPS and the member of staff receiving the training. This training log shall be kept on the premises and made available for inspection by police and relevant authorities upon request.
- 11. No deliveries shall take place between 20:00 and 07:00 hours
- 12. No high strength beers, lagers, and ciders above 6.0% ABV shall be stocked or sold.
- 13. A clear and unobstructed view into the premises shall be maintained at all times.
- 14. A personal licence holder shall be present on the premises and supervise the sale of alcohol throughout the permitted hours for the sale of alcohol
- 15. An incident log shall be kept at the premises, and made available for inspection on request to an authorised officer of Brent Council or the Police, which will record the following:
 - (a) all refusals
 - (b) any complaints received
 - (c) any incidents of disorder





- (d) any faults in the CCTV system or searching equipment or scanning equipment
- (e) any visit by a relevant authority or emergency service.
- 16. No single cans of beers, largers or ciders shall be sold at the premises.
- 17. The licence holder and DPS shall undertake the BIAAB level 2 Award for Personal Licence Holders Qualification Certificate.
