

Police representation to the application for a new Premises Licence for Walnut Wholefoods LTD, 78 Walm Lane, NW2 4RA.

I certify that I have considered the application shown above and I wish to make representations that the likely effect of the grant of the application is detrimental to the Council's Licensing Objectives for the reasons indicated below.

I am of the opinion that the risk to the Council's licensing objectives can't be mitigated by simply requesting stringent conditions on the proposed licence. I request the application for a new premises licence be **refused**, for the reasons stated below.

An officer of the Metropolitan Police, in whose area the premises are situated, who is authorised for the purposes of exercising its statutory function as a 'Responsible Authority' under the Licensing Act 2003.

The application has been made for a premises licence under section 17 of the act.

The Police representations are primarily concerned with Crime & Disorder, and Public Nuisance.

Dear Sir/Madam,

On Friday 6th November 2020, we (Metropolitan Police, Brent Licensing) received an application for a Premises Licence under Section 17 of the Licensing Act 2003, the applicant being;

Mr Hasan GUL.

The application can be summarised as follows:-

Walnut Wholefoods LTD has applied to be a supermarket / off licence selling food and alcohol. Mr GUL has applied for a licence to sell alcohol (Off Premises) from;

0600hrs - 2100hrs Monday to Friday. 0800hrs - 1700hrs on Saturdays. 0800hrs - 1500hrs on Sundays.

With the store to be open to the public during the same hours.

The application states the following;

- There will be a Challenge 25 Policy
- Staff will be trained on age restricted products
- CCTV will be kept for 31 days and maintained
- Incident and Training logs to be kept
- Noise signage to be displayed

Regarding this Application it is important to note that Street Drinking is a serious and well documented problem in many areas of the borough of Brent. So much so that there have been a number of official measures put in place to restrict the supply and consumption of alcohol most pertinently:

Cumulative Impact Zone (CIZ)

Willesden High Road which includes Walm Lane has been identified as one of ten Cumulative Impact Zones (CIZs) in Brent, where the authorising of further licences may undermine the promotion of the licensing objectives.

Data captured from various sources including alcohol related police and ambulance call outs has been mapped and shown sufficient evidence to implement CIZs in the specified area. In particular crime data and evidence shows a correlation between concentrations of off-licences and alcohol related anti-social behaviour, particularly that associated with street drinking.

High Road, Willesden

High Road, Willesden is busy large parade of shops in Willesden Green Ward. High Road, Willesden is in an area of medium to high levels of deprivation.

High Road & Walm Lane, Willesden are hotspots for alcohol flagged calls to the Police for crime and anti-social behaviour, and to the ambulance service for call outs.

The below map has been taken from Appendix B of the Brent CIZ Proposal, which shows a snapshot of violence with injury crimes, and off licences in the Willesden CIZ and surrounding areas (01/06/2017 to 31/05/2019). The proposed venue is to the right of the CIZ (Walm Lane junction with St. Pauls Avenue). Note the proximity of off licences;




From a Police perspective, it is believed that any additional alcohol retailer within the Willesden CIZ will add to the supply of alcohol to street drinkers and directly contribute towards the existing problem. An opportunity to reduce the supply of alcohol should be explored at every opportunity especially when the addition of a new premises would clearly exacerbate the problems being experienced already, highlighted in the stats below taken from Police.uk Crime Map. These following stats cover the area in September 2020.

The following map shows the locations of hotspots within the Willesden Green CIZ, the '25' Hotspot falls almost exactly on the location of the proposed off licence (NW2 4RA) & the '18's indicate the same street.



The following graphic is also taken from Police.uk and shows the crime rates per month in the area of the proposed off licence (NW2 4RA) averaging at approximately 200 crimes per month.



Below is a list of the crimes in the area of the proposed venue, evidenced in more detail, with redactions due to data protection. This list includes a snapshot of some of the crimes which have occurred in the last year. The types of crimes listed and the frequency that they occur can be attributed to, and are exacerbated by, the consumption of alcohol.

Each of the below entries is within 3-5 minutes' walk from 78 Walm Lane, NW2 4RA, taken from police indices from 01/01/2020 – 10/11/2020;

On Tuesday the 10th November 2020 at 1305hrs, I contacted the applicant by telephone and asked if he was happy to answer a few questions about the application, to which he replied yes. Following pleasantries I asked the following questions relevant to his application, and recorded his replies;

PC DARWOOD: Do you know what a Cumulative impact zone / CIZ is?

Mr GUL: No

PC DARWOOD: Are you aware that your stores application falls within a CIZ?

Mr GUL: No

PC DARWOOD: Do you have a solicitor with knowledge of CIZs?

Mr GUL: No but I can get one.

PC DARWOOD: Will you be working at the store? Mr GUL: Yes, me and my business partner will be

PC DARWOOD: Are you a PLH?

Mr GUL: Yes, for 15 years, my business partner is also a PLH, I worked in a bar before PC DARWOOD: Important knowledge for anyone who is a PLH is the 4 licensing objectives, can you tell me what you know of them?

Mr GUL: No, if I'm honest I don't remember them

PC DARWOOD: I advise you to study them as, if you are granted your licence, you will be expected to adhere to them.

Mr GUL: Okay I will do that after this phone call

PC DARWOOD: What will you be selling if you were to get your licence approved?

Mr GUL: We are trying to do something different in the area, somewhere that brings people together, we wont be selling cigarettes or cheap alcohol like cans of beer. We want to sell Organic wines to go with peoples groceries.

PC DARWOOD: You haven't put that anywhere on your application Mr GUL, you have applied for an alcohol licence which applies to selling all alcohol. So, If you were unable to sell alcohol what would you sell?

Mr GUL: Fruit and veg mainly and other groceries, ... it would be an issue as we have designed the shop to sell good quality wine, we have a whole wine section. Alcohol is not as big a part of the business as groceries, biggest percentage, dairy 10%, wine 10%.

PC DARWOOD: In general; What do you know of the Willesden Green area?

Mr GUL: We have been here four months already, we have researched the area before buying the shop. We specifically chose this location because of the heritage, we want to keep the same tiles from the original building.

PC DARWOOD: Have you been operating without alcohol sales, in the last 4 months?

Mr GUL: No, with all the paperwork and construction, it has filled our time

PC DARWOOD: Do you have any questions for me?

Mr GUL: No, not a question but we don't want to sell cigarettes etc, we want to sell organic wine and hopefully plastic free.

Following the telephone conversation, I have concerns with the applicant's business plan for this premises.

He seems to be very passionate and knowledgeable about wines, claiming to want to only sell organic wines. However he has not stated any of this on his application. There is nothing written to prevent the applicant selling single cans of beer or miniatures on top of his projected wine sales, which would clearly exacerbate the ongoing street drinking issues in the area.

The applicant also stated his purpose is to mainly sell groceries alongside wine sales, and has then continued, stating that alcohol sales will only be roughly 10% of his business, which would suggest he could operate without an alcohol licence.

It's inadvisable to open another store that's main purpose, I believe, is to sell wine, as the applicant has stated that there is already a wine section in the store. The applicant had no knowledge of the licensing objectives, which, in an area subject to a CIZ, is not adequate.

This application, if granted, will directly contribute to the ongoing problems that the CIZ is in place to prevent.

Willesden Green and Walm Lane in particular, cannot cope with another off-licence. The area is already saturated with similar venues. There are 9 similar premises within a 3 minute walk that sell alcohol (not including bars and pubs – Angies III for example). The temptation to provide lower cost alcohol in an attempt to undercut competition will be high.

Even with the strictest of conditions attached ANY additional supplier of alcohol within the Cumulative impact zone will be a direct contributor to crime and disorder and anti-social behaviour.

I request that this application for a Premises licence at Walnut Wholefoods LTD, 78 Walm Lane, NW2 4RA be refused.

I do not believe there are any conditions that could be attached to the licence to negate the risk of the objectives being undermined. I accept the decision does not rest with me but with the committee. With that in mind, if the licence was granted I would ask for Licensable Activities and Opening Hours to be restricted (namely 1000hrs opening time) and I would ask for the following conditions:

- 1. CCTV shall be installed to Home Office Guidance standards and maintained in a good working condition and recordings shall be kept for 31 days and shall be made available to police and licensing officers immediately upon request. A member of staff fully conversant with the use and operation of the CCTV system and how to provide footage to police or local authority requests shall be present throughout the permitted hours for sale of alcohol.
- 2. A CCTV camera shall be installed to cover the entrance of the premises and capture clear facial recognition images and a clear head and shoulders image of every person entering or leaving the premises. Suitable signage re the use of CCTV must be displayed.
- 3. A sign stating "No proof of age No sale" shall be displayed at the point of sale
- 4. A "Challenge 25" policy shall be adopted and adhered to.
- 5. An incident/refusal book shall be kept at the premises, and made available for Inspection on request to an authorised officer of Brent Council or the Police, which will record the details (including day, date, time, summary of incident) of any of the following: all crimes reported to the venue all ejections of patrons any complaints received any faults in the CCTV system any refusal of the sale of alcohol including 'Off Deliveries/sales of alcohol' any visit by a relevant authority or emergency service.
- 6. A copy of the premises licence summary including the hours which licensable activities are permitted shall be visible from the outside of each entrance to the premises.
- 7. Any staff directly involved in selling alcohol for retail to consumers, staff who provide training and all managers will undergo regular training of Licensing Act 2003 legislation. This will be documented and signed for by the DPS and the member of staff receiving the training. This training log shall be kept on the premises and made available for inspection by police and relevant authorities upon request.
- 8. Promotions that encourage irresponsible drinking shall not be permitted.
- 9. A clear and unobstructed view into the premises shall be maintained at all times.
- 10. A suitable intruder alarm complete with panic button shall be fitted and maintained.
- 11. No high strength beers, lagers, and ciders above 5.5% ABV shall be stocked with the exception of premium beers.
- 12. A personal licence holder shall be present on the premises and supervise the sale of alcohol throughout the permitted hours for the sale of alcohol

- 13. A minimum of two members of staff shall be present throughout the permitted hours for the sale of alcohol.
- 14. No single cans of beer, lager or cider shall be sold
- 15. No miniatures to be sold (5cl or 50ml)
- 16. Outside of the hours authorised for the sale of alcohol, all alcohol within the trading area is to be secured behind locked grills, locked screens or locked cabinet doors so as to prevent access to the alcohol by customers or staff.
- 17. All alcoholic drinks shall be clearly labelled or marked with the name of the premise.
- 18. A notice asking Customers to leave quietly from the premises shall be displayed by the exit/entrance.
- 19. Invoices are to be produced to Police, or a member of an appropriate authority, upon request to evidence payment of duty on goods.

Thank you for the earlier email with attached representation from the Police.

We respect and acknowledge the representations made including the concerns raised due to the sites location.

We wish to confirm the issues raised would be addressed by proposed conditions and additional conditions as requested by the licensing authorities. Ultimately, the proposed new premises will only sell limited type and quantity of alcohol unlike a traditional "off licence" or supermarket. The premises will concentrate as an organic shop/market selling various items and include a limited selection of alcohol. It's unlikely to draw the type of patrons which cause an issue within a community due to alcohol consumption, even so measures will be in place to prevent sale to an individual who may seem unfit to be sold alcohol or underage. Necessary records will be kept of such incidents.

We are happy to proceed with a committee hearing to forward our proposal and reassure the committee including responsible authorities the premises will be run properly with the necessary measures in place in order to cause an issue within the community due to alcohol sales. We also wish to highlight, if upon the premises licence being granted, all responsible authorities have the necessary powers to request the licence to be reviewed if concerns are raised in the future but we wish for an opportunity to be given to the applicant to prove the premises will be operated beyond satisfaction.

Licensing Representation to the Initial Application for the Premises Licence at Walnut Wholefoods Ltd, Walnut, 78 Walm Lane, NW2 4RA

I certify that I have considered the application shown above and I wish to make a representation that the likely effect of the grant of the application is detrimental to the Licensing Objectives for the reasons indicated below.

An officer of the Licensing Authority, in whose area the premises are situated, who is authroised for the purposes of exercising its statutory function as a 'Responsible Authority' under the Licensing Act 2003.

The application has been made for a new premises licence under section 17 of the Act.

The Licensing Authority representations are primarily concerned with the four licensing objectives;

- the prevention of crime and disorder;
- public safety;
- the prevention of public nuisance; and
- the protection of children from harm.

Cumulative Impact Zone (CIZ)

The Council's current Licensing Policy came into effect 7th January 2020. Crime and complaints assessments in 2015, did not identify any requirement for a CIZs. However, since 2016 there has been a significant and notable increase in alcohol related crime and anti-social behaviour which is having an adverse impact in some areas and neighbourhoods generating complaints from residents, councillors and the Police. This is undermining the licensing objectives and also has potential to undermine the vitality of Brent's town centres.

Data captured from various sources including alcohol related police and ambulance call outs have been mapped and have shown suitable evidence to implement CIZs in the specified areas. In

particular crime data and evidence shows a correlation between concentrations of off-licences and alcohol related anti-social behaviour, particularly that associated with street drinking.

High Road Willesden / Walm Lane have been identified as one of ten Cumulative Impact Zones (CIZs) in Brent, where the authorising of further licences may undermine the promotion of the licensing objectives.

The Statement of Licensing Policy states: -

Willesden High Road / Walm Lane

This area has high levels of alcohol related ambulance call outs as well as associated crime along its entire length. Therefore, it is proposed that a CIZ be introduced for off-licences on High Road, Willesden, NW10 from the junction of Church Road up to the junction of Walm Lane and Willesden Lane.

Data captured from various sources including alcohol related police and ambulance call outs have been mapped and have shown suitable evidence to implement CIZs in the specified areas. In particular crime data and evidence shows a correlation between concentrations of off-licences and alcohol related anti-social behaviour, particularly that associated with street drinking.


Street Drinking Hotspots

There are relatively few calls to police specifically about street drinking. This may be because they are recorded as other ASB types such as littering or noise. Between 01/06/2017 and 31/05/2018, there were only 53 calls to police. The following year, there were 142. This represents an increase of 168%. Part of this increase may be attributed to callers being aware of the borough wide PSPO on drinking in public which came into effect in October 2017.




Calls to police specifically related to street drinking between 01/06/2017 and 31/05/2019

Alcohol-related ambulance and Police calls between 01/06/2017 to 31/05/2019


Hotspot of Violence with Injury Crimes

The purpose of the CIZ in Willesden, is to address the issues mentioned above.

The Premises

The premises, namely Walnut Wholefoods Ltd, Walnut, 78 Walm Lane, NW2 4RA falls within one of Brent's ten CIZs.



Walnut, 78 Walm Lane, NW2 4RA

Walm Lane is a busy road that has a large parade of shops surrounded by residential dwellings. Willesden Green Station is within close proximity of the 78 Walm Lane. There are a number of licensed premises within a few minutes walk of each other.

Public Space Protection Order (PSPO)

The entire Borough of Brent is subject to a Public Space Protection Order for street drinking and therefore it is an offence to drink alcohol in any public place.

If a police officer reasonably believes that a person is, or has been, consuming intoxicating liquor within these areas, the officer may require the person concerned:

- a) not to consume in that place anything which is, or which the officer reasonably believes to be, intoxicating liquor
- b) to surrender anything in his/her possession which is, or which the officer reasonably believes to be, intoxicating liquor or a container for such liquor (other than a sealed container)
- c) An officer may dispose of anything surrendered to him/her as above.
- d) Issue fixed penalty notices on offenders
- e) Prosecute persistent offenders

However, in reality there are limited police officer resources, which in practice would prevent the above from being enforced. This therefore places a greater emphasis on the responsibility of those premises that are selling alcohol for consumption off the premises. It is clear that if off licences did not exist, the number of street drinkers would decline.

Therefore simply selling alcohol to customers who once off the premises, are no longer the responsibility of the licence holder, the Designated Premises Supervisor (DPS) and/or members of staff is no longer a viable option.

Premises Licence Application

The applicants of the new premise licence is Walnut Wholefoods Ltd. The directors are Mr Hasan Musdagi and Mr Hasan Gul. Mr Gul is also the proposed DPS.

On Tuesday 24th November 2020, I conducted a visit in the area and noted the premise was under refurbishment.

On Thursday 3rd December 2020, I spoke to Mr Gul via telephone to obtain further information related to the application.

The following questions were asked and recorded below:

Esther Chan (LA): When did you take over the business?

Hasan Gul: September 2020.

Esther Chan (LA): Are you the business rate payer?

Hasan Gul: Yes, I have registered.

Esther Chan (LA): When do you intend to open the premise?

Hasan Gul: Depend on various applications related to opening hours, sign outside shop, compressor unit and alcohol licence. We had intentions to open on 18th December 2020.

Esther Chan (LA): What sort of goods and services will you provide?

Hasan Gul: Organic and health foods based on quality, natural, vegan and gluten free goods.

Esther Chan (LA): Do you intend to deliver alcohol?

Hasan Gul: We are considering and designing a website. It will be based on demand.

Esther Chan (LA): Will you supply beers, lagers and ciders over 5.5% abv?

Hasan Gul: No, our focus is on quality wines.

Esther Chan (LA): If the application for the premise licence is refused, will this affect your business?

Hasan Gul: Yes, alcohol sales will generate 10% -15% profit.

Esther Chan (LA): Are you are aware the premise fall in a CIZ? Hasan Gul: Yes, I have been made aware by PC Ally Darwood.

Esther Chan (LA): Can you explain what a CIZ is?

Hasan Gul: We are in a zone, where there is a history of people street drinking.

Esther Chan (LA): What do you know about the area? Hasan Gul: Mixed, multicultural and upcoming area.

Esther Chan (LA): What makes your business unique?

Hasan Gul: We have a professional background. We want to add value and quality to the neighbourhood by providing natural and first class produce.

Esther Chan (LA): When did you obtain your personal licence?

Hasan Gul: I have had my personal licence for 15/16 years and my business partner has had his personal licence for 10 years.

Esther Chan (LA): Can you explain the four the licensing objectives?

Hasan Gul: Preventing crime and disorder, preventing nuisance, protecting children and public safety.

Esther Chan (LA): Do you or your business partner have experience in running an off licence/supermarket?

Hasan Gul: We ran a grocery/off licence for 7-8 years in Borehamwood. We currently run a fruit and veg stall in Nags Head Market.

Esther Chan (LA): How many staff will you employ?

Hasan Gul: 6-8 members of staff.

Esther Chan (LA): Who will be responsible for training the staff?

Hasan Gul: The directors with professional advice.

Esther Chan (LA): Explain your age verification policy? Hasan Gul: We will adopt a Challenge 25 policy.

Esther Chan (LA): Why do you want to supply alcohol from 6am on Monday – Friday?

Hasan Gul: Not sure how it works but happy to reduce the hours for the supply of alcohol.

Operational Plan, Training Manual & Conditions

According to Section M of the application form, the steps described to promote the licensing objectives are general.

The Licensing Authority would expect to see information on how the business plans to ensure that their particular premises will go above and beyond in promoting the licensing objectives in a crime hot spot.

Safeguarding the Local Area

The Statement of Licensing Policy lists considerations to be made when applying for a new premises licence, particularly those considerations relating to street drinking.

However, there are no specific conditions that are mentioned in the application to address the likes of such things outside of the premises that could be directly linked back to the premises. This includes items such as the clearing up of litter which may be left outside the premises by customers, the labelling of alcohol with the premises name in order to link street drinkers back to the premises or measures to discourage street drinkers from loitering outside the premises.

As per Brent Council's Statement of Licensing Policy, a voluntary offering of a ban on high strength alcohol sales does not necessarily address the requirements under a Cumulative Impact Zone.

Summary

The Statement of Licensing Policy states that any licence application in a CIZ area will need to demonstrate with evidence that its operation will not add to any cumulative impacts that the CIZ is seeking to address. Further, new applicants and those applying for variations would be required to demonstrate how their premises will not contribute to street drinking in those areas.

The effect of adopting a CIZ is to "create a rebuttable presumption" that applications for licences which are likely to add to the existing cumulative impact will normally be refused (or subject to certain limitations) unless the applicant can demonstrate that there will be no negative cumulative impact on the licensing objectives.

Although the applicant mentions he has experience in running a similar premises in the past, the operating schedule fails to demonstrate that a grant will not lead to a negative cumulative impact on one or more of the licensing objectives and to the contrary add to the issues of an existing saturated area.

It is on this basis, that the Licensing Authority ask that the application for a new premises licence is refused by the Licensing Sub-Committee. Adding conditions to a premises licence, in the Licensing Authority's opinion is not adequate when the application does not demonstrate what is being put in place in order to avoid further cumulative impact. Adding an additional off licence to the eight that already exist in the immediate area, will no doubt be detrimental to the local area.

If the committee however decide that there is sufficient evidence to the contrary, the Licensing Authority would ask that the following conditions be added to the operating schedule:-

The Licensing Authority require the following points to be included in the operating schedule or added as conditions on the premises licence:

1. CCTV shall be installed to Home Office Guidance standards and maintained in a good working condition and recordings shall be kept for 31 days and shall be made available to police and authorised Officers from Brent Council.

- 2. The CCTV system shall be capable of obtaining clear facial recognition images and a clear head and shoulders image of every person entering or leaving the premises.
- 3. A CCTV camera shall be installed to cover the entrance to the premises and further cameras to cover the entire servery area and till.
- 4. A member of staff shall always be present on the premises whilst they are open who is capable operating the CCTV system and able to facilitate immediate viewing of CCTV footage upon the request of the Police and Authorised Officer of the Licensing Authority.
- 5. Promotions that encourage irresponsible drinking shall not be permitted.
- 6. A "Challenge 25" policy shall be adopted and adhered to at all times.
- 7. A sign stating "No proof of age No sale" shall be displayed at the point of sale.
- 8. A copy of the premises licence summary including the hours which licensable activities are permitted shall be visible from the outside of each entrance to the premises.
- 9. Any staff directly involved in selling alcohol for retail to consumers, staff who provide training and all managers will undergo regular training (every 12 months) of Licensing Act 2003 legislation. This will be documented and signed for by the DPS and the member of staff receiving the training. This training log shall be kept on the premises and made available for inspection by police and relevant authorities upon request.
- 10. Outside of the hours authorised for the sale of alcohol, all alcohol within the trading area is to be secured behind locked grills, locked screens or locked cabinet doors so as to prevent access to the alcohol by customers or staff.
- 11. All alcoholic drinks shall be clearly labelled or marked with the name of the premises.
- 12. A notice asking Customers to leave quietly from the premises shall be displayed by the exit/entrance.
- 13. A single incident log shall be kept at the premises, and made available for inspection on request to an authorised officer of Brent Council or the Police, which will record the following:
 - (a) all crimes reported to the venue
 - (b) all ejections of patrons
 - (c) any complaints received
 - (d) any incidents of disorder
 - (e) all seizures of drugs or offensive weapons
 - (f) any faults in the CCTV system
 - (g) any refusal of the sale of alcohol
 - (h) any visit by a relevant authority or emergency service.
- 14. No high strength beers, lagers, and ciders above 5.5% ABV shall be stocked or sold at the premises.
- 15. No single cans of beer, lager or cider be sold.
- 16. No miniatures (5cl or 50ml) to be sold.

- 17. A clear and unobstructed view into the premises shall be maintained at all times.
- 18. Invoices are to be produced to Police, a member of an appropriate authority or council officers upon request to evidence payment of duty on goods.
- 19. All deliveries shall take place during the normal working day (i.e. 09:00 to 18:00 daily).
- 20. A lockable safe with deposit slot and anti-fishing mechanisms must be used at the counter till area in order to prevent crime.
- 21. A suitable intruder alarm and panic button shall be fitted and maintained.
- 22. A personal licence holder shall be present on the premises and supervise the sale of alcohol throughout the permitted hours for the sale of alcohol.
- 23. All alcoholic drinks shall be clearly labelled or marked with the name of the premises.
- 24. An electronic till prompt should be used for all alcohol sales.
- 25. No 'Off Sale' deliveries permitted at any time.



I certify that I have considered the application shown above and I wish to make representations that the likely effect of the grant of the application is detrimental to the Council's Licensing Objectives for the reasons indicated below.

I am of the opinion that the risk to the Council's licensing objectives can't be mitigated by simply requesting stringent conditions on the proposed licence. I request the application for a new premises licence be **refused**, for the reasons stated below.

An officer of the Metropolitan Police, in whose area the premises are situated, who is authorised for the purposes of exercising its statutory function as a 'Responsible Authority' under the Licensing Act 2003.

The application has been made for a premises licence under section 17 of the act.

The Police representations are primarily concerned with Crime & Disorder, and Public Nuisance.

Dear Sir/Madam,

On Friday 6th November 2020, we (Metropolitan Police, Brent Licensing) received an application for a Premises Licence under Section 17 of the Licensing Act 2003, the applicant being;

Mr Kanagaratnam Selvaratnam.

The application can be summarised as follows:-

Kanaga Mart Ltd has applied to be an off licence selling food and alcohol. Mr Selvaratnam has applied for a licence to sell alcohol (Off Premises) from;

Sale of Alcohol:

1100hrs - 2300hrs Monday to Sunday.

Opening Hours:

0700hrs - 2300hrs Monday to Sunday.

The application states the following;

- No high strength beers, single can or miniatures to be sold
- CCTV will be kept for 31 days and maintained
- Noise signage, and no loitering to be displayed
- Staff to be trained on Age restricted products

Regarding this Application it is important to note that Street Drinking is a serious and well documented problem in many areas of the borough of Brent. So much so that there have been a number of official measures put in place to restrict the supply and consumption of alcohol most pertinently:

Cumulative Impact Zone (CIZ)

Sudbury Town Centre, Wembley has been identified as one of ten Cumulative Impact Zones (CIZs) in Brent, where the authorising of further licences may undermine the promotion of the licensing objectives.


Data captured from various sources including alcohol related police and ambulance call outs has been mapped and shown sufficient evidence to implement CIZs in the specified area. In particular crime data and evidence shows a correlation between concentrations of off-licences and alcohol related anti-social behaviour, particularly that associated with street drinking.

Sudbury Town Centre, Wembley

Sudbury Town Centre is a medium sized shopping parade in Wembley. Sudbury Town Centre is a hotspot for alcohol related calls to the Police for crime and anti-social behaviour. Calls are related to the area from the roundabout at Butlers Green, to the junction of Sudbury Crescent and along Harrow Road, where this proposed venue is situated.

The below map has been taken from Appendix B of the Brent CIZ Proposal, which shows a snapshot of violence with injury crimes, and off licences in the Sudbury CIZ and surrounding areas (01/06/2017 to 31/05/2019).






From a Police perspective, it is believed that any additional alcohol retailer within the Sudbury CIZ will add to the supply of alcohol to street drinkers and directly contribute towards the existing problem. An opportunity to reduce the supply of alcohol should be explored at every opportunity especially when the addition of a new premises would clearly exacerbate the problems being experienced already, highlighted in the stats below taken from Police.uk Crime Map. These following stats cover the area in September 2020.

The following map shows the locations of hotspots within the Sudbury CIZ, the '26' and '41' Hotspots fall on the location, and the immediate surroundings of the proposed off licence (HAO 2LW).



The following graphic is also taken from Police.uk and shows the crime rates per month in the area of the proposed off licence (HAO 2LW) averaging at approximately 120 crimes per month.



Below is a list of the crimes in the area of the proposed venue, evidenced in more detail, with redactions due to data protection. This list includes a snapshot of some of the crimes which have occurred in the last year. The types of crimes listed and the frequency that they occur can be attributed to, and are exacerbated by, the consumption of alcohol.

Each of the below entries is within 3-5 minutes' walk from 755 Harrow Road, Wembley, HAO 2LW, taken from police indices from 01/01/2020 – 10/11/2020;

On Wednesday the 11th November 2020 at 1225hrs, I contacted the applicants by telephone and asked Mr SELVARATNAM if he was happy to answer a few questions about the application, to which he responded yes, however when I asked questions, his wife, Mrs SELVARATNAM answered on his behalf with him next to her.

I asked the following questions relevant to the application, and recorded their replies;

PC DARWOOD: Do you know what a Cumulative impact zone / CIZ is?

Mrs Selvaratnam: Yeah, it's a red zone
PC DARWOOD: What does that mean to you?

Mrs Selvaratnam: There is more than... selling... *inaudible*

PC DARWOOD: Could you say that again.

Mrs Selvaratnam: Red zone

PC DARWOOD: Okay I don't think you quite understand what it means, generally its an area that's been deemed to have a lot of crime and anti-social behaviour, and an area which already has a lot of shops that sell alcohol etc.

Mrs Selvaratnam: okay

PC DARWOOD: Do you have a solicitor? Mrs Selvaratnam: Yes I can get one

PC DARWOOD: Will you be working at the store? Mrs Selvaratnam: Yes me and my husband

PC DARWOOD: Are you and your husband Personal Licence Holders?

Mrs Selvaratnam: Yes I am

PC DARWOOD: How long have you been a PLH?

Mrs Selvaratnam: I got it this week maybe two weeks ago

PC DARWOOD: Okay great, can you tell me the 4 licensing objectives, what you know of

them?

Mrs Selvaratnam: Don't sell to under 18s

PC DARWOOD: Yes that's part of one, protecting children from harm, can you tell me any others?

Mrs Selvaratnam: Nuisance

PC DARWOOD: Okay, what does that mean to you?

Mrs Selvaratnam: Drunk people and disturbing the public

PC DARWOOD: What will you be selling if you were to get your licence approved?

Mrs Selvaratnam: Beer. Wine. Whiskey. All alcohols

PC DARWOOD: And if your licence was not approved, what would you sell?

Mrs Selvaratnam: Groceries, Red bulls, Juices

PC DARWOOD: Do you think you could operate without alcohol sales?

Mrs Selvaratnam: No. Business would be very low. I can't. It would be very bad. PC DARWOOD: What do you know of the Sudbury area, have you worked here before?

Mrs Selvaratnam: I live in the area, three minutes' walk away from the shop

PC DARWOOD: That's great, what is it like living there?

Mrs Selvaratnam: Mess. Little bit dangerous PC DARWOOD: Why do you think that is?

Mrs Selvaratnam: So many people around.

PC DARWOOD: Okay, Do you have any questions for me? *Mrs Selvaratnam: When will I hear about the application?*

PC DARWOOD: The council will contact you regarding the next steps.

Following the telephone conversation, I have concerns with the applicants' business plan for this premises. The applicants have a vague knowledge of the Licencing Objectives, however from the phone call I doubt their capability to uphold the objectives in practical application.

The applicants live in the area where the proposed shop will be situated and have admitted to the area being messy, crowded and dangerous. Despite this, when asked about what they will sell, they listed **all alcohols.** When asked if they could operate without alcohol the applicant has said, 'No. Business would be very low. I can't. It would be very bad.' This would suggest the purpose of this application is to solely sell alcohol.

To re-iterate, this application, if granted, will directly contribute to the ongoing problems that the CIZ is in place to prevent. Sudbury in particular, cannot cope with another off-licence. The area is already completely saturated with similar venues. In such a small strip of shops there are **9** similar premises (Lycamobile, Tesco, European Food, Sudbury Supermarket, Paneer Food & Wine, Everyday Food & Wine, Hamptons Food & Wine, Sudbury Town Post Office and Off Licence, Waterloo Food & Wine) within a 3 minute walk that all sell alcohol and that is not including The Swan Public House and the several restaurants, some of which also have the capacity for alcohol sales. The area will not benefit in the slightest from another off licence, it will be detrimental, and the temptation to provide lower cost alcohol in an attempt to undercut the plethora of competition will be extremely high.

Even with the strictest of conditions attached ANY additional supplier of alcohol within the Cumulative impact zone will be a direct contributor to crime and disorder and anti-social behaviour.

I request that this application for a Premises licence at *Kanaga Mart Ltd, 755 Harrow Road, Wembley, HAO 2LW* be refused.

I do not believe there are any conditions that could be attached to the licence to negate the risk of the objectives being undermined. I accept the decision does not rest with me but with the committee. With that in mind, if the licence was granted I would ask for Licensable Activities and Opening Hours to be restricted and I would ask for the following conditions:

- 1. CCTV shall be installed to Home Office Guidance standards and maintained in a good working condition and recordings shall be kept for 31 days and shall be made available to police and licensing officers immediately upon request. A member of staff fully conversant with the use and operation of the CCTV system and how to provide footage to police or local authority requests shall be present throughout the permitted hours for sale of alcohol.
- 2. A CCTV camera shall be installed to cover the entrance of the premises and capture clear facial recognition images and a clear head and shoulders image of every person entering or leaving the premises. Suitable signage re the use of CCTV must be displayed.
- 3. A sign stating "No proof of age No sale" shall be displayed at the point of sale
- 4. A "Challenge 25" policy shall be adopted and adhered to.
- 5. An incident/refusal book shall be kept at the premises, and made available for Inspection on request to an authorised officer of Brent Council or the Police, which will record the details (including day, date, time, summary of incident) of any of the following: all crimes reported to the venue all ejections of patrons any complaints received any faults in the CCTV system any refusal of the sale of alcohol including 'Off Deliveries/sales of alcohol' any visit by a relevant authority or emergency service.
- 6. A copy of the premises licence summary including the hours which licensable activities are permitted shall be visible from the outside of each entrance to the premises.
- 7. Any staff directly involved in selling alcohol for retail to consumers, staff who provide training and all managers will undergo regular training of Licensing Act 2003 legislation. This will be documented and signed for by the DPS and the member of staff receiving the training. This training log shall be kept on the premises and made available for inspection by police and relevant authorities upon request.
- 8. Promotions that encourage irresponsible drinking shall not be permitted.
- 9. A clear and unobstructed view into the premises shall be maintained at all times.
- 10. A suitable intruder alarm complete with panic button shall be fitted and maintained.
- 11. No high strength beers, lagers, and ciders above 5% ABV shall be stocked with the exception of premium beers.
- 12. A personal licence holder shall be present on the premises and supervise the sale of alcohol throughout the permitted hours for the sale of alcohol

- 13. A minimum of two members of staff shall be present throughout the permitted hours for the sale of alcohol.
- 14. No single cans of beer, lager or cider shall be sold
- 15. No miniatures to be sold (5cl or 50ml)
- 16. Outside of the hours authorised for the sale of alcohol, all alcohol within the trading area is to be secured behind locked grills, locked screens or locked cabinet doors so as to prevent access to the alcohol by customers or staff.
- 17. All alcoholic drinks shall be clearly labelled or marked with the name of the premise.
- 18. A notice asking Customers to leave quietly from the premises shall be displayed by the exit/entrance.
- 19. Invoices are to be produced to Police, or a member of an appropriate authority, upon request to evidence payment of duty on goods.

Licensing Representation to the Initial Application for the Premises Licence at Kanaga Mart Ltd, 755 Harrow Road, Wembley, HA0 2LW

I certify that I have considered the application shown above and I wish to make a representation that the likely effect of the grant of the application is detrimental to the Licensing Objectives for the reasons indicated below.

An officer of the Licensing Authority, in whose area the premises are situated, who is authroised for the purposes of exercising its statutory function as a 'Responsible Authority' under the Licensing Act 2003.

The application has been made for a new premises licence under section 17 of the Act.

The Licensing Authority representations are primarily concerned with the four licensing objectives;

- the prevention of crime and disorder;
- public safety;
- the prevention of public nuisance; and
- the protection of children from harm.

Cumulative Impact Zone (CIZ)

The Council's current Licensing Policy came into effect 7th January 2020. Crime and complaints assessments in 2015, did not identify any requirement for a CIZs. However, since 2016 there has been a significant and notable increase in alcohol related crime and anti-social behaviour which is having an adverse impact in some areas and neighbourhoods generating complaints from residents, councillors and the Police. This is undermining the licensing objectives and also has potential to undermine the vitality of Brent's town centres.

Sudbury Town has been identified as one of ten Cumulative Impact Zones (CIZs) in Brent, where the authorising of further licences may undermine the promotion of the licensing objectives.

The Statement of Licensing Policy states: -


'Sudbury Town - Harrow Road and Watford Road

This relatively small town centre has a relatively high number of alcohol related ambulance call outs and anti-social behaviour. The Licensing service also receives high volumes of calls regarding street drinking. It is proposed that a CIZ be introduced for off-licences on Harrow Road from the junction of Sudbury Roundabout (adjacent to District Road) up to the junction of Chestnut Avenue, along Watford Road up to the junction of Homefield Avenue'.

Data captured from various sources including alcohol related police and ambulance call outs has been mapped and shown sufficient evidence to implement CIZs in the specified area. In particular crime data and evidence shows a correlation between concentrations of off-licences and alcohol related anti-social behaviour, particularly that associated with street drinking.

Street Drinking Hotspots

There are relatively few calls to police specifically about street drinking. This may be because they are recorded as other ASB types such as littering or noise. Between 01/06/2017 and 31/05/2018, there were only 53 calls to police. The following year, there were 142. This represents an increase of 168%. Part of this increase may be attributed to callers being aware of the borough wide PSPO on drinking in public which came into effect in October 2017.




Calls to police specifically related to street drinking between 01/06/2017 and 31/05/2019

Alcohol-related ambulance and Police calls between 01/06/2017 to 31/05/2019


Hotspot of Violence with Injury Crimes

The purpose of the CIZ in Sudbury, is to address the issues mentioned above.


The Premises

The premises, namely Kanaga Mart Ltd, 755 Harrow Road, Wembley, HA0 2LW falls within one of Brent's ten CIZs.



Kanaga Mart Ltd, 755 Harrow Road, Wembley, HA0 2LW

The premises itself is located along the main High Street in the heart of the town centre, where there are a number of businesses. In relation to the supply of alcohol for off sales, there are eight existing off licences that have premises licences, all within a few minutes walk of eachother.



Public Space Protection Order (PSPO)

The entire Borough of Brent is subject to a Public Space Protection Order for street drinking and therefore it is an offence to drink alcohol in any public place.

If a police officer reasonably believes that a person is, or has been, consuming intoxicating liquor within these areas, the officer may require the person concerned:

- a) not to consume in that place anything which is, or which the officer reasonably believes to be, intoxicating liquor
- b) to surrender anything in his/her possession which is, or which the officer reasonably believes to be, intoxicating liquor or a container for such liquor (other than a sealed container)
- c) An officer may dispose of anything surrendered to him/her as above.
- d) Issue fixed penalty notices on offenders
- e) Prosecute persistent offenders

However, in reality there are limited police officer resources, which in practice would prevent the above from being enforced. This therefore places a greater emphasis on the responsibility

of those premises that are selling alcohol for consumption off the premises. It is clear that if off licences did not exist, the number of street drinkers would decline.

Therefore simply selling alcohol to customers who once off the premises, are no longer the responsibility of the licence holder, the Designated Premises Supervisor (DPS) and/or members of staff is no longer a viable option.

Premises Licence Application

Operational Plan, Training Manual & Conditions

Although the application proposes a number of conditions, it does not appear any different to a standard 'off licence' in terms of its unique selling point.

Simply listing a number of conditions from Brent's pool of model conditions without any type of substantive operational plan for example, appears inadequate. The Licensing Authority would expect to see information on how the business plans to ensure that their particular premises will go above and beyond in promoting the licensing objectives in an already saturated area. This could also include the 'training manual' mentioned in the application form which should give detailed information on the training that is covered. This would go some way in reassuring the Licensing Authority that the business has taken the impact on the local area of adding another off licences to the eight that already exist.

Safeguarding the Local Area


The Statement of Licensing Policy lists considerations to be made when applying for a new premises licence, particularly those considerations relating to street drinking.

However, the conditions that are mentioned in the application fail to address the likes of such things outside of the premises that could be directly linked back to the premises. This includes items such as the clearing up of litter which may be left outside the premises by customers, the labelling of alcohol with the premises name in order to link street drinkers back to the premises or measures to discourage street drinkers from loitering outside the premises.

As per Brent Council's Statement of Licensing Policy, a voluntary offering of a ban on high strength alcohol sales does not necessarily address the requirements under a Cumulative Impact Zone.

The Plan

Other considerations mentioned are the appropriate location of alcohol in relation to the sales counter so as to be directly supervised by staff. In the case of this application, the plan supplied shows that the beer fridge cannot be properly supervised by staff at the counter. Relying on CCTV camera screens to watch customers would be difficult when there are other customers being served simultaneously.



Supply of Alcohol and Opening Hours

The application does not address how alcohol will be displayed during the hours when licensable activities are not permitted but the premises are still open to members of the public. In this case it includes when the premises are not permitted to supply alcohol from Monday to Sunday daily from 7am until 11am.

History & Previous Knowledge

The application does not mention the licence holders history of any previously run premises or background knowledge of how a premises supplying alcohol would be run. The assumption then, is that the licence holder does not have any previous experience which may in turn undermine the licensing objectives.

Summary

The Statement of Licensing Policy states that any licence application in a CIZ area will need to demonstrate with evidence that its operation will not add to any cumulative impacts that the CIZ is seeking to address. Further, new applicants and those applying for variations would be required to demonstrate how their premises will not contribute to street drinking in those areas.

The effect of adopting a CIZ is to "create a rebuttable presumption" that applications for licences which are likely to add to the existing cumulative impact will normally be refused (or subject to certain limitations) unless the applicant can demonstrate that there will be no negative cumulative impact on the licensing objectives.

Other than the list of proposed conditions, the application and operating schedule fails to demonstrate that a grant will not lead to a negative cumulative impact on one or more of the licensing objectives and to the contrary add to the issues of an existing saturated area.

The application also fails to describe any previous experience the licence holder has in operating a premises that supplies alcohol.

It is on this basis, that the Licensing Authority ask that the application for a new premises licence is refused by the Licensing Sub-Committee. Adding conditions to a premises licence, in the Licensing Authority's opinion is not adequate when the application does not demonstrate what is being put in place in order to avoid further cumulative impact. Adding an additional off licence to the eight that already exist in the immediate area, will no doubt be detrimental to the local area.

If the committee however decide that there is sufficient evidence to the contrary, the Licensing Authority would ask that the following conditions be added to the operating schedule:-

The Licensing Authority require the following points to be included in the operating schedule or added as conditions on the premises licence:

- CCTV shall be installed to Home Office Guidance standards and maintained in a good working condition and recordings shall be kept for 31 days and shall be made available to police and authorised Officers from Brent Council.
- 2. The CCTV system shall be capable of obtaining clear facial recognition images and a clear head and shoulders image of every person entering or leaving the premises.
- 3. A CCTV camera shall be installed to cover the entrance to the premises and further cameras to cover the entire servery area and till.
- 4. A member of staff shall always be present on the premises whilst they are open who is capable operating the CCTV system and able to facilitate immediate viewing of CCTV footage upon the request of the Police and Authorised Officer of the Licensing Authority.
- 5. Promotions that encourage irresponsible drinking shall not be permitted.
- 6. A "Challenge 25" policy shall be adopted and adhered to at all times.

- 7. A sign stating "No proof of age No sale" shall be displayed at the point of sale.
- 8. A copy of the premises licence summary including the hours which licensable activities are permitted shall be visible from the outside of each entrance to the premises.
- 9. Any staff directly involved in selling alcohol for retail to consumers, staff who provide training and all managers will undergo regular training (every 12 months) of Licensing Act 2003 legislation. This will be documented and signed for by the DPS and the member of staff receiving the training. This training log shall be kept on the premises and made available for inspection by police and relevant authorities upon request.
- 10. Outside of the hours authorised for the sale of alcohol, all alcohol within the trading area is to be secured behind locked grills, locked screens or locked cabinet doors so as to prevent access to the alcohol by customers or staff.
- 11. All alcoholic drinks shall be clearly labelled or marked with the name of the premises.
- 12. A notice asking Customers to leave quietly from the premises shall be displayed by the exit/entrance.
- 13. A single incident log shall be kept at the premises, and made available for inspection on request to an authorised officer of Brent Council or the Police, which will record the following:
 - (a) all crimes reported to the venue
 - (b) all ejections of patrons
 - (c) any complaints received
 - (d) any incidents of disorder
 - (e) all seizures of drugs or offensive weapons
 - (f) any faults in the CCTV system
 - (g) any refusal of the sale of alcohol
 - (h) any visit by a relevant authority or emergency service.
- 14. No high strength beers, lagers, and ciders above 6.0% ABV shall be stocked or sold at the premises.
- 15. A clear and unobstructed view into the premises shall be maintained at all times.
- 16. Invoices are to be produced to Police, a member of an appropriate authority or council officers upon request to evidence payment of duty on goods.
- 17. All deliveries shall take place during the normal working day (i.e. 09:00 to 18:00 daily).
- 18. A lockable safe with deposit slot and anti-fishing mechanisms must be used at the counter till area in order to prevent crime.
- 19. A suitable intruder alarm and panic button shall be fitted and maintained.
- 20. A personal licence holder shall be present on the premises and supervise the sale of alcohol throughout the permitted hours for the sale of alcohol.
- 21. All alcoholic drinks shall be clearly labelled or marked with the name of the premises.
- 22. All alcoholic drinks must be bagged into a different coloured or labelled bag to that of other items. Where alcohol is to be mixed with other groceries, the bag should be the same coloured one that is used for sales of alcohol.

- 23. An electronic till prompt should be used for all alcohol sales.
- 24. No single cans of beer, lager or cider.
- 25. No sale of miniature spirits (5cl).
