Please give a general description of the premises (please read guidance note 1)

Burger Bitez is a burger bar with a difference. All of the burgers are home-made to a unique recipe. The patties are 'smashed' in front of the customer and all food is made freshly to order. Although it will undoubtedly be billed as such, it is not a fast food premises per se, it is in essence a restaurant first, that offers the takeaway option. There is essence nothing rushed about the preparation or service.

This restaurant has been a long time coming for the proprietor, Mohammed Al-Ali who has spent his entire life learning the trade from his father, amassing 15 years of experience.

His father has owned a number of businesses over the years, all of which Mohammed has worked in, from part time while studying to full time. Previously the family owned Al-Sultan in Colindale, Sultan gardens in Kingsbury and most recently Noor Palace, a wedding and events venue in Ealing.

Mohammed stepped away from the family business for a brief time while he entered the motor trade industry, but soon returned when his father gave him the opportunity to set up and run his own business, in his own way.

The premises has only been open for a few months and already customers are coming from far and wide to dine or take away. Whilst it is early days, thoughts are already leading toward opening another Burger Bitez nearer to Ealing where a huge amount of custom originates.

Mohammed was brought up on the importance of customer service and it is something that he strives toward each and every day. Another goal is that he wants to assist his father into an early retirement given that he has committed his whole life to running the family businesses from dawn to the early hours 7 days a week.

The premises has been designed with attention to detail suggesting on first look that it is not a normal burger restaurant, there is a little class not just about the product but the premises too.

The dining area is spacious to ensure even when the premises is at capacity, that it does not look crowded. Admittedly a lot more people could be accommodated in the premises than actually are, but to permit that would compromise on the customer service.

The premises has a substantial CCTV system throughout ensuring that there are no black spots, all areas are covered with cross overs. The premises has a shutter to the front for security and a steel rear door.

This application has come a little earlier than the applicant imagined it would. This is entirely down to customer demand and requests.

 - 1. An incident log shall be kept at the premises, and made available for Inspection on request to an authorised officer of Brent Council or the Police, which will record the following:
 - all crimes reported to the venue
 - all ejections of patrons
 - any complaints received
 - any incidents of disorder
 - any faults in the CCTV system
 - any visit by a relevant authority or emergency service.
- 2. CCTV shall be installed to Home Office Guidance standards and maintained in a good working condition and recordings shall be kept for 31 days and shall be made available to police and authorised Officers from Brent Council.
- 3. The CCTV system shall be capable of obtaining clear facial recognition images and a clear head and shoulders image of every person entering or leaving the premises.
- The CCTV system shall display on any recording, the correct date and time of the recording
- 5. A member of staff trained in the use of the CCTV system shall be available at the premises at all times that the premises are open to the public
- 6. A CCTV camera shall be installed to cover the entrance of the premises and further cameras installed to cover the internal area and servery counter.
- 7. Signage stating that CCTV is in operation at the premises will be clearly displayed at the premises
- 8. A copy of the premises licence summary including the hours which licensable activities are permitted shall be visible from the outside of each entrance to the premises.
- 9. A clear and unobstructed view into the premises shall be maintained at all times.
- Adequate and appropriate supply of first aid equipment and materials must be available on the premises at all times
- 11. No persons carrying cans or bottles of alcohol shall be admitted to the premises at any time.

- 12. Staff will attend to any spillages within the venue as soon as practicable to minimise risk of injury to customers.
- 13. There will be no takeaway service of food for immediate consumption all food taken away is to be closed/wrapped up.
- 14. Clear notices must be prominently displayed requesting customers to leave the premises and the area in a quiet and orderly manner.
- 15. During licensable hours all deliveries will be conducted by bicycle or electric vehicle only.
- 16. Delivery drivers should be asked to keep noise to a minimum when collecting takeaways and must not be permitted to loiter unnecessarily.
- 17. The licensee undertakes to use only experienced and reputable delivery companies whereby deliveries will only be delivered to the registered address as per the booking.
- 18. Staff shall carryout regular checks to ensure the area is clear of litter, to monitor customer behaviour and to ensure there is no outbreak of noise from the premises.
- 19. Staff training must be documented and based on legislation and operating procedures. All training shall be signed and dated, and a copy of such records will be available for inspection by Police and local authority enforcement officers.
- 20. Deliveries of goods to the premises shall only be accepted between the hours of 09.00hrs and 18.00hrs.
- 21. Waste must not be placed externally between the hours of 21.00hrs and 08.00hrs.
- 22. The licensee will provide adequate bins for use by customers and encourage their use
- 23. The locks and flush latches on the exit doors shall be unlocked and kept free from fastenings other than push bars or pads whilst the public are on the premises
- 24. Any socket outlets (or other power supplies and portable equipment) that are accessible to staff or the public shall be suitably protected by a residual current device (RCD having a rated residual operating current not exceeding 30 milliamps).
- 25. No person shall be permitted to sit on the floor, on stairs or in gangways and passageways

26. Where chairs and tables are provided, internal gangways are kept unobstructed
27. Child Sexual Exploitation Training will be included in staff induction and annual refresher training – the licensee will link in with police licensing for updates and advice.

Dear Cllr Mistry,

I write to you on behalf of my client Burger Bitez Ltd. Firstly I'd like to apologise for the time it has taken for me to write a response to your letter dated 6th of October.

I wanted to wait until the consultation period had ended to establish whether we had attracted any other objections. Unfortunately, due a printing matter which was out of our hands, the consultation period was extended for a further 17 days to the 13th of November.

Firstly, I would like to re-iterate comments within the application with regard to my client's business. Whilst a burger restaurant does not at first thought seem niche, this small but expanding business is. The burgers are all handmade on site and cooked fresh along with every other ingredient. The premises has been furnished to a standard that does not usually associate with a burger restaurant. These are not empty meals; each individual food offering is substantial. Pricing of the goods is also another factor that often changes the type of customer a business attracts. As such these products could never be called fast food, they are not light on the pocket.

The family have built up a trusted reputation for their customer service, and above all this comes first. This is ingrained in the applicant from years of training from his father and assisting at his numerous hospitality businesses throughout the years.

One thing that was mentioned during my first conversation with my client was his relationship with his neighbours. Whilst he wants to provide a service

to his customers, many of whom have asked for this (such as numerous night workers in the area), he will not do so to the detriment of his neighbours.

There are a number of conditions attached to the operating schedule that we submitted that ensure every care is taken not to cause any disturbance. This was further enhanced after discussion with the police. Most notably we included the condition that all deliveries must be conducted by bicycle or electric vehicle only. This is something another client of mine has trialled and penned as 'silent delivery'.

We have also assured that no vehicle will be left idling, and that delivery drivers will keep noise to an absolute minimum. This is easily controlled as each driver will be aware of not just the licence conditions, but the reputation of the business, and those that do not adhere to the operation protocols of the business may well find that they don't deliver for the company again. It is in their best interests, and this is something I have found with other clients that does get results.

My client is not trying to turn the area into a 'night life' area. We are aware that there are other premises open at similar times to this application and interestingly not competition either. My client has a product that neighbours, local residents and night workers to the area have requested later opening for, and that may indicate why no members of the public have objected to this application.

With regard to the anti-social behaviour issues that the area is suffering, we have what we consider adequate conditioning within our proposed schedule to ensure that this business does not add to that. Furthermore, neither the police nor the environmental service requested any further conditioning to mitigate such issues, had they I am sure my client would have been happy to discuss.

At the conclusion of what was a 45 day consultation period, during which we ensured the blue notice remained on the window of the premises, no members of the public have submitted any objection. Nor have the licensing authority, the police or any other of the responsible authorities.

You will note below that conditions were agreed with the police during consultation, the majority of which are reworded versions of those we submitted on application. This is not because we 'left something out', it is merely that different authorities and police prefer their own wording from borough to borough. Also, the licensing authority requested an additional with regard to 'right to work documents'. I have combined our original operating schedule and that of what has been amended below. Amendments are in bold, additions in italics. Therefore, all that is seen below is what has been agreed going forward.

We totally understand your concerns for this application and that is why we have been sensitive and responsive to any issues raised. We hope that the fact no neighbours, businesses or members of the public have objected and that we have happily amended the operating schedule to suit allays any fears you have.

An officer of the Metropolitan Police, in whose area the premises are situated, who is authorised for the purposes of exercising its statutory function as a 'Responsible Authority' under the Licensing Act 2003.

The application has been made for a new premises licence under Section 17 of the Licensing act 2003. The Police representations are concerned with all four of the licensing objectives.

Police require the following points should be included in the operating schedule or added as conditions on the premises licence.

The Application

The application is for a new 'high end' burger restaurant with an eat-in and take away service available for its customers. The only licensable activity is for late night refreshments. The venue is already in business and now wishes to add the late night refreshments to its operating schedule to expand the business.



Members of the Committee,

I write as representative to the applicant Mr Mohammed Al-Ali of Burger Bitez Ltd. We are set for a committee hearing this coming Thursday the 8th of December and though it may be useful to give you further insight to the business.

As you are aware, Burger Bitez are seeking licensable hours to permit Late Night Refreshment 2300-2345 Sunday to Thursday and 2300-0145 Fridays and Saturdays.

As the application states, Burger Bitez is a burger bar with a difference. Independently owned, the burgers are all home-made and 'smashed' on the premises. The vast majority of their dishes and a number of the sauces are also home-made. In terms of food produce, this is what sets them apart from standard 'fast food' premises.

Added to the quality of the food on order is the high specification of the premises. The attention to detail when the premises was designed earlier this year was to present a venue set apart from other similar establishments. A venue that had the look of a restaurant not of a standard fast food premises. If you are not familiar with Burger Bitez, the photos below provide an insight, a menu is also attached.

Application

The application was submitted at the end of September with a final date for representations the 27th of October 2022. As a result of an issue with the printers, the legal notice was not published within the stipulated ten working days. I informed the authority of this matter, which was out of our hands, and offered to withdraw and re-submit the application. Thankfully the authority stated that there was no necessity to do so and extended the consultation period to the 13th of November 2022. During the entire period, which was

over 6 weeks my client kept the blue notice on display in the window of the premises.

Mr Al-Ali always planned on submitting an application for late night refreshment, but this came earlier than he anticipated due to calls from the public. This is no surprise given that his main focus is on customer service, the quality of food, the ambience of the premises and his high standards are clearly evidenced amongst the online reviews I have pasted below.

These high standards also came across the first time I met Mr Al-Ali, he informed and showed me that he had already purchased an electric bike to assist with deliveries. He was conscious of the environmental impact and that on the noise of vehicles informing me that he would only use electric vehicles for deliveries. Whilst discussing this we agreed to implement what I term as 'silent delivery' during the hours of darkness. Bicycles or electric vehicles to transport the deliveries, with the agent contacting the customer just before delivery to save any loud knocking on doors.

During consultation discussion was had with the police and the licensing authority. Some additional conditions were added, but most were amendments of those already offered. At the end of consultation, none of the responsible authorities had objected. Neither had any members of the public. The only representation was that of councillor Mistry.

This is an extremely important point. As stated, the notice was on the premises for an extended time some 6 weeks plus. Therefore, the public had sight and knowledge of the application for over two weeks longer than one would normally. No objections. Furthermore, it was the general public and customers of my client that actually asked for this service to be extended. Finally, on hearing that my client had received the one objection a number of signatures of support were gathered, as per the attached sheet.

I appreciate that there is an opportunity during the consultation process for anyone to submit a representation in favour of an application but, I have never experienced such. We are all very quick to try and stop something that we do not agree with, but if we agree with it we often say and do nothing. This is exactly what has happened here with these residents and businesses that wholeheartedly support this application. Not necessarily because they want to dine at the premises. But, because unlike you and I, they know the applicant extremely well, they trust him and his ethos and they want to put their heads above the parapet and state as the very people the councillor represents, that they actually want this to happen.

With regard to other premises in the area we cannot comment as we are only dealing with the merits of my client. But given that the public and the experts in the responsible authorities offered no objection one could reasonably assume that there are no issues or complaints in the area and as such we are firm in our belief that if granted, this application would have no negative affect on the night-time economy

We wholeheartedly respect and understand the councillors concerns for their constituents, but the neighbours and nearby residents have had several weeks to object if they wished to, and they have not. Unfortunately, we have not had a reply to our letter to the councillor so have not had the opportunity to discuss the matter with them as we did the responsible authorities.

We look forward to discussing the matter further at committee for which my client will be present and happy to assist you in making a decision.
