The application is for the review of a premises licence held by Beronmoor Ltd. The premises are known as The Kilburn Arms, 97-101 Willesden Lane, NW6 7SD.

#### 2. Grounds for Review

The grounds for review are the Prevention of Public Nuisance.

The premises is causing a nuisance to residents impacting negatively on their lives.

#### 3. Relevant Representations

Representation has been received from a local resident. Support for the premises has been received from the Ward Councillor, Town Centre Warden & a patron of the premises.

#### 4. Background

The premises was previously reviewed on 5 January 2023 where live music was restricted to Saturdays only until 11pm. The decision was subsequently appealed by the premises and a decision settled out of court where live music was reinstated to the times mentioned below.

These premises are currently licensed for:

Live Music from 8.00pm to 10.30pm Sunday to Tuesday, 11pm Wednesday to Friday and midnight Saturday.

Recorded Music from 8pm to midnight Sunday to Thursday, and 1am Friday & Saturday. Late Night Refreshment from 23.00pm to 1.00am Monday to Thursday and 2.00am Friday to Sunday.

The sale of alcohol from 10.00am to 2.00am Monday to Sunday. and to remain open from 10.00am to 2.30am Monday to Sunday.

The Designated Premises Supervisor is Mr Constantin Tofan.

As residents whose house is not only within proximity, but in fact attached to the Kilburn Arms. The noise and vibrations transmit through the walls into our bedroom and kitchen.

We wish to contest the current license of the Kilburn Arms under the "prevention of public nuisance".

The grounds for review are based on increased amounts of offences since the Kilburn Arms has had live bands on every Wednesday and Saturday Nights as well as the occasional Friday nights which has been persistent since March 2022. Ever since we first contested their license in 2022 the situation has only worsened. Brent have imposed some minor restrictions on their license and they struggle to adhere to these.

We know that their license has been in place prior to when we purchased our home off of Brent Council in 2012. Minor reductions have been imposed but the situation has worsened for residents.

#### **SITUATION:**

Our case has been ongoing since March 2022 with regards to noise and public nuisance. The issue has deteriorated despite the weather being colder. We are now fearing when the weather gets warmer and we have to have the windows open.

Our first meeting with the Kilburn Arms was on the **17**<sup>th</sup> **May 2022** and also where we negotiated the following:

- all doors to the pub should be closed once the music starts at 8pm
- the back terrace must be closed at 10pm
- the duration should be between 8pm and 11pm with the last song played at 10.55pm
- that they seek ways to soundproof the venue

Following visits/communication with The Kilburn Arms, have been:

- 19th July 2022 Letter sent from the residents to The Kilburn Arms
- 7th June 2022 Diane Lewis, Brent Noise team emailed and visited the Kilburn Arms
- 12<sup>th</sup> October 2022 residents met with the on-duty manager
- 28<sup>th</sup> August 2022 residents met with Costas

Brent council have taken over communications with the Kilburn Arms in 2023 as our direct conversations with the pub are ineffective and not taken seriously.

#### **ISSUES:**

We have kept a noise diary (attached) and regular noise recordings via the NoiseApp. As you can see the dates and times are consistent with times of the music playing regularly running over the 11pm cut off. Furthermore, the noise and disturbance from the terraces, often running into the early hours of the morning. The recent planning application for the front and back terrace has now impacted our peace and quiet in our own home.

As residents with two young children, we noticed that they are quite anxious and restless on Wednesday and Saturday nights. The music and sound from the Kilburn Arms premises cause our children to wake from their sleep on these evenings. This has a knock-on effect on our sleep and as a result our whole family suffer on Thursdays and Sundays!

Because some weeks the situation has been so unbearable, we have in the past felt compelled to get out of the comfort of bed to go round the Kilburn Arms in pajamas after 11pm as the music is still going on, with doors wide open and in full swing with no sign of stopping! Once the live music ends, recorded music is played through speakers onto the decking. Evidence has previously been submitted.

We now feel that we are trapped in our own home when the live music nights are on as the crowd has been known to be hostile and we have no peace or quiet. It is hard to relax after a hard day at work with the uncertainty of when we can actually fall asleep.

The first occasion on going round to the Kilburn Arms past 11pm, we were met with sincere apologies from the manager however on every occasion after this, we have been quickly dismissed, with the on-duty staff showing a reluctance to stop the music and the conversations have been confrontational making us feel intimidated. We had to call the police as one of the punters from the pub was aggressive and followed my husband to the door of our home.

The following mornings of live music events (Thursdays and Sundays), we clear up broken glass from our entrance to our house and during the summer months when the weather was hot, hose down the doorway as it smells of urine!

It is also apparent that there is a strong smell of marijuana which we can now smell on Wednesday and Saturday nights coming from the terraces (front and back). Now that our children are a little older, they are becoming more aware and waking more often with nightmares when the music is on.

The Kilburn arms are now not only impacting young working parents but now impacting on the quality of sleep and heightening the levels of anxiety on our young children (4 and 2 years old).

#### **CONCLUSION:**

As a result of the actions of the pub, we are unable to enjoy peace in our own home and feel intimidated on busier nights. Their irresponsible actions are disturbing our young children, creating a state of fear and panic in the early hours of the morning which comes from the pub every Wednesday and Saturday which is negatively impacting our lives and fashioning an unhealthy environment.

What we would like to make clear is that we <u>DO NOT</u> want to end live music for the Kilburn Arms however we would like to see them cooperate with us and police it effectively. We would like to see the following implemented:

- The Kilburn Arms should <u>NOT</u> be required to stage performances of live music, or the playing of recorded music from **Sunday to Friday (AM and PM).**
- Live music, or the playing of recorded music should be permitted only on Saturday evenings from 8pm to 11pm. (Band warmups should also be conducted within this time frame)
- All outdoor seating/space should be closed **at 9pm** every day throughout the year. This means people who drink at the pub outdoors should not be congregating on the terrace past 11pm. From what I have observed, other pubs in the local area stop live music and last orders are at 10.30-10.45pm and everyone must disperse by 11.15pm.
- The doors to the Kilburn Arms should always closed when the music is played. Please
  note the front doors leading onto Willesden Lane should be double closed, not just the
  internal doors.
- The back doors to the back terrace should always be closed when live music, or recorded music is played.

If you have made representations relating to this premises before, please state what they were and when you made them We have contested the Kilburn Arm's license in 2022 and went through to a hearing in January 2023 which the terms above were imposed until they contested the councils decision in 2023. Ever since they appealed and settled out of court with Brent Council, there has been little to no difference to where we were in 2022! We feel as residents we have been let down, as their operating hours license are incredibly unfair. We would also like to mention that even with some minor conditions imposed, the Kilburn Arms have really struggled to adhere to these i.e. Closing all doors when the music is on, managing the dispersal of patrons and closing the rear terrace at 10.30pm. The music is still as ever, LOUD.

#### Hi everyone,

The Kilburn Arms on Willesden Lane is a precious remnant of the-once vibrant Kilburn night-time economy (in Queen's Park ward). The live music is gentle stuff and the middle-aged crowd is just the kind of diverse group we love to see in this neighbourhood.

One resident has been conducting an assiduous campaign for years now and last year succeeded in limiting their music night hours (11 o'clock on Wednesday and 12 o'clock on Saturday) - to which he agreed in an out-of-court settlement.

Someone - I presume the same person since nobody else lives next to the pub - has complained again less than four months after this matter was decided and agreed upon. When Brent noise abatement officers were called in a couple of years ago, they deemed the levels acceptable and anecdotally, one can barely hear the music outside.

If one family is so sensitive to low-level sound next door as to want to permanently curtail the enjoyment of hundreds of their fellow citizens, perhaps they shouldn't have bought a house within a few metres of a live music venue.

Hi Sima

I have to concur with Cllr Molloy on this – I'm not aware of any anti-social behaviour or noise issues associated with this pub. I've never received any complaints about it (either official or anecdotal). I've previously worked with the pub to support live music there as part of our Kilburn Fringe festival in October 2022 and found them to be an accommodating and responsible establishment.

Officially, the pub sits just outside the Kilburn town centre boundary, but in close enough proximity to other hospitality establishments on Willesden Lane where we would expect and want night time activity that supported a vibrant major town centre and was in keeping with Kilburn's recognised London Plan status as having a night time economy of more than local significance.

I don't know the exact nature of the noise complaint, but if it is from the same person as previously in January 2023, it suggests there may be some form of personal vendetta at play. If you haven't done so already, it may also be worth you contacting Andrew Hewitt as the ASB Localities Officer for his opinions.

It is incredibly distressing that we hear that the neighbour again is trying to create trouble for the venue and the community.

This person is simply exaggerating and telling untruths, clearly doesn't like peaceful people and good folk being in a public space!, not to mention costing this honest business a lot of money in costs and shortened hours.

What's more distressing for me is that his reports are being taken seriously and supported by yourselves without any proof.

Why do we not see licence people coming and actually witnessing the events? How can you make demands and bring great stress without attending. This is a disgrace both on on the side of the council department and this individual who is clearly obsessed and suffering with some anti social behaviour.

There has NEVER been a overly loud band, an argument or anti social behaviour outside of the bar to our knowledge and we attend every session.

This person simply does not want to hear a sound coming from this area of venue and forecourt.

Why then move next door to a community hub?

How can the council once again cause so much stress to this business based on completely unfounded and untrue reports from one unlawful individual, who chose to move next door to a music venue!

What is happening with this licence department?

I have to say more than one person has admitted being suspicious of the licence department as they are not attending or listening to the facts and the truths. Is someone is this department known to the accuser?

- (2) In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises—
  - 1. (a)games or other activities which require or encourage,

or are designed to require or encourage, individuals to— (i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or (ii) drink as much alcohol as possible (whether within a time limit or otherwise);

- (b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective;
- (c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective;
- (d) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner;
- (e) dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of disability).

#### Free Water

The responsible person must ensure that free potable water is provided on request to customers where it is reasonably available.

#### Age Verification Policy

- (1) The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.
- (2) The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.
- (3) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either—
- (a) a holographic mark, or
- (b) an ultraviolet feature.

#### Small Measures to be Available

The responsible person must ensure that—

- (a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures—
- (i) beer or cider: 1/2 pint;
- (ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and
- (iii) still wine in a glass: 125 ml;

- (b) these measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and
- (c) where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available

#### Minimum Price of Alcohol

- **1.**A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.
- 2. For the purposes of the condition set out in paragraph 1—
- (a)—duty | is to be construed in accordance with the Alcoholic Liquor Duties Act 1979;
- (b)—permitted price∥ is the price found by applying the formula—

#### $P = D + (D \times V)$

where—

- (i)P is the permitted price,
- (ii)D is the amount of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and
- (iii)V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol;
- (c)—relevant person∥ means, in relation to premises in respect of which there is in force a premises licence—

- (d)—relevant person means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and
- (e)—valued added tax∥ means value added tax charged in accordance with the Value Added Tax Act 1994.
- 3. Where the permitted price given by Paragraph (b) of paragraph 2 would (apart from this paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.
- 4.(1)Sub-paragraph (2) applies where the permitted price given by Paragraph (b) of paragraph 2 on a day (—the first day||) would be different from the permitted price on the next day (—the second day||) as a result of a change to the rat e of duty or value added tax.
- (2) The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

#### Requirement for a DPS

- (1) No supply of alcohol may be made under the premises licence-
- (a)at a time when there is no designated premises supervisor in respect of the premises licence, or
- (b)at a time when the designated premises supervisor does not hold a personal licence or their personal licence is suspended.

#### Annex 2 – Conditions consistent with the operating schedule

- Closed Circuit Television (CCTV) shall be installed and maintained in accordance with the Association of Chief Police
  Officers (ACPO) guidance, and all recorded images kept and made available to the Police and the Licensing Authority for
  31 days.
- 2. All entry and exit points will be covered enabling frontal identification of every person entering in any light condition.
- 3. The CCTV system shall continually record whilst the premises is open for licensable activities and during all times when customers remain on the premises and will include the external area immediately outside the premises entrance.
- All recordings shall be stored for a minimum period of 31 days with date and time stamping.
- 5. Viewing of recordings shall be made available immediately upon the request of Police or authorised officer throughout the entire 31-day period.
- 6. A staff member from the premises who is conversant with the operation of the CCTV system shall be on the premises at all times when the premises is open. This staff member must be able to provide a Police or authorised council officer copies of recent CCTV images or data with the absolute minimum of delay when requested.
- 7. All doors and windows shall remain closed during any entertainment and where a door is used for patrons to enter or leave the premises the door shall be lobbied and fitted with a self-closing device.
- 8. Signs shall be placed in the garden and the frontage instructing customers to recognise the residential nature of the area and conduct their behaviour accordingly. The management shall reserve the right to ask patrons to move inside the premises or leave if it is felt that they could be disturbing the neighbours.
- 9. No noise or vibration shall be detectable at any neighbouring noise sensitive premises after 23:00hrs. The level of music at all times shall be arranged so as not to cause a nuisance to local residents.
- Notices asking customers to leave quietly shall be conspicuously displayed at all exits.
- 11. The Portman Group proof of age scheme or similar such scheme shall be adopted.
- 12. Toilets shall be checked regularly for the use of drugs and other illegal activities.
- 13. Adequate and appropriate first aid equipment shall be available on the premises.

- 14. Suitable and sufficient fire fighting equipment shall be provided and maintained in good order.
- 15. Regular surveys (checks) shall be carried out when the premises are used for entertainment to ensure the level of music is arranged so as not to cause a nuisance to local residents.
- Notices advertising the number of a local licensed taxi service shall be displayed in a prominent position.
- 17. Door supervisors of a sufficient number and gender mix, shall be employed from 20:00 hours on any day when the premises are open for the sale of alcohol past midnight.
- 18. A copy of the premises licence summary including the hours which licensable activities are permitted shall be visible from the outside of each entrance to the premises.
- 19. Outside drinking shall only be allowed at the tables provided and no customer shall be allowed to take glasses or bottles away.



I would just like to clarify a few facts with regard to the representations made by Cllr Molloy, The Town Centre Manager and the representative from the charity.

Firstly with regard to Cllr Molloy's submission 3.3, I would like to make it absolutely clear that we had no part in the out-of-court settlement reached by Brent and Mr Tofan, which seems bizarre to us as it is ourselves who were/are being impacted by the noise from the pub. We were unable to even make any representations toward that settlement and we certainly did not agree to the outcome of the settlement as incorrectly stated by Cllr Molloy.

We would also point out that our house	. (Cllr Molloy seems to
think it is a few metres away!) In fact, it is our	that physically abut the pub.
And as the live music is played on our side of	the public house the noise travels easily through these
walls into our . (Noise travels more e	asily through solid walls than through air.) Although the
noise might not seem very loud to Cllr Molloy	in the street outside, I can assure the panel that it is in
our established!	·

Cllr Molloy also suggests that we must be 'so sensitive to low-level sound'. We are not. We have lived happily next to the pub since 2013. It is only in recent years that the lateness and the intensity and frequency of the live music that has created problems for us.

Secondly with regard to the submission 3.4 by Mr Hay, the Town Centre Manager, we would point out that the pub is NOT within the Kilburn town centre boundary it is instead in a residential area and that this is not the right location to encourage late night-time city-centre activity. The pub is not particularly close to any other hospitality establishments in the area and those other establishments on Willesden Lane, as far as we are aware, do not have late night live music licences.

Mr Hay also suggests that 'there may be some form of personal vendetta at play'!! We are astounded by his comment. He has taken no trouble to try and speak with us. We have no issue or other dealings with the management of the pub. In fact, we wish them well financially. And we are happy for music to be played at reasonable times, at a reasonable noise level. All we ask is that the noise is kept down late at night, particularly during the week, in order that we and our two young children can sleep. Is that a vendetta???

Finally, I respond to the submission 3.5 from the representative of a local charity. I would like to reassure the individual that we are not 'trying to create trouble for the venue and the community'! He suggests that our submission is without proof - we have submitted logs of the noise that we have noted over many months and videos. He suggests that I am 'telling untruths', and that I am 'an unlawful individual' and that I should 'be taken to court'!? This is all simply nonsense - what 'untruths' and how am I 'unlawful'??

Again we have no problem with folks from the local community meeting in the pub listening to live music. All we ask is that it doesn't happen late at night midweek. I can't think that such a restriction will be harmful to his 'community'.

By the way I regret that Brent have failed to redact my name from this individual's submission. As I have mentioned I have suffered personal abuse from individuals who frequent the pub and this will not help.

I hope you are both well. Apologies for not responding to you sooner.

Myself and Licensing Officer, Mohammed Serdouk arranged to meet with Costas and Evie late last year to discuss expectations following the hearing. We reminded them of the requirement to ensure that ALL doors are kept closed during the playing of live and recorded music. Certainly during my recent monitoring, I could see that at least two of the doors have remained open which will have contributed to excess noise. I have since emailed them to remind them of the requirements and I will continue to monitor compliance from "street level" during night shifts. We also had a discussion about how to possibly prevent noise from transmitting through the fish and chip shop internal door, causing noise to emanate through the entrance door on the main road. I noted a degree of break-out noise through this door during one of my recent visits.

As we have been continuing to monitor both noise and compliance of their conditions (and we will continue to do so, including visits at weekends), for now you are not required to submit further reports to us.



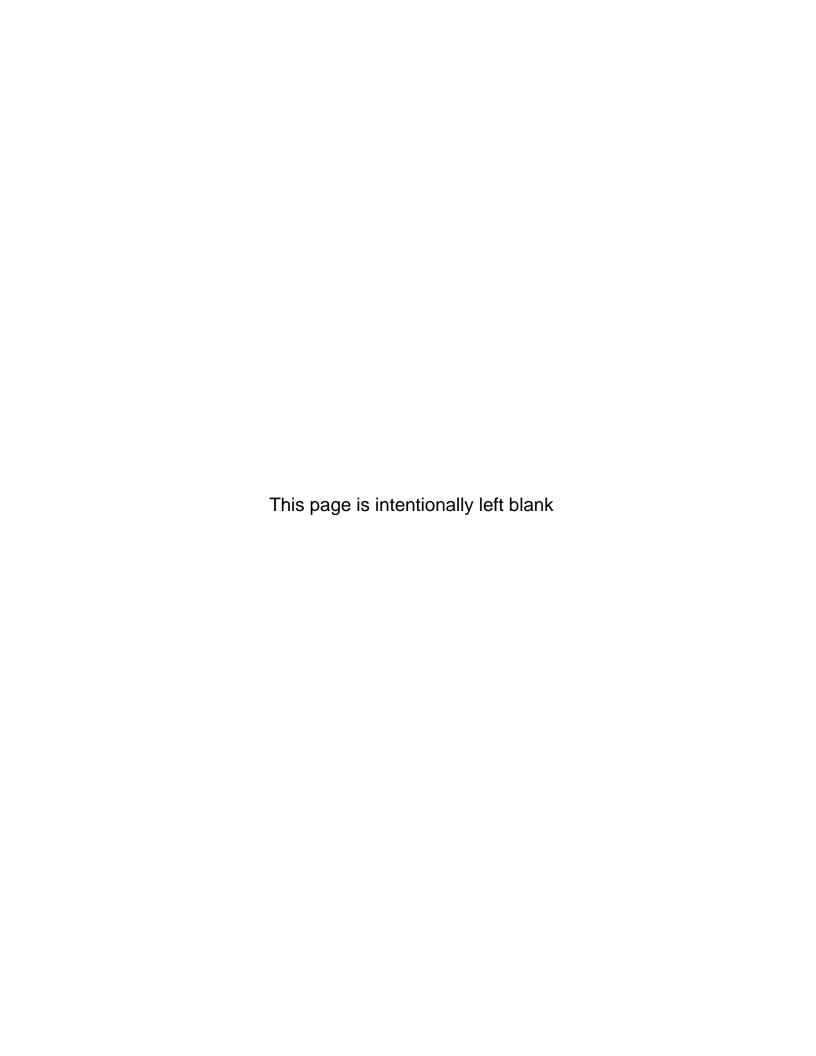

Dear sir/madam,

I wanted to bring to your attention the issues we have been having with **The Kilburn Arms, 97-101 Willesden Lane, NW67SD**. They are unfortunately still making our home life unbearable on Wednesday, Friday and Saturday nights and we have been in contact with the noise team at Brent Council (Diane Lewis), Who has been very helpful.

On Wednesday night (13th July) I had to visit the pub to kindly ask them to close their doors as the music was particularly loud. The music started at c.7.15pm and went on until 11pm. Soon after I visited the pub (c.8pm) they then opened the doors up again but thought it was futile in going round again as the manager was quite rude and abrupt with me the first time. When the music ended, the drinkers stayed for a good hour outside of our door and on their front terrace (which I believe has retrospective planning) making a lot of noise and revving their car engines. This then woke up my 7month old baby at 12.15 am.

On Friday 15th July, The Kilburn Arms failed to disperse their customers until 12.30am and I logged a ticket with the Met police (CAD 2610 16/07/2022) so they could review the issue. We are living in constant fear, and we are suffering from lack of sleep now and our anxiety levels are running high.

Unfortunately for us, on Saturday (16<sup>th</sup> July) I went round to the pub at 10.50pm to kindly ask that could they make sure that their customers kindly leave their premises quietly as we didn't want a repeat of the Friday, however I was met with some hostility from one of the managers on how they deal with customers leaving their premises. It soon transpired that the pub goers didn't leave the terraces until midnight as we struggled with getting to sleep.

I am afraid the situation is getting worse as every week passes. Wednesday nights are particularly bad, and we are left feeling shattered every Thursday morning, often struggling to function properly at work.

I wish to understand if it is possible to formally review their music license and operating hours, as from what I have observed, other pubs in the local area stop live music at 10.30-10.45pm and everyone has to disperse by 11.15pm.

Why is the Kilburn Arms so different and lack any form of respect for their neighbours?

I look forward to hearing from you on what the next steps might be as I am considering speaking with a solicitor.


