

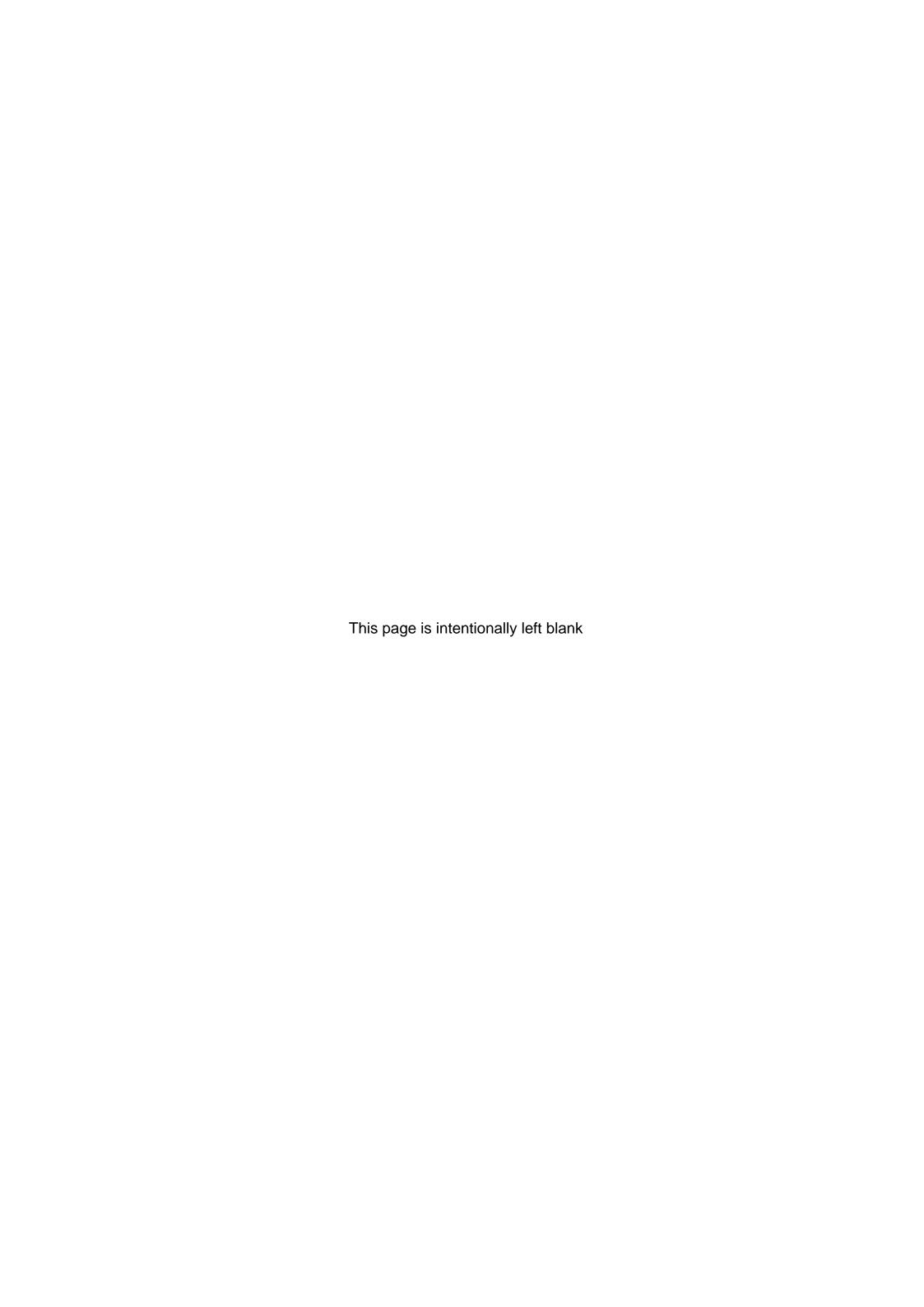

Good afternoon Kashif,

Thank you for coming back to me so promptly, I really appreciate it.

From my point of view, I do have concerns regarding the terminal hour for licensable activity being 03:00 during the week (even if it has been reduced from originally applied for 05:00 terminal hour). I fully understand and appreciate your right as a proprietor of a business to try and make as much profit as you can, especially in the current financial climate.

As the Responsible Authority on behalf of the Licensing Department, my duty is to scrutinize each premises licence application paying mind to the cause and effect that this application will have on the four licensing objectives. Whilst I am satisfied that the risk factor has been inherently reduced by premises not selling alcohol, I am mindful that there could be a reasonable assumption that having a terminal hour so late during the week could undermine the licensing objective of "the prevention of public nuisance" on nearby residents, even if the premises is closed to members of the public.

Therefore, I would like to see the operating schedule reduced to the following for the provision of late night refreshment:

Sunday – Thursday: 23:00 – 01:00 Friday – Saturday: 23:00 – 03:00

There is of course much more scope and acceptance that premises are more likely to be open later outside the standard working week.

I would also be most grateful if you could let me know if you would be satisfied with taking on the attached conditions to form annex two of your premises licence. I don't believe the ones I have put forward are too dissimilar with what is already in your operating schedule and your response to my email below — I have simply translated this information into workable conditions that are proportionate, justifiable, and capable of being met.

Of course, you are free to accept, amend or reject the attached annex two conditions and amendment to the operating schedule. I would advise you to have a think, read the conditions carefully and make sure that they fit the business model. It's important to find the right balance between promoting the four licensing objectives and having conditions in place that work for you.

With that said, if no agreement can be found by way of mediation between the amended operating schedule and the proposed conditions, then I would most likely submit a formal representation against the premises licence application.

Good afternoon,

I am the delegated officer of the Licensing Authority, in whose area the above-mentioned premises is situated, and who is authorised for the purposes of exercising its statutory function as a 'Responsible Authority' under the Licensing Act 2003.

Having read the new premises licence application, I'm concerned that that there is not enough information within the operating schedule to ascertain how the premises will promote the four licensing objectives whilst undertaking permitted licensable activities (i.e the provision of late-night refreshment).

Therefore, I would be most grateful if you could answer the below questions, so I can put forward some conditions based on those answers:

- 1) I understand you have already agreed to a reduction in hours permitted for licensable activity, and subsequently the premises licence application has been amended insofar as the terminal hour for late night refreshment is now 03:00. Just as a point of clarification, are you able to confirm if the premises will remain open to members of the public to walk in until 03:00, or are you closing the premises to the public after a certain point and only selling hot food by way of delivery thereafter? (i.e., via Uber Eats, Just Eat, Deliveroo etc..)
- 2) What measures will you put in place to ensure that noise/disruption is kept to a minimum whilst the premises are open beyond 23:00?

There is no right or wrong answer to the above, I am just seeking further information so that I can put forward some conditions to be agreed that promote the four licensing objectives whilst also fitting the proposed business model.

Proposed Annex Two Conditions

Flames Burger Kitchen, 787 Harrow Road, HA0 2LP

- 1. The premises shall install, operate, and maintain a digital colour CCTV system. The CCTV system shall continually record whilst the premises are open and all recordings shall be kept for at least 31 days.
- 2. CCTV footage shall be made available to the Police and any authorised Officers from Brent Council upon request. CCTV footage shall be provided on removable media (I.e., USB, hard drive, CD etc..) within 48 hours of request.
- 3. The CCTV system shall display on any recordings, the correct date and time of the recording.
- 4. Signage stating that CCTV is in operation shall be clearly and prominently displayed at the premises.
- 5. An incident log shall be kept at the premises, and always made available for inspection upon request by an authorised officer of Brent Council or the Police. The incident log shall include the time/date of the incident, description of the incident and signed off by the relevant staff member. The incident log shall record the following:
- (a) any complaints received.
- (b) any incidents of crime or disorder.
- (c) any faults in the CCTV system.
- (d) any visit by a responsible authority or emergency service.
- 6. A prominent, clear, and legible notice shall be displayed at the exit requesting patrons to respect the needs of local residents and to leave the premises and area quietly.
- 7. A prominent, clear, and legible notice shall be displayed at the exit requesting patrons to dispose of their waste in litter bins.
- 8. A prominent, clear, and legible notice shall be displayed facing the street that stipulates that the premises is closed for walk-in customers after 23:00, and that all orders must be made by way of arranged collection or delivery.
- 9. All orders placed must be made by way of arranged collection or delivery while the premises is conducting licensable activities.
- 10. The premises shall be closed to walk-in customers while conducting licensable activities, except for those collecting pre-placed orders.
- 11. There shall be no provision for customers, delivery drivers nor anyone else to remain inside the premises unless collecting pre-placed orders during the hours permitted for licensable activities.
- 12. There shall be no provision for customers to consume their meal on the premises during the hours permitted for licensable activities.
