The grounds for summary review are serious crime/ disorder involving incidents which took place on 22 June and 13 October 2024.

#### 4. Background

Police officers applied for an expedited review which was heard on 31 October 2024. As an interim measure members suspended the premises licence until the full review hearing.

The Designated Premises Supervisor is John Joseph Flaherty.

The steps a Committee may take are:

- To modify, remove or add conditions
- To exclude the sale of alcohol or other licensable activity
- Remove the Designated Premises Supervisor
- Suspend the licence for up to 3 months.
- Revoke the licence

I am giving this certificate because I am of the opinion that other procedures under the Licensing Act are inappropriate in this case because:

The incident on the 13<sup>th</sup> October 2024, constitutes serious violent disorder, involving a trained licensed Security Industry Authority (SIA) door supervisor, who is employed to protect patrons and ensure public safety. The incident June 25<sup>th</sup> 2024 details previous serious violence at the venue and I note the subsequent failure to take suitable steps to ensure the safety of patrons at the premises and local community. I fully support a Summary review being implemented as it is clear that the venue is not being run to an acceptable standard of safety as evidenced by these incidents. I am concerned there is likley to be further violence if immediate remedial action is not taken.

Erin's Hope is a Public House located in 189 Edgware Road, London, NW9 6LP. The premises benefits a Premises Licence for the following activities and hours.

Reglulated Entertainment:

Monday to Sunday - 0900 to 02:30

late Night Refreshment:

Monday to Sunday - 23:00 to 02:30

Sale & Supply of Alcohol:

Monday to Sunday - 09:00 to 02:30

The Opening Hours of the Premises:

Monday to Sunday - 09:00 to 03:00

The Premises Licence Holder (PLH) and Designated Premises Supervisor (DPS) is Mr John Joseph Flaherty who has been responsible for the premises licence since August 2008 to date. Edgware Road is a major road forming the A5 road, attracting busy transport hubs. The premises is surrounded by both commercial and residential dwellings (Exhibit MJS/01).

On Sunday, 13th October 2024, at approximately 00:20 hours, police received a call from a member of the public reporting a violent altercation outside Erin's Hope. The caller stated that a member of the door staff had struck a male individual forcefully and pushed him to the ground, resulting in head injuries and visible bleeding.

Mr Flaherty was contacted by Police on Monday 14th October 2024, regarding the incident the night before, he wasn't aware of the incident, but mentioned that SIA had dealt with a drunk trying to enter the pub, he seemed shocked when told of the incident, he was unable to check the CCTV as he was on his way to a funeral, on Tuesday 16<sup>th</sup> October 2024 Mr Flaherty sent the Pubs external CCTV of the incident to Police via Whatsapp, he was again spoken to on the phone, where he stated that the SIA had not acted correctly and he was shocked by his actions.

Upon reviewing the venue's external CCTV footage, the following events were observed:

A black male, identifiable by his bald head and long brown coat, was positioned near the front door of Erin's Hope. The individual appeared to be wearing an SIA badge on his right arm, suggesting he was a licensed member of door staff.

A white male was seen engaging with the black male, and from their body language and gestures, they appeared to be arguing.

The white male placed a bottle of water near his feet, which was subsequently kicked away by the black male. The black male then assumed a fighting stance, raising both fists in preparation for physical confrontation.

The white male turned away, seemingly unwilling to engage further. At this point, the black male charged at him, striking him on the back of the head with both hands and using his body weight to propel the white male forward. The victim fell headfirst into nearby railings, covering a distance of approximately six feet.

The CCTV then shows the black male continuing to assault the victim while he was on the ground, although the camera did not fully capture this portion of the incident. The assailant then retrieved a metal bucket from the front of the venue and approached the victim, who was being assisted by members of the public.

Multiple bystanders witnessed the assault.

The victim was transported to the hospital by the London Ambulance Service (LAS) with injuries initially classified as grievous bodily harm (GBH). Upon further investigation, the victim stated he had little memory of the incident due to intoxication, recalling only an argument. He mentioned an old injury had reopened and was bleeding heavily, which led to his hospital visit. As a result, the crime report has been reclassified as actual bodily harm (ABH).

#### CAD Exhibited as MJS/02

The premises previously came to the attention of the Police in June 2024 due to a 'stabbing' incident. Police received a report of a 'stabbing' at the Erin's Hope Public House.

On Sunday 22nd June 2024 at approximately 0130 hours Suspect has entered ERIN'S HOPE pub in COLINDALE NW9. The suspect had approached the victim and demanded £20 from victim stating that this money was owed. Victim and Suspect have entered a verbal and physical altercations involving them pushing one another before suspect is taken out of the pub by security staff. During this time a woman believed to be suspect's girlfriend has assaulted Victim by punching him in the back of the head.

When suspect was outside of the pub, the victim also exited. Suspect was being aggressive and was being restraining by a member of door staff and was brought away from the venue.

Suspect escaped the grasp of the staff member and lunged at Victim who has attempted to defend himself. Suspect has continued to attack Victim before being dragged away by the staff member. At some point during the suspect's attack, victim has received a 1cm stab wound in his chest which he had not noticed until it was pointed out. Victim also received a cut to his left hand pinky finger which he also didn't realise until paramedics were assessing him for further injuries. Victim believes that suspect had used a small knife such as a Stanley knife to cause the injury.

The woman believed to be suspects girlfriend then attacks Victim by punching him further when suspect was taken away.

On reviewing the CCTV system, it was apparent that there was serious disorder within and outside the venue. On speaking with the Licence Holder, Mr Flaherty seemed to be unaware of all the facts of the incident and unable to verify details of the SIA company.

During our telephone conversation on Monday 24 June 2024, he did not appear to appreciate the level of seriousness of the incident and presented a lack of knowledge regarding the licensing conditions embedded on the premises licence and upholding the licensing objectives.

Patrons were permitted to enter premises after 01:00hrs and permitted to take open containers outside the defined plan, contrary to Condition:

Condition 5 - Customers shall not be permitted to take open glass containers outside the premises as defined on the plan submitted to and approved by the Licensing Authority.

Condition 6 - No entry or re-entry shall be permitted after 01:00 hours.

On Tuesday 25 June 2024, Mr Flaherty was invited to Brent Civic Centre to discuss the incident in the presence of the Licensing Inspector from Brent Council. Mr Flaherty had invited his security company, the director of Guard Sec International Ltd, to attend the meeting. During the meeting, I raised my serious concerns regarding the incident. Mr Flaherty presented little knowledge of the conditions embedded on the premises licence.

In light that Mr Flaherty had responded to my request to discuss the issues in person as a matter of urgency, I offered him the opportunity to demonstrate that he is a responsible licence holder and DPS by following an action plan with a timeframe. This included a minor variation to add robust conditions as per our agreement

On Friday 28 June 2024, Mr Flaherty confirmed in an email that he was happy to accept the action plan.

It had been noted that Mr Flaherty failed submit the minor variation to impose the above additional conditions by 23 July 2024.

Between July 2024 to September 2024, the Licensing Inspector and I have communicated with Mr Flaherty on numerous occasions to obtain an update about the minor variation. Mr Flaherty advised us that he was either awaiting advice from his solicitors or away due to personal circumstances.

On the 16<sup>th</sup> October 2024 PC Graves, and PC Hicks attended Erin's Hope to conduct a licensing compliance visit and found several breaches to the licence. Both Officers statements attached to the bundle.

#### **Summary**

This incident on the 13<sup>th</sup> October 2024, clearly constitutes violent disorder, involving an assault perpetrated by a trained and licensed Security Industry Authority (SIA) door supervisor. The assailant, who is employed to protect patrons and ensure public safety, reacted inappropriately and violently to a situation involving a drunk individual. His excessive use of force is not in line with the professional conduct expected of trained security staff, whose role includes de-escalating confrontations, not exacerbating them.

Members of the public rely on door staff to maintain order and respond to difficult situations with calm professionalism. The actions of this individual door supervisor, as captured on CCTV, fall far below these expectations and demonstrate a dangerous lapse in judgment.

Venue History and Management Concerns: Erin's Hope has a recent history of violent incidents and poor management oversight. In June 2024, a patron was stabbed by another intoxicated individual wielding a knife. Following this incident, the Premises Licence Holder (PLH) and Designated Premises Supervisor (DPS) met with Licensing Police and Council Licensing Officers. During this meeting, the PLH acknowledged poor management practices and agreed to implement a set of conditions designed to improve the running of the venue. An action plan was established, with a timeframe for introducing these conditions via a minor variation to the premises licence.

However, the PLH/DPS has failed to follow through on these commitments, repeatedly offering excuses for the delay, including personal and legal issues. Despite these claims, the failure to implement agreed conditions suggests a lack of serious engagement with the responsibilities of managing a licensed premises.

The most recent incident is further evidence of poor control and management at Erin's Hope. The lack of oversight has allowed another serious offence to occur, further endangering the public. Police Recommendation: The Police request an immediate suspension of Erin's Hope's premises licence pending a full review. The ongoing lack of proper management, the failure to implement agreed licensing conditions, and the involvement of venue staff in violent disorder create significant concerns for public safety. The Police believe that without immediate intervention, further serious incidents are likely to occur at this venue.

The suspension of the premises licence will allow for a thorough investigation into the operational failures at Erin's Hope and provide time for the subcommittee to consider appropriate long-term measures to address the issues at this establishment.

Actions to be implemented:

Serious Crime & Disorder: In crime report CAD 623/22JUNE24 Police received a report of a 'stabbing' at the Erin's Hope Public House. On arrival, police found a make with a stab wound to upper left torsal. On reviewing the CCTV, it was apparent that there was serious disorder within and outside the venue. On speaking with the Licence Holder, Mr Flaherty, he seemed to be unaware of all the facts of the incident and unable to verify details of the SIA company. During our telephone conversation on Monday 24 June 2024, he did not appear to appreciate the level of seriousness of the incident and presented lack of knowledge regarding the licensing conditions and upholding the licensing objectives. Patrons were permitted to enter premises after 01:00hrs and permitted to take open containers outside the defined plan. Conditions embedded on the premise licence not fully met. To ensure that the prevention of crime and disorder and public safety licensing objectives are upheld at all times, police suggest:

Phase 1 The premises shall remain <u>closed</u> until the following additional conditions to the premises licence have been completed within two (2) weeks from the above start date:

- CCTV shall be installed to Home Office Guidance standards and maintained in a good working condition and recordings shall be kept for 31 days and shall be made available to police and authorised Officers from Brent Council.
- 2. CCTV cameras shall be installed to cover the internal and external areas of the premises.
- 3. The CCTV system shall be capable of obtaining clear facial recognition images and a clear head and shoulders image of every person entering or leaving the premises.
- 4. A staff member from the premises who is conversant with the operation of the CCTV system shall be on the premises at all times when the premises is open. This staff member must be able to provide a Police or Authorised Council Officer copies of recent CCTV images or date with the absolute minimum of delay when requested.
- 5. The Licence holder/Manager shall inspect and test that the CCTV is operational and working correctly on a weekly basis. A signed and dated record of the CCTV examination and any findings shall be kept on the premises and made available to the police and authorised officers of the Local Authority on request.
- 6. All Staff shall be trained (and shall undergo refresher training every 12 months) in respect of the CCTV operation, maintaining the incident log, the challenge 25 policy, prevention of proxy sales, signs of intoxication, dealing with refusal of sales and any subsequent confrontational behaviour from customers, all training records shall be made available for inspection by authorised officers of Brent Council and the Police.
- 7. The premises licence holder or the DPS shall ensure that an "authorisation to sell

alcohol" document is kept and maintained at the premises. Each employee involved in the supply of alcohol at the premises must be named on this document with it being signed off by the DPS.

- A minimum of two SIA registered door supervisors shall be on duty from 20.00 hours on any day that the venue is permitted to serve alcohol beyond 00.00 hours until the close of business.
- A register/log containing the names, badge number, dates & times of duty security staff and any incidents that occur shall be kept and made available to the Police and Licensing Authority

The Licensing Authority Metropolitan Police as the Responsible Authorities under the Licensing Act 2003 reserves the right to initiate a Review of your Premises License and take enforcement action with reference to the commission of offences under the 'Act' should you fail to follow the Action Plan or further evidence suggest you not upholding the licensing objectives.

I must point out that these breaches amount to an offence under section 136 Licensing Act 2003, namely conducting licensable activities without authority, which carries an unlimited fine, and/or up to 6 months imprisonment.

#### 2. The Application

The Application was for an expedited review of the premise licence, pursuant to section 53a of the Licensing Act 2003, upon the application of the police following two serious instances of crime and disorder, the first on 22 June 2024 and the second on 13 October 2024.

#### 3. Representation

The Police were represented by Sergeant Michael Sullivan & Michael Feeney (Counsel).

The designated premises supervisor, John Flaherty, attended together with the premises manager, Ross Leorenza. He was unrepresented.

#### 4. The Hearing

The Chair welcomed attendees and asked them to introduce themselves. There were no interests to declare.

Ms Linda Legister of Brent Licensing introduced the application, explaining that it was a summary review brought by the Metropolitan Police on the basis that there were two

serious instances of crime and disorder at the premises. Ms Legister explained the terms of the review and the options available to the panel once they had heard the review evidence. She explained that the summary review was pending a full review hearing within 28 days.

Counsel for the police addressed the panel. The panel were shown two pieces of CCTV. This part of the hearing was heard in private because there was a public interest in doing so because the footage was part of an ongoing police investigation.

Once back in public, Mr Feeney submitted that on 13 October 2024, one member of the door staff aggressively attacked a member of the public, causing a head wound to open and cause significant bleeding. On 22 June 2024, a physical altercation occurred that started inside the venue and moved outside. This altercation resulted in someone receiving a minor stab wound to the chest. Mr Feeney submitted that the two serious incidents demonstrated scenes of unmanaged chaos caused by inadequate management of the premises. He drew the panel's attention to multiple breaches of the premises licence, including people outside with glass containers and people coming in and out of the venue after 1am, which amount to breaches of the licence.

Secondly, Mr Feeney submitted that the licence holder had failed to engage with the police and responsible authorities. He stated the police did not apply to review the licence lightly and had first sought to engage with the licence holder to work to meet the licence objectives. After the first incident, there was a meeting with the licence holder who agreed to an action plan with a number of conditions. Nevertheless, the licence holder failed to do the steps agreed and despite the police following up on a number of occasions, nothing was done. Mr Feeney argued this showed the licence holder does not understand what was needed to be done and shows he does not take the matter seriously. This track record indicates that nothing will change in the interim period pending full review, and something similar will happen again.

Thirdly, Mr Feeney submitted that there was a lack of oversight and management from the licence holder. After the June incident, the licence holder was completely unaware of what happened, unable to verify the SIA company being used and ignorant to the premises licence conditions. He stated that the position was the same on 16 October 2024, when the police visited the premises following the 13 October 2024 incident. He submitted that the licence holder did not know what happened, did not know the licence conditions and had made no improvements whatsoever. He stated that there was a significant risk the same thing would happen again.

Mr Feeney submitted that taken together, the panel could not be satisfied that any steps short of suspension would stop the violence from happening again. The police were therefore seeking a suspension of the premise licence.

A number of questions were asked of the police by the members of the committee:

The police stated there was a longer history involving a similar incident outside the premises in 2023. The police stated a reduction in hours would be insufficient given the failings of management who were not in control earlier in the evening. The police were not aware of the manager, Mr Leorenza, but Mr Faherty is the designated premises supervisor who is responsible for promoting the licence objectives. The police confirmed that there is no suggestion Mr Flaherty had acted dishonestly, but submitted the scenes of unmanaged chaos indicate that he is out of his depth. The police confirmed there was no evidence of any incidents happening in the rear of the premises, and they confirmed that Mr Flaherty had willingly provided the CCTV evidence to the police without any issues.

The police are aware that Mr Flaherty has held a licence since 2008, but consider that since the first incident in 2023, there have been two serious incidents in 2024, so the concern is they are speeding up. Mr Feeney submitted that you would expect the premises to have been getting better, not worse, since the police have been involved. It was noted that between the June and October 2024 incidents, there were now screens to indicate the area for smoking.

Sergeant Sullivan stated that following the June 2024 incident, the licence holder came in for an open and honest discussion about the breaches and the running of the premises. He stated that Mr Flaherty left him feeling confident that he would sort the issues out and put in a variation application to add in the conditions they had discussed but this was not done. The police expressed a worry that Mr Flaherty was just using words, without following up with his actions.

The police were unaware if the members of the public attending the premises often came from other local pubs. The police stated that were not aware of any incidents which have taken place before midnight that caused them any alarm.

The police stated that the member of the security staff who was outside during the June 2024 incident could not have done more in that instance, as he was alone during most of the incident. The criticism lay with the overall management, drunkenness, people outside with glasses and people being allowed to enter the premises after 1am.

The police informed the panel that in the October 2024 incident, it was a member of the public who called the police. The licence holder stated that the premises management called the police during the June 2024 incident.

The hearing then heard the licence holder's response to the application:

Mr Flaherty stated that the door staff were left to control the incidents. He stated that in June 2024, they called the police themselves. Regarding the October 2024 incident, it occurred outside of the premises. He stated that they had been operating under a licence for approximately 30 years without issue. These events have happened over the last few months, but they have had no problems for the years before that.

He stated that he runs the pub well. They trade 10:00am – 17:00pm, and then again during the evenings. Mr Flaherty stated that they have DJs playing late in the evenings on Friday and Saturdays, closing at 01:30am. Mr Flaherty submitted that since the October 2024 incident, they have been closing the premises between 10:30 - 11pm at night and there have been no further incidents or problems whatsoever.

A number of questions were asked of the premises licence holder by the members of the committee:

Mr Flaherty stated that he visits the premises every day, including on the days of both of these incidents. He became aware of them due to the noise and confusion at the front door. In the June 2024 incident, he knew about the argument because there was shouting and a commotion inside, but the people involved were removed from the premises. The premises do not allow drinking outside or glasses outside, but it is possible there was confusion during these incidents. Mr Flaherty was in the office when the incident started but Mr Leorenza saw the incident on the camera, stopped the argument and ensured the security intervened and put those involved outside. Mr Flaherty stated he filled in the incident book himself.

Mr Flaherty has had a licence since 1994, and owned and run the pub for 30 years. He lives 8-10 minutes away by car. He has one manager, Mr Leorenza, who has worked for him for 18 years and has been a manager for 2.5 years. Mr Leorenza stated that he has had a licence for a year. Mr Flaherty stated he had applied for it. He also has 2 part time staff. Mr Flaherty is heavily involved in the business, he orders the drinks, works on the bar, checks outside and walks around the premises to check people are doing their jobs correctly. Mr Flaherty recruits the door security firm. Mr Flaherty and his staff clean the venue themselves after the shift. The pub closes at 01:30am, and the staff go home by 02:30am.

Sometimes customers come from other venues, such as the Wetherspoons opposite. He stated that no one is allowed in after 01:00am, and the door staff are employed to vet how intoxicated people are and to bar them entry if they are too intoxicated.

Mr Flaherty stated that he did not implement the action plan because he went to his solicitor to obtain advice. His solicitor went on holiday and then stopped communicating with him. Despite attempts to get hold of his solicitor, he has been

unable to contact him. He did not think about applying to remove or change his licence conditions himself but did ask his solicitor for advice about his licence but he has been uncontactable.

Mr Flaherty stated that he knows the door staff personally to see and talk to. They generally tend to get the same door staff but not all of the time. The security staff check whether people are too intoxicated to come in and refuse entry. The bar staff can also refuse to serve people who are too intoxicated, which happens about 5-6 times per month. Mr Flaherty will record this in the incident book once weekly, typically on a Saturday night. The member of security staff during the June 2024 incident is the same as the member of security staff involved in the October 2024 incident.

The late crowd on Friday and Saturday nights are a different crowd to the usual customers. Since this incident, he has sacked the door security staff, stopped the music early and closed the venue early to make sure there is no further trouble.

Mr Flaherty and Mr Leorenza were both unable to tell the Committee any of the 4 licensing objectives.

The police then asked Mr Flaherty a number of questions:

Mr Flaherty accepted that it was his responsibility as the licence holder to control and manage the licence, even though he employed door staff to help control the premises. Mr Flaherty accepted that what happened outside the premises was his problem, but considered when the incident was inside the premises it was contained.

Mr Flaherty stated that he did not implement the measures in the action plan because he was waiting for his solicitor's response. His solicitor went on holiday and then has not responded to him. He did not want to apply to vary the conditions himself because his solicitor did say he would look at it and get back to him before he went quiet. He did try and contact another solicitor, but he had a stroke so was unable to assist.

Mr Flaherty knew that there was a condition on his licence not to use glass containers, but he was using them because his customers would not use his premises if they were given plastic containers to drink from. He did not apply to vary this condition as an unreasonable condition because his solicitor did not respond to him. He did not realise it was a condition on his licence from before the action plan, though this has been a condition in Mr Flaherty's original licence.

The parties were then asked to sum up.

The main 4 points for the police were that firstly, Mr Flaherty had been actively involved in the management of the premises and training staff, but this was not

enough to prevent these incidents from happening. He does not know his licensing objectives and the fact that Mr Flaherty thought the condition to not use glass containers had been added in June 2024, when it had been on his licence since 2005, was symptomatic of a premise licence holder who was not in control.

Secondly, he submitted that Mr Flaherty had failed to recognise the seriousness of the incidents by suggesting it was a well-run pub with door staff in control.

Thirdly, that despite Mr Flaherty owning and running the pub for a long time, the evidence shows it is rapidly deteriorating and getting worse. He is running the pub with very few members of staff who are doing long hours, such that they are overwhelmed and ignoring the licensing objectives.

Finally, no measures short of suspension would be adequate to protect the licensing objectives because Mr Flaherty does not know what the conditions are, and he has ignored the opportunity to alter his licence accordingly. The police are not saying that Mr Flaherty is a bad or dishonest man, but his management is inadequate in a high-risk premises and an incident will happen again if the licence is not suspended.

Mr Flaherty submitted that he had run the pub for 30 years and everything has been ok. They work hard and run the pub in the best way that they can. He accepts what is going to come but they have tried. They got rid of their security company as a result of the incident. They have stopped playing music or opening late on Friday and Saturday evenings to avoid the late crowd. If they are open from 9am to 9pm they would have no problems whatsoever.

The sub-committee went into closed session to consider its decision.

#### 5. Determination of the Application

The sub-committee determined the application in accordance with the Licensing Act 2003 and in accordance with the statutory licensing objectives. The committee had regard to section 182 of the Licensing Act 2003 and the statutory guidance. The authority had regard to section 17 of the Crime and Disorder Act 1998. The committee had regard to the need to reach a decision that was necessary, proportionate and justified on the evidence presented to it.

#### 6. Decision:

The committee's decision is as follows:

The committee has read the papers and listened carefully to the evidence and submissions presented at the hearing. The committee is mindful of its duty under

the Licensing Act 2003 section 53b to take such steps as it considers necessary to

promote the licensing objectives.

Although the licence holder has recently implemented earlier closing hours on Friday and Saturday evenings, with no music on Friday and Saturday evenings, the committee considers that the fact the premises licence holder has failed to implement the action plan, which was accepted on 25 June 2024, they have no confidence that these steps will be sufficient to promote the licensing objectives. The committee are also concerned by the premise licence holder's lack of knowledge of the licensing objectives, or proposals, to fill the committee with such confidence to fulfil the licensing objectives, by both the premises licence holder

and the manager.

The committee has decided to suspend the licence pending full review with

immediate effect.

7. Right of appeal

There is no appeal against Interim Steps.

The premises licence holder may make representations against the interim steps taken by the licensing authority. There is no time limit to make the representations,

however these may be superseded by the full review.

# <u>Erin's Hope 189 Edgware Road NW9 4DS – To Replace Existing Conditions & Hours</u>

1.CCTV shall be installed to Home Office Guidance standards and maintained in a good working condition and recordings shall be kept for 31 days and shall be made available to police and authorised Officers from Brent Council (New Replacement Condition).

To Replace Current Condition 1 - CCTV shall be installed and maintained in a working condition.

To Replace Current Condition 2 - All CCTV recordings shall be kept for 14 days and shall be made available to police and licensing officers if requested.

- 2.CCTV cameras shall be installed to cover the internal and external areas of the premises (New Condition).
- 3. The CCTV system shall be capable of obtaining clear facial recognition images and a clear head and shoulders image of every person entering or leaving the premises (New Condition).
- 4. A staff member from the premises who is conversant with the operation of the CCTV system shall be on the premises at all times when the premises is open. This staff member must be able to provide a Police or Authorised Council Officer copies of recent CCTV images or date with the absolute minimum of delay when requested (New Condition).
- 5. The Licence holder/Manager shall inspect and test that the CCTV is operational and working correctly on a weekly basis. A signed and dated record of the CCTV examination and any findings shall be kept on the premises and made available to the police and authorised officers of the Local Authority on request (New Condition).
- 6. All Staff shall be trained (and shall undergo refresher training every 12 months) in respect of the CCTV operation, maintaining the incident log, the challenge 25 policy, prevention of proxy sales, signs of intoxication, dealing with refusal of sales and any subsequent confrontational behaviour from customers. All training records shall be made available for inspection by authorised officers of Brent Council and the Police (New Condition).
- 7. No entry or re-entry shall be permitted after 21:00 hours.

To Replace Current Condition 6 - No entry or re-entry shall be permitted after 01:00 hours.

- 8. The premises licence holder or the DPS shall ensure that an "authorisation to sell alcohol" document is kept and maintained at the premises. Each employee involved in the supply of alcohol at the premises must be named on this document with it being signed off by the DPS (New Condition).
- 9. Customers permitted to temporarily leave and then re-enter the premises to smoke must be restricted to a designated smoking outside premises facing Edgware Road, with suitable barriers. No more than five (5) customers will be permitted to remain in

the designated smoking area at any one time from 20:00hrs until the close of business (New Condition).

- 10. An incident log shall be kept at the premises, and made available for inspection on request to an authorised officer of Brent Council or the Police, which will record the following:
- (a) all crimes reported to the venue
- (b) all ejections of patrons
- (c) any complaints received
- (d) any incidents of disorder
- (e) all seizures of drugs or offensive weapons
- (f) any faults in the CCTV system
- (g) any refusal of the sale of alcohol
- (h) any visit by a relevant authority or emergency service.

#### (New Condition)

- 11. A copy of the premises licence summary including the hours which licensable activities are permitted shall be visible from the outside of each entrance to the premises (Current Condition 4).
- 12. Customers shall not be permitted to take open glass containers outside the premises as defined on the plan submitted to and approved by the Licensing Authority (Current Condition 5).
- 13. The total number of people permitted on the premises including staff and performers shall not exceed 100 (Current Condition 7).

Licensing Act 2003 (Section 53A) – Summary Review Re: Erin's Hope, 189 Edgware Road, NW9 6LP

The Brent Police Licensing Team initiated a Summary Review of Erin's Hope Public House following a series of serious violent incidents at the venue. These incidents occurred in close succession. The first, in June 2024, involved a customer being stabbed by another patron. The most recent incident, in October 2024, saw a member of the door staff assault a member of the public. Both crimes took place in the early hours of the morning.

Following the sub-committee hearing held on Monday, 21 October 2024, I wish to formally submit supplementary evidence in support of the expedited review initiated due to serious incidents occurring at the premises in both June and October 2024.

Upon reviewing the historical reports and records associated with the premises, it is evident that the recent incidents stem from ongoing issues related to inadequate management practices. The nature of the incidents while serious points to mismanagement as the underlying cause.

These issues, if not addressed, may continue to undermine the promotion of the licensing objectives, specifically the prevention of crime and disorder and the promotion of public safety.

It is acknowledged that Mr Flaherty, the premises licence holder and Designated Premises Supervisor (DPS), has operated this establishment for several years, and it holds a longstanding presence within the local community.

During the sub-committee heraing, I appreciate his cooperation in the hearing and his proactive measures, including the voluntary reduction in opening hours and the cessation of regulated entertainment on receipt of the Summary Review. These are positive steps; however, they may not fully mitigate the risks identified without additional oversight and structural changes.

The police engaged with Mr Flaherty, following the initial incident and identified several breaches of the venue's licence conditions. An action plan was developed and agreed upon by Mr Flaherty in an effort to mitigate the risk of further serious incidents. As part of this, Mr. Flaherty was asked, and agreed, to submit a minor variation to the licence to incorporate these conditions.

Despite multiple attempts by the police and local authorities to contact Mr Flaherty regarding the submission of the variation, this has not been completed. Mr. Flaherty has consistently cited personal issues or unresponsive legal counsel as reasons for the delays.

Research indicates that several serious incidents, including violence and anti-social behaviour, have occurred in connection with the premises over the past few years. Additionally, numerous licence breaches have been identified during this time, such as failures in CCTV recording. In particular, recent incidents this year highlighted further shortcomings, as noted in both a warning letter and the agreed action plan.

Analysis of the timing of these incidents reveals that they often occur in the early hours when patrons are leaving other local licensed establishments. During the summary review, Mr Flaherty acknowledged that this contributes significantly to violence at the venue.

Despite the presence of SIA door staff, their effectiveness in upholding licensing objectives has been minimal. CCTV footage shows instances of drunkenness, patrons being permitted outside with alcohol, and a general lack of control at the entrance. In fact, the latest CCTV footage suggests that the door staff themselves may have instigated the violence.

Mr Flaherty has sought to distance himself from the disorder by claiming it occurred outside the venue and that the door staff are not his responsibility. He has also stated that he has managed pubs for 30 years without prior issues. However, reports to the police over the past few years indicate a pattern of disorder, licence breaches, and antisocial behaviour complaints linked to the premises.

At the hearing, Mr Flaherty attempted to portray the operation of his venue as trouble-free, attributing recent incidents to external factors rather than to himself or the pub. However, when questioned by the sub-committee regarding the conditions attached to the venue's license, it became evident that he was unfamiliar with them. Upon being challenged about potential breaches, Mr Flaherty grew defensive, asserting that his regular patrons would not accept such conditions.

When asked to outline the four licensing objectives, Mr Flaherty was unable to demonstrate any knowledge of them. Further inquiries were made about the pub's operating hours and staffing levels, to which he responded that the pub was open from 9 a.m. until the early hours of the morning, seven days a week. He mentioned that both he and his manager worked full-time, with two part-time staff covering the remaining hours.

The committee expressed concern that this staffing arrangement was unsustainable for such extended hours and could be contributing to the pub's operational challenges, a point to which Mr Flaherty reluctantly agreed.

Of particular concern were two recent incidents involving violence in close succession. Mr Flaherty had been given an opportunity to address the issues by agreeing to an action plan, but for reasons known to him, he declined to take advantage of the assistance offered by both the Police and the Council's licensing team. This failure to act prompted the Police to initiate a summary review.

After reviewing the recent incidents and the pub's history, the Police concluded that the venue could still be successful if Mr Flaherty took steps to comply with the conditions recommended by law enforcement. It was noted that many of the incidents occurred in the early hours of the morning, often involving individuals leaving other venues or already intoxicated.

Given the pub's location on the busy A5 road, which sees significant foot traffic, the Police recommended reducing the venue's operating hours, proposing a closing time of 11 p.m. to mitigate the risk of violence.

Mr Flaherty informed the committee that he had already implemented this earlier closing time since the most recent incident and believed it was effective. He further noted that his busiest periods were earlier in the day and during the early evening, with little activity afterward aside from patrons seeking additional alcohol late at night. He mentioned that he had also discontinued DJ nights and stated that imposing this earlier closing time would not significantly impact the business.

ASB from the pub Erin hope music very loud till 2am drunks urinating on the Indian restaurant shutters informant confronted then and got abused signs are up on lamppost about drinking in the street, Informant phoned the council out of hour but nothing could be done that night, reported to Barnet council Monday morning and made a report, informant has spoken to officers many times about the drinking in the streets but nothing's been done also there are people drinking outside now at 8pm.

In light of the above, I would respectfully recommend the imposition of the following robust conditions to ensure future compliance and assist Mr Flaherty in promoting the licensing objectives effectively (Exhibit MJS/08).

These conditions are intended to support Mr Flaherty in maintaining a safe and responsible environment at the premises, while also addressing the concerns raised by the serious incidents earlier this year. The aim is to safeguard public safety and ensure ongoing compliance with the Licensing Act 2003.

CCTV Coverage: The installation and maintenance of high-quality CCTV cameras, covering all key areas both inside and outside the premises, with a minimum retention period for footage of 31 days.

Staff Training: Mandatory training for all staff on the prevention of crime and disorder, responsible alcohol retailing, and the proper handling of incidents involving public safety. This training should be updated regularly, with records maintained for inspection.

Enhanced Operating Hours Restrictions: Formalisation of reduced opening hours to limit the risk of late-night disorder.

In consideration of the incidents that occurred after midnight, it would be prudent to adjust the operating hours, limiting them to a terminal hour of midnight from Monday to Sunday, it is clear that the premises were serving alcohol to intoxicated patrons, which contributed to the escalation of the altercation in June 2024.

I trust that the sub-committee will consider these recommendations carefully as part of the expedited review process.



# <u>Erin's Hope 189 Edgware Road NW9 4DS – To Replace Existing Conditions & Hours</u>

1.CCTV shall be installed to Home Office Guidance standards and maintained in a good working condition and recordings shall be kept for 31 days and shall be made available to police and authorised Officers from Brent Council (New Replacement Condition).

To Replace Current Condition 1 - CCTV shall be installed and maintained in a working condition.

To Replace Current Condition 2 - All CCTV recordings shall be kept for 14 days and shall be made available to police and licensing officers if requested.

- 2.CCTV cameras shall be installed to cover the internal and external areas of the premises (New Condition).
- 3. The CCTV system shall be capable of obtaining clear facial recognition images and a clear head and shoulders image of every person entering or leaving the premises (New Condition).
- 4. A staff member from the premises who is conversant with the operation of the CCTV system shall be on the premises at all times when the premises is open. This staff member must be able to provide a Police or Authorised Council Officer copies of recent CCTV images or date with the absolute minimum of delay when requested (New Condition).
- 5. The Licence holder/Manager shall inspect and test that the CCTV is operational and working correctly on a weekly basis. A signed and dated record of the CCTV examination and any findings shall be kept on the premises and made available to the police and authorised officers of the Local Authority on request (New Condition).
- 6. All Staff shall be trained (and shall undergo refresher training every 12 months) in respect of the CCTV operation, maintaining the incident log, the challenge 25 policy, prevention of proxy sales, signs of intoxication, dealing with refusal of sales and any subsequent confrontational behaviour from customers. All training records shall be made available for inspection by authorised officers of Brent Council and the Police (New Condition).
- 7. No entry or re-entry shall be permitted an hour before the closing hour.

# To Replace Current Condition 6 - No entry or re-entry shall be permitted after 01:00 hours.

- 8. The premises licence holder or the DPS shall ensure that an "authorisation to sell alcohol" document is kept and maintained at the premises. Each employee involved in the supply of alcohol at the premises must be named on this document with it being signed off by the DPS (New Condition).
- 9. Customers permitted to temporarily leave and then re-enter the premises to smoke must be restricted to a designated smoking outside premises facing Edgware Road, with suitable barriers. No more than five (5) customers will be permitted to remain in

the designated smoking area at any one time from 20:00hrs until the close of business (New Condition).

- 10. An incident log shall be kept at the premises, and made available for inspection on request to an authorised officer of Brent Council or the Police, which will record the following:
- (a) all crimes reported to the venue
- (b) all ejections of patrons
- (c) any complaints received
- (d) any incidents of disorder
- (e) all seizures of drugs or offensive weapons
- (f) any faults in the CCTV system
- (g) any refusal of the sale of alcohol
- (h) any visit by a relevant authority or emergency service.

## (New Condition)

- 11. A copy of the premises licence summary including the hours which licensable activities are permitted shall be visible from the outside of each entrance to the premises (Current Condition 4).
- 12. Customers shall not be permitted to take open glass containers outside the premises as defined on the plan submitted to and approved by the Licensing Authority (Current Condition 5).
- 13. The total number of people permitted on the premises including staff and performers shall not exceed 100 (Current Condition 7).
- 14. A "Challenge 25" policy shall be adopted and adhered to at all times (**New Replacement Condition**).

To Replace Current Condition 11 – The Portman Group proof of age scheme or similar such scheme shall be adopted.

- 15. A suitable burglar alarm shall be fitted and maintained (Current Condition 10).
- 16. Notices clearly explaining the licensee's drugs policy shall be displayed at the entrance and at suitable places throughout the premises (Current Condition 12).
- 17. All furniture and soft furnishings shall comply with relevant fire safety standards (Current Condition 13).
- 18. A fire detection and warning system together with suitable and sufficient fire extinguishers shall be installed and maintained (Current Condition 14).
- 19. An emergency lighting system shall be installed and maintained in good order (Current Condition 15).

- 20. All deliveries shall take place during the normal working day (i.e. 09:0 to 18:00 daily) (Current Condition 18).
- 21. Notices asking customers to leave quietly shall be conspicuously displayed at all exits (Current Condition 19).
- 22. Nudity, striptease and other entertainment of an adult nature shall not be permitted on the premises (Current Condition 20).
- 23. No children under 16 shall be admitted unless accompanied by a responsible adult (Current Condition 21).
- 24. All alcohol and soft drinks shall be served in plastic or toughened glasses when the premises is open to the public on Friday and Saturday.

# To Replace Current Condition 9 - All alcohol and soft drinks shall be served in plastic or toughened glasses

- 25. A minimum of two SIA registered door supervisors shall be on duty from 20.00 hours on any day that the venue is permitted to serve alcohol beyond 00.00 hours until the close of business (**New Condition**).
- 26. A register/log containing the names, badge number, dates & times of duty security staff and any incidents that occur shall be kept and made available to the Police and Licensing Authority (New Condition).
- 27. Door supervisors shall wear clothing that can be clearly and easily identified on CCTV (New Condition).

### **Current Conditions to be Removed:**

Current Condition 8 – The licensee or his/her deputy shall be a member of, and actively participate in the local pubwatch scheme.

Current Condition 16 - Notices advertising the number of a local licensed taxi service shall be displayed in a prominent position.

Current Condition 17 - Public transport information including night time travel options shall be made available.
