If a Member is aware they have a Personal Interest\*\* in an item of business, they must declare its existence and nature at the start of the meeting or when it becomes apparent.

If the Personal Interest is also significant enough to affect your judgement of a public interest and either it affects a financial position or relates to a regulatory matter then after disclosing the interest to the meeting the Member must leave the room without participating in discussion of the item, except that they may first make representations, answer questions or give evidence relating to the matter, provided that the public are allowed to attend the meeting for those purposes.

#### \*Disclosable Pecuniary Interests:

- (a) **Employment, etc. -** Any employment, office, trade, profession or vocation carried on for profit gain.

- (e) **Licences-** Any licence to occupy land in the council's area for a month or longer.
- (f) **Corporate tenancies -** Any tenancy between the council and a body in which the Councillor or their partner have a beneficial interest.
- (g) **Securities -** Any beneficial interest in securities of a body which has a place of business or land in the council's area, if the total nominal value of the securities exceeds £25,000 or one hundredth of the total issued share capital of that body or of any one class of its issued share capital.

This application cannot be used to vary the licence so as to extend the period for which the licence has effect or to vary substantially the premises to which it relates. If you wish to make that type of change to the premises licence, you should make a new premises licence application under section 17 of the Licensing Act 2003.

- 1. You do not have to pay a fee if the only purpose of the variation for which you are applying is to avoid becoming liable for the late night levy
- 2. Describe the premises. For example, the type of premises, its general situation and layout and any other information which could be relevant to the licensing objectives. Where your application includes off-supplies of alcohol and you intend to provide a place of consumption of these off-supplies of alcohol, you must include a description of where the place will be and its proximity to the premises.

  - Indoor sporting events: no licence is required for performances between 08.00 and 23.00 on any day, provided that the audience does not exceed 1000.
  - Boxing or Wrestling Entertainment: no licence is required for a contest, exhibition or display of Greco-Roman wrestling, or freestyle wrestling between 08.00 and 23.00 on any day, provided that the audience does not exceed 1000. Combined fighting sports defined as a contest, exhibition or display which combines boxing or wrestling with one or more martial arts are licensable as a boxing or wrestling entertainment rather than an indoor sporting event.
  - Live music: no licence permission is required for:
    - o a performance of unamplified live music between 08.00 and 23.00 on any day, on any premises.
    - o a performance of amplified live music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
    - o a performance of amplified live music between 08.00 and 23.00 on any day, in a workplace that is not licensed to sell alcohol on those premises, provided that the audience does not exceed 500.
    - o a performance of amplified live music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
    - o a performance of amplified live music between 08.00 and 23.00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local authority concerned, or (ii) the school or (iii) the health care provider for the hospital.

- Recorded Music: no licence permission is required for:
  - o any playing of recorded music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
  - o any playing of recorded music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
  - o any playing of recorded music between 08.00 and 23.00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local authority concerned, or (ii) the school proprietor or (iii) the health care provider for the hospital.
- Dance: no licence is required for performances between 08.00 and 23.00 on any day, provided that the audience does not exceed 500. However, a performance which amounts to adult entertainment remains licensable.
- Cross activity exemptions: no licence is required between 08.00 and 23.00 on any day, with no limit on audience size for:
  - any entertainment taking place on the premises of the local authority where the entertainment is provided by or on behalf of the local authority;
  - o any entertainment taking place on the hospital premises of the health care provider where the entertainment is provided by or on behalf of the health care provider;
  - o any entertainment taking place on the premises of the school where the entertainment is provided by or on behalf of the school proprietor; and
  - o any entertainment (excluding films and a boxing or wrestling entertainment) taking place at a travelling circus, provided that (a) it takes place within a moveable structure that accommodates the audience, and (b) that the travelling circus has not been located on the same site for more than 28 consecutive days.
- 4. Where taking place in a building or other structure please tick as appropriate (indoors may include a tent).
- 5. For example state type of activity to be authorised, if not already stated, and give relevant further details, for example (but not exclusively) whether or not music will be amplified or unamplified.

Licensing Representation to the Variation Application for the Premises Licence at Recanto Kings, Unit 25 Sapcote Trading Centre, 374 High Road, NW10 2DH

I certify that I have considered the application shown above and I wish to make a representation that the likely effect of the grant of the application is detrimental to the Licensing Objectives for the reasons indicated below.

An officer of the Licensing Authority, in whose area the premises are situated, who is authroised for the purposes of exercising its statutory function as a 'Responsible Authority' under the Licensing Act 2003.

The application has been made to vary the premises licence under section 34 of the Act.

The Licensing Authority representations are primarily concerned with the four licensing objectives;

- the prevention of crime and disorder;
- public safety;
- the prevention of public nuisance; and
- the protection of children from harm.

#### **Background**

The initial premises was granted in June 2024 for the supply of alcohol from 10:00hrs to 23:00hrs.

In October 2024, the licence holder applied for a variation of the premises licence. The application seeked to extend the licensable area of the business to include the seating outside. To extend or add the following:

- Sale of Alcohol hours Sunday to Thursday from 10:00 Am Until 00:00, on Fridays and Saturdays from 10:00 Am Until 01:30 Am
- To add Late Night Refreshment Sundays to Thursday from 23:00 until 00:00
- To Regulated Entertainment Sunday to Thursday from 23:00 Until 00:00 and Friday and Saturday from 23:00hrs until 01:30hrs.

The variation application was granted in November 2024 with added conditions.

Current Full Variation Application submitted on 4 July 2025 seeks to extend:

- the Sale of Alcohol hours Sunday to Thursday from 10:00 Am Until 01:30 Am, on Fridays, Saturdays and Sundays from 10:00 Am Until 02:30 Am;
- To add Late Night Refreshment Sundays to Thursday from 23:00 Until 01:30 and on Friday, Saturday and Sundays from 10:00 Am Until 02:30 Am
- Add Regulated Entertainment Sunday to Thursday from 23:00 Until 01:30 and on Friday, Saturday and Sunday from 23:00 Until 02:30 Am

#### **History of Compliants and Non Compliances**

#### Complaint 1

9 July 2024 - Complaint made reference to overcrowding, staff selling alcohol to intoxicated patrons, disorderly conduct taking place without any mitigation by staff, patrons taking glass drinking vessels outside to the front area and patrons using their vehicles antisocially upon ingress/egress to the premises. In addition, it also referred to someone being run over.

17 July 2024 - An inspection carried out at the premises. Issues mentioned within the complaint were raised. The employee, confirmed that it was a singer from his premises who was injured. They stated that the speeding cars are not his patrons, and that they are a local issue. He clarified that his premises provided CCTV to the police. also confirmed that the premises only provides alcohol in addition to a seated table meal. During the inspection, it was noted that the premises were making use of the front external area however this was not on the premises plan. Further to this, certain conditions within annex two were not being complied with.

23 July 2024 - Warning letter issued. Appendix EC/01

#### Complaint 2

2 September 2024 - Complaint made to Council stipulating in reference to the premises that "Loud music every night and general antisocial behaviour.", "a place that has live music every night till about 12-1 am every night", & "Shouting and screaming people.".

5 September 2024 - Inspection carried out at the premises to follow up on previous visit and make the premises licence holder aware of the complaint that pertains to noise issues. As per previous warning letter, the premises licence holder had taken steps to comply with the conditions 6, 7, 8,

10, 15 & 21. The non-compliant matters were that his CCTV only went as far back as 7 days and that he was unable to produce an incident log. From the CCTV that he could provide, there was no evidence that licensable activities were being undertaken beyond the hours permitted of his premises licence.

#### **Complaint 3**

5 September 2024 – Nuisance Control Team informed the Licensing Authority an additional noise complaint relating to Recanto Kings.

16 September 2024 - Advisory letter issued to the premises licence holder (PLH) stating that the Licensing Authority were made aware of two noise complaints and that he should be mindful about taking steps to reduce any possible noise breakout. Further request that the PLH also rectifies his CCTV so the data is retained for 31 days and purchases an incident log. A copy of the letter also sent to the Met Police and Nuisance Control Team (Appendix EC/02).

23 September 2024 - Confirmation that the PLH has purchased a logbook and included the previous two licensing visits, thereby adhering to the relevant condition.

26 September 2024 - Stills from CCTV provided that shows that the footage has been increased (12 days from the submission of the photo and the date stipulated on the stills) - therefore indicating that the retention storage has been updated. Additional advice provided to ensure remind the PLH to be mindful of any live music undertaken and to put in measures to reduce any possible noise breakout.

#### **Complaint 4**

17 January 2025 – Nuisance Control Team contacted the Licensing Authority to make us aware of a complaint that the department had received via the NoiseApp on 8 January 2024. Nuisance Control Officer confirmed that they would follow it up from a Nuisance Control Team position, however, Nuisance requested that the Licensing Authority also follow this up from a LA2003 position.

21 January 2025 - A visit to the premises was conducted and Licensing Officer informed Mr that a noise complaint about his premises was received. Verbal advise given that he might wish to be mindful of the volume of noise pertaining to any live/recorded music. Mr agreed to provide any CCTV once specific dates that relate to the complaint were provided.

28 January 2025 - Confirmation from the Nuisance Control Team stating that the complainant is unable to use Noise App, therefore no dates can be ascertained. Furthermore, Nuisance Control Team also confirmed that they did a visit on Saturday 25 January 2025 at 23:15, however did not detect excessive noise from the premises.

24 February 2025 - Response from complainant confirming address as close to the premises and a list of dates with respective descriptions relating to the allegation of noise. Response provided to the complainant advising her to provide Brent Nuisance Control Team with the respective log sheets, so that they can investigate further and that the Licensing Authority will review the CCTV in due course - however the point was made that if the CCTV did not align, then it could be from a different premises.

25 February 2025 - Diary sheets provided to Brent from complainant via email. Brent Nuisance Control Team respond with out of hours contact number so that they can carry out a noise assessment in person.

#### Closure Notice – Section 19 Criminal Justice and Police Act 2001

11 July 2025 - Licensing Police issued a Closure Notice at 21:32hrs after discovering a number of breaches, namely:

Condition 14 - Alcohol shall only be provided as an accompaniment to a main meal in the restaurant area as defined on the plans submitted to the licensing authority.

Condition 15 - Customers shall not be permitted to take any open drink containers outside the premises as defined on the plan submitted to and approved by the Licensing Authority.

Condition 21 - Staff training must be documented and based on legislation and operating procedures. All training shall be signed and dated and a copy of such records will be available for inspection by Police and local authority enforcement officers.

Condition 24 - An incident log shall be kept at the premises, and made available for inspection on request to an authorised officer of Brent Council or the Police, which will record the following:

- (a) all crimes reported to the venue
- (b) all ejections of patrons
- (c) any complaints received
- (d) any incidents of disorder
- (e) all seizures of drugs or offensive weapons
- (f) any faults in the CCTV system
- (g) any refusal of the sale of alcohol
- (h) any visit by a relevant authority or emergency service.

The Licensing Authority received a copy Closure Notice Section 19 (Appendix EC/03) and Notification of alleged offences under the Licensing Act 2003 (Appendix EC/04) on15 July 2025.

#### **Consultation Visit**

On Tuesday 22 July 2025, I visited the premises and spoke with the Events Manager, Ms in respect of the current variation to extend the hours of licensable activities.

Ms was aware of the recent Closure Notice Section 19 issued by the Police and familiar with the breaches identified at the time of their visit.


She advised me that live singing and karaoke are provided on Thursdays to Sundays between 21:00hrs to 23:00hrs.

Ms was asked how she would mitigate noise emanating from the premises, she stated that a noise limiter has been installed, although the levels have not been set to a standard agreed by the Council. Alogside, the noise limiter, staff undertake regular external checks to assess noise levels

Ms is not aware of any complaints and as far as she is aware, there are no residential dwellings in the vicinity.

# <u>Plan</u>

During my visit, it has been noted that layout of the premises does not coincide with the plan attached to the premises licence. The stage has been relocated and there is a small bar by the front entrance.

The Licensing Authority has considered the variation application in light of ongoing concerns and representations made by responsible authorities.

It is noted that the premises has been subject to a number of complaints and identified breaches, as evidenced by both the Police and the Licensing Officer. These concerns raise questions regarding the current management and operational standards of the venue.

Of particular concern is the recent introduction of a new bar area within the premises. Police observations from 11 July 2025 suggest this facilitates vertical drinking, which is considered to increase the potential for disorder and noise, particularly in late evening hours.

Furthermore, the premises is located in close proximity to residential dwellings. The Licensing Authority has received allegations of noise nuisance, and it appears the premises does not operate under an effective Noise Management Plan to mitigate impact on nearby residents.

In light of the above, the Licensing Authority is not satisfied that the promotion of the licensing objectives, particularly the prevention of public nuisance and the prevention of crime and disorder, will be upheld by granting this variation.

#### Recommendation

The Licensing Authority recommends **refusal** of the variation application to extend licensable activities.

Section 136 - Unauthorised licensable activities (Non-compliance of conditions)

Recanto Kings, Unit 25 Sapcote Trading Centre, 374 High Road, NW10 2DH (Premises licence number: 31677)

Following on from an inspection carried out at the above premises on Wednesday 17 May 2024, Brent London Borough Council's Licensing Department do not have any major concerns regarding your management of the premises.

The reason for my visit was that I had recently received a complaint alleging that the premises had issues with overcrowding, staff selling alcohol to intoxicated patrons, disorderly conduct taking place without any mitigation by staff, patrons taking glass drinking vessels outside to the front area and patrons using their vehicles antisocially upon ingress/egress to the premises.

Although I am mindful that some complaints made to the Council might be malicious, it should be worthwhile noting that the Licensing Authority has a duty to investigate any complaint made. As this premises licence has only been recently granted, I am happy to treat the above complaint in insolation. With that said, should further complaints be made, there will be further levels of scrutiny applied (I.e., checking CCTV of random dates etc..).

Nonetheless, as a consequence of my visit to the premises, it is the view of the Licensing Authority that whilst there is not any evidence to suggest that you are undermining any of licensing four objectives (The prevention of crime and disorder, public safety, the prevention of public nuisance and the protection of children from harm) – there does seem that there are a few issues regarding the compliance of certain conditions set out within annex two of your premises licence.

I do appreciate that your employee was fully co-operative and helpful during my visit. It was however fairly apparent that some annex two conditions were clearly not being compiled with, although I did note there was an element of willingness to become fully compliant.

I think you should be mindful of the fact that failure to adhere to any of the conditions stipulated within your premises licence could result in you committing a criminal offence each you undertake licensable activities (i.e., the sale of alcohol). This is pursuant to Section 136(1)(a) of the Licensing Act 2003 (Unauthorised licensable activities) as any sale of alcohol made would not be in accordance with the lawful authorisation of your premises licence.

Offences committed under the Licensing Act 2003 and/or further non-compliance of conditions in addition to further complaints being made could result in the premises licence being called into review where it could ultimately be revoked.

Furthermore, as you are personally liable for any offences committed under the Licensing Act 2003 in relation to the premises licence, you could also face an unlimited fine and/or be imprisoned for up to 6 months if prosecuted.

As such, I believe it's only fair that we give you one calendar month to try and rectify the matters relating to the non-compliance of your conditions. I don't foresee any of them being particularly difficult to resolve.

I therefore request that you contact me by **Friday 23 August 2024** via email to confirm that you have carried out the necessary provisions to be compliant with the conditions of your premises licence. I have included guidance that can be found enclosed at the rear of this letter.

Of course, if you do have any questions regarding this letter, please feel free to email me using the above details at any time and I will be willing to assist you as much as possible.

# <u>List of conditions and recommended actions.</u>

Recommend actions for Mr to take to rectify breaches of premises licence annex two conditions in respect to Recanto Kings, following an inspection on Wednesday 17 May 2024:

# Annex Two, Condition 4

4. A member of staff trained in the use of the CCTV system shall be available at the premise at all times that the premises are open to the public.

Inspection – Whilst your CCTV operation adheres to the conditions 1, 2, 3 & 5. I am of the viewpoint that this condition is not being fully complied with. Whilst your staff do have access to the CCTV monitor, I believe the intention of this condition is to be able to provide CCTV to any authorised Officer or Police Officer upon request. I understand that most modern CCTV footage are stored/retained on mobile devices these days, however this is usually only accessible for one person. As such, unless you are always at the premises whilst it is open to the public and undertaking licensable activities, then perhaps it could be possible that premises are breaching this condition each time that you leave physically the premises.

Recommendation – I would advise you to add an additional condition by submitting a minor variation to the Licensing Authority. A condition such as "CCTV footage shall be made available to the Police and any authorised Officers from Brent Council upon request. CCTV footage shall be provided by email, drop box link or any kind of removable media (I.e., USB, hard drive, CD etc..) within 24 hours of request." would suffice. Equally, you can ensure that all staff can provide CCTV if requested.

# Annex Two, Condition 7 & 8.

- 7. A "Challenge 25" policy shall be adopted and adhered to at all times
- 8. A sign stating "No proof of age -- No sale" shall be displayed at the point of sale.

Inspection – A challenge 25 policy has been undertaken by the premises; however, the respective poster was not displayed. Further to this, there was not a notice stating "No proof of age – no sale" either.

Recommendation – Whilst Valdcy confirmed that he would put up the challenge 25 poster behind the service area, an additional poster will need to be displayed that states "No proof of age – no sale".

Offence – Failure to adhere to this condition breaches Section 136(1)(a) of the Licensing Act 2003 (Unauthorised licensable activities).

# Annex Two, Condition 6 & 10.

- 6. CCTV signage will be displayed, reminding customers that CCTV is in operation.
- 10. Notices asking customers to leave quietly shall be conspicuously displayed at all exits

Inspection – No such signage was displayed at the premises.

Recommendation – To put up signage stating that CCTV is in operation and a notice by the exit requesting that patrons leave the premises quietly. I have included examples of these below:

Offence – Failure to adhere to this condition breaches Section 136(1)(a) of the Licensing Act 2003 (Unauthorised licensable activities).

# Annex Two, Condition 15.

15. Customers shall not be permitted to take any open drink containers outside the premises as defined on the plan submitted to and approved by the Licensing Authority.

Inspection – Valdcy confirmed that patrons take open alcoholic drinks outside to the front area of the premises. As such this would usually be in breach of this condition, given the external area used by the premises is not on the premises plan.

It should be noted however that this condition is suspended pursuant to 172F(5) of the Licensing Act 2003 in which the Business and Planning Act 2020 temporarily amended the legislation. This effectively means that any conditions that pertains to off sales being sold in any open container are suspended for all intents and purposes.

This legislative provision that suspends the conditions pertaining "open alcoholic drink containers" is due to expire on 31 March 2025.

Recommendation – Once this legislative provision expires, should any patron take their drink outside the plan (which only covers the internal area of the premises), then an offence under the Licensing Act 2003 would take place. To rectify this, you can submit a minor variation application to update the premises plan and have the front area included for "consumption purposes only".

Offence – Failure to adhere to this condition breaches Section 136(1)(a) of the Licensing Act 2003 (Unauthorised licensable activities).

# Annex Two, Condition 17.

17. A suitable intruder alarm complete with panic button shall be fitted and maintained.

Inspection – Unless there was a misunderstanding, there was no such alarm installed at the premises.

Recommendation – If you feel it's unnecessary to install an intruder alarm with a panic button, you can request to remove this condition by way of a minor variation.

Offence – Failure to adhere to this condition breaches Section 136(1)(a) of the Licensing Act 2003 (Unauthorised licensable activities).

Annex Two, Condition 21

Page 4 of 6

21. Staff training must be documented and based on legislation and operating procedures. All training shall be signed and dated and a copy of such records will be available for inspection by Police and local authority enforcement officers.

Inspection – Valdcy confirmed that no training takes place at the premises.

Recommendation - Whilst I appreciate that this condition leans heavily upon one's interpretation of what "Legislation and operating procedures" exactly entails as a topic of training - I believe that there are reasonable steps that you can take as a licence holder to comply with this condition and to show responsible management of a licenced premises.

As mentioned previously, there is a duty placed upon you as the licence holder to promote the four licensing objectives. Ensuring all staff who are engaged in selling alcohol are adequately trained in doing so would consequently be seen as a pro-active measure undertaken by you to promote all four licensing objectives. Furthermore, evidencing that this training/refresher training has taken place would go even further in satisfying this condition.

Therefore, I have attached a document at the rear of this letter named "Authorisation list for the sale of alcohol". Completing this document with each member of your staff who sells alcohol at the premises works two-fold for you. It ensures compliancy with the above condition and evidences a written record that you have provided "Legislation and operating procedures" training to staff members. Additionally, it also shows that the DPS has given authorisation for that member of staff to sell alcohol. Upon completion of the training, the staff member can include their name, signature, and date to the list.

I would also advise that all staff members are trained on a yearly basis, with new staff members trained upon employment.

Offence – Failure to adhere to this condition breaches Section 136(1)(a) of the Licensing Act 2003 (Unauthorised licensable activities).

# Annex Two, Condition 24

- 24. An incident log shall be kept at the premises, and made available for inspection on request to an authorised officer of Brent Council or the Police, which will record the following:
- (a) all crimes reported to the venue
- (b) all ejections of patrons
- (c) any complaints received
- (d) any incidents of disorder
- (e) all seizures of drugs or offensive weapons
- (f) any faults in the CCTV system
- (g) any refusal of the sale of alcohol
- (h) any visit by a relevant authority or emergency service.

Inspection – There was no incident log kept on the premises.

Recommendation – As this condition is self-explanatory, you should keep a log with the above information. All that is required is for you put the time/date and reason according to the above (a-h).

Upon purchasing one of these logs, you can put the first entry as "Brent Council Licensing Inspection 17.07.2024, 15:00" and then it can be signed off by Valdcy. Thereafter, you can complete it as and when any incidents take place that would fall into the description of (a) - (h) from the above list. It is probably also worthwhile to include the incident in which the singer was injured, despite that not happening on your premises.

Offence – Failure to adhere to this condition would be considered a criminal offence pursuant to section 136(1)(a) of the Licensing Act 2003 (Unauthorised licensable activities).

# Conclusion

I fully appreciate that this is a lot of information for you to take in all at once. I would advise you to carefully read the above and carry out the recommendations. I have nonetheless condensed the below so that it is more palatable:

- 1) Put up the signage/notices that pertain to CCTV, requesting patrons leave the premises quietly, challenge 25 poster and "No ID, no sale" notice.
- 2) Purchase an incident log and include my visit on 17.07.2024 and the incident in which a singer was run over.
- 3) Conduct training for all members of staff who are engaged with selling alcohol at the premises. Ensure that the training is signed off by the DPS and the respective staff member.
- 4) Submit a minor variation application to include the astroturf frontage of the premises. You can also request to add the condition relating to CCTV being provided, and request to remove the condition relating to the intruder alarm. If you need any assistance with submitting the minor variation application, please feel free to email me using the details provided above.

Section 136 - Unauthorised licensable activities (Non-compliance of conditions) Chapter 7: Promotion of the four licensing objectives

Recanto Kings, Unit 25 Sapcote Trading Centre, 374 High Road, NW10 2DH (Premises licence number: 31677)

After the follow up inspection carried out at the above premises on Thursday 5 September 2024, Brent London Borough Council's Licensing Department do not have any major concerns regarding your management of the premises, although there are some important advisory matters that I believe should be brought to your attention.

The reason for my visit was that I had recently received a secondary complaint on 2 September 2024 pertaining to live music and the behaviour of patrons at the premises. A snippet of this complaint states that:

"Loud music every night and general antisocial behaviour.", "a place that has live music every night till about 12-1 am every night", & "Shouting and screaming people."

As this was a second complaint of a similar nature, I thought that it would be remiss of me not to make you aware of this allegation.

Further to this, the Licensing Authority has also received the following additional complaint made to Brent Council's Noise Nuisance Team on 5 September 2024:

"Every night they have live music events and it's become unbearable to live with this constant noise pollution It goes on most nights into the early hours.", "It's like living next door to a Page 1 of 5

nightclub.", "I cannot get to sleep because of the music literally vibrating my home." & "This needs to be stopped or completely soundproof the property."

As such, given the context of these complaints, and that there have been three complaints made in total since the licence was issued in June 2024 - I would say that it is probably worthwhile being mindful about the level of noise emitting from your premises. This is predominantly in relation to the live music, recorded music, and noise from patrons at the premises.

It therefore might be beneficial to introduce measures that help minimise this disturbance. Such measures can include soundproofing the premises, ensuring that the volume of any live/recorded music is reduced, investigating any weak points inside your premises to reduce noise breakout, ensuring that all doors and windows are shut and instructing staff to ensure that all patrons keep conversational noise to a minimum.

Should complaints continue to be received, it might be considered that the licensing objective of "the prevention of public nuisance" is being undermined. The promotion of the four licensing objectives remains an integral responsibility of licence holders under the legislation and failing to promote the objectives could give rise to a review of your premises licence.

Continued issues leading to substantiated noise nuisance complaints may also result in the issuing of a noise abatement notice for the premises under the Environmental Protection Act 1990 from Brent Council's Nuisance Control Team.

As such, it is of the utmost importance that as the premises licence holder, you should consider the possible impact of any activities on local residents and continue to promote the four licensing objectives at all times.

In respect of the inspection and compliance of the conditions, I was pleased to see that you have undertaken measures as detailed within the warning letter that I had sent 23 July 2024, following on from my inspection on 17 July 2024. Consequently, I gratefully acknowledge that you have rectified most of the conditions and are now compliant with the below:

- 6. CCTV signage will be displayed, reminding customers that CCTV is in operation *New CCTV* signage is displayed throughout the premises.
- 7. A "Challenge 25" policy shall be adopted and adhered to at all times Challenge 25 policy signage is displayed twice at the point sale, one in front and one behind the bar.
- 8. A sign stating "No proof of age -- No sale" shall be displayed at the point of sale "No proof of age No sale" signage is displayed twice at the point sale, one in front and one behind the bar.
- 10. Notices asking customers to leave quietly shall be conspicuously displayed at all exits Signage was displayed near the exit to the premises.
- 15. Customers shall not be permitted to take any open drink containers outside the premises as defined on the plan submitted to and approved by the Licensing Authority You confirmed that you do not allow patrons to take their alcoholic drinks outside.
- 21. Staff training must be documented and based on legislation and operating procedures. All training shall be signed and dated and a copy of such records will be available for inspection by Police and local authority enforcement officers You presented me with evidence that each

member of staff had undertaken the relevant staff training, signed off by the relevant staff member. The topics included on this list went over and beyond what is stipulated within the condition.

Further to this, you also confirmed that you would replace "Part A" which is currently displayed behind the service area, with the two pages of "Part B" of your premises licence summary.

It should be noted that your willingness to comply with the conditions of your premises licence demonstrates good management and co-operation with the Licensing Authority insofar that you take your responsibility as the premises licence holder seriously.

The only outstanding issues are in relation to the two below conditions:

- 1. CCTV shall be installed to Home Office Guidance standards and maintained in a good working condition and recordings shall be kept for 31 days and shall be made available to police and authorised Officers from Brent Council. While you were able to show CCTV footage from the previous 7 days (which didn't show any licensable activities take place beyond your permitted hours), you could not go back further than 7 days. As such, this is in breach of this condition. I understand that you're engineer stated that due to the high definition of the cameras, it reduces the memory available to retain footage however this is something that will need to be addressed.
- 24. An incident log shall be kept at the premises, and made available for inspection on request to an authorised officer of Brent Council or the Police, which will record the following:
- (a) all crimes reported to the venue
- (b) all ejections of patrons
- (c) any complaints received
- (d) any incidents of disorder
- (e) all seizures of drugs or offensive weapons
- (f) any faults in the CCTV system
- (g) any refusal of the sale of alcohol
- (h) any visit by a relevant authority or emergency service.

I understand that you were under the impression that you had an incident log, however as you were unable to provide it upon request, this would also mean that you were in breach of this condition.

As stated previously in my correspondence, I think you should be mindful of the fact that failure to adhere to any of the conditions stipulated within your premises licence could result in you committing a criminal offence each time you undertake licensable activities (i.e., the sale of alcohol). This is pursuant to Section 136(1)(a) of the Licensing Act 2003 (Unauthorised licensable activities) as any sale of alcohol made would not be in accordance with the lawful authorisation of your premises licence.

Offences committed under the Licensing Act 2003 and/or further non-compliance of conditions in addition to further complaints being made could result in the premises licence being called into review where it could ultimately be revoked.

Furthermore, as you are personally liable for any offences committed under the Licensing Act 2003 in relation to the premises licence, you could also face an unlimited fine and/or be imprisoned for up to 6 months if prosecuted.

I believe it's only fair that we give you one calendar month to try and rectify the matters relating to the non-compliance of your conditions. I don't foresee any of them being particularly difficult to resolve.

I would also like you to confirm that you have undertaken measures to mitigate against the noise complaints that Brent Council have received.

I therefore request that you contact me by **Friday 18 October 2024** via email to confirm that you have carried out the necessary provisions to be compliant with the remaining two conditions of your premises licence and have taken steps to reduce any potential noise related issues. I have included guidance that can be found enclosed at the rear of this letter.

Of course, if you do have any questions regarding this letter, please feel free to email me using the above details at any time and I will be willing to assist you as much as possible.

Upon purchasing one of these logs, you can put the first entry as "Brent Council Licensing Inspection 17.07.2024, 15:00" and then a secondary entry can be included as ""Brent Council Licensing Inspection 05.09.2024, 15:30".

Once you have entered these entries into your incident log, I would be most grateful if you could email me a photo confirming that you have entered these visits into your log as required as per the condition of your premises licence.

- 2) To comply with Annex Two, Condition 24, I would advise that you speak to your CCTV engineer so that the retention is increased from 7 days to 31 days. Once this has been rectified, I would be most grateful if you could let me know via email.
- 3) Put in measures to negate any noise related issues at your premises. This can be done by reducing the volume of music, changing the hours of the live music so that it finishes earlier, ensuring that all doors and windows are shut during any performance of live music, ensuring that patrons keep conversational levels to a minimum and considering any other additional measures.
- 4) Submit a minor variation application to include the astroturf frontage of the premises. If you need any assistance with submitting the minor variation application, please feel free to email me using the details provided above.

The application has been made for a new premises licence under section 17 of the Licensing act 2003. The Police representations are concerned with all four of the licensing objectives, namely:

- The prevention of crime and disorder;
  - Public safety;
- The prevention of public nuisance; and

The venue is located in an industrial estate which is just off of Dudden Hill Lane NW10. The industrial estate is off from the main road away from residential properties and other noise sensitive areas.

## **Recanto Kings History:**

The venue initially applied for a Premises Licence on the 08/05/2024. The initial application was for the sale of alcohol, Monday to Sunday from 10:00hrs to 23:00hrs and open to the public, Monday to Sunday from 07:00hrs to 23:30hrs. This Licence was granted in June 2024.

On the 23/07/2024 the venue was issued with a warning letter by the local authority due to complaints that they received regarding unauthorised licensable activities taking place. This was not even one month after their licence was granted.

The venue then submitted an application to Vary the premises licence on the 08/10/2024 to extend the hours of their licensable activities to the current licence. Police were happy for this variation to be granted as no incidents of note had come to police attention and had no concerns other than the one warning letter that was issued by the Local Authority as mentioned above.

Since this variation was granted there had been a number of incidents that have come to police attention that do raise concerns. There have been a number of reports made to police that suggest that these incidents are happening late in the evening and early hours of the morning. These incidents consist of Violence, ASB and drug use.

On Friday the 11 July 2025 Police attended the venue and carried out a Licensing visit and discovered multiple breaches of the premises Licence. Breaches are listed as follows:

Condition 13 – The supply/sale of alcohol shall be by waiter or waitress service. Customers were ordering from the bar directly.

Condition 14 – Alcohol shall only be provided as accompaniment to main meal in the restaurant area as defined on the plans submitted to the licensing authority.

There were many tables that appeared to not have ordered any food and were only drinking.

Condition 15 – Customers shall not be permitted to take any open drink containers outside the premises as defined on the plan submitted to and approved by the licensing authority. The venue had a number of tables and chairs outside of the licensable area which customers were using to consume alcohol.

Condition 21 – Staff training must be documented and based on legislation and operating procedures. All training shall be signed and dated and a copy of such records will be available for inspection by police and local authority enforcement officers.

DPS admitted that some staff had not been trained despite serving alcohol.

Condition 24 – An incident log shall be kept at the premises, and made available for inspection on request to an authorised officer of Brent Council or the Police, which will record the following:

- A) All rimes reported to the venue.
- B) All ejections of patrons.
- C) Any complaints received.
- D) Any incidents of disorder.
- E) All seizures of drugs or offensive weapons.
- F) Any faults in the CCTV System.
- G) Any refusal of the sale of alcohol.
- H) Any visit by a relevant authority or emergency service.

This incident log was not up to date with only a couple of incidents recorded.

Condition 29 – The playing of live or recorded music shall not be permitted in any external area. As police arrived there was a guitarist performing in the front patio of the premises.

Police then issued the venue with a closure notice – Section 19 Criminal Justice and Police Act 2001. This was served on the DPS Mr Jose Neves De Foria Junior.

Police then returned to the venue on the 26 July 2025. Police observed that there were tables and chairs outside of the licensable area and were being used by customers.

Police strongly object to the variation of the premises licence until the venue can demonstrate that they can run the venue correctly and with in accordance with their licence.

As seen with the incidents listed, they take place late in the evening or early hours of the morning. By extending the hours this will only allow more incidents to take place and will undermine the licensing objectives.

The prevention of crime and disorder.

The prevention of public nuisance.

Again police are objecting to the variation of the licence.

# Age Verification Policy

- (1) The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.
- (2) The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.
- (3) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either--
- (a) a holographic mark, or
- (b) an ultraviolet feature.

## Minimum Price of Alcohol

- 1.A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.
- 2. For the purposes of the condition set out in paregraph 56

- (a)—duty is to be construed in accordance with the Alcoholic Liquor Duties Act 1979;
- (b)—permitted price is the price found by applying the formula--

$$P = D + (D \times V)$$

where--

- (i)P is the permitted price,
- (ii)D is the amount of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and
- (iii)V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol;
- (c)—relevant person means, in relation to premises in respect of which there is in force a premises licence--
- (i)the holder of the premises licence,
- (ii)the designated premises supervisor (if any) in respect of such a licence, or
- (iii)the personal licence holder who makes or authorises a supply of alcohol under such a licence;
- (d) —relevant person means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and
- (e)—valued added tax means value added tax charged in accordance with the Value Added Tax Act 1994.
- 3. Where the permitted price given by Paragraph (b) of paragraph 2 would (apart from this paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub- paragraph rounded up to the nearest penny.
- 4.(1) Sub-paragraph (2) applies where the permitted price given by Paragraph (b) of paragraph 2 on a day (—the first day|) would be different from the permitted price on the next day (—the second day|) as a result of a change to the rat e of duty or value added tax.
- (2) The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

# Requirement for a DPS

- (1) No supply of alcohol may be made under the premises licence-
- (a)at a time when there is no designated premises supervisor in respect of the premises licence, or
- (b)at a time when the designated premises supervisor does not hold a personal licence or their personal licence is suspended.
- (2) Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.



- 3. The CCTV system shall display on any recordings, the correct date and time of the recording.
- 4. A member of staff trained in the use of the CCTV system shall be available at the premise at all times that the premises are open to the public.
- 5. A CCTV system will be installed at the premises covering the entrance, the external area and all internal areas.
- 6.CCTV signage will be displayed, reminding customers that CCTV is in operation.
- 7. A "Challenge 25" policy shall be adopted and adhered to at all times
- 8. A sign stating "No proof of age -- No sale" shall be displayed at the point of sale.
- 9. A copy of the premises licence summary including the hours which licensable activities are permitted shall be visible from the outside of each entrance to the premises.
- 10. Notices asking customers to leave quietly shall be conspicuously displayed at all exits.
- 11. No high strength beers, lagers, and ciders above 6.0% ABV shall be stocked or sold at the premises.
- 12. All deliveries shall take place during the normal working day (i.e. 09:00 to 18:00 daily).
- 13. The supply/sale of alcohol shall be by waiter or waitress service.
- 14. Alcohol shall only be provided as an accompaniment to a main meal in the restaurant area as defined on the plans submitted to the licensing authority.
- 15. Customers shall not be permitted to take any open drink containers outside the premises as defined on the plan submitted to and approved by the Licensing Authority.
- 16. No children shall be permitted on the premises unless accompanied by a responsible adult.
- 17. A suitable intruder alarm complete with panic button shall be fitted and maintained.
- 18. Delivery drivers should be asked to keep noise to a minimum when collecting takeaways.
- 19. Challenge 25 -- if the driver considers the recipient of alcohol appears under 25, recognised photographic identification to be requested before any alcohol is given to the recipient.

- 20. Acceptable proof of age shall include identification bearing the customer's photograph, date of birth and integral holographic mark or security measure. Suitable means of identification would include PASS approved proof of age card, photo-card driving licence and passport. No ID -- No delivery.
- 21. Staff training must be documented and based on legislation and operating procedures. All training shall be signed and dated and a copy of such records will be available for inspection by Police and local authority enforcement officers.
- 22. At the time the order is placed, a declaration will be required from the person placing the order that the person is over '18 years of age'.
- 23. Alcohol shall only be delivered to a residential or business address and not to a public place.
- 24. An incident log shall be kept at the premises, and made available for inspection on request to an authorised officer of Brent Council or the Police, which will record the following:
- (a) all crimes reported to the venue
- (b) all ejections of patrons
- (c) any complaints received
- (d) any incidents of disorder
- (e) all seizures of drugs or offensive weapons
- (f) any faults in the CCTV system
- (g) any refusal of the sale of alcohol
- (h) any visit by a relevant authority or emergency service.
- 25. The Minimum age of delivery drivers will be 18.
- 26. Alcohol 'Off' Sales will be restricted to home deliveries and take away as part of a food order.
- 27. The front external seating area shall not be open to members of the public after 23:00 hours.
- 28. All children under the age of 12 years shall be accompanied by an adult whilst on the premises.
- 29. The playing of live or recorded music shall not be permitted in any external area.

Supplementry Information to the Variation Application for the Premises Licence at Recanto Kings, Unit 25 Sapcote Trading Centre, 374 High Road, NW10 2DH

Further to the representation from the Licensing Authority on 24 July 2025, a subsequent referral from Trading Standards dated 12 August 2025 was received, alleging certain concerns raised by a customer:

"Good morning.

I would like to make a complain about a business, its a restaurant I have been yesterday and I found out what I believe to be a illegal activity.

I have been out with my family to celebrate my birthday and I have arrived there at 2pm to lunch, around 4pm the owner came in every person including my child to charge a £5 fee each person to "musical couvert" that was to be starting later on.

I have told her that there was NO SIGn saying anything about it, neither in their website and she said: PAY OR LEAVE.

as It was my birthday, we had NO option because some of us was still eating by that time. My husband went to the car just outside to leave my presents there and when he returned the security did not allow he inside again because she ordered it. despite all our guests were inside, she did not allow he in.

I believe its ilegal to charge someone already inside, if she was charging should be for costumers arriving after the start time for the music not the ones who came for lunch at lunch time.

I also would like to let you know about the capacity issue, as its believed this place is overcrowded with more. than capacity supports, every saturday and sunday after 7pm, which caused people to fight every weekend due to overcrowding. also as there is only 1 toilet for man and 1 for woman, people leave the premises to wee outside between the parked cars (which are in front of other business, causing a horrible urin smell and pool of wee for people passinb by.

I know people who lived around the corner and they said every weekend there is a fight there, yesterday By the time I was there I saw a fight of a man and woman and the owner stepped in, and after been punched he was running after the woman to punch her.

as its a brazilian restaurant, most of its costumers have no right to stay in the country so they obbey to anything the owner says.

he didnot do anything against her when inside probably because there is loads of cameras inside, but then runned after her outside as there is just cameras from other business that closes at night.

before I left I saw the owner returning with blood all over his face, which clearly he have fought someone.

I have been there once before and loved their food, but I left when in a fight a man broke a bottle on a womans face slicing her forehead, it was about 4 months ago..

well, I am just worried specially with kids as its a restaurant, parents take kids there and can have same experience I had as its frequently happening.

if you check their instagram page you will be able to see some overcrowding, its called RECANTOKINGS."

The restaurant name is Recanto kings, address is 374 HIGH ROAD, London, NW10 2DH.(its inside a business area)

On receipt of the referral, the Licensing Officer communicated with the complainant to address the issues raised.

In response, the Licensing Officer informed the complainant that, given their assertion that the licensing objective of the prevention of crime and disorder is currently being undermined, the matter would be forwarded to the relevant licensing counterparts within the Metropolitan Police for further attention.

Following the complainant's email, it was understood that a visit to the premises occurred on Monday 11 August 2025. To assist with the ongoing investigation into the allegations

of overcrowding and incidents of fighting both inside and outside the premises, the Licensing Officer requested clarification on specific details.

On 13 August 2025, the complainant responded, confirming that the incident in question actually took place on Sunday 10 August 2025, providing additional relevant information.

"Thank you for your email.

It was on Sunday 10/08/2025, not on Monday 11th.

1- the fight happened between 8pm and 10pm, I don't remember the exacly time but I believe it was around 9ish.

2-he returned about 20 minutes after the fight started.

- When leaving the premises after the lady he went the opposite way(turning right), not to the main road.
- the lady charging people for the music did it around 5pm, she was wearing a pink t-shirt and is the owners wife.

If you check the cameras you will be able to see it.

My husband told her its illegal as there was NO Signs on the walls neither she told about the charging on her instagram advert and she told him: its a brazilian restaurant not English so we follow the brazilian rules, then he confronted her saying she is not in Brazil so she needs to follow UK rules and she said I don't care, you pay or Leave now."

This information has since been forwarded to the Police for further investigation.
