Police Representations to the Temporary Event Notices for

13 Marian Way, NW10 4XH

I certify that I have considered the notices shown above and I wish to make representations that the use of the premises for the temporary event would undermine the crime prevention initiative, for the reasons indicated below.

An officer of the Metropolitan Police, in whose area the premises are situated, who is authorized for the purpose of exercising its statutory function as a 'Responsible Authority' under the Licensing Act 2003.

Temporary Event Notices have been given under section 100 Licensing Act 2003 by

Ms. Tammy Mpitu, 13 Marian Way, London, NW10 4XH applied for sales of alcohol, late night refreshments and provision of regulated entertainment on 7th – 8th August 2026 from 20:00hrs to 04:00hrs. Capacity 90-100.

Police are formally making representations to the notice under section 104 Licensing Act 2003. The Police objection is primarily concerned with the prevention of crime and disorder, public safety and public nuisance.

Police received an application for a Temporary Event Notice on the 22 July 2026.

Prevention of Crime and Disorder

The proposed event is to take place within the rear garden of a residential property located in an area that experiences ongoing issues relating to serious crime, gang activity, drug dealing and misuse, violence, and associated anti-social behaviour. The locality is well known to the Police and partner agencies

and continues to require enforcement and preventative interventions to address these concerns.

The application seeks authorisation for the sale of alcohol, regulated entertainment, and late-night refreshment until 04:00hrs at a private residential address situated within a residential estate. Unlike a purpose-built commercial venue designed to accommodate licensable activities, the premises lack the physical infrastructure and management controls typically expected for an event of this nature and duration.

The event is being publicly promoted through the social media platform TikTok, with tickets available for purchase at £10 per person. The public advertising and sale of tickets indicate that attendance is not confined to family members and friends but is being actively marketed to members of the public, including individuals from outside the local area. This significantly increases the likelihood of attracting a substantial number of attendees who may be unknown to the organiser.

The use of social media to promote the event raises further concerns regarding crowd management and the prevention of crime and disorder. Public online advertising can rapidly increase attendance beyond anticipated levels, particularly where the proposed venue is a residential property that is neither designed nor authorised to host large-scale public events.

The Police are particularly concerned by the combination of alcohol sales, regulated entertainment, and late-night refreshment continuing until 04:00hrs. Events operating into the early hours of the morning present an increased risk of alcohol-related violence, disorder, criminal damage, drug use, and anti-social behaviour. These risks are amplified given the location of the premises and the public nature of the event.

There is also a history of complaints and enforcement action associated with this address, which raises serious concerns regarding the management of licensable activities.

On 31 December 2024, Brent Council received complaints from local residents relating to a party at the premises. It was alleged that excessive noise continued until approximately 04:00hrs, significantly affecting residents' quality of life and ability to sleep. Video evidence submitted by a complainant also suggested that alcohol may have been sold from the premises and that entry tickets were being offered for sale.

As a result of these concerns, a warning letter was issued on 23 January 2025 regarding potential offences under Section 136 of the Licensing Act 2003, relating to unauthorised licensable activities, including the suspected sale of alcohol and the possible provision of regulated entertainment.

The previous allegations of unauthorised licensable activities, together with the history of complaints at the premises, undermine confidence in the applicant's ability to effectively promote the licensing objectives during the proposed Temporary Event Notice.

Prevention of Public Nuisance

The premises are situated within a residential estate where residents are entitled to the peaceful enjoyment of their homes, particularly during night-time hours.

The proposed event includes regulated entertainment, alcohol sales, and late-night refreshment until 04:00hrs. The Police believe the event is likely to cause significant public nuisance through amplified music, DJs and sound systems, noise from attendees, and the movement of vehicles arriving and departing throughout the night. Additional disturbance is likely to arise from shouting, congregation of patrons, door slamming, and dispersal in the early hours of the morning.

Given that the event is proposed within a rear garden, there is limited opportunity to contain noise when compared with a suitably designed licensed premises. As a result, neighbouring residents are likely to experience prolonged disturbance during the evening and overnight period.

These concerns are supported by a documented history of complaints relating to noise from events held at the premises. Furthermore, on 26 February 2026, Brent Council served a Noise Abatement Notice on the property. The Police also understand that Peabody Housing was notified of a breach of tenancy conditions arising from nuisance-related concerns.

The existence of a Noise Abatement Notice demonstrates a clear history of noise issues associated with the premises and provides strong evidence that similar problems are likely to arise should the TEN be permitted.

Public Safety

The Police have significant concerns regarding the safe management of attendees at an event operating until 04:00hrs within a residential estate affected by crime and anti-social behaviour.

The application does not provide sufficient reassurance that adequate measures are in place to manage attendance, control entry and exit, prevent disorder, safeguard against drug-related activity, manage intoxicated individuals, or ensure the safety of both attendees and local residents.

In light of the location of the premises, the public advertising of the event, the proposed licensable activities extending into the early hours, the history of complaints, the previous allegations of unauthorised licensable activities, and the subsequent service of a Noise Abatement Notice, the Police are not satisfied that the event can be operated without adversely impacting the licensing objectives.



Conclusion

For the reasons set out above, the Metropolitan Police Service objects to this Temporary Event Notice on the grounds that permitting the event would undermine the licensing objectives, in particular the prevention of crime and disorder, the prevention of public nuisance, and public safety.

Section 136: Unauthorised licensable activities
13 Marian Way, Harlesden, NW10 4XJ

It has recently come to the attention of Brent Council's Licensing Authority that unauthorised licensable activities, such as the sale of alcohol and the provision of live or recorded music, may have taken place at the above residential address without the requisite lawful permission from the Council.

I have enclosed evidence of a social media post advertising one of these events at the rear of this letter, which indicates that there is a paid bar. Further to this, there have been a number of noise complaints made to the Council relating to amplified recorded music emanating from a marquee at the rear of the garden.

It should be noted that under the Licensing Act 2003, the sale of alcohol and the provision of live or recorded music are defined as licensable activities. This means that any individual selling alcohol or charging entry to be entertained by either live or recorded music with a view to making a profit, even at a private event that is open to the wider public (such as through ticket sales), is required to obtain the necessary authorisation. This applies regardless of whether the event is held at a residential address. In order to lawfully undertake such activities, you would need to either apply for a premises licence or submit a Temporary Event Notice – the latter being more appropriate for one-off, ad hoc or occasional events.

Under section 136 of the Licensing Act 2003, it is a criminal offence to carry on or attempt to carry on a licensable activity on or from any premises without the correct authorisation. A person found guilty of this offence is liable to imprisonment for up to six months and/or an unlimited fine.

Given the above, I would strongly advise that you cease any unauthorised sales of alcohol or unauthorised provision of live or recorded music at these events, as doing so could amount to a criminal offence under section 136 of the Licensing Act 2003 and may result in prosecution.

I would be grateful if you could contact me via the email address provided at the top of this letter on or before **Friday 30 January 2025**, to confirm that such events have ceased, or that no further unauthorised licensable activities will be carried out in the future unless the appropriate authorisation has been obtained from Brent Council.

Equally, if you wish to provide any defence or a response in respect of this letter.

I am prepared to treat this matter informally on this occasion. However, should I not hear from you, or if further unauthorised events are identified, I will have to consider whether more formal enforcement action is appropriate.

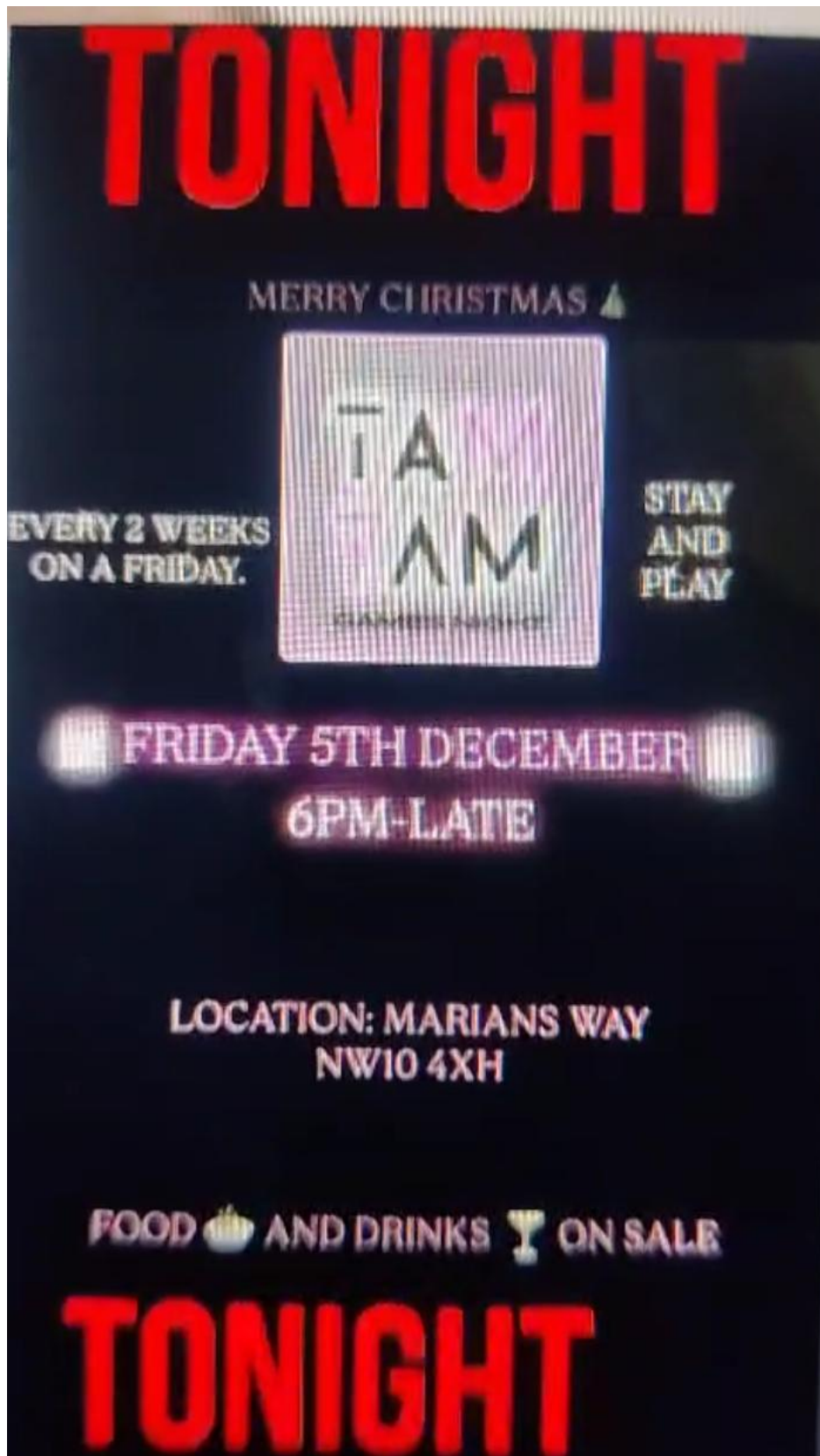

Good morning both,

The email thread below has been forwarded to me by my colleague.

Thank you for taking the time to contact us and for including the video advertising these events. Just to introduce myself, I am the delegated Licensing Enforcement Officer for the Harlesden/Willesden area at Brent Council. Please accept my sincere apologies for the delayed response, I had to take some emergency leave and was unable to reply sooner.

I hope you don't mind that I am responding to you both together, given that [REDACTED] continued on from [REDACTED] original email.

If either of you could confirm the house number on Marian Way that this complaint relates to, I would be most grateful. I note that the Instagram video provided refers only to the road/postcode, with the exact house number omitted.

Regarding the loud music and noise, I note that you have mentioned that you have uploaded recordings to the Noise App, which is monitored by Brent Council's Nuisance Control Team (NCT). If you are in contact with other affected neighbours, you may wish to encourage them to do the same. Upon receiving a noise report, the NCT will investigate and assess whether the noise amounts to a statutory nuisance under the Environmental Protection Act 1990. If substantiated, they may serve the property with an abatement notice.

It should be noted that the Nuisance Control Team operates separately from the Licensing Department and that they have their own delegated powers relating specifically to nuisance. As such, it would not be appropriate for me to speak on their behalf, however I will forward this response to the relevant officers so that they are aware.

In terms of steps I can take on behalf of the Licensing Department, these relate to the unauthorised sale of alcohol. Under the Licensing Act 2003, the legislation under which I have delegated authority, certain activities require authorisation from the Council (e.g., sale of alcohol, live music, recorded music, etc.). While it is difficult to determine whether the live/recorded music in this instance would be licensable, given that this is a private dwelling rather than a public premises, the provision of alcohol (whether via a paid bar or as part of a ticketed entry) would constitute an unauthorised licensable activity.

The limitation is that, because this is a private dwelling, I cannot conduct a site visit to initiate contact, nor do I have powers to physically stop these events. However, I do have powers to pursue prosecution where evidence of unauthorised licensable activity exists.

Once the address is confirmed, I will write to the occupant responsible for hosting these events to inform them that, under section 136 of the Licensing Act 2003, it is an offence to carry on, or attempt to carry on, a licensable activity without the correct authorisation from the Licensing Authority. A person guilty of such an offence is liable to imprisonment for up to 6 months and/or an unlimited fine. I will also ensure that my Licensing counterparts within the Metropolitan Police Service are copied into any warning letter issued.

As mentioned above, if either of you could confirm the house number, I would be most grateful. Likewise, should you see any further advertising, please let me know and continue updating the Noise App.

On Friday 2nd I used the Noise complaints app to take 3 recordings of the party throughout the night, which kept me awake until 4am.

Please can you let me and my co-owners of our building know what you will do to resolve this issue. It cannot continue, and is dramatically effecting our wellbeing.
