

Premises Location

The premises is a small public house located in Neasden Lane shopping centre.





Background

The premises was originally owned by a Mr Tim Sheehan under premises licence number 261872 and subsequently transferred to a Sharon Mullarkey (SF001). However, as a result of problems at the premises and the fact that the premises was still found to be related to Tim Sheehan, the premises licence was revoked in August 2018 (SF002).

A new application was then applied for and granted in May 2019 to a Mr Mark Counihan (SF003). The application appeared before the Licensing sub-committee as a result of concerns that Mr Sheehan was still involved in the business. The decision for this premises licence as per the committee (SF004), determined that the 'premises had an incredibly poor history, most of which is down to mis-management by Mr Sheahan' (pg3) and 'It was emphasised that the basis of the application was that Mr Sheahan was going to remove himself from running the premises, and the Applicant would have day to day management of the premises' (pg2).

The current Licence Holder Mr Counhian has never been available since prior to the initial lockdown in March 2020. Strong evidence has also been found that Mr Tim Sheehan is still involved in the premises. In May 2019 an application to vary the Designated Premises Supervisor (DPS) was applied for and changed from Margaret Harnett to a Ms Camelia Mihoc. Camelia Mihoc has been the DPS ever since. This was confirmed in a text message by Ms Mihoc on 11th May 2021 (SF005).

Complaints and Enforcement to Date

Based on the data provided by the Institute for Government Analysis on page 6 of this document, the following complaints were received and inspections undertaken at a time when Government restrictions prevented the premises from opening but subsequently were found to be contravening those restrictions. This is with the exception of the inspection undertaken on 4th July 2020 and 11th December 2020.

- On 23rd March 2020, a telephone complaint was received to state the premises are still
 operating and customers are entering via the rear.
- On 25th March 2020, the Licensing Enforcement Officer Esther Chan spoke to the DPS Camelia Mihoc who confirmed the premises had been closed.
- On 7th April 2020, a complaint was received to the police that drunks were stumbling out of the premises.
- On 11th April 2020, a complaint was received to the police stating that the previous licence holder Tim Sheehan is letting people call him to arrange letting them in via the rear of the premises to drink in the pub.
- On 29th April 2020, a complaint was received that the premises was open to members of the
 public, despite there being a national government lockdown. Information was also received that
 Tim Sheehan is still involved in the business.
- On 29th April Sgt Damien Smith attended the premises three times and then at 17.42hrs found persons on the premises. As officers drove past the front of the venue a male staggered out of the front door known as the licence holder, he said he'd been checking on the pub and pointed at the Field. He then informed officers he has the keys. Officers asked the male to open the door with his key or reasonable force would be used under the Licensing Act 2003 (Sec 179) as they suspected licensable activity was taking place inside. The male handed the keys to police. Entry using the key was made and inside the venue there were customers sat at the bar with pints of alcohol on the go and some were smoking with the DPS present.

The previous licence holder Mr Tim Sheehan was sat inside drinking alcohol and appeared drunk. All were asked to leave with immediate effect and all complied. Closer inspection of the venue revealed that two whole new barrels of alcohol had been delivered and ready for consumption. The DPS was told that Licensing will apply for a review of the premises licence and the Local authority will be informed. Two new beer barrels arrived whilst police were on the scene. A statement provided by Sgt Smith is attached (SF006).

- On 30th April 2020 an email was received from Sgt Damien Smith stating that anonymous intelligence received to the police to state the premises is open to members of the public carrying out licensable activities
- On 4th May 2020 a call was made to 999, when police attended Mr Tim Sheehan, Ms Mihoc and another male were outside the premises door. The call had been made by Tim Sheehan. When officers went in, the taps were wet and the premises smelt strongly of cigarette smoke.
- On 7th May 2020 the police and I attended the The Field. Sgt Smith went to the rear of the
 premises to find a male sat on the steps. He stated he was waiting for Tim Sheehan to let him
 in. Tim arrived and was rude to officers. When the police said they would force entry, Tim
 Sheehan replied, that he would sue, which was suspicious because he should have nothing to
 do with the premises. The male (a priest from Gerrards Cross), collected the items he stated
 he came to collect and left.
- On 12th May 2020, I attended the premises to serve a prohibition notice (SF007) based on the
 visit undertaken by the Police on 29th April 2020 where the premises were found to be open
 and carrying out licensable activities. On this day, the police arranged removal of the CCTV
 hard drive as evidence. A replacement was to be given to the premises.
- On 17th May 2020, a complaint was received that the premises are opening on Friday's, Saturday's and Sunday's and letting customers in through the back door after making a call to Tim Sheehan.
- On 26th May 2020, I visited the premises to speak to the DPS regarding the prohibition notice that was served as further complaints were still being received.
- On 12th June 2020, a complaint was received that on Sunday 7th June 2020, stating the premises was busier than ever with at least 15 customers in the premises.
- On 19th June 2020, a complaint was received that there were at least 8 customers in the premises.
- On 4th July 2020, Esther Chan, a licensing enforcement officer visited the premises with the
 police. The premises were permitted to be open on this day. At the time of the visit, Ms Chan
 spoke to the DPS regarding the CCTV and the DPS stated that when the police took their hard
 drive and swapped it with another one, they did not give the premises the password to the
 CCTV system. A number of non-compliances were found in relation to the premises licence
 conditions.
- As a result of non-compliances during the inspection at the premises on 4th July 2020, Esther wrote a warning letter to the premises on 16th July 2020 (SF008). The letter asked Mr Counihan to make contact as there was no telephone number or email address to communicate with him. Mr Counihan did not reply. A year earlier on 5th Jul 2019, I had

written a similar warning letter to the premises in relation to premises licence conditions that were breached (SF009).

- On 11th December 2020, I visited the premises and gave advice on manual registration and 2m spacing. The premises were again permitted to be open on this day. Whilst at the premises, checks were made to ensure the premises had the password given to the premises by the police for the CCTV hard drive. I checked past dates to ensure the CCTV was recording.
- On 18th December 2020, an anonymous call was received at approx. 15.00hrs stating the premises is open with customers currently there.
- On 18th December 2020, PC Paul Scott attended at 18.10hrs and did not find anyone at the premises.
- On 19th December 2020, PC Paul Scott attended the premises and did not find anyone at the premises.
- On 31st December 2020, during routine visits, PC Paul Scott attended the premises twice following a complaint that the premises was open, to find the premises appeared closed. Another police unit attended later and found the same outcome.
- On 6th January 2021 a complaint was received that the premises is open but no specific dates
 or times were given.
- On 8th January 2021, Covid Enforcement officers and visited the premises to find three males at the rear external area all appearing to be under the influence of alcohol. There was no definitive evidence they had come from inside the premises. There was no sound from within the premises.
- On 16th January 2021, Covid Enforcement officers and visited the premises @ 23.26hrs to find four men coming from the back of the premises. At 23.33hrs there were two men at the rear who were clearly drunk. No direct evidence that they had come from within the premises.
- On 17th January 2021, Covid Enforcement officers and and visited the premises @ approx. 20.23hrs to find two men leave the rear of external area to the premises. At 20.57hrs another man was seen leaving the rear of the external area. Observations ceased at 21.21hrs.
- On Monday 25th January 2021 I sent a text message to the DPS to ask for CCTV footage in relation to the 16th/17th January 2021. The DPS agreed to download this. I was to collect on Wednesday 27th January 2021 (SF010).
- On Wednesday 27th January 2022 I attended the premises to collect the CCTV footage. The DPS stated the following:- she did not have the USB stick, the CCTV was not working, they were awaiting a technician, they had had a power cut, they could not get a technician in because they couldn't afford it. When I asked why Ms Mihoc had let me attend without informing me, she apologised and said it was because I may have wanted to come in to confirm it wasn't working. I did not go into the premises. Myself and Ms Mihoc checked the DPS's phone and there were no recordings.

- On 3rd February 2021, I sent a warning letter to the premises stating the premises were contravening a condition on their licence, primarily the one where CCTV must record for 31 days. The premises were given 7 days from the date of the letter to repair the CCTV or a review of the licence would be instigated (SF011). In the same letter, the licence holder was asked to again provide a contact email and telephone number in order to communicate with him. Mr Counihan did not reply to this letter.
- On 16th February 2021 on recognising that the premises may state they had not received the
 letter, I sent a text to the DPS (SF012) to ask whether the CCTV had been repaired. The DPS
 replied stating that it was still not working and would be repaired within the next few days. This
 was 7 days overdue from date on which the CCTV should have been functioning as per the
 letter above.
- As will be seen in the information below, the police again removed the CCTV hard drive when they attended on 19th February 2021 and found licensable activities being undertaken.
- I sent a text to the DPS (SF012) on 22nd February 2021 asking whether the CCTV was now functioning to which the DPS replied stating that the CCTV drive had been removed by the police on 19th February 2021
- Friday 19th February 2021

This business was visited on Friday 19th February 2021 at 15.35 hours when the rear door to The Field, 249 Neasden Lane, NW10 1QG was seen opening with one male exiting the rear of the premises. The male admitted he was drinking in the premises, that there were other persons in the premises. He was drunk and issued with an FPN. As the rear door was then shut by another male holding the door, the police officers were therefore unable to gain entry.

At 16.40hrs, after calling for back up, the Police forced entry into the rear of the premises to find the following:

- The lights were on in the premises
- There were 11 (eleven) beer glasses with alcohol on the bar tops. The alcohol was very cold to the touch
- . There were 2 (two) televisions turned on
- There were 2 (two) walking sticks
- There were 4 (four) newspapers (3 dated with 19th February 2021 and 1 dated 18th February 2021)
- . 4 (four) of the nozzles were attached to the beer pumps
- The nozzle for the Guinness tap was dripping
- · A calendar at the property was showing the month of February
- There was a coat on one of the bar stools and when the pockets were checked it was found to belong to a Mr Tim Sheehan. The police called Mr Sheehan and he agreed to return to the premises. When asked questions relating to his presence, Mr Sheehan's answers did not add up. Mr Sheehan then stated he was at the premises to check on things. Under the previous premises licence, condition Mr Tim Sheehan was not permitted to be anywhere near the premises. He was the previous licence holder and as a result of the premises licence being revoked, there were concerns that someone else may become a new licence holder as a cover up to him still being the owner. Increasing evidence has shown that Mr Sheehan is still involved in the business.
- Till transactions for 13th January 2021, 14th January 2021, 24th January 2021, 18th February 2021 and 19th February 2021.
- 2 (two) cash & carry invoices dated 3rd February 2021 and 8th February 2021 during a time when the premises should be closed

- Reset reports for 22nd December 2020, 31st December 2020, 12th January 2021, 14th January 2021, 17th January 2021 and 19th February 2021 which show regular transactions from the start of December. There were also individual receipts for other dates which have all been seized.
- Sign in sheets from customers attending regularly since December

I attach statements from Police officers and a Covid Enforcement officer who attended on the day (SF013), (SF014), (SF015), (SF016).

- As a result of the visit on 19th February 2021 a Fixed Penalty Notice (FPN) was issued to the
 premises via post on 25th February 2021 (SF017). At the time of writing this review application,
 payment has not been received for this.
- On 21st April 2021 a further complaint was received stating that the premises are letting people
 into the premises then locking the door, not responding to police or anyone who tries to check
 the premises.
- Friday 23rd April 2021

On Friday 23rd April 2021 at approximately 14.00hrs, I visited The Field as a result of complaint dated 21st April 2021 which stated that the premises was again opening at a time when Government restrictions prevented them from operating.

On entering the alleyway at the rear of the premises, I noticed an unknown male sat at a bench. He asked me if I was looking for the pub, to which I responded 'yes'. He then whistled over to a an older unknown male who appeared from behind a wall. The first male sat at the bench then told the male that I wanted to enter the pub. The male looked me up and down, asked if I wanted to go in, to which I nodded and he responded 'I don't know you, but I trust you', proceeded to unlock the door with a key, let me in and then close the door behind me and locked it.

I walked down a small corridor in the premises which led to a second door and upon opening this, entered to find nine males sat in the premises drinking alcohol and two members of staff behind the bar. I introduced myself, asked everyone to stop drinking and the males all stood up and slowly made their way to the back door.

The staff behind the bar immediately began to throw away the alcohol and clean up behind the counter. All of the beer pumps were lit up and had the nozzles attached. The till was also turned on and lit up. Once all of the males left, I spoke to the two members of staff who had both worked at the premises for approximately two weeks. They had both begun working as cleaners but had subsequently been asked to work behind the bar serving customers. They were both aware that they should not be serving any customers at the premises and when asked, stated that they knew it was wrong. I asked if they knew who the owner was and they responded 'Mark', but knew nothing else about him.

I then stated to the two females that I was going to go behind the bar to check for any evidence of paperwork, where I found receipts and delivery notes dated; 12th, 14th, 15, 17th and 22nd April 2021. I exhibit photographs of these and of the premises taken whilst onsite (SF018). I then left the premises at approximately 14.15hrs.

Further Information

- I am aware the business has applied for a Government grant issued to businesses that were unable to operate during the pandemic. This grant was issued to the business.
- The business rate payer is registered as Mr Mark Counihan when checked on 10th May 2021

Summary

On three different occasions, the premises have been found to be operating at a time when Government restrictions in relation to the Covid-19 pandemic, have prevented them from doing so. It is clear from the evidence shown that the persons running the premises have no regard for the law and have continued to operate as they so wish, causing continuous nuisance. They have also caused issues of public safety in terms of the pandemic by permitting persons to congregate in the premises. They have also locked customers in the premises via a key to the rear door. Should there have been an emergency, they may not have been able to get out.

In relation to CCTV, this has not been available and despite a deadline to provide CCTV, this was not met. It appears that the premises were knowingly avoided the recording of CCTV so that they could operate during the lockdown without being caught.


It has been impossible to make direct contact with Mr Counihan and despite efforts to contact him, the Licensing Team have received no response.

It is also clear that Mr Tim Sheehan is still involved in the premises. Since last year Mr Sheehan has either been seen or mentioned on seven (7) occasions in relation to The Field. As stated premises licence number 261872 previously held by Mr Tim Sheehan was revoked and the new premises licence was granted on the basis that Mr Sheehan no longer had any involvement in the business.

Despite an inspection and warning letter 2 months after the premises licence being granted in May 2019 where conditions were not being met, it was again found that in July 2020 the premises were once again not upholding the premises licence conditions.

Both Council officers and the Police have spent an enormous amount of time attending the premises as a result of contraventions, time that could have been more effectively spent elsewhere.

It is unquestionable that the premises are unable to uphold three licensing objectives, namely prevention of crime and disorder, prevention of public nuisance and public safety and the only option the Licensing Authority see for this premises licence is for it to be revoked with immediate effect.
