I am employed by the London Borough of Brent as a Covid Regulatory Support Officer, working within the Environmental and Regulatory Team Department. I do Covid-19 Patrols in the Borough of Brent. I keep an eye on Businesses and the Public to make sure the Covid-19 Government Legislation is adhered too. I also advise if need be.

This is a statement of mine in respect of Illegal Trading by the business named The Field (Pub), 249 Neasden Parade, Neasden Lane, Neasden NW10 1QG, outside Covid-19 Government Legislation Rules.

On Friday, 19th February 2021, at approximately 15:30pm, I, was involved in a joint Police Patrol, along with one PCSO, in Neasden Parade, Neasden Lane. I made a deliberate visit to the Rear Service Road of The Field Pub, as we suspected that there was activity going on inside the Pub.

While we were standing outside, the Black Rear Door openend and two white males came out. The male that opened the door saw us and quickly closed the door. The other male, who was wearing bright blue jogging bottoms and top, was so intoxicated, that he rammed into the railing. He even had wet himself. I was standing and observing what was going on, while the Police took the details of the two men. They asked him to call someone inside the Pub and ask them to open the door. But no one opened the door. I asked the Sergeant to see if they can enter the premises, because we had seen customers coming out. The Sergeant then arranged entry into the premises I stood in the Service Road with some of the Police. The rest of the Police, gained entry into the premises from the front door entrance, then the rear door was opened from inside. The Police went in and I stood outside by the rear door.

I was then asked to come in by the Sergeant. I went inside and I saw pint glasses on the tables and on the bar area. Some were empty, half full, and some were full and cold, as if they had just been poured into the glass. I saw approximately 7-9 glasses. The newspaper was dated 19th February 2021, and the Television was on.

I watched the Police completing their search, printing out till receipts and obtaining other evidence. I saw a black jacket on the back of a chair and asked the Police Officers if it belonged to any of them? They said 'No'. Then one of them emptied the pockets and found ID, a Bank Card and Keys, belonging to a Mr Tim Sheahan. I was asked by the Sergeant to call Mr Sheahan and ask him if he knew who the Licencee was. I called him and he kept on replying 'No', to my questions, as if he was programmed to say 'No'. I then put the phone down.

While in the premises, I saw a white male walked straight in from the Front Entrance. When asked by the Policewoman, what he was doing there, he replied, he had come to check something and left his keys in the Pub when he was there at 10.00 am the same morning. The male was Mr Tim Sheahan.

I asked the Sergeant if he needed me further, he replied, 'No, but thank-you for your help'. I left when the time was approximately 17:35.

During the inspection of the premises I took 23 colour digital photographs using my work mobile phone camera. I later downloaded these and now produce colour printouts of each image in evidence, exhibited by me as exhibits AA1 to AA23, inclusive.

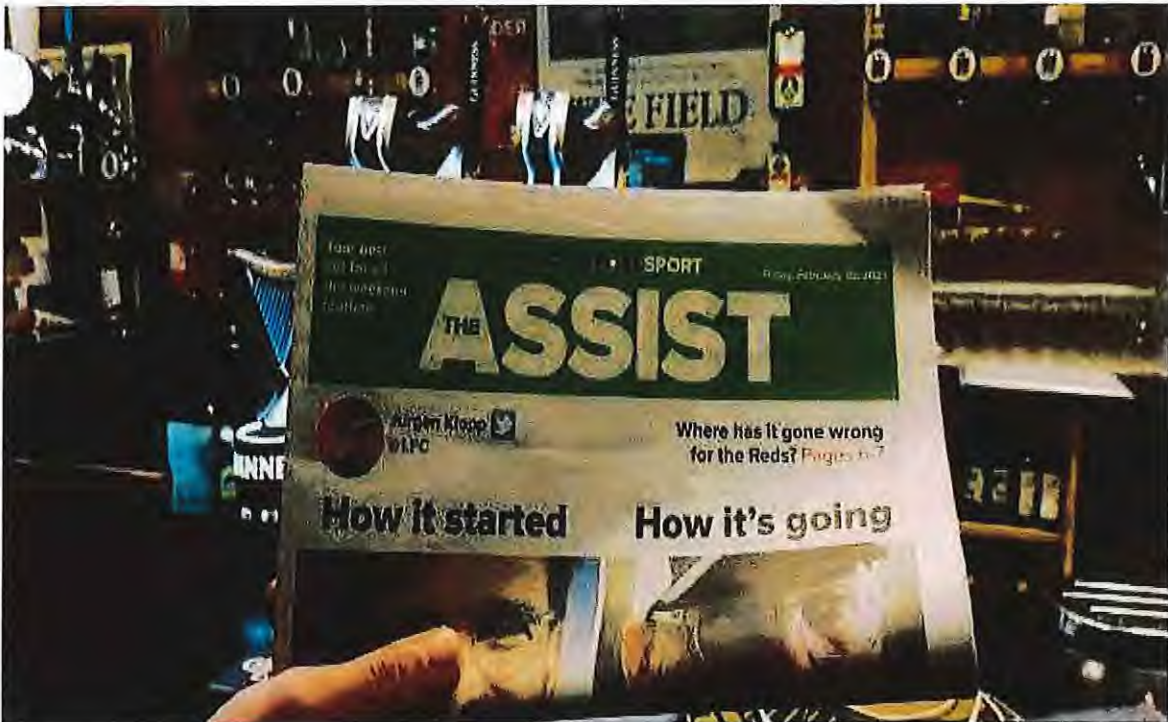

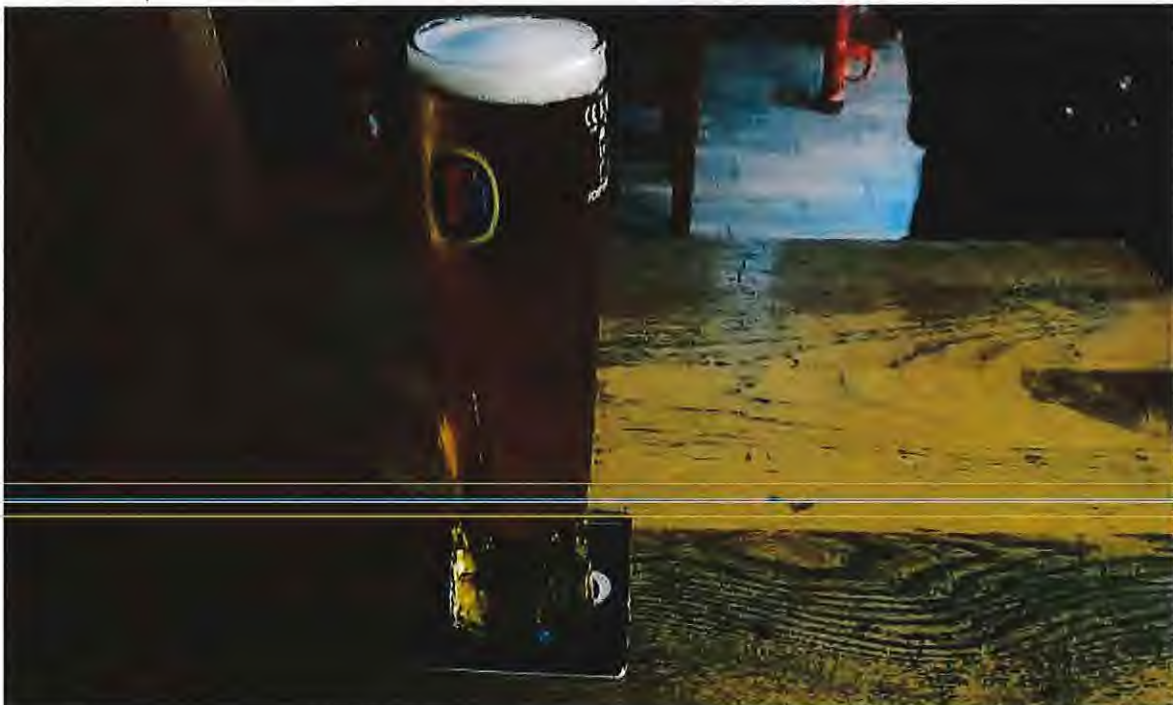
