Offence Summary and Officer's Initial Actions:

Police were on patrol and come across huddle of people in the street pushing and shoving between them and seemed to be crowded around a vehicle.

Police initially tried to split any groups up that seemed to be in heated arguments and get them away from the area.

It appears that all parties have been in Aura Shisha lounge, one group of males and the others were a mixture of males and females. Someone from the opposing group has shouted towards [REDACTED] and his friends 'FUCK SUDBURY' which has offended him. This has turned into a heated argument. Between the two feuding groups someone has hit [REDACTED] in the face causing a minor cut to the lip.

The opposing friend group (LINKED CRIS 19[REDACTED]/22) have stated that they were approached by [REDACTED] and his friend group, they have started to argue and assault them including the females and they defended them.

[REDACTED] was drunk, he was verbally abusive in general and was pushed away more than once to prevent any further incidents. He was making attempts to walk over towards the other group but was stopped and was making comments which agitated the other group. Police stayed to prevent a BOP. [REDACTED] was asked to leave for over 20 minutes but just continued to

walk the area, once all of the other group left officers left the area. [REDACTED] was with 4 other friends from his group.

[REDACTED] is no trace to PNC and IIP.

Due to the number of people being involved being between 15-20 we are unable to initially establish who the suspect is, [REDACTED] declined medical treatment after having initially had LAS called, declined to be taken to hospital or any other treatment. He did not give a statement and was unable to give exact details of the suspect.
