Who one didn't have bookings or with a girl. A friendly bouncer has approached us and mentioned that we should call the friend of ours whos birthday it was to come out and verify us to get inside. As so, I called my friend to come out to verify us. At this time we was standing opposite the bouncers behind the gate. All of a sudden my friend beside me got punched by the bouncer. He was fully attached by this security for absolute no reason whatsoever. I understand that bouncers have all the rights to do their job by kicking people our and not taking any sort of abuse verbally or physically. However, in this occasion, this report is getting filed because we understand that we didn't give them any reasons for this assault. This led the bouncers to attack myself and 2 other friends. They was man handling us as we were some sort of teddy bears. We only retaliated in a pure self defence reason. We are not supermen or think of us in any way to get into a fight with bouncers. The worse think about this is that we were also not intoxicated. I can't stress enough about this situation due to the fact that were assaulted for no reason. My understanding of the law in bouncers is that they are not allowed to assault public members but like I keep mentioning; they had 0 reasons.

VIW1 states that he and his two friends were trying to get into venue. They were stopped and not allowed in.

One of the bouncers came away from the door and came over to speak to them calmly. He told them that he knew the owner and that they should call their friend to come out and verify the reservation and that they would be let in.

Whilst this was happening and VIW1 was calling his friend, a different bouncer “came out of nowhere” and “swung for” his friend, punching him in the face.

VIW1 states that he and his friend retaliated but only in self-defence and then all the bouncers joined in. One of them punched VIW1 in the left side of his face “as he was leaving” causing bruising to the inside of his mouth.

VIW1 states that one of his friends has a chipped tooth. I have advised him to pass CMS details on to his friends so that they can be added
