



Initial actions:

Officers arrived on scene after the victim called police and stated that someone had tried to take his chain off of him from around his neck. When officers arrived on scene the victim made himself known to police and officers took the victim in the rear of their vehicle for a drive around of the immediate area to look for suspects potentially still on scene or in the area.

Victim then told police that this incident occurred twenty minutes prior to him calling police and that he believes the males were long gone from the area, the male was mostly concerned about how the bouncers working on the venue location had refused him entry to the nightclub because they suspected his ID to be out of date.

The male gave his details to police and provided the below account. Police confirmed the victims ID on PNC and informed the door staff of the location who then allowed the victim in for his own safety. Officers asked LA CCTV to have a look at their cameras for potential evidence however this was no trace.


