Police were on patrol and come across huddle of people in the street pushing and shoving between them and seemed to be crowded around a vehicle.

Police initially tried to split any groups up that seemed to be in heated arguments and get them away from the area.

It appears that all parties have been in Aura Shisha lounge, one group of males and the others were a mixture of males and females. Once having left someone in one of the group has shouted towards the others 'FUCK SUDBURY' which has turned into a heated argument. Between the group someone has hit [REDACTED] in the face causing reddening to the eye.

The friend group with [REDACTED] have stated that they were approached by the opposing group, they have started to argue and assault them including the females and they defended them

[REDACTED] was drunk, he did not seek medical attention and was taken away by his family and friends to prevent any further incidents.

[REDACTED] is no trace to PNC and IIP.

Due to the number of people being involved being between 15-20 we are unable to initially establish who the suspect is, [REDACTED] has not given a statement and no further investigation at this stage.
