JARVIS-EAMES 1836NW. VIW1 observed SUS1 on the pavement fighting with another female. VIW1 pulled the vehicle to the side of the road and both VIW1 and PC JARVIS-EAMES exited the vehicle in order to stop the female from fighting. VIW1 and PC JARVIS-EAMES took VIW1 by each arm and escorted her to another part of the pavement away from the altercation. Whilst VIW1 and PC JARVIS-EAMES were talking to SUS1 to find out what had happened SUS1 has slapped VIW1 on the Right Wrist. This not only assists the CPS in making an informed decision in terms of charging for the correct offence but it also assists the Bench in applying the correct sentencing guidelines based on the seriousness of the injury.

suspect, make sure the capacity at the time of the assault is ascertained before a disposal decision to NFA is made. We are not medically trained to NFA based on a suspect being sectioned or having MH issues.

- Include the Deputy Commissioner's Impact Statement within the post-charge COPA file. This won't always be available for overnight cases to court but they must be requested.
- Make sure the DPP's Guidance on Charging is adhered to. Know what is suitable for Police charge and what should be referred to CMT/CPS for review to charge.
- Where the suspect is bailed or RUI'd and CMT or CPS have authorised a charge, ensure these post charge/PCR casefiles are passed to CMT for sign off and not signed off by the OIC's supervisor.
- Ensure the Streamlined Disclosure Certificate is completed and fit for purpose.
- VCOP – Please make sure you contact the victim and update them regularly throughout every stage of the investigation. This includes arrest of suspect, suspect bailed to return and BTR alterations, suspect charged & any bail conditions, case closed undetected or suspect NFA, other case disposals – cautions, PND etc, regular monthly updates until disposal.
- Ensure the 'PH' flag (Op Hampshire) is added to this CRIS report.
