Church End Youth Anchor Programme

Brent Council is appointing a qualified and experienced Operator to deliver youth focussed services in a high-quality all-inclusive facility for young people aged between 16 – 25, supporting them with development & skills training and provide more opportunities linked to work experiences, employment opportunities & entrepreneurship pathways.

The project will also help diversify Church Road's high street offer by creating a space that is genuinely owned/used by all communities to socialise, gather, learn and collaborate. To support the high street diversification, the space could also offer after school hours, weekends, half-term and holidays as well as provide robust services and programmes for the community during the day, serving as a local hub for residents and the wider community with a range of social, economic, recreational and learning opportunities.

Brent Council carried out an extensive procurement process to appoint an experienced Operator (i.e., service provider, workspace Operator, youth-led charity or a mix of all working in partnership) to deliver an innovative, inclusive, safe, welcoming, inspiring & creative, financially self-sufficient youth hub provision in Church End over a 10-year period.

Council officers have identified a suitable contractor providing the most economically advantageous offer in accordance with the relevant evaluation criteria and therefore

recommend award of a contract for Young Brent Foundation (YBF) in partnership with United Borders (UB) to successfully deliver this programme.

The project will be located on the ground floor of the Hornby Court development at High Road, London NW10 2AZ (450sqm GIA), which lies in a key anchor location on the high street.

This Equality Analysis is being conducted for the development of the youth anchor programme within the dedicated space at Hornby Court NW10 over the 10-year lease term period.

2. Who may be affected by this policy or proposal?

Church End Youth Anchor will be a youth provision at the heart of its community, in every sense. Actively welcoming people of all ages although the primary activities are for 16 – 25 year olds, culture and background, it will be a social space: a place full of life, energy and fun that will support and celebrate creativity and imagination, and allow knowledge and ideas to be accessed, produced, and shared.

Efficient to run, and easy to maintain, the Youth Anchor will be a really useful local landmark: a high quality design that is able to respond to changing aspirations, offering the spaces and services that its community needs, now and in the future.

The Youth space will be co-designed with young people from the local area in the bid to encourage collaboration, creativity, and social engagement, ensuring it is conducive to fostering positive youth development and growth. YBF and United Borders has appointed development and construction company, Hollybrook Homes to lead on the detailed design and fit out of the space to meet the agreed end user requirements.

YBF and United Borders have developed a full and robust programme for the space which seeks to operate on a typical 6-day week, with tailored activities and events catering to the diverse needs and interests of the community. The weekdays will be dedicated to a diverse and progressive youth work programme, including skill-building workshops, career development seminars, and mentorship sessions.

The space will offer after school support services, such as tutoring, homework assistance, and educational counselling led by youth organisations United Borders, N.Gage and The Cut. The space will be available to the wider community at the weekends, offering community engagement events, cultural festivals, and interactive workshops as well as providing opportunities for residents, businesses, and visitors to interact, gather and participate in various activities. The space will also incorporate flexible co-working spaces and event rental facilities, encouraging collaboration and entrepreneurial activities among young people and local entrepreneurs.

Added Value: the space will support digital transformation through coding and robotics workshops, Al education and events, tech mentoring programmes, tech entrepreneurship incubators, experimental retail and innovative Uses: Pop-Up Retail

Spaces, temporary installations, interactive augmented reality exhibition and art installations as well as hackathons and innovative challenges.

The Church End Youth Anchor programme is viewed as having positive impacts on groups with the protected characteristics of age, sex, race and disability.

There will be the provision of an affordable youth provision and a workspace offer for businesses and employment or entrepreneurial opportunities. It has the potential to advance equality of opportunity for groups disproportionately affected by unemployment and economic inactivity.

The space will also be accessible to all users and will include wheelchair access accommodating people with physical difficulties.

Over the last 2 years, extensive community engagement has taken place which has helped to shape the more recently adopted Church End Masterplan and SPD (adopted in May 2023).

In 2022, external consultants Social Life were commissioned to deliver on a scoping feasibility study to assess the viability and demand for a youth provision in Church End. Within a 2 month period, over 100 young people from the roundwood ward were interviewed via a series of street interviews to glean insights into what they wanted to see in Church End and if a Youth Anchor provision would be something they would be interested in. The responses were all positives and in favour of a youth provision in Church End. Following this, a series of co-design workshops were delivered within the secured space with young people who inputted initial ideas into the co-design of the unit, following an indicative programming schedule which highlighted the space would be accessible to all in the community.

Other groups engaged with over the last two years include:

- Over 30 Charity Youth Organisations across Brent and outside the borough,
 who had an interest in bidding to be the potential operators
- Local businesses on Church Road
- Local primary schools
- Local Faith Organisations Churches and Mosques.
- A core group of Senior Officers across Brent Highways and Infrastructure, Property, Regeneration, Economic Development, Culture, Transport Planning, Comms and Engagement
- Brent residents generally

AGE

Details of impacts identified

The aim of the Youth Anchor provision is to attract and welcome people of all ages although the primary activities are aimed at young people aged between 16 - 25. The building wll be co-designed with young people and the furniture and fit out will be designed for a range of ages. At least 50% of the population in Church End is aged between 0-25 years old, with the largest age group populations ranging between of 20-25, 25-29 and 30-34 years (ONS, Estimate for 2020).

The Youth Anchor space will have specific and separate zones for teens and older users and there are designated quiet areas so different groups do not disturb each other.

The local area has also recently welcomed North Brent School with 220 pupils (aged between 11 – 18 years old) who will all become potential users of the space.

DISABILITY

Details of impacts identified

The building itself will be fully accessible and the project team will work closely with the Operator and Works Contractor to ensure the detailed design of the building in the next stage continues to comply with DDA regulations.

RACE

Details of impacts identified

The Youth Anchor focusses on bringing in 16 - 25 years old who are likely to live in the immediate area, which primarily includes Black African, Caribbean and Somali communities. This is reflected in the most recent census population results which shows that the largest population group in Church End is Black, 34% (ONS, Estimate for 2020).

The designed programme of skills development and activities will support young people to access employment opportunities developing a range of local leaders.

<u>SEX</u>

Details of impacts identified

Following an extensive research engagement exercise carried out in 2022 where over 100 young people were interviewed, a significantly larger proportion the interviewees were male youth (71%) versus female (25%) despite targeting women only during Brent festival on the 8th October. (Source: Social Life Street Interviews, August to October 2022).

Many of the public locations where interviews were carried out were male dominated, and summer programming at the youth centres mainly attracted boys and young men.

This discrepancy was addressed in the co-design workshops where we had more female representation (50% of the co-design workshop cohorts were women) and it was highlighted that young women need a dedicated space to gather, socialise and learn.

Therefore the provision will offer dedicated spaces an activities for young women, for example encouraging more young women to explore tech etc.

There are certain detailed design/ management questions which need to be addressed in the next stage in order to ensure that negative impacts on protected groups are minimised. These cannot be addressed now as the detail has not been designed yet:

- Are assistance dogs welcome?
- Can lighting be adjusted to assist people with a sight impairment?
- Will emergency procedures clear and easy to understand for the majority of customers?
- Will directional signs be clear and easy to understand for the majority of customers?

- Will we use heavy doors which may be more difficult for some people to open due to their age or disability?
- Will we be using easy read English and possibly a symbol format in signage for the public

Monitoring of the ongoing impact of the youth anchor project will be achieved by:

- Development of design in next stage to ensure that detailed specification is delivered to a high standard. Regular detailed design reviews will take place and it is hoped that all outstanding design packages will be resolved in the next stage.
- Continue good communication to residents and stakeholders about the development as it progresses on site. The communication strategy for the delivery stage needs to be developed with the appointed Operator.
