- 9) Have you obtained any public liability insurance for the event?
- 10) How will you ensure that all equipment (stage, marquee, electrical items used) will be safe?
- 11) Will the event area have any fencing installed around the permitter?
- 12) How will the event log any incidents of disorder, medical issues, complaints etc...?
- 13) How will the premises negate against causing noise related complaints from the live music? (Especially as it's stipulated to end at 23:30 on certain days)
- 14) Have you undertaken a noise management plan?
