#### **APPENDIX ONE:**

### Mount Vernon Cancer Centre Review: Engagement with London population

### 1. Introduction

Patient, public and stakeholder engagement to identify the issues and develop solutions to the challenges at Mount Vernon Cancer Centre began at the start of the review in 2019 and has continued throughout.

This paper outlines a summary of the public facing engagement that has taken place in London boroughs during that time.

# 2. Patient and public engagement:

During the first phase of the programme, an independent company ran a survey and several face to face engagement events.

- 50% of the face to face workshops took place in North West London
- At least 27% of those completing the survey were from NWL based on their selection of closest A&E to where they live

Following a pause of the review programme to enable clinical and operational teams to focus on responding to COVID-19, the programme entered Phase 2 – the development of options. October 2020 – April 2021.

This included a range of online focus groups and workshops covering topics including clinical model and estates, radiotherapy and cancer specific pathways. In addition, there were a number of discussions with individuals and attendance at established groups, as well as meetings with Health Scrutiny Chairs and Healthwatch organisations. These have included discussions with the Chair of Northwood Resident's Association and a meeting with a Harrow Somali Women's Group.

Of 73 attendances at focus groups to help develop proposals, approximately 42% of participants declared they were from NWL, with Harrow having the largest proportion.

• The areas of Harrow and Hillingdon are relatively well represented, but there has been little engagement from Brent and Ealing.

Following this, locality events were held (online due to Covid concerns) to understand the impact of the proposals on people living in different areas. Eight of these were specific to the North London population.

Once a preferred proposal had been identified and tested, feedback from patients and the public was used to identify themes for the next series of workshops. These included transport and access, care closer to home, learning disabilities, disabled access and experience, and also some geographical ones, including one for residents of North Central London who had been less likely to attend events than those from North West London. In addition to established communication methods and publication through organisations and groups, a targeted social media campaign was used to communicate information about the locality events, particularly targeting residents of North Central London.

More than 100 face to face and online focus groups were held in total.

• The majority of these were either general events or themed and not specifically targeted at one population rather than another. However, 13 events have been held exclusively for London patients and residents over the course of the review.

Regular information, including updates following Programme Board meetings, and information about how to get involved, is distributed to a network of almost 1,000 stakeholders. This includes communications teams in ICBs, providers, Healthwatch, and Local Authorities within the Mount Vernon Cancer Centre catchment, who use their own networks to further disseminate the information. It also includes all MPs within the catchment (originally 48, now 44 following boundary changes).

A dedicated, interactive MVCC review website was launched in January 2021. The website has received 28,389 visits and has 239 people have registered with the site, 38% of whom have registered with a London postcode. The interactive style of the site enables people to post ideas, stories and questions, amongst other activity.

A number of meetings have been held with the Chair of the Northwood Residents' Association who have a track record for campaigning. Updates on the proposals for Mount Vernon Cancer Centre have been included in each of the Northwood Residents' Association newsletters for the past few years, and the chair recently reported that they felt well engaged with and ready for the change.

## 3. Patient Reference Group

A Patient Reference Group has been meeting regularly since early in the review to review the case for change, help set criteria and develop proposals. Membership is proportionate to the volume of patients treated at Mount Vernon Cancer Centre from each area and members are nominated via Healthwatch. Hillingdon and Harrow have very active members and one of the Hillingdon members accompanied the Health Overview and Scrutiny Chairs on their visit to the cancer centre in November 2024.

#### 4. Healthwatch

# **Healthwatch Hillingdon:**

- Healthwatch Hillingdon was a member of the communications and engagement group throughout the development of proposals and early engagement. This group was set up at the start of the programme to advise on and assist with the communications and engagement planning and activity linked to the programme.
- Healthwatch Hillingdon has had a place on the programme board since the beginning of the programme and accompanied the Independent Clinical Review team for their visit.
   Members were also part of the panel appointing UCLH as preferred provider.
- Nominated three representatives to the Patient Reference Group

#### **Healthwatch Harrow:**

- Has become engaged since 2020 and participated in a Healthwatch workshop (8<sup>th</sup> October 2020) to help develop proposals. Representatives have also attended some of the focus groups.
- Nominated two patient representatives to the Patient Reference Group
- Has helped with access to some local communities to undertake some bespoke work, for example with the Somalian community.

**Healthwatch Brent and Healthwatch Ealing** were invited to the 2020 workshop to develop proposals. They have been regularly provided with information about public facing events with a request to distribute to appropriate patient groups. They were asked to nominate a patient representative to the Patient Reference Group but were unable to provide a representative.

**Healthwatch Central West London** (Kensington and Chelsea) participated in the Healthwatch workshop and has had patient representation at some events.

Healthwatch Hammersmith and Fulham, Healthwatch Haringey, and Healthwatch Hounslow are among other Healthwatch organisations invited to the workshop and provided with information about the events with a request to distribute to appropriate patient groups.

All NW London Healthwatch organisations receive regular updates about the programme.

# 5. Health Scrutiny

## **Joint Health Overview and Scrutiny**

The Mount Vernon Cancer Centre Joint Health Overview and Scrutiny Committee (MVCC JHOSC) comprises representatives from the following councils: Bedford, Brent, Buckinghamshire, Central Bedfordshire, Ealing, Harrow, Hertfordshire, Hillingdon, Luton and Slough. It is tasked with reviewing and scrutinising the consultation proposals and consultation with regard to services currently delivered at MVCC.

Ten Local Authorities are fully represented, including the London Boroughs of Hillingdon, Harrow, Brent and Ealing.

Seven out of 17 voting members are from North West London Boroughs (around 40% compared to a 33% share of the cancer centre's patient population). A non-voting member from Barnet attends (approximately 2% share of the patient population).
