Police representations to the application for a full Variation of Premises Licence for 'O'Bombeiro, 25, Park Parade, NW10 4JG'

Police certify that we have considered the application shown above and wish to make representations that the likely effect of the grant of the application is detrimental to the Council's Licensing Objectives for the reasons indicated below.

An officer of the Metropolitan Police, in whose area the premises are situated, who is authorised for the purposes of exercising its statutory function as a 'Responsible Authority' under the Licensing Act 2003.

The Police representations are concerned with all four of the licensing objectives, namely:

- The prevention of crime and disorder;
  - Public safety;
  - The prevention of public nuisance;

## **Current licence provides for the following licensable activities:**

#### Sale of alcohol:

Sunday to Thursday from 11:00hrs to 23:30hrs Friday to Saturday from 11:00hrs to 01:30hrs

### **Late Night Refreshments:**

Sunday to Thursday from 23:00hrs to 23:30hrs Friday to Saturday from 23:00hrs to 01:30hrs

#### **Regulated Entertainment:**

Sunday to Thursday from 11:00hrs to 23:30hrs Friday to Saturday from 11:00hrs to 01:30hrs.

#### **Opening Hours:**

Sunday to Thursday from 08:00hrs to 00:30hrs

Friday to Saturday from 08:00hrs to 02:00hrs.

The application is to remove condition 4 of annex 3 that was imposed by the licencing committee after a riview hearing:

<u>Conditioin 4 annex 3:</u> No attractions are to be present in the back room. The pool table, fruit machine, televisions and other paraphernalia must be removed. Furniture is only permitted in the back room if and insofar as is necessary for seating and serving customers with bookings for sit-down dining.

The above condition was imposed by the licensing committee after a review hearing on the 20/04/2024. This review was instigated after a quantity of drugs were discovered in the back room when it had a pool table in it which resulted in the venue being subject to a closure order.

The venue is located on Park Parade NW10. The locality of the premises is well known for antisocial behaviour and drug use. Drug dealing.

By removing condition 4 annex 3. This will inadvertently put the venue and licence holder in breach of a number of other conditions that were imposed by the subcommittee during that hearing.

<u>This will put the venue in breach of condition 1 Annex 3:</u> No access to the premises is permitted save for: customers sitting down for a meal, customers performing personal takeaway collections, staff, and visitors with a legitimate business purpose in attending the premises (e.g. deliveries of food and drink, maintenance and decoration etc.).

This will put the venue in breach of condition 3 Annex 3: Customers are prohibited from accessing the back of the premises beyond the corridor save for access to the toilets or back yard, unless they have a booking and have provided their name and details. Customers with a booking are permitted to access the back of the premises only for sit-down dining.

This will put the venue in breach of condition 7 Annex 3: Alcoholic beverages are to be served only as an ancillary to food.

Police strongly oppose the removal of condition 4 Annex 3 as this will undermine conditions 1, 3 and 7 of Annex 3 imposed by the licensing committee. The conditions were imposed due to the drug activity that were taking place at the venue back in 2023 and 2024. Since these conditions have been imposed there has been no reported incidents of drugs or ASB (Anti-Social Behaviour) at the venue. The removal of the conditions may invite the activities of anti-social behaviour back into the venue and return it to what it was. This will also remove the restaurant aspect of the venue and turn it back into a pub/ night club environment and may result in the venue returning to what it was previously

Again police are objecting to the variation of the licence.
