

1. Consumption of alcohol -
  - On street drinking is an issue daily not just on Stadium event days. The inclusion of this in the Wembley PSPO and making this PSPO “every day rather than Stadium event days” would be beneficial as this would assist in eliminating street drinking, encouraging anyone into licensed premises, making the wider public realm a more pleasant and welcoming space, reduce litter and may have an impact on other ASB / VAWG issues / other crime.

2. Use of illegal drugs or psychoactive substances
  - The use of illegal / psychoactive substances:
    - Drug Dealing; is an issue which has been a focus for the local policing teams on and off for some time with varying levels of success. Whilst the police have been relatively successful in removing drug dealing in and around Wembley Park for limited periods of time, dealers inevitably return or the vacuum is filled by others after a short period. Drug dealing has become less overt and more hidden as a result of the police action but does still occur.
    - Whilst not limited to, the number of student residences in the area undoubtably contributes to the attractiveness of the location to dealers as there is a large proportion of users in close proximity. Concentrating efforts in these areas may assist in reducing the dealers market.
    - As above with street drinking, extending this into the wider PSPO covering Brent and enforcing daily would have an impact making the wider public realm a more pleasant and welcoming space, reduce litter and may have an impact on other ASB / VAWG issues / crime.

  - **As above with street drinking, extending this into the wider PSPO covering Brent and enforcing daily would have an impact making the wider public realm a more pleasant and welcoming space, reduce litter and may have an impact on other ASB / VAWG issues / crime.**

8. Use of megaphone or microphone with speaker

  - **As above with street drinking, extending this into the wider PSPO covering Brent and enforcing daily would have an impact making the wider public realm a more pleasant and welcoming space, reduce litter and may have an impact on other ASB / VAWG issues / crime.**

11. Illegal trading of tickets (ticket touting)
- Whilst not a major issue daily, there is a need for enforcement on OVO Arena event days. Illegal ticket touts are in position prior to most events in the OVO Arena. Ticket touts limit space on public footpaths forcing pedestrians into the public highway and exploit fans who think they are getting a genuine ticket which is not always the case. This can lead to “disturbances and disputes” with OVO Arena staff and other members of the general public when they are refused entry to the venue.
  - As above with street drinking, extending this into the wider PSPO covering Brent and enforcing daily would have an impact making the wider public realm a more pleasant and welcoming space, reduce litter and may have an impact on other ASB / VAWG issues / crime.
