

**Fees and Charges for 2026 - 2027**

Setting fees & charges for regulatory services (such as licensing or planning) is a non-executive function and must be approved by Full Council, unless Full Council delegates this responsibility to a committee or officer. In contrast, fees & charges for discretionary services are usually executive functions and therefore require approval from Cabinet or Cabinet Members, who may also delegate this authority.
