### **Brent Council proposed changes to Kensal Rise Primary School**

#### **1. Introduction**

Kensal Rise Primary School, Harvist Road, Kilburn, NW6 6HJ is a Community school located in the southern part of the borough. It provides 630 school places for primary aged children between the ages of 4 to 11. It also provides a nursery with 90 full time and part time places.

Brent Council's strategy for Special Educational Needs and Disabilities (SEND) is to support mainstream schools to include pupils with identified SEN within their provision. This includes some pupils with statements for Speech, Language and Communication Needs (SLCN) many of whom are currently successfully included in mainstream schools with additional support provided through the statement and/or by the school.

Some pupils need more intensive support in their mainstream school and a further part of the strategy has been to support the development of Additionally Resourced Provision (ARP) for low incidence needs including SLCN. ARPs usually consist of a base where pupils can receive small group intensive support to help them overcome their barriers to learning.

This proposal is part of a review of the range of existing provision for meeting pupils' SEN across Brent schools in line with current and projected demand. The aim of this review is to ensure that children achieve the best outcomes possible in good value, cost effective school provision.

Kensal Rise primary school has a 20 place ARP for children with SLCN. The ARP has never had more than 15 pupils placed there and currently it has 10 pupils. 4 of these pupils are currently in Year 6 and they will leave the school in July 2013. This will leave 6 pupils in a 20 place provision which is not cost effective. It is estimated that there is a surplus of ARP places for SLCN to meet projected demand within Brent up to 2020.

Brent Council is therefore consulting with staff, parents and the community on the proposal to close the 20 place ARP with effect from September 2013.

<p><b>2.</b></p>	<p><b>Background</b></p> <p>Over the last 5 years there has been a decline in demand for ARP support for pupils with SLCN. This has partly been due to improvements in technology and the knowledge and awareness of mainstream school staff enabling more children with SLCN to have their needs met in normal mainstream school classes. This has in turn allowed an increase in parents wanting their children to attend their local school with their peers.</p> <p>Brent Council currently maintains a total of 45 ARP places for primary aged children with SLCN, 25 places at Oakington Manor Primary School and 20 places at Kensal Rise Primary School. There will be 19 pupils on the roll of Oakington Manor ARP in September 2013 which with the 6 pupils at Kensal Rise provides a total of 25 pupils in provision of 45 places in total.</p> <p>According to SEN pupil place projections there will no future increase in requirement for SLCN ARP places.</p> <p>At present there are no plans to place any more pupils with statements for SLCN in either of the ARPs. The pupils at Kensal Rise ARP are receiving good support maximizing their opportunities to achieve good outcomes, however 6 pupils in a provision for 20 is not cost effective.</p>
<p><b>3.</b></p>	<p><b>The proposal</b></p> <p>Brent Council is therefore proposing to change the character of Kensal Rise Primary School by closing the 20 place ARP for pupils with statements of Special Educational Needs for Speech, Language and Communication Needs with effect from September 2013.</p> <p><b>What will happen?</b></p> <p>The Kensal Rise ARP consists of 2 classrooms (only 1 of which is being used at present due to low demand) which are adapted to help meet the needs of the pupils. The school also receives additional funding to support one specialist teacher, some input from a speech and language therapist and dedicated teaching assistant support.</p> <p>The proposal is to close the classrooms as specialist classrooms with effect from 1<sup>st</sup> September 2013 allowing them to be used for mainstream teaching. The additional funding arrangements would also cease with effect from 1<sup>st</sup> September 2013.</p> <p><b>Who will this affect?</b></p> <p>This will affect the 6 pupils expected to still be in the ARP at the beginning of September 2013. They and their parents will be offered places at the ARP provision at Oakington Manor Primary School or the opportunity to remain at Kensal Rise Primary School with individual packages of support. Parents will be invited to visit the Oakington Manor Primary School ARP provision to help in making a decision. They will be eligible for assistance with transport to Oakington Manor if they decide that they want a place at the school for their child.</p>

4.	<p><b>Additional information</b></p> <p>Speech, Language and Communication Needs (SLCN)</p> <p>The majority of pupils with SLCN attend their local mainstream school with support. Some children, particularly those of secondary age who have additional emotional, social and/or communication difficulties are placed in special school provision. The proposed closure of the ARP at Kensal Rise Primary School in line with the changing incidence of demand for this type of provision enables the Council to continue to maintain a range of cost effective provision. This provides parents with choice across a continuum of provision matching the continuum of need from severe in special schools to specialist support in ARPs to within mainstream classes with additional support.</p>
5.	<p><b>The changing demand for ARP places</b></p> <p>Brent Council is addressing the future need for ARP and special school places through a number of initiatives guided by careful analysis of SEN incidence data and the development of projections that take account of the overall projected increase in the Borough's population. This proposal should be viewed in the context of other recent developments that are aimed at providing good quality provision close to home address.</p>

The proposals will result in more effective use of resources across the local authority area enabling rationalisation on to one site.

The proposals will enable the resources for this type of SEN to be centralised on to one site at a more central location within the Local Authority, as a direct result of discontinuing provision at Kensal Rise. The provision at this more central site is fully accessible and within the building of a large primary school enabling pupils free access to mainstream classes and teaching. Specialist teaching staff will be centralised on to one site transferring from the discontinued provision, which will enable greater mutual support and development of expertise. The supply of places will match the projected demand for the future and reduce wastage of resources as a result of maintaining significant over capacity.

Notice is given in accordance with Sections 19(1) and 21(2) of the Education and Inspections Act 2006 (as amended by the Education Act 2011) that the London Borough of Brent (the Local Authority) intends to make a prescribed alteration to Kensal Rise Primary School, Harvist Road, Kilburn, NW6 6HJ (DfE number 3042065) from 01 September 2013.

Kensal Rise Primary School is maintained by the Local Authority as a community school. The London Borough of Brent is proposing to change the character of Kensal Rise Primary School (Community) by closing its Additionally Resourced Provision (ARP) for pupils with statements of Special Educational Needs (SEN) for Speech Language and Communications Need (SLCN).

Kensal Rise Primary School currently has a 20 place ARP for children with SLCN. The ARP has never had more than 15 pupils placed there and currently has 10 pupils, 4 of which are currently in Year 6 and they will leave the school in July 2013. This will leave 6 pupils in a 20 place provision which is not cost effective. It is estimated that there is a surplus of ARP places for SLCN to meet projected demand within Brent up to 2020.

This proposal will affect the 6 pupils expected to still be in the ARP at the beginning of September 2013. They and their parents will be offered places at an alternative existing ARP at Oakington Manor Primary School. Parents will be invited to visit the Oakington Manor Primary School ARP provision to help in making a decision. They will be eligible for assistance with transport to Oakington Manor if they decide that they want a place at the school for their child.

Alternatively the 6 pupils and their parents will be offered the opportunity to remain at Kensal Rise Primary School with individual tailored packages of support which will support the pupils to achieve their objectives in a similar way to the ARP.

The Council will ensure that the pupils and parents are not disadvantaged in any way as a result of closing the provision in the current Kensal Rise ARP.

This proposal is part of a review of the range of existing provision for meeting pupils' SEN across Brent schools in line with current and projected demand.

All applicable statutory requirements to consult in relation to this proposal have been complied with.

### **Brent Council proposed changes to the Special Educational Needs provision at Oakington Manor Primary School**

#### **1. Introduction**

Oakington Manor Primary School, Oakington Manor Drive, Wembley, HA9 6NF is a Foundation primary school located in the central part of the borough close to Wembley Stadium. It provides 630 school places for primary aged children between the ages of 4 to 11. It also provides a 25 place Additionally Resourced Provision (ARP) for children with Speech, Language and Communication Needs (SLCN) and a nursery with 72 part-time places.

Brent Council's strategy for Special Educational Needs and Disabilities (SEND) is to support mainstream schools to include pupils with identified SEND within their provision. This includes some pupils with statements for SLCN and some with statements for Autism Spectrum Difficulties (ASD), who are high functioning and capable of accessing mainstream curriculum. Many of the pupils identified with these needs are currently successfully included in Brent's mainstream schools, some with additional support provided through a statement of special educational needs and many others supported by targeting school support.

Some pupils with SLCN and high functioning ASD however, need more intensive support in their mainstream school and a further part of the strategy has been to support the development of ARPs in mainstream schools. These ARPs usually consist of a base where pupils can receive small group intensive support to help them overcome their barriers to learning. With this type of provision the pupils are supported to spend as much of the week as possible in mainstream classes.

This proposal is part of a review of the range of existing provision for meeting pupils' SEND across Brent schools in line with current and projected demand. The aim of this review is to ensure that children achieve the best outcomes possible in good value, cost effective school provision. Currently Brent primary aged pupils have access to 45 ARP places for SLCN and no ARP place provision for ASD.

Brent Council is therefore consulting with staff, parents and the community on the proposal **to increase the number of ARP places at Oakington Manor primary school from 25 to 35 and to change the designation from SLCN to SLCN and ASD with effect from September 2013.**

***If you haven't already received a letter from Oakington Manor primary school inviting you to a meeting we would like to invite you. The meeting is to discuss the proposed changes to the school described above and is arranged for Wednesday 24<sup>th</sup> April at 3.30pm in the school hall.***

## **2. Background**

### **How many ARP places for SLCN are there now and what is the expected demand?**

Currently there are a total of 45 ARP places for primary aged pupils with SLCN in Brent, 25 places at Oakington Manor Primary School and 20 places at Kensal Rise Primary School. Presently, it is expected that there will be no more than 25 pupils with SLCN needs in ARP provision by September 2013. The LA will therefore be funding too many places and not using resources efficiently.

According to pupil place projections for special educational needs, the requirement for SLCN ARP places will not rise above 25 before 2020. At present there are no plans to place any more pupils with statements for SLCN in either of the ARPs.

### **Why has this situation developed?**

Over the last 5 years there has been a decline in demand for ARP places for pupils with SLCN. This has partly been due to improvements in technology and the knowledge and awareness of mainstream school staff enabling more children with SLCN to have their needs met in normal mainstream school classes. This has in turn allowed an increase in parents wanting their children to attend their local school with their peers.

### **What about ARP places for ASD?**

There are no ARP places for primary aged children with high functioning ASD who are capable of accessing mainstream classes in Brent at present.

However over the last 5 years the number of statemented pupils aged 4-11 identified with ASD **across the whole spectrum of needs, including those who are higher functioning and capable of accessing mainstream classes**, has increased by 20%. Numbers in the Y1 to Y4 age group particularly indicate a continuing increase in need for future years.

This has resulted in an increase in demand for special school places for primary aged pupils with ASD in recent years, which is in contrast to the lower and more stable demand for SLCN places described above. The following table illustrates this increase:

	<p>To ensure that parents and carers have a balanced choice of provision to match the varying severity of needs of children with ASD, Brent needs to develop ARP provision for primary aged pupils who have high functioning ASD in a similar way to meet this increasing demand.</p>
<p><b>3. The proposal</b></p>	<p>Brent Council is therefore proposing to change the character of Oakington Manor Primary School by increasing the number of ARP places from 25 to 35 and to change the designation from SLCN to SLCN and ASD with effect from September 2013. This will ensure that the ARP provision for SLCN is maintained at the forecast level of 25 and will increase the ARP provision for primary aged children with high functioning ASD capable of accessing mainstream classes by 10. It will also enable the flexibility in the use of these places between the two identified needs.</p> <p><b>What will happen?</b></p> <p>The Oakington Manor ARP consists of 2 classrooms which are adapted to help meet the needs of the pupils. The school also receives additional funding to contribute to the cost of two specialist teachers, input from 1.3 speech and language therapists and dedicated teaching assistant support.</p> <p>The proposal is to refurbish these classrooms, adding improvements in acoustic treatment and convert a third identified classroom to increase the capacity. The additional funding arrangements would also need to be adjusted to reflect the increase in capacity and change in designated need with effect from 1<sup>st</sup> September 2013.</p> <p><b>Who will this affect?</b></p> <p>The 25 pupils expected to still be in the ARP at the beginning of September 2013 will not be affected. The only change they will experience is that they will be taught in the newly refurbished classrooms.</p> <p>Parents and carers of primary aged children with high functioning ASD capable of accessing mainstream classes will have access to ARP provision. They do not have this at the moment and therefore they and their children will have an increased number of options for placement.</p>
<p><b>4. Additional information</b></p>	<p><b>Speech, Language and Communication Needs (SLCN)</b></p> <p>The majority of pupils with SLCN attend their local mainstream school with support. Some, who need a higher intensity of support, access ARP places in mainstream schools to enable them to access mainstream classes. This provides parents with choice across a continuum of provision matching the continuum of need from severe in special schools to specialist support in ARPs to within mainstream classes with additional support.</p>

## **The growing demand for school places for children with Autism Spectrum Disorders (ASD)**

The table below provides further information about the increased demand on school provision over the last 5 years as a result of the increasing number of pupils with ASD in Brent. It illustrates the increasing need to place pupils with ASD in independent/non maintained special schools outside the Borough boundary involving pupils having to travel long distances.

The proposed change in the designation of Oakington Manor ARP will provide parents of primary aged pupils with high functioning ASD who are capable of accessing mainstream classes with increased options for the education of their children.

Brent Council is proposing to change the character of Oakington Manor Primary School by increasing the number of Additionally Resourced Provision (ARP) places from 25 to 35 and to change the designation from Speech Language and Communications Needs (SLCN) to SLCN and Autistic Spectrum Disorders (ASD) with effect from September 2013. This will ensure that the ARP provision for SLCN is maintained at the forecast level of 25 and will increase the ARP provision for primary aged children with high functioning ASD capable of accessing mainstream classes by 10. It will also enable the flexibility in the use of these places between the two identified needs.

The Oakington Manor ARP consists of 2 classrooms which are adapted to help meet the needs of the pupils. The school also receives additional funding to contribute to the cost of two specialist teachers, input from 1.3 speech and language therapists and dedicated teaching assistant support.

The proposal is to refurbish these classrooms, adding improvements in acoustic treatment and convert a third identified classroom to increase the capacity. The

additional funding arrangements would also need to be adjusted to reflect the increase in capacity and change in designated need with effect from 1 September 2013.

The 25 pupils expected to still be in the ARP at the beginning of September 2013 will not be affected. The only change they will experience is that they will be taught in the newly refurbished classrooms.

### **Alteration description**

A description of the proposed alteration and in the case of special school proposals, a description of the current special needs provision.

Currently there are a total of 45 ARP places for primary aged pupils with SLCN in Brent, 25 places at Oakington Manor Primary School and 20 places at Kensal Rise Primary School. Presently, it is expected that there will be no more than 25 pupils with SLCN needs in ARP provision by September 2013. The LA will therefore be funding too many places and not using resources efficiently.

According to pupil place projections for special educational needs, the requirement for SLCN ARP places will not rise above 25 before 2020. At present there are no plans to place any more pupils with statements for SLCN in either of the ARPs.

#### **Why has this situation developed?**

Over the last 5 years there has been a decline in demand for ARP places for pupils with SLCN. This has partly been due to improvements in technology and the knowledge and awareness of mainstream school staff enabling more children with SLCN to have their needs met in normal mainstream school classes. This has in turn allowed an increase in parents wanting their children to attend their local school with their peers.

#### **What about ARP places for ASD?**

There are no ARP places for primary aged children with high functioning ASD



who are capable of accessing mainstream classes in Brent at present.

However over the last 5 years the number of statemented pupils aged 4-11 identified with ASD **across the whole spectrum of needs, including those who are higher functioning and capable of accessing mainstream classes**, has increased by 20%. Numbers in the Y1 to Y4 age group particularly indicate a continuing increase in need for future years.

This has resulted in an increase in demand for special school places for primary aged pupils with ASD in recent years, which is in contrast to the lower and more stable demand for SLCN places described above. The following table illustrates this increase:

Brent Council's strategy for Special Educational Needs and Disabilities (SEND) is to support mainstream schools to include pupils with identified SEND within their provision. This includes some pupils with statements for SLCN and some with statements for Autism Spectrum Difficulties (ASD), who are high functioning and capable of accessing mainstream curriculum. Many of the pupils identified with these needs are currently successfully included in Brent's mainstream schools, some with additional support provided through a statement of special educational needs and many others supported by targeting school support.

Some pupils with SLCN and high functioning ASD however, need more intensive support in their mainstream school and a further part of the strategy has been to support the development of ARPs in mainstream schools. These ARPs usually consist of a base where pupils can receive small group intensive support to help them overcome their barriers to learning. With this type of provision the pupils are supported to spend as much of the week as possible in mainstream classes.

This proposal is part of a review of the range of existing provision for meeting pupils' SEND across Brent schools in line with current and projected demand. The aim of this review is to ensure that children achieve the best outcomes possible in good value, cost effective school provision. Currently Brent primary aged pupils have access to 45 ARP places for SLCN and no ARP place provision for ASD.

Brent Council is therefore consulting with staff, parents and the community on the proposal to increase the number of ARP places at Oakington Manor primary school from 25 to 35 and to change the designation from SLCN to SLCN and ASD with effect from September 2013.

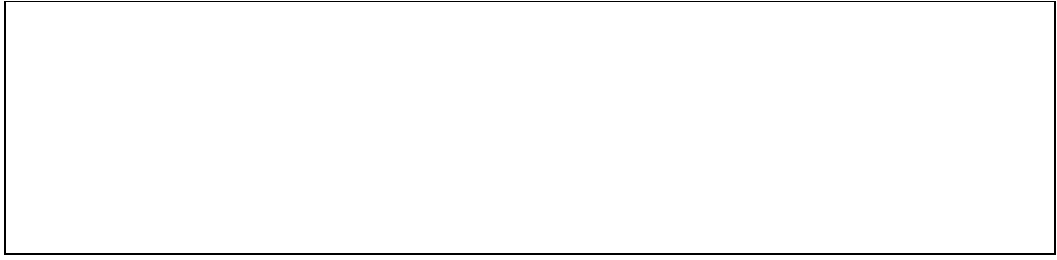

- Sylvie introduced the panel and gave background information about Oakington Manor Primary School and the speech and language unit.
- Carmen gave an explanation of the type of need the children who will attend the unit will have. Nothing will change for the current children in the unit except they will gain a sensory room. Parents from Kensal Rise unit have a choice of either keeping their children at Kensal Rise Primary School with a specialised programme or accepting a place at Oakington Manor drive ARP unit. The main school will continue to have 3 classes in each year group.
- Judith spoke about the consultation process.

	Issues \ comments	Response given
1.	My child has been in this unit a year now. What will be the changes with regard to staffing?	There will be an additional teacher plus one teaching assistant. Depending on the need of the children the teacher may be a speech and language specialist.  The staff will come under the Oakington Manor domain.
2.	I have received a letter with regard to planning permission at this school.	The planning permission letter has nothing to do with this meeting.
3.	Would some SEN children go to the LCC (Language and Communication Centre)?	If the child has language impairment they might, otherwise no. The Special Educational Needs Assessment Service (SENAS) will have to confirm that.
4.	Will the new teacher be an internal teacher? Familiarity is very important for the children.	The new teacher will not necessarily be an internal candidate but it will be somebody who wants to work with children with SEN. The job will be advertised so that everybody has a fair chance of applying for it.
5.	So nothing will change for the existing children?	Children already here will stay here, unless their statements change. Plus there will be a sensory room.
6.	How will you allocate the places?	Through the Special Educational Needs Assessment Service (SENAS). SENAS staff will visit each child and their family.

7.	Will children at Oakington get first priority?	No.
8.	When parents first applied they were denied a place but they now fit the criteria.	There is a difficulty when statements are prepared. Parents can choose which school they wish their child to attend but the statement may say otherwise according to the child's needs.

It is designated to provide school places for secondary aged students between the ages of 11 to 19 with moderate learning difficulties (MLD).</p> <p>The school has provision for 108 places (aged 11 -16) and also has a Sixth Form currently with 28 places (aged 16 – 19) making 136 places in total.</p>
2.	<p><b>The proposal</b></p> <p>The Local Authority is proposing to:</p> <ul style="list-style-type: none"> <li>• expand the school by 40 places for students aged 11 – 16 and</li> <li>• change the designation of the school to provide for the needs of students with moderate learning difficulties (MLD), severe learning difficulties (SLD) and autistic spectrum disorders (ASD).</li> </ul> <p>Brent Council is therefore consulting with staff, parents and the community on the proposal to increase the capacity of the school by 40 places from 136 to 176 and change the character from a designation of MLD to MLD, SLD and ASD from September 2014.</p> <p>The proposal supports the aims of Brent's overarching plan for Children and Families (Children and Young People's Plan). It's aimed at priority 1, ensuring that children and young people are healthy and safe and priority 2, ensuring sufficient school places to meet continuing increasing demand. The proposal also supports the LA's strategy for increasing the range of provision for students with disabilities and SEN and the proportion of school buildings accessible to students with disabilities</p> <p>The change to a broader designation will increase the flexibility of the school to admit pupils with a broader range of associated needs. It is proposed that the change in designation will also apply to the sixth form but the capacity will remain unchanged.</p>

### 3. Who will be affected by the proposal?

The change to the broader designation will allow the current students to continue with their education at Woodfield School whilst enabling students with more severe learning difficulties to be admitted.

The change will provide greater choice of special school placement for families and students in the future and will significantly provide an option that is within Brent and much closer to their home address.

#### **Arrangements for the pupils currently on the roll of Woodfield School**

The proposed change to expand and broaden the designation of Woodfield School will not affect the education of students currently attending. It is envisaged that the extension to the accommodation can be achieved with minimal disruption to their education. This proposed development compliments the new 20 place Additionally Resourced Provision (ARP) at Alperton Community School. This enables Year 10 students with MLD at Woodfield the opportunity to access mainstream provision which frees up places at Woodfield for those students with more severe learning difficulties.

#### **When is the change proposed to take place?**

It is proposed to change the designation of Woodfield special school from MLD to MLD, SLD and ASD and to provide the additional 40 places with effect from September 2014.

#### **How will the staff be supported?**

A significant number of the students already attending Woodfield School have statements of SEN for SLD and ASD. Many staff therefore have some experience of these needs. In addition the full implications for staff development will be properly planned for and staff will be provided with the opportunity of accessing a full training programme in SLD and ASD specialism as appropriate. They will be supported by the LA's services to schools, and will be provided with opportunities for visiting existing SLD and ASD provision and forging partnerships to support the development.

#### **What changes will need to be made to the school building?**

A new building providing specialist classroom accommodation for 40 students with statements of SEN for SLD and ASD will need to be added to the existing school.

There has been an initial feasibility study on the building of this classroom accommodation. The decision on how to proceed with this feasibility will be made with the full involvement of the senior leadership team and Governing Body of the school.

The proposed expansion will represent a significant investment in the school to ensure that the premises are adapted according to the outcome of the feasibility to fully meet the needs of the new intake of pupils. **The feasibility plans are available to be viewed on request by contacting the school at [admin@woodfield.brent.sch.uk](mailto:admin@woodfield.brent.sch.uk) or by telephoning on 020 8205 1977.**

#### 4. Additional information

##### Basis for the proposed change in Designation.

The numbers of statemented pupils in the 11-19 age range with SLD and ASD identified as primary needs has increased over the last 5 years. The forecast from the Local Authority's projection data is that there will continue to be a need for special school support for secondary aged students with very complex SLD and ASD needs. The following table is taken from the LA's population report on future need for special school places. It shows a projected need for 91 additional special school places for secondary aged students (32 for ASD and 59 for SLD) by 2020.

The capacity in Brent special schools for secondary aged students ASD and SLD is limited and there has been a need to increase placements at independent and non-maintained schools outside the Borough boundary often requiring pupils to travel long distances.

There has also been an increase in incidence of students with a more complex range of issues and combination of layered needs which require informed, specific support.

#### 5. The growing demand for secondary aged ASD/SLD places

The proposed change in designation will provide parents with increased options for special school places. Currently there is little additional capacity in Brent special schools for pupils with these types of SEN. The table below illustrates the increasing need to place pupils with SEN in independent/non maintained special schools outside the Borough boundary over the last 5 years. Many of these places involve pupils having to travel long distances. The proposed changes to Woodfield special school will develop the school's future in line with the staff's growing experiences, the future incidence of SEN and increasing demand for special school places, providing school places within the Borough closer to pupils' homes.

- Carmen explained the growing demand for school places, the growing population and the growing percentage of Special Educational Need children requiring a school place. Sending children to schools out of the borough is not cost effective. Educating the children closer to home has many advantages. The 40 additional places will be introduced gradually over a number of years from September 2014.
- Judith explained the consultation process and the timescales.

<b>1.</b>	How will the places be phased in?	We will introduce additional Year 7 places every academic year.
<b>2.</b>	How many places will there be in Year 7 when at capacity?	Year 7 places will increase from 20 to a maximum of 28.
<b>3.</b>	How many pupils are there currently in Year 7?	23. We are hoping to eventually have 5 additional classes with 8 pupils in each class.
<b>4.</b>	Will the new block be single storey?	Yes, using the part of the site which is not suitable for play space. It will have a green roof and minimal impact in terms of the environment e.g. green roof and insulation.
<b>5.</b>	How will the new pupils arrive at school?	Brent Transport, which means there will be a few additional buses.

The London Borough of Brent is proposing to change the character of Woodfield Special School by expanding the school by 40 places for students aged 11 – 19 and change the designation of the school to provide for the needs of students with moderate learning difficulties (MLD), severe learning difficulties (SLD) and autistic spectrum disorders (ASD) from September 2014.

Woodfield Special School currently has 108 places for children aged 11 – 16 and a Sixth Form currently with 28 places (136 places in total). The proposal is to increase the places for children aged 11 – 19 to 176 places in total from September 2014. This will provide the school with increased flexibility to allocate pupils to places across the full 11 – 19 age range.

Woodfield Special School currently has a designation for MLD. The proposal is to change this designation to MLD, SLD and ASD from September 2014. The change to the broader designation will allow the current students to continue with their education at Woodfield Special School whilst enabling students with more severe learning difficulties to be admitted. A new building providing specialist classroom accommodation for 40 students with statements of SEN for SLD and ASD will need to be added to the existing school.

This proposal is part of a review of the range of existing provision for meeting pupils' SEN across Brent schools in line with current and projected demand.

All applicable statutory requirements to consult in relation to this proposal have been complied with.

### **Explanatory Notes**

- The proposed change to expand and broaden the designation of Woodfield School will not affect the education of students currently attending.
- It is envisaged that the extension to the accommodation can be achieved with minimal disruption to their education. This proposed development compliments the new 20 place Additionally Resourced Provision (ARP) at Alperton Community School. This enables Year 10 students with MLD at Woodfield the opportunity to access mainstream provision which frees up places at Woodfield for those students with more severe learning difficulties.
- There has been an initial feasibility study on the building of the classroom accommodation. The decision on how to proceed with this feasibility will be made with the full involvement of the senior leadership team and Governing Body of the school.
