The premises was the venue of a shooting and GBH that occurred in the early hours of 29th June 2014.

On 2nd March 2014 a new premises licence application was received from The Lounge, Unimix House, Abbey Road, NW10 7TR. The application was for a cafe/restaurant and was supported by a professionally produced architects plan, the licensable activities applied for were the sale of alcohol, regulated entertainment and late night refreshment.

On the night of 28th June 2014 and prior to be furnished as a cafe, this premise was used for a foam party. This was without the knowledge of the relevant authorities and was not a use agreed as part of the application process. It was not even known at that time that the premises had opened.

Whilst this function was ongoing a shooting took place where between two and four rounds were fired resulting in the injury to one person, there was also a subsequent serious assault resulting in a broken jaw. Both of these injuries required hospital treatment and are still being investigated. It is also alleged that a noxious substance similar to tear gas was discharged within the building.

There is photographic evidence that the Condition 24 relating to capacity had been breached. In addition there is CRIS evidence that Condition 7 had been breached in relation to plastic glasses. Condition 22 had also been breached for failing to notify the relevant authorities of the event.

The premises licence holder has indicated that he intends to surrender the licence but the necessary paperwork has not been completed to date. It is my opinion the the premises licence holder is incapable of running this venue within the conditions agreed and there is a serious risk of further crime and disorder should it re open I am therefore asking the committee to revoke the premises licence.

I reserve the right to produce evidence which amplifies the grounds for review which may take place at, or in the vicinity of the premises, between the service of this application and the hearing and / or during the time allowed for any appeal proceedings.
