The Gwalia Working Mens Club holds a Club Premises Certificate which allows the supply of alcohol from 11.00am until 01.30am Monday to Sunday, and is open to members and guests from 11.00am until 02.00am Monday to Sunday.

The Gwalia is failing to promote all four of the licensing objectives, prevention of crime and disorder, the prevention of public nuisance, public safety, and the protection of children from harm

Police have no faith in the ability of the Committee to operate the premises responsibly and therefore wish to bring the matter before the sub-committee for consideration.

The Brent Licensing Police team have tried to work with Mr Simmons and the committee to turn the club around, but with no success as Mr Simmons has been obstructive and has refused to fulfil police requests.

Officers spoke to Mr Simmons on the **19/06/2015** after information was received that there was to be a Traveller party in the Harlesden area, and that there was current tension between rival families. Mr Simmons informed officers that there was no event booked for that weekend, but that the club did hold regular Traveller functions which often resulted in fights, but the club rarely called police as they normally close the bar and let them fight it out. Resulting in the club retaining the £500 deposit which is taken with every booking. Mr Simmons went on to say he had taken several bookings for July 2015 for traveller events, in addition to numerous non traveller events booked by non members, he explained the money generated from these events was what was keeping the

club from going into administration.

On the **25/06/2015** Officers held a meeting with Mr Simmons at the Civic Centre to discuss the clubs current issues around holding unlicensed functions. Mr Simmons confirmed that the club holds several non members, (unlicensed events) a month, this has been happening for many years. He also reiterated that the club holds Traveller functions, on average two a month, that a lot of them get out of hand with fights breaking out, and damage being caused to the premises. They don't call police but just close the bar. He went on to say that they take a £500 deposit and if there is any trouble or damage they keep the deposit.

Mr Simmons was advised that in future the club needed to submit a Temporary Event Notice (TEN) for all non member events. Mr Simmons was also informed that there were current tensions between local traveller families which had been resulting in serious violence, and that police had concerns that this could escalate at these unlicensed functions. Mr Simmons seemed unfazed by this, and was adamant that the club will continue holding these events.

On the **23/08/2015** at about 01.10 hours, police received three (3) 999 calls regarding a large fight happening at the Gwalia Club, on police arrival they found a group of Travellers outside the club, this was made up of men women and children. Several people had blood on their faces. It was established that they had been inside the Gwalia club attending an engagement party when two separate groups started fighting. Police separated the two groups to prevent any further incidents. No one wanted to make any allegations however one group stated that they feared the other group coming back out of the Gwalia and attacking them. It was decided by officers to remove this group from the area to prevent this happening. Officers noted that some of the group were very drunk and unable to stand up unaided.

On the **26/08/2015** I contacted the three people that had called the police on the **23/08/2015** to report the fight. The first person I spoke to was a local resident, who did not want her details disclosed. She stated that she was asleep when she heard a large disturbance outside; when she looked out she saw a large group of people fighting and one male lying in the road unconscious with what appeared to be a head injury. She mentioned that this was a regular occurrence, this time it seemed more serious than usual, and that is why she called police as she feared for people's safety. I then phoned and spoke to one of the other callers, she stated she was passing by when the fight started, and called police as there were people with injuries. She did not hang around and left the area, again she did not want her details disclosed.

I then called the third person; I spoke to a female who stated that she had called police when the fighting started as she was frightened, and that people were getting injured. She also went on to say that she feared for the children that were inside the Gwalia. She stated that it was her engagement party and that her mother had booked the hall for it. She was asked if she or anyone at the venue were members of the Gwalia, she replied no none of them are members, but this is where travellers book events. She stated that her mother had given the club a £500 deposit, and that the club had refused to give it back because of the trouble.

I then called the club chairman Mr Brian Simmons to discuss the incident. I asked him if he had submitted a TEN for the event on the 23/08/2015 as the police had no record of one being submitted, Mr Simmons said that there had been no function at the club on the 23/08/2015 and that the fight had taken place outside the club, but had nothing to do with the Gwalia. I then informed him that I had spoken to the public who had called 999 and they had confirmed to me that there was an event in the club and the fight was between patrons from the club.

Mr Simmons continued to deny that an event had taken place. I asked him if he could supply me with a copy of the CCTV footage for that date. I also informed him that I had spoken to one of the Police officers that had attended the 999 calls and he had confirmed that the people involved had stated that they had been to an engagement party in the club, also that he had witnessed members of the fighting groups going back into the club, and that this officer would be supplying me with a

statement about what he had witnessed. Mr Simmons became angry and abruptly hung up.

A formal letter requesting a copy of the clubs CCTV from the 23/08/2015 was hand delivered to the club dated 29/08/15, I called Mr Simmons a few days later to ask if he had received the letter. He confirmed he had, but stated that he had not downloaded the CCTV, and that if I wanted it, it was down to me to come and get it off the system. I reminded him of his licensing conditions, to which he became angry and eventually put the phone down on me for a second time - No CCTV from this date was ever given to police.

On the **27/08/2015** A TEN was submitted for an event that was to be held at the Gwalia on the 11/09/15. Due to the recent history and the lack of cooperation from Mr Simmons police submitted representations objecting to this notice. At the Licensing committee hearing the Gwalia Club decided to withdraw the TEN and cancel the function on the advice of their solicitor. Mr Simmons informed officers that he had been in contact with his solicitor (Hodders Solicitors) who would be contacting the Licensing unit.

Police spoke to Mr James Tompkins from Hodders solicitors, who are acting for the Gwalia club. It was decided that a meeting would be held with officers from Brent Police Licensing Team, the Gwalia Committee members and Mr Tompkins, to discuss how the club could move forward and put a plan of action together for the club to operate successfully, progress and work within their authority.

On the **08/10/2015** a meeting was held at the Gwalia Club, police outlined their concerns around recent events at the club and suggested several things the club should do when considering holding non member events; these were agreed by the handful of committee members that were present.

- 1. The club Must submit a TEN for every non member function, and this must be submitted with a minimum of 10 working days, as per the legislation.
- 2. A signed contract for non member events will be submitted to the police prior to the event, along with a copy of the applicants photo ID.
- 3. Each non member event will have door stewards consisting of Committee members.
- 4. The front of the Premises will not be used as a smoking area, and no congregating.
- 5. No pint glasses or bottles will be used on these events, only toughed glass or plastic.

Police further requested that the club provide a copy of the clubs rules, an up to date list of club members, an up to date list of the clubs Committee members, and the minutes from the last club meeting. This request was emailed to Mr Tompkins.

Several requests have been made via Mr Tompkins for the above information, but police have never been given the requested information.

On the **12/12/2016** officers from Brent Licensing team were conducting licensing visits on the Borough of Brent, at about 01.00 hours they drove into Manor Park Road Harlesden NW10 from Craven Park Road NW10, when their attention was drawn to a large group of drunken youths in the road directly outside The Gwalia Workingmen's Club.

It was estimated that there were between 50 to 70 teenagers most seemed very drunk and most were staggering across the road dodging traffic, some were slouched on the pavement, and a couple were vomiting against the wall of the club. The majority of the teens were very loud, shouting to one another and laughing. Officers entered the club there were still youths leaving and there were still people inside. Officers spoke to a drunk male who confirmed that an 18th Birthday party had taken place, this was apparent as there were people removing 18th birthday banners and Balloons. There was a DJ packing away his equipment and glasses and bottles being removed from tables and put on the bar. Mr Brian Simmons was present and spoken to. On seeing officers he said 'oh fuck sake not you again' He immediately stated that it was a members function and that police had no right to be in the club. Police informed him that they had spoken to one of the drunken revellers outside who had stated that it had been an 18th Birthday party and not a private members party. Mr Simmons stated that a Pat Conway was the member who was holding the party, when asked if officers could speak to Pat Conway Mr Simmons replied 'he's not here'. He was then asked if there was anyone supervising the drunken teenagers outside he said 'yes we had security on the door but they have gone now'. Officers were then approached by an aggressive female, who demanded to see the officers warrant cards, she then stated that it was her niece's 18th Birthday party; however the niece had gone off to hospital with her mother, as she had injured herself by falling off the stage whilst dancing as she was drunk. She was asked 'what relation she was to Pat Conway, to which she replied 'I don't know Pat, who's Pat'? Another committee member then came over and started being abusive to officers and said words to the effect of, why are you here this is a private members club you have no right to be in here, fuck off you fucking arsehole, he was warned about his behaviour. By this time several other people had come over and were shouting and arguing with officers all were very anti police and seemed to think that we were there to cause problems for the club. One of the people made reference to there being in excess of Two Hundred (200) people in the club tonight, and there were no problems. Officer then went outside as they had concerns for the drunken teens and assisted in removing them from the road. There were no door supervisors.

Again police to date have never been given the requested information.

Police have a copy of the Gwalia Club Rule Book in their Archives and can only assume that it is still current, as the Licensing Authority have no recent documentation

On page 26 of the Gwalia Rule book, it deals with the point of Members introducing Visitors, it reads.

34. Introduction of Visitors

A member may personally introduce friends as his guests, and an Associate may introduce female friends as a guest, but no member or Associate may introduce more than two friends at any one time. The visitor and the member or Associate introducing him shall sign their names in a book kept for that purpose.

Further down the page it goes on to mention who is allowed to make payments for intoxicating liquor - it states

Members and Associates must accompany guests introduced by them during the period of their stay in the club, and no guest shall be permitted to make any payments for intoxicating liquor directly or indirectly.

Police are sceptical that these rules are being adhered to, and evidence of this suggest that on the 12th December 2015, an 18th Birthday party was held at the club, with in excess of two Hundred people.

Police doubt that there are enough members of this club that would have been present at the Party to accommodate this amount of signed in guests.

However if the club had been forthcoming with the police's formal request for the clubs CCTV footage, Committee and club members list on the **16/12/2015** any uncertainty could have been dismissed.

From comments that were made on the night of the party, police believe that this was a non member's function, and this is highlighted in officer's statements, and in previous paragraphs in this review.

Police records show that on the **23/05/2005** the club applied to the local Magistrates Court for the renewal of it's Club Registration Certificate, this was applied for by the Club Secretary Mr Harry George Rawlinson, on the **16/08/2005** Mr Rawlinson made a further application to the local

Authority to convert the Club Registration Certificate to a Club Premises Certificate, this was to conform with the new Licensing Act 2003. On the **31/05/2006** the secretary Mr Rawlinson made application on behalf of the club to vary the premise licence extending the hours until 01.00. Representations were made to this application by the police, licensing sergeant Adrian Adolphus requested numerous conditions be attached to the certificate. Hodders solicitors represented the venue, the club agreed for these conditions to be attached to the certificate.

Within Sergeant Adolphus's representation letter, dated the **24/06/2006** he highlighted the fact that the sale of intoxicating liquor to persons other than members and their guests is no longer a provision of a club premises certificate and therefore they would have to submit a Temporary Event Notice or consider applying for a premises licence to entertain non members or hire the premises for other use.

Since this variation application in **May 2006** the police and local authority have not received any correspondence from the club as regard to changes of committee members, members, or rules.

On Sunday **06/11/11** Suspect was arrested for ABH, this was as a result of Suspect attending a christening at Gwalia Working Mans club, on Manor Park Road, NW10, and after having had too much alcohol to drink, he punched Victim 1 in the head, back and body. Victim 1 stated this attack was unprovoked; suspect became mad like a raging bull removed his shirt before attacking people and the property and had to be restrained by people in the venue. There was reddening to Victim 1 back and neck where he was punched. Victim 1 refused medical attention.

Crimint: QKRT433057. January 2014 - Police called to Gwalia working mans club in Harlesden at 0103 hours by the manager after a wedding became out of hand. The customers were from the local Irish community and all seemed to be suffering from to much drink, the venue had suffered smashed glasses and up turned tables when local units arrived. Also present were small children running around. The manager was spoken to and did not wish to make any allegations but needed police assistance in removing the wedding party of around 120 people from the venue. This took over an hour so not to push everyone out in to the road at once a dog unit was also present. No security had been employed by the club.

Police reserve the right to give evidence on any further incidents which may take place at, or in the vicinity of the premises, between the service of this application and the hearing and/or during the time allowed for any appeal proceedings.

Summary

The above evidence highlights a clear mismanagement of the club by the Chairman Mr Simmons and the Committee, police had tried to work with the Gwalia to promote the licensing objectives but it appears that they have no intention of wanting to comply, Mr Simmons has been obstructive and rude throughout the time police have attempted to work with him, and he seems to think that the police are trying to ruin the club.

The above evidence shows a complete disregard for the Licensing objectives, the club has also failed to show any regards towards local residents who would have to witness the disorder outside their front doors when these unlicened events occur.

Police feel that there is no other option other than to ask for the Committee to consider revoking the clubs licence as all other intervention has failed, the club already has a large amount of conditions attached to it licence, and adding more conditions to it would not help as the club has shown a complete disregard for most of its current conditions, an example of this is when Mr Simmons informed me that the clubs CCTV system only records for about 7days, when the licence states it must record for a minimum of 31 days..

These regular unlicensed functions are allowed by the club without any control measures being put in place, there are no door supervisors employed and very little to no checks completed on the people booking the club. This was apparent when officers withnessed the large group of rowdy teenagers that were found drunk and staggering in and out of the road after a birthday party in the club with no supervision. More worryingly is that the club is allowing people to fight in the club and not call police, this shows a complete lack of responsibility of a responsible club, and it appears only by luck that there hasn't been a more serious incident at the venue, however if this is allowed to continue then it will only be a matter of time.
